G. F. Bowen, Governor. ORDER IN COUNCIL. At the Government House, at Wellington, the eleventh day of November, 1868.

Present :

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by "The Marine Act, 1867," it is enacted that the Governor may, by Order in Council, from time to time delegate all or any of the powers and authorities vested in him by the said Act unto any person or persons, for any period, and subject to any regulations, restrictions, or stipula-tions which may be specified in such Order, and every such delegation may from time to time alter or revoke:

Now therefore I, Sir George Ferguson Bowen, the Governor, by and with the advice and consent of the Executive Council of the Colony, do by this Order delegate unto

JAMES ALEXANDER BONAR, Esq.,

Chairman of the Council of the County of Westland, such of the powers vested in me as Governor by section seven of the said Act as enable me to erect, superintend, and maintain harbour marks, buoys, lights, and beacons, within the limits of the Ports of Okarita, Hokitika, and Greymouth, or the approaches thereto, in the County of Westland, so long as he shall continue to hold the office of Chairman of the Council thereof, subject however to such directions as may from time to time be issued by the Colonial Marine Engineer as to the size, position, and colour of such harbour marks, buoys, lights, and beacons; and do also delegate to James Alexander Bonar, Esq., the powers vested in me by sections twelve, thirtcen, seventeen, and forty-two of the said Act, to have and exercise the said powers hereby delegated so long only as he shall continue to hold the office of Chair-man of the Council of the County of Westland, and no longer.
