At the Government House, at Wellington, this twenty-seventh day of January, 1869.

Present: HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Maori Real Estate Management Act, 1867," it is enacted that if any title to or interest in any hereditaments shall accrue to any Maoris who, or any of whom, shall be infants, lunatics, or under legal disability, it shall be lawful for the Governor in Council, if he think fit, to order that such hereditaments, or any part thereof, or interest therein, as shall to the Governor in Council

be shown to belong to such infant, lunatic, or other person under legal disability, shall be vested in Trustees as the Governor in Council shall think fit:

And whereas, by virtue of a Crown Grant bearing date the twenty-second day of September, one thousand eight hundred and sixty-eight, the parcel of land and hereditaments described in the Schedule hereto became vested in Te Harawira Turangapito, Mata Turangapito, Te Mate Tahora, Metiria Turangapito, and Hineitearakahia, of the Wanganui District, Province of Wellington, aboriginal fiatives of New Zealand: And whereas the said Te Harawira Turangapito, Mata Turangapito, Te Mate Tahora, Metiria Turangapito, and Hineitearakahia are infants

under the age of twenty-one years:

Now, therefore, His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, with the advice and consent of the Executive Council of the Colony, in exercise and in pursuance of the powers and authorities vested in him by the said Act, doth hereby order that the lands described in the Schedule hereto shall be and remain vested in

TAMEHANA TE AEWA, and TARETE MORINGA,

both of Whanganui District, aboriginal natives, as Trustees within the meaning and for the purposes of the said Act for the said Te Harawira Turangapito, Mata Turangapito, Te Mate Tahora, Metiria which may be referred to you by the Colonial Secre-

Turangapito, and Hineitearakahia, their heirs and assigns for ever.

All that parcel of land in the Province of Wellington, in the Colony of New Zealand, containing by admeasurement one (1) rood and thirty-six (36) perches more or less, situate at Ranana, in the Whanganui District, being called or known by the name of "The Store Block," and numbered Forty N. tary, and to ascertain whether the claimants making the same have done any of the things described in the fifth section of "The New Zealand Settlements Act, ' and further to make inquiry into the character of certain purchases and gifts of land within the said boundaries alleged to have been made by and to Europeans; and do appoint you a Commission for the purposes of the said deed, and do enjoin you to make such adjudications, awards, and reports, in all the matters hereby referred to you, as may consist with the equity of the cases respectively; and do authorize and empower you to order the attendance of such persons, and the production of such books, papers, maps, and other things, as may be needful for the due prosecution of such inquiry, and to administer oaths and take declarations to and from all or any of the persons so summoned; and do enjoin you to report to me from time to time without delay the decisions and awards which you shall make under the powers hereof.
