HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Mining Companies Limited Liability Act, 1865," it is enacted that the Governor in Council may from time to time appoint in and for each mining district some proper person to be Official Agent in and for such district, and may require of such person such security as he shall think fit.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of New Zealand, doth hereby appoint

GEORGE FACHE, Esq.,

of Clyde, in the Province of Otago, to be Official Agent, subject to the provisions contained in the said Act, in and for the Mining District of the Otago Gold Fields, vice H. J. Cope, Esq., resigned, and doth hereby require of the said George Fache security by bond, with two approved sureties, in the form and to the amount specified in the Schedule hereto.

Now the condition of the above-written obligation is such that if the said from time to time, so long as he shall continue and be employed in the said office, shall duly perform the duties of the said office, and duly account for and pay over all moneys which shall come to the possession or be under the control of himself or his agents, by reason of or by virtue of the said office or employment; and shall from time to time observe and keep all such orders and instructions as he shall receive from the Governor of New Zealand for the time being touching the due performance and execution of the said office; and shall from time to time, and at all times hereafter, so long as he shall hold the said office, well and truly, faithfully and honestly, to the best of his skill and ability, exercise, obey, discharge, and perform all the duties thereof, and also all the powers, directions, duties, and obligations given to, conferred upon, or to be performed and discharged by him under any law for the time being relating to the said office; and shall, when thereunto required, deliver up all books, deeds, orders and decrees of the Judges of the District Court or of the Supreme Court, vouchers, and other papers relating to the said office, and also such commission, warrant, or authority as he hath received or shall receive from the Governor, to such person as the Governor shall direct and appoint to receive the same, then this obligation to be void and of none effect, or else to remain in full force and virtue: provided always that no more than the sum of two hundred and fifty pounds shall be recoverable from

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.
WHEREAS by "The Marine Act, 1867," it is enacted that the Governor may by Order in enacted that the Governor may, by Order in Council, from time to time delegate all or any of the powers and authorities vested in him by the said Act unto any person or persons, for any period, and subject to any regulations, restrictions, or stipula-tions which may be specified in such Order, and every such delegation may from time to time alter or revoke: And whereas His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, did on the eleventh day of November, 1868, with the advice and consent of the Executive Council of New Zealand, delegate to the Honorable James Alexander Bonar, Chairman of the Council of the County of Westland, certain of the said powers and authorities: And whereas it is expedient to revoke the said delegation:

Now therefore I, Sir George Ferguson Bowen, the Governor of New Zealand, by and with the advice and consent of the Executive Council of New Zealand, do hereby revoke the delegation of the said powers and authorities to the Honorable James Alexander Bonar, and do hereby, with the consent

and advice as aforesaid, delegate to

### CONRAD Hoos, Esq.,

Chairman of the Council of the County of Westland, such of the powers vested in me as Governor of New Zealand by section seven of the said Act as enable me to erect, superintend, and maintain har-bour marks, buoys, lights, and beacons, within the limits of the Ports of Okarita, Hokitika, and Greymouth, or the approaches thereto, in the County of Westland, so long as he shall continue to hold the office of Chairman of the Council thereof, subject however to such directions as may from time to time be issued by the Colonial Marine Engineer as to the size, position, and colour of such harbour marks, buoys, lights, and beacons; and do also delegate to Conrad Hoos, Esq., the powers vested in me by sections twelve, thirteen, seventeen, and forty-two of the said Act, to have and exercise the said powers hereby delegated so long only as he shall continue to hold the office of Chairman of the Council of the County of Westland, and no longer.

AT HEREAS by "The Public Revenues Act, 1868," it is enacted that it shall be lawful for the | the Charts.

Governor in Council from time to time to alter or rescind any regulations made under the authority of "The Public Revenues Act, 1867," or of "The Public Revenues Act, 1868," and to make other regulations not inconsistent with "The Public Revenues Act, 1867," in the place thereof, and that all such regulations shall be published in the New Zealand Gazette, and shall come into force upon a day to be named therein: And whereas, in pursuance of the said powers, His Excellency the Governor, with the advice and consent of the Executive Council of the said Colony, did, on the second day of December, 1868, make and order certain regulations, the second section of the fourth of which regulations is as follows:—" Every Receiver whose office is in a place where there is no branch of a Bank, and who shall not be authorized to retain fees received by him by way of salary, shall transmit his collections to the Bank at Wellington, by Post Office Order or by Registered Letter, upon the last day of each month, with forms of Bank Receipt prepared in duplicate, and the Bank will transmit one copy of the duplicate Bank Receipt to the Receiver by return of post, and will send the other copy to the Receiver-General": And whereas it is expedient to alter and amend the said fourth regulation:

Now, therefore, His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, in pursuance and in exercise of the powers and authorities for that purpose vested in him, doth hereby, with the advice and consent aforesaid, make and ordain that the said fourth regulation shall be amended by inserting after the word "salary" the words "shall when so directed in writing by the Colonial Treasurer, transmit his collections to the nearest branch of the Bank, or if not so directed," so that the said clause when amended shall read thus:—" Every Receiver whose office is in a place where there is no branch of a Bank, and who shall not be authorized to retain fees received by him by way of salary, shall, when so directed in writing by the Colonial Treasurer, transmit his collections to the nearest branch of the Bank, or if not so directed, shall transmit his collections to the Bank at Wellington, by Post Office Order, or by Registered Letter, upon the last day of each month, with forms of Bank Receipt prepared in duplicate, and the Bank will transmit one copy of the duplicate Bank Receipt to the Receiver by return of post, and will send the other copy to the Receiver-General.'

HE following Letter from Commodore Rowley Lambert, C.B., on Mr. Woods' Survey of the New Zealand Coasts, is published for general information.

E. W. STAFFORD.

H.M.S. "Challenger," at Wellington, 22nd February, 1869.

SIR,—With reference to your Excellency's letter of the 11th instant, and my reply thereto, I have the honor to acquaint you that I have seen Mr. Woods, examined his surveys and plans of the New Zealand Coasts, and compared the same with the Admiralty Charts.

The survey is projected on reliable data, and appears to have been executed with great care and accuracy; and the sketches of the different headlands in water colours render them more distinguishable than in the pen and ink etchings usually marked on

The positions of several prominent headlands, hitherto incorrect, have been determined, and the delineation of the Coast corrected by Mr. Woods, who has likewise collected much valuable hydrographical information respecting the same.

I would recommend the completion of the West Coast Surveys, and also that the South Coast of the Middle Island, from Cape Saunders to Cascade Bay, and parts of East Coast of the North Island, hereafter mentioned, be re-surveyed :- D'Houssez Group, just northward of Mercury Bay, the islands and rocks in and adjacent to the Hauraki Gulf, and additional soundings procured in the Bay of Plenty

Mr. Woods has brought to my notice the advisability of determining the true meridian of Wellington, to effect which a series of observations should be intrusted to three competent and duly qualified officers,—say, the Officer in charge of Observatory, the Officer in charge of Marine Survey, the Chief Resident Surveyor, at Wellington; and the result of such work should be forwarded periodically to the Hydrographer of the Navy, together with the longitudes of other positions of the coast surveyed, deduced from the Wellington Observatory meridian, which would be most useful for the sufer projection. which would be most useful for the safe navigation of these seas.

It is necessary that the work of such observations should also be forwarded for the inspection of the Hydrographer.
