ORDER IN COUNCIL.

At the Government House, at Wellington, this  
sixteenth day of April, 1869.

Present :

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Bonded Warehouse Duty Act, 1866," it is amongst other things enacted that the occupier of any warehouse appointed for the free warehousing and securing goods therein liable to duty under the provisions of "The Customs Regulation Act, 1858," shall pay to the Collector of Customs, or such other officer as may from time to time be appointed by the Commissioner of Customs for such purpose, an annual duty according to the Schedule thereto annexed: And whereas by "The Customs Regulation Act Amendment Act, 1868," it is amongst other things provided that it shall be lawful for the Governor in Council, by an Order for that purpose, at any time to exempt from the payment of duty chargeable under "The Bonded Warehouse Duty Act, 1866," the owner or occupier of any warehouse to be appointed after the passing of the Act now in recital for the warehousing or securing of goods liable to duty at any Port, excepting those at Auckland, New Plymouth, Wanganui, Wellington, Napier, Nelson, Greymouth, Hokitika, Lyttelton, Christchurch, Timaru, Oamaru, Dunedin, and Invercargill: And whereas application has been made for a license for a Warehouse, situate upon section 224, Town of Kaikoura, fronting Fyffe's Quay, of which James Davidson is the owner or occupier, and it is expedient that the owner or occupier of the said Warehouse should be exempt from payment of the duty chargeable under "The Bonded Warehouse Duty Act, 1866:"

Now therefore I, Sir George Ferguson Bowen, Governor of New Zealand, in exercise and pursuance of the said power and authority, and with the advice and consent of the Executive Council of New Zealand, do hereby order that the occupiers and owners of the said Warehouse shall be exempt from payment of the duty chargeable thereon under "The Bonded Warehouse Duty Act, 1866."

TO ALL TO WHOM THESE PRESENTS SHALL COME,  
GREETING :

WHEREAS by "The Municipal Corporations Act, 1867," it is enacted that for the first election of Councillors under the said Act in every borough in which no Councillors shall as yet have been in office, those persons enrolled on any electoral roll which, under the provisions of "The Registration of Electors Act, 1866," shall for the time being be in force, whose qualifications are in respect of lands and tenements situate within the borough, and none other, shall, on such day as the Governor shall appoint, not being less than forty days after the same shall have become such borough, and in the manner therein mentioned, elect the whole number of Councillors by the said Act assigned to such borough; and by the said Act it is also provided that every election of Councillors for any borough not divided into wards shall be held by and before the Mayor of the borough, and that if at any time there shall be no Mayor, the Council of the borough, or, if there be no such Council, the Governor may and shall appoint some person by and before whom such election shall be conducted:

And whereas the Town of Blenheim was, by Proclamation bearing date the sixth day of March, one thousand eight hundred and sixty-nine, constituted a borough under the said Act:

And whereas it has been made to appear to me that there is no Mayor of the said borough, nor any Council of the said borough, and that the said borough is not divided into wards:

Now know ye that I, Sir George Ferguson Bowen, the Governor of New Zealand, in exercise and pursuance of the powers vested in me by the said Act, do hereby appoint the fifteenth day of May, one thousand eight hundred and sixty-nine, to be the day whereon the first election of Councillors for the Borough of Blenheim shall take place, and Stephen Lunn Muller, Esquire, to be the person by and before whom the said election shall be held.

GOVERNMENT NOTICE, No. 23, 1869.

His Excellency the Lieutenant-Governor directs it to be notified that two vessels have arrived in the Harbour of Port Natal from Australia, conveying a number of passengers, who have informed certain officers of this Government, at Durban, that they have come to Natal under a misapprehension which is widely spread in Australia, that what are there termed "payable gold-fields" exist, either in Natal, or the country of the Chief Moselikatse, at a distance of upwards of eight hundred miles in the interior of Africa, and beyond the territories of the Transvaal, or South African Republic.

The Lieutenant-Governor therefore deems it advisable to inform the public generally, both in Natal and elsewhere, that this Government is not in possession of evidence of the existence of gold in remunerative quantities, either in Natal or in the territories referred to, although auriferous spots have been discovered in both.

The Lieutenant-Governor deems it expedient also to caution persons at a distance against being misled by individual impressions of imperfect information, and against supposing that there exists at present in Natal such a demand for labour as would supply by its profits, to persons without capital, the means of proceeding into the interior.

NOTICE TO MARINERS.

NEW LIGHTHOUSES IN COURSE OF ERECTION  
ON THE COASTS OF NEW ZEALAND.

Marine Department,  
Wellington, 22nd April, 1869.

SEVERAL new Lighthouses being in course of erection in New Zealand, the following preliminary description of them is published for general information; more exact and detailed descriptions will be published when the works are more advanced.

It is anticipated that the lights will be ready for exhibition early in 1870.

1.—*Lighthouse on Farewell Spit, Cook Strait.*

The lighthouse is to be erected in the immediate vicinity of "Bush End," on Farewell Spit, at the western entrance to Cook Strait.

The light is intended to show all round, and is to be a revolving white light, of the second order dioptric, attaining its greatest brilliance once a minute.

Over the Spit end it is intended to make the light show red instead of white as elsewhere, in order to caution mariners of their approach to that danger.

The light will be elevated about 120 feet above the sea level, and will be visible in clear weather about 17 nautic miles, allowing 15 feet for the height of the observer's eye, and at lesser distances according to the state of the atmosphere.

The tower is to be an open-framed structure of timber, and will be 118 feet in height from the ground to the top of the lantern.

2.—*Lighthouse on Cape Campbell, Cook Strait.*

The lighthouse will be erected on a knoll at the northern extreme of the high land of Cape Campbell, on the south side of the eastern entrance to Cook Strait.

The light will show all round where not intercepted by the land, and is to be a revolving white light of the second order dioptric, attaining its greatest brilliance once a minute.

The light will be elevated about 155 feet above the sea level, and will be visible in clear weather about 19 nautic miles, allowing 15 feet for the height of the observer's eye, and at lesser distances according to the state of the atmosphere.

The tower is to be an open-framed structure of timber, and will be about 73 feet in height from the ground to the top of the lantern.

3.—*Lighthouse on Nugget Point, Molyneux Bay.*

The lighthouse is to be erected on a well-defined knoll, about 240 feet high, at the outer extremity of Nugget Point, the southern limit of Molyneux Bay (in 46° 27' South latitude, and 169° 51' East longitude, as measured on the Admiralty chart).

The light will show to seaward over an arc of about 225°, and will be a fixed white light of the first order dioptric.

The light will be elevated about 252 feet above the sea level, and will be visible in clear weather about 23 nautic miles, allowing 15 feet for the height of the observer's eye, and at lesser distances according to the state of the atmosphere.

The tower will be of stone, and painted to suit the background. It will be 31 feet in height from the ground to the top of the lantern.

4.—*Temporary Light at Manukau Heads.*

A small fifth order apparatus has been ordered from England, and will be erected on one of the beacons on the South Head of Manukau Harbour, on its arrival.

The light will be a fixed white light of moderate power, though from the great elevation of the land

(about 500 feet) it may be seen, in very exceptionally clear states of the atmosphere, at a distance of nearly thirty nautic miles.

This light is only meant to benefit vessels accustomed to trade on the coast; it is not intended in any way to encourage vessels to attempt to enter Manukau Harbour during the night, nor is it meant to encourage strangers to approach the port.

## SNAG IN ENTRANCE TO BULLER RIVER.

SINCE publication of the Notice to Mariners with reference to the Snag in the Fairway of the North Channel of the Buller River, dated the 7th of the present month, information has been received that the channel has worked farther to the north-east, so that the sailing directions then published are no longer correct.

Vessels entering in daylight must keep the Flagstaff and the Beacon carrying the red flag (which is only hoisted at tide time) in one; and failing this, they must be steered in close accordance with the directions of the semaphore arm at the Flagstaff.

As the channel shifts so rapidly, no directions can be given for entering by night; and only masters who are so thoroughly acquainted with the port and the local signals as to be able to take it without special directions, would be justified in attempting it.

## NOTES.

*Mongonui.*—Fine weather during the month; small rainfall; light winds.

*Auckland.*—Strong gale on the 1st from S.W.; also high wind on the 23rd and 24th from same quarter, which increased to a gale on 25th. On the whole, fine weather with little rain.

*Taranaki.*—Fine weather generally; thunder on the 11th; fog on the 3rd; earthquakes on 4th, 10th, and 15th—all slight.

*Napier.*—Fresh gales on 23rd, 24th, and 25th, from W., but no rain. Fine clear weather; very slight rain; strong winds occasionally.

*Wellington.*—Stormy and unpleasant weather on 4th and 5th, from N.W.,—very dry; on 8th strong N.W. wind and drizzling rain. Severe gale on night of 26th, from N.W., with rain; velocity of wind recorded on morning of 27th, for previous twenty-four hours, was 860 miles; very heavy rain on the 10th,—1.030 inches registered at 9.30 a.m. on 11th. The rainfall on the whole is considerably below the average for same month in previous years, and, with the above exceptions, the wind was moderate and the weather pleasant. There were twenty-one days of N.W. wind.

*Nelson.*—Fine weather at this station; unusually small rainfall; winds moderate.

*Christchurch.*—Fine bright clear weather generally during this month; slight rainfall and very light winds. On the 24th, there was a strong N.W. gale with clear sky.

*Hokitika.*—Gale from S.W. on 2nd; strong S.W. wind on 10th, accompanied with heavy rain and thunder; gale from S.W., with rain, on 21st, also on 24th; hail on 19th. Wet, cold, and unpleasant weather generally, although fine in the middle and towards end of the month.

*Bealey.*—Gale on 18th from N.W., with heavy rain, up to morning of 19th; also gale from same quarter on 24th and 25th. Fine weather generally in the early part of this month, but wet and stormy towards the end; heavy rain on 19th,—1.346 inches in twenty-four hours.

*Dunedin.*—On the whole, fine clear weather, with light winds and little rain, up to the 21st; on 22nd, 23rd, and 24th, stormy weather from N.W. and W.; snow fell on 24th; thunder on the 4th and 8th; fog on 26th and 30th. The latter part of the month was rather wet and unpleasant.

*Southland.*—The Observer remarks that "the weather was very fine, dry, and warm, until the 21st; temperature in shade on the 16th, 80°, the highest recorded in March since 1862; on 21st, equinoctial gales set in from W. and N.W., with violent squalls of hail and rain, and some severe thunder-storms on 23rd and 24th; there was also thunder on 21st and 22nd, though not so heavy; storms lasted without cessation until 25th. Remainder of month showery and unsettled. On 27th, air saturated for thirty-six hours, mean temperature of air and evaporation being identical; on 31st, range of temperature only 6°. There were seventeen days of N.W. wind, and twelve of W. Rainfall greater than that for same month in previous years. The maximum fall of rain for twenty-four hours was on 24th, 1.22 inches. Hail fell on 21st, 23rd, and 24th."

## GENERAL REMARKS.

The weather was unusually fine and pleasant at all the stations in the North Island during this month; the fall of rain was considerably below the average for previous years, and although there were a few gales from N.W., yet the mean velocity of wind was low; the barometer readings for the month are high in every case in the North Island. On the West Coast of the South Island, and south of Christchurch, the weather was not so fine; several severe storms from S.W. and N.W. occurred, accompanied with hail, thunder, and heavy rain.
