#### G. F. Bowen, Governor. ORDER IN COUNCIL. At the Government House, at Wellington, this twenty-fifth day of August, 1869.

#### Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Electric Tele-graph Act, 1865," the Governor of New Zealand is empowered to establish lines of electric telegraph, and to purchase any lines of electric telegraph then existing: And whereas by the said Act it is amongst other things enacted that it shall be lawful for the Governor, by Order in Council, to make regulations for the transmission and delivery of all despatches, messages, and communications by means of any such line, and in like manner to fix and determine the fees, rates, or dues to be demanded and received for the transmission of any such despatch, message, or communication, and for the delivery thereof respectively, and the modes and times of payment; and to regu-late the conduct, management, working and maintenance of any such telegraph line, and any such fees, rates, dues, or regulations from time to time to increase or lower, repeal, alter, or vary respectively, and direct and make such others as may be deemed expedient; and that such fees, rates, and dues may be legally recovered; and such regulations shall have the force of law when published in the Government

Gazette of the Colony: And whereas by an Order in Council duly made and issued, bearing date the eleventh day of August, one thousand eight hundred and sixty-nine, the Governor in Council did, in pursuance of the said recited power and authority, fix and deter-mine the fees, rates, or dues to be demanded or received for the transmission of any such despatches, messages, or communications by means of any line of telegraph which has been or hereafter shall be established or purchased under the powers conferred by the said Act: And whereas it is expedient to revoke the said Order in Council, and to fix a new tariff of charges :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by the herein-before recited Act, doth, with the advice and consent

of the Executive Council of New Zealand, revoke the said Order in Council of the eleventh day of August, one thousand eight hundred and sixty-nine, and doth hereby fix and determine that the fees, rates, and dues specified in the Schedule hereto shall be the fees, rates, and dues to be demanded and received for the transmission of despatches, messages, and com-munications, and the delivery thereof respectively by such lines of telegraph as aforesaid ; and doth further declare that this order shall take effect on and after the first day of September, one thousand eight hundred and sixty-nine.

# HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

HEREAS at a sitting of the Native Lands Court of New Zealand held at Matamata, in the District of Waikato, Province of Auckland, on the twenty-second day of February, one thousand eight hundred and sixty-nine, the claim of Hakiriwhi and others to a piece of land called Te Aroha, situate at Upper Thames, was heard, and a certain order was thereupon made by the Court aforesaid: And whereas it is enacted by "The Native Lands Act, 1865," and "The Native Lands Act, 1867," that the Governor in Council may order a rehearing of any matter judicially heard before the Court aforesaid, before one or more Judges of the Court, and one or more Assessors, as may be specified in the Order in Council ordering such rehearing, and within such a period of time as may be limited in such Order, provided that no such order for a rehearing shall be made after six months shall have elapsed from the date of the original decision: And whereas it is expedient that the said claim shall be reheard before the said Court :

Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council of the Colony, in pursuance and exercise of the above recited power and authority, doth hereby order that the aforesaid claim of Hakiriwhi and others to the aforesaid piece of land shall be reheard before two Judges and two Assessors of the Native Lands Court; and doth order that such rehearing shall take place before the thirty-first day of December, one thousand eight hundred and seventy.

OSWALD CURTIS, NATHANIEL EDWARDS, WILLIAM HUNTER REYNOLDS, HENBY HOWORTH, GEORGE MAUBICE O'RORKE, EDWARD CEPHAS JOHN STEVENS, and JONAS WOODWARD, to be Commissioners to investigate and report upon the Laws relating to Building and Land Societies, the operation of such Laws, and the working of such Societies, and to make such suggestions in connection therewith as to you may seem fit: And I do, by these presents, by and with the advice and consent aforesaid, grant to you, or any two of you, full power and authority to carry into effect the purposes of this Commission by all lawful ways and means whatever: And I do, by these presents, ordain that this Commission shall continue in full force and virtue; and that you, the said Commissioners, or any two of you, shall and may, from time to time, and at any place, proceed in the execution thereof, although the same be not continued from time to time by adjournment: And I do further will and direct that you do, within six months after the date of this Commission, or as much sooner as the same can be done (using all diligence), certify to me, under your hands and seals, or under the hands and seals of any three of you, your several proceedings and your opinion touching the premises.
