A PROCLAMATION.

WHEREAS by an Act of the Imperial Parliament, passed in the fifteenth and sixteenth years of the reign of Her present Majesty, cap. 72, intituled "An Act to grant a Representative Constitution to the Colony of New Zealand," the several Provinces of Auckland, New Plymouth, Wellington, Nelson, Canterbury, and Otago are thereby established, and it is enacted that for each of the said Provinces there shall be a Superintendent and Provincial Council:

And whereas by the said Act it is further enacted that every Provincial Council shall continue for the period of four years from the day of return of the writs for choosing the same and no longer: Provided always that it shall be lawful for the Governor of New Zealand, by Proclamation or otherwise, to dissolve the same whenever he shall think it expedient so to do:

Now therefore I, Sir George Ferguson Bowen, the Governor of the Colony of New Zealand, do, by this Proclamation, dissolve the Provincial Council of the said Province of Auckland accordingly.

Given under the hand of His Excellency Sir George Ferguson Bowen, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, at the Government House, at Wellington; and issued under the Seal of the said Colony, this seventh day of September, in the year of our Lord one thousand eight hundred and sixty-nine.

WHEREAS by an Order in Council made on the twenty-fifth day of March, one thousand eight hundred and sixty-one, the Province of Southland was constituted and established under "The New Provinces Act, 1858," and it is provided by the Constitution Act that it shall be lawful for the Governor of New Zealand, by Proclamation or otherwise, to dissolve the Provincial Council of any Province whenever he shall think it expedient so to do:

Now therefore I, the Governor of the Colony of

Now therefore I, the Governor of the Colony of New Zealand, in exercise of the said power, do. by this Proclamation, dissolve the Provincial Council of the said Province of Southland.

Given under the hand of His Excellency Sir George Ferguson Bowen, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, at the Government House, at Wellington; and issued under the Seal of the said Colony, this seventh day of September, in the year of our Lord one thousand eight hundred and sixtynine.

To all to whom these Presents shall come, Greeting:

WHEREAS by "The Regulation of Elections Act, 1858," it is enacted that it shall be lawful for the Governor, by warrant under his hand, from time to time to appoint polling places for each

Electoral District, within or without the limits thereof, and to appoint any one of such places to be the principal polling place for the district, and all or any of such polling places at any time to abolish, and to appoint other polling places in lieu thereof:

And whereas by warrant under the hand of the Governor, bearing date the eleventh day of July, one thousand eight hundred and sixty-five, Mr. Blakie's Barn, Ryal Bush, was appointed a polling place for the District of New River, for the election of Members of the Provincial Council of the Province of Southland: And whereas it is expedient to abolish the same:

Now know ye that I, Sir George Ferguson Bowen, the Governor of the said Colony, in pursuance of the power and authority in me vested by the said Act, do hereby abolish the above-named polling place for the District of New River, for the election of Members of the Provincial Council of the Province of Southland, and do appoint in lieu thereof

The School House, Wallacetown, and The Police Station, Winton.

And I do appoint the School House, Wallacetown, to be the principal polling place for the said District.
