IN pursuance and exercise of the power and authority in me vested in this behalf by "The Resident Magistrates Act, 1867," I, Sir George Ferguson Bowen, the Governor of the Colony of New Zealand, do hereby proclaim and declare that from and after the first day of October next, the jurisdiction of the Resident Magistrate's Courts for the

## WANGANUI DISTRICT

# and the

# MANAWATU DISTRICT,

as the same are respectively defined in a Proclamation bearing date the third day of September, one thousand eight hundred and sixty-eight, and a Proclamation bearing date the twenty-fourth day of June, one thousand eight hundred and sixty-nine, shall be extended to One Hundred Pounds.

Given under the hand of His Excellency Sir George Ferguson Bowen, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, at the Government House, at Wellington; and issued under the Seal of the said Colony, this second day of September, in the year of our Lord one thousand eight hundred and sixty-nine.

To the Honorable Nathaniel William Levin, a Member of the Legislative Council; Jonas Woodward, Esquire, Receiver-General; and Arthur William Follett Halcombe, Esquire:

WHEREAS it is expedient, for divers good causes and considerations, that a Commission should forthwith issue for the purposes hereinafter mentioned:

Now know ye, that, reposing great trust and confidence in your zeal and ability, I, Sir George Ferguson Bowen, G.C.M.G., the Governor of New

Zealand, with the advice and consent of the Executive Council of New Zealand, do, by these Presents, authorize and appoint you the said

NATHANIEL WILLIAM LEVIN,

JONAS WOODWARD, and ARTHUR WILLIAM FOLLETT HALCOMBE,

ARTHUR WILLIAM FOLLETT HALCOMB

to be a Commission to examine all the documents purporting to be Bonds and Debentares issued under any Act or Acts of the General Assembly, or under any Act or Ordinance of any of the several Provinces in New Zealand, and all Coupons belonging thereto, which have been received in exchange or as payment for Debentures issued under the authority of "The Consolidated Loan Act, 1867," and to determine whether the said documents are genuine, and to accept, on behalf of the Colony, so many of the said documents as you shall find to be authentic: And I do, with the like advice and consent as aforesaid, appoint you to inquire whether the condition of a certain Bond bearing date the twenty-sixth day of January, one thousand eight hundred and sixtynine, under the hands and seals of Penrose Goodchild Julyan and William Charles Sargeaunt, of Spring Gardens, in the County of Middlesex, in England, whereby the said Penrose Goodchild Julyan and William Charles Sargeaunt became bound to William Fitzherbert, Esquire, in the sum of twenty thousand pounds ( $\pounds 20,000$ ), has been fulfilled, and whether they ought to be released from their Bond, or whether the said Bond should be put in suit: And I, with the like advice and consent, enjoin you, that you dc, before the twenty-first day of October next, or as much sconer as the same can conveniently be done (using all diligence), certify to me under your hands and seals, or under the hands and seals of any one or more of you, your several proceedings, and your opinion touching the premises: And I, with the like advice and consent, appoint the said Jonas Woodward to be Chairman, and to preside at all your meetings whereat he shall be present: And I, with the like advice and consent, order that this present Commission shall continue in full force and virtue, and that you the said Commissioners, or any one or more of you, shall and may from time to time proceed in the execution thereof, and of every matter and thing therein contained, though the same be not continued from time to time by adjournment.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the seventeenth section of "The Public Revenues Act, 1867," it is provided that it shall be lawful for the Governor in Council, to direct that any money in the Public Account to credit of the Public Trust Fund shall be invested at interest with any bank or banks or otherwise, upon such terms, and at such interest and for such periods, as the Colonial Treasurer shall think fit:

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of New Zealand, doth hereby direct that the sum of fifteen thousand pounds, out of the moneys payable to the Public Account to the credit of the Public Trust Fund, shall be invested in Debentures issued under "The Consolidated Loan Act, 1867."

At the Government House, at Wellington, this ninth day of September, 1869. Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by "The Gold Fields Act Amend-W ment Act, 1868," it is enacted that it shall be lawful for the Governor, if and whenever he shall have by lease, agreement, or otherwise, by consent of the Native owners of any land over which the Native title has been extinguished, or the Native owners of any land over which the Native title has not been extinguished, obtained power from such Native or other owners to authorize entry on such lands for mining for gold, by Proclamation issued under the third section of "The Gold Fields Act, 1866," to include such land within any Gold Field, or to pro-claim such land a Gold Field: And by the said Act it is further enacted that it shall be lawful for the Governor in Council, under his hand and the Public Seal of the Colony, from time to time to delegate to the Superintendent of any Province, or to such other person as the Governor may deem fit, all or any of the powers vested in the Governor by the preceding sections of the said Act (including the above-recited sections), subject or not to any limitations or restrictions as the Governor may think fit :

Now, therefore, His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, with the advice and consent of the Executive Council of the Colony, in pursuance and exercise of the power for that purpose vested in him by the said Act, doth hereby delegate to

JOHN WILLIAMSON, Esq.,

Superintendent of the Province of Auckland, all the powers vested in the Governor by the said recited section of "The Gold Fields Act Amendment Act, 1868," to have, hold, and exercise within the Province of Auckland, the said powers hereby delegated to the said John Williamson, so long as he shall continue and remain Superintendent of the said Province, and no longer: Provided always that no Proclamation affecting any lands shall be made by the said John Williamson under the powers hereby delegated to him, unless the Governor shall have obtained power to authorize entry on such lands for mining for gold, in the manner required by the said Act.

HIS EXCELLENCY THE GOVERNOE IN COUNCIL.

WHEREAS it is enacted by "The Customs Duties Act Amendment Act, 1861," that it shall be lawful for the Governor, by any Order in Council, from time, to time to be dealer the from time to time to declare that any Wine, Ale, Beer, or Spirits may be delivered out of Bond without payment of Duties of Customs, for the consumption of the Officers of Her Majesty's Troops in the Colony of New Zealand, and the Officers of Her Majesty's Navy serving on board any of Her Majesty's Ships in the seas adjoining thereto, subject nevertheless to such Regulations as in any such Order in Council shall be prescribed, and may from time to time, by any further Order in Council, amend or alter any such Order: And whereas an Order was made in Council, in exercise of the said power, on the tenth day of January, one thousand eight hundred and sixtyseven, directing that Wine only might be delivered out of Bond as aforesaid without payment of Duties of Customs, and it is expedient to make alterations in the privileges thereby granted : Now, therefore, His Excellency the Governor, with

the advice and consent of the Executive Council of New Zealand, doth hereby revoke the before-mentioned Order in Council, and doth order and declare that Wine, Ale, Beer, and Spirits may be delivered out of Bond, without payment of Duties of Customs, for the consumption of any Military or Naval Mess, upon the certificate of the President that such Wine, Ale, Beer, and Spirits are for Mess consumption; also to the General or other Officer commanding each Station, upon the certificate of a like character from any Officer of his or their Staff; and to other Officers upon the presentation of a similar certificate, signed by an Officer appointed by the Officer commanding the Troops. The certificate in all cases to be countersigned as approved by the senior Officer of the Station or Ship, and to state that the articles required are for the use of the persons for whom remission of Duty is applied for.
