SIE,-I am commanded by my Lords Commissioners of the Admiralty to transmit to you herewith, for the information of the Secretary of State for the Colonies, the enclosed New Regulations for the entry and examination of Naval Cadets with reference to the nominations for Colonial Cadetships, and to call your attention more especially to the passages marked, viz., paragraphs 3, 4, 5, 15, 16, 21, 26, 27, and 32.

### REGULATIONS RESPECTING NAVAL CADETS. (FOR THE INFORMATION OF CANDIDATES.)

1. Two examinations for naval cadetships will be held annually under the direction of the Admiralty Director of Education, viz., on the third Wednesday in June, and on the last Wednesday in November, but the appointments, as cadets, of the successful candidates will date from the 15th July or the 15th January.

The first examination under these regulations will

take place in November, 1869.2. No candidate will be eligible for examination in November whose age will not be within the prescribed limits on the 15th January following, or for examination in June whose age will not be within the prescribed limits on the 15th of July following.

3. The limits of age for examination in November, 1869, will be not less than 12 nor more than 14 years of age.

For examination in June, 1870, not less than 12

nor more than  $13\frac{1}{2}$  years of age. After June, 1870, no candidate is to be examined who is under 12 or above 13 years of age.

4. The number of naval cadets to be entered at each examination will be determined by the Admiralty, and twice the number to be entered will be nominated to compete for cadetships.

5. Every candidate will be required to pass the medical examination according to the prescribed regulations, and must have been found physically fit for the Royal Navy.

He must be in good health and free from any physical defect of body, impediment of speech, defect of sight or hearing, and also from any predisposition to constitutional or hereditary disease or weakness of any kind, and in all respects well developed and active in proportion to his age.

Any candidate rejected at the medical examination will be finally excluded from the Royal Navy.

6. The candidate will be required to produce (1) a certificate of birth or declaration thereof made before a Magistrate; (2) a certificate of good conduct from the masters of any schools at which he may have been educated within the two previous years, or if educated at home from his tutors or the clergyman of the parish in which he resides; and (3) a certifi-cate of good health.

voluntary subject will be counted towards the total.

9. A candidate who obtains the number of marks prescribed for passing, but who may not be successful in the competition, will be allowed to compete again at the next examination without a fresh nomination. No candidate will be allowed to compete more than twice.

10. Candidates rejected for the first time at the examination in August, 1869, are to be allowed a second trial in November without a fresh nomination; but they must then compete with other candidates, and should they not succeed in the competition they will not be allowed another trial.

11. Any candidate who fails to appear at the next examination after he has obtained a nomination will not be allowed to present himself without a fresh nomination, except in the case of illness certified by a physician or surgeon approved by their Lordships, in which case non-appearance will have the effect of unsuccessful competition, entitling the candidate to present himself at the following examination only.

12. For all cadets entered under these regulations after the examination in August, 1869, the annual rate of payment will be as at present during the year 1870, and afterwards at the rate of  $\pounds 70$  per annum for the period in the "Britannia," and  $\pounds 50$ for the year in the sea-going training ship, to be paid half-yearly in advance to the Accountant-General of the Navy. But the Lords Commissioners of the Admiralty reserve the power of selecting, from among the candidates nominated at each halfyearly examination, a number, not to exceed twelve, being sons of Officers of the Royal Navy or Marines, or of Civil Officers under the Board of Admiralty, with respect to whom the annual payment for the two years in the "Britannia" will be £40 only. In selecting these their Lordships will have regard solely to the pecuniary circumstances of the parents or guardians of the cadets.

13. Candidates who succeed in the competition will be appointed to the "Britannia."

14. The date of entry of those who pass in June is to reckon from the 15th July of the same year; of those who pass in November from the 15th January of the next year.

15. The period of training on board the "Britan-nia," will be, as now, four terms; but there will be two terms in each year instead of three. The first term of each year will be from February to July, the second from August to December.

A week's vacation will be allowed at Easter.

16. There will be an examination at the end of each term, and an intermediate examination at Easter for cadets in their first year.

17. Cadets who join in August, and who pass an unsatisfactory examination in December, will be warned that they will be discharged at the following Easter if they do not show sufficient improvement. Cadets who join in February and pass an unsatis-factory examination at Easter, will be similarly warned with respect to the examination in July.

Any cadet who passes unsatisfactorily at a subsequent examination will be discharged.

## CIRCULAR No. 46. C. Admiralty, 3rd August, 1869.

## Regulations respecting Naval Cadets (and Midshipmen).

THE Lords Commissioners of the Admiralty having decided-

- (1) To increase the time during which naval cadets will be under training, part of such time being spent in sea-going training ships, and the whole period being considered one of probation;
- (2) To introduce the system of limited competition for naval cadetships; and
- (3) Still further to reduce the number of naval cadets annually entered;

have been pleased to make the following regulations: 1. These regulations will take effect after the ex-

amination in August, 1869.

2. Two examinations for naval cadetships will be held annually under the direction of the Admiralty Director of Education, viz., on the third Wednesday in June, and on the last Wednesday in November, but the appointments, as cadets, of the successful candidates will date from the 15th July or the 15th January.

3. The first examination under these regulations will take place in November, 1869.

4. No candidate will be eligible for examination in November whose age will not be within the prescribed limits on the 15th January following, or for examination in June whose age will not be within the prescribed limits on the 15th July following.

5. The limits of age for examination in November, 1869, will be not less than 12 nor more then 14 years of age.

For examination in June, 1870, not less than 12

nor more than  $13\frac{1}{2}$  years of age. After June, 1870, no candidate is to be examined who is under 12 or above 13 years of age.

6. The number of naval cadets to be entered at each examination will for the present be reduced to 37; and twice the number to be entered will be nominated to compete for cadetships.

Should fewer than the authorized number pass at any examination, the difference will be made up at the next examination, and the number nominated will be proportionately increased.

7. Every candidate will be required to pass the medical examination according to the prescribed regulations, and must have been found physically fit for the Royal Navy.

He must be in good health and free from any physical defect of body, impediment of speech, defect of sight or hearing, and also from any predisposition to constitutional or hereditary disease or weakness of any kind, and in all respects well developed and active in proportion to his age.

Any candidate rejected at the medical examination will be finally excluded from the Royal Navy.

8. The candidate will be required to produce (1) a certificate of birth or declaration thereof made before a magistrate; (2) a certificate of good conduct from the masters of any schools at which he may have been educated within the two previous years, or, if educated at home, from his tutors or the clergyman of the parish in which he resides; and (3) a certificate of good health.

9. The candidates will be required :----Marks assigned.

No marks amounting to less than one-sixth in a voluntary subject will be counted towards the total.

11. A candidate who obtains the number of marks prescribed for passing, but who may not be successful in the competition, will be allowed to compete again at the next examination without a fresh nomination. No candidate will be allowed to compete more than twice.

12. Candidates rejected for the first time at the examination in August, 1869, are to be allowed a second trial in November without a fresh nomination; but they must then compete with other candidates, will not be allowed another trial.

13. Any candidate who fails to appear at the next examination after he has obtained a nomination will not be allowed to present himself without a fresh nomination, except in the case of illness, certified by a physician or surgeon approved by their Lordships, in which case non-appearance will have the effect of unsuccessful competition, entitling the candidate to present himself at the following examination only.

14. Every Flag Officer (except an Admiral Superintendent of a dockyard), on hoisting his flag, will be allowed three nominations for competition; every Commodore of the first class two; every Captain appointed to the command of a ship, of whatever class (except Captains of stationary ships, Captains Superintendent of dockyards or victualling yards, and the Captain of the yacht), one; but no Officer will be allowed to exercise this right a second time within three years; and no Captain appointed to a ship during her commission will be allowed a nomination if the right has been exercised within a year during the same commission by a previous Captain.

A fresh nomination will be allowed to the Officer should a candidate be rejected at the medical examination, but not in the event of the candidate failing to pass the test at the examination under the Director of Education.

15. Seven nominations will be given annually to the Colonies, under the regulations hitherto in force as to nomination and examination; but the limits of age will be the same as for candidates nominated in the United Kingdom,—and cadets passing in the Colonies will, in all other respects, be subject to these regulations, and must be at once sent to England, to undergo the course of training.

Printed examination papers are to be sent out to Commanders-in-Chief and Senior Officers on foreign stations, under seal, and the candidates' examination papers, with a report of the marks awarded at the examination, are to be forwarded to the Admiralty (should the candidate succeed in passing), together with the duplicate certificate of health.

16. For all cadets, including Colonial cadets, entered under these regulations after the examina-tion in August, 1869, the annual rate of payment will be as at present during the year 1870, and oftenwards at the rate of 670 pay expuse afterwards at the rate of  $\pounds 70$  per annum for the period in the "Britannia," and  $\pounds 50$  for the year in the sea-going training ship, to be paid half-yearly, in advance, to the Accountant-General of the Navy. But the Lords Commissioners of the Admiralty reserve the power of selecting from among the candidates nominated at each half-yearly examination a number, not to exceed twelve, being sons of Officers of the Royal Navy or Marines, or of Civil Officers under the Board of Admiralty, with respect to whom the annual payment for the two years in the "Britannia" will be £40 only. In selecting these, their Lordships will have regard solely to the pecuniary circumstances of the parents or guardians of the cadets.

In the event of the full number so selected not succeeding in the competition, their Lordships may make the number up from among the sons of Officers as above who have succeeded at that examination.

17. Candidates who succeed in the competition will be appointed to the "Britannia."

18. The date of entry of those who pass in June is to reckon from the 15th July of the same year; of those who pass in November from the 15th January of the next year.

19. The period of training on board the "Britannia" will be, as now, four terms; but there will be Admiralty.

22. Notice will be given of the minimum number of marks which must be obtained at each examination.

23. At the examination at the end of the fourth term cadets will be classified according to their merits in seamanship, study, and conduct; and they will be allowed time for their service in the "Britannia" as follows :----

24. The examination and rating of cadets, as midshipmen, in the sea-going training ships, is to be regulated according to the time notified in their certificates, thus :-

Cadets who obtain 12 months' time will be rated as midshipmen at once on passing out of the " Britannia."

25. After passing the final examination in the "Britannia," the midshipmen and cadets will be appointed to a sea-going training ship for one year.

...

26. Any cadet or midshipman who, at any time during his three years' probation, may be certified by the Medical Officer of the "Britannia" or of the sea-going training ship, to have become subject to any disease or physical defect likely to render him unfit for service, will, on the circumstances being reported to their Lordships, be at once discharged.

27. After six months in the sea-going training ship an examination is to be held, and at the end of twelve months a second; and any midshipman or cadet failing to pass the test at either of these examinations will be at once discharged from Her Majesty's Service.

At the latter of these examinations they will be classified in three classes.

28. The examination paper for the first examination will be transmitted under seal to the sea-going training ship; and the work of the cadets or midshipmen is to be returned under seal to the

or cadet for his period of service in the sea-going training ship; but those who having obtained twelve time on discharge from the "Britannia" months' pass in the first class on discharge from the seagoing training ship, and whose conduct has been uniformly good, will be allowed to count an additional six months' time. In the case of these, the rule as regards the age (nineteen) of passing for lieutenant will be relaxed. These officers will be allowed to pass their examinations for lieutenant after the age of eighteen, provided they have completed the neces-sary service; but they will not be eligible for promotion from the rank of sub-lieutenant to that of lieutenant till they are nineteen years of age.

30. The period of service required to enable officers to pass for lieutenant will be five years, including the time allowed in the training ships.

31. The existing rules as to other examinations

required of midshipmen are to be adhered to. 32. The parent or guardian of every cadet will be required to provide outfit as under the present regulations, and to sign a declaration (on the admis-sion of the cadet to the "Britannia") to the effect that he shall be immediately withdrawn on the receipt of an official intimation of his being considered unfit for the Royal Navy.

33. Cadets who entered the "Britannia" in December, 1868, or April, 1869, will pass out in July, 1870, and those who may enter in August, 1869, will pass out in December, 1870. Three months' extra time will be allowed to cadets who entered in December 1869. entered in December, 1868.

### Cadets for Navigating Duties.

34. Twenty-four are to be entered annually by competition-twelve at each half-yearly examination; twenty-four nominations are to be made for each examination.

In other respects, including age, these regulations are to apply to navigating cadets. The annual payment for navigating cadets will

be £40.

In the middle of last October, at 2 a.m., the ship "Pare Joie," from Hong Kong to Buenos Ayres, whilst standing to the eastward on the starboard tack, with the wind from the southward, struck on a rock at the entrance of Gaspar Strait, and remained there for twenty-four hours. The Peak of Gaspar Island bore South half East, distant five (5) miles. This rock is marked "doubtful" on the Admiralty Charts, and in a position four and a half  $(4\frac{1}{3})$  miles to the westward of where the "Pare Joie" struck.

The Admiralty Sailing Directions for the China Seas mention that it is doubtful whether such a rock exists.

On 9th there was a N.W. gale, with heavy rain; also on 24th and 25th stormy from same quarter, but no rain; on 28th a thunder storm occurred, with very heavy rain—3750 inches recorded up to morning of 29th; slight earthquake on 10th at 940 a.m. Twenty-six days of N.W. wind.
Hokitika.—Very wet on night of 9th, with strong N.W. wind; stormy on 15th from S.W., with rain; also strong wind from same quarter on 17th and 21st; a gale on night of 28th from S.W., with heavy rain and squalls; foggy on 14th, 15th, 21st, and 26th. Prevailing winds from S.W. and N.W.
Dunedin.—Storm from S.E. on 3rd, with heavy rain. Rainfall far above the average; heavy falls recorded on 2nd, 3rd, and 29th, when considerably over the inch fell in each case. There was, however, some pleasant weather during the month, though dull. Prevailing wind from W.

 Southland.—Rainfall greatest recorded for eleven years in any one month, although number of rainy days was not excessive. Four heavy falls occurred.—2:61 (4th), 3:02 (14th), 2:12 (29th), 1:09 (31st),—the three first from S.E., and last from N.W. Strong winds on 24th and 26th from N. and N.W., without rain; thunder on 31st. In the intervals between the floods, the weather was fine generally. Prevailing wind S.E.

## GENERAL REMARKS.

Month marked by excessive rainfall in the North and South of the Islands, and continued dry westerly winds about the central portion, especially on the West Coast.
