

WHEREAS by the seventeenth section of "The Outlying Districts Sale of Spirits Act, 1870,' it is enacted that the Ordinance of the Lieutenant-Governor and Legislative Council of New Zealand, intituled "An Ordinance to prohibit the Sale &c. of Spirits, and to regulate the Sale &c. of other Intoxicating Liquors, to Persons of the Native Race," Session VIII., Number 3, shall, except in any such Town, District, or Province as may be included in any such Order in Council as thereinafter provided, be repealed on and from the thirty-first day of December, one thousand eight hundred and seventy: And whereas it is by the eighteenth section of the said Act enacted that it shall be lawful for the Governor in Council, at any time before the said thirty-first day of December, to suspend the opera-tion of the last preceding section of the said Act within any Town, Province, or District within the Colony, and at any time thereafter to revoke any such Order in Council, and upon any such revocation the said Ordinances shall be repealed within the Town, District, or Province to which the said lastnamed Order relates: And whereas it is desirable to suspend the operation of the said seventeenth section of the said Act in the District described in the Schedule hereto:

Now therefore, His Excellency Sir George Ferguson Bowen, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said Colony, in pursuance and in exercise of the powers and authorities vested in him by the said Act, doth hereby order and declare that the operation of the said seventeenth section of the said "Outlying Districts Sale of Spirits Act,

1870," shall be and the same is hereby suspended in the District described in the Schedule hereto.

### SCHEDULE.

AUCKLAND.

This District comprises all that area which is bounded towards the North by a line from Okura on the East Coast to Muriwai on the West Coast; towards the East by the sea, Waitemata Harbour; Whau Creek and Portage, to the Manukau Harbour; towards the South by the Manukau Harbour; towards the South by the Manukau Harbour; and towards the West by the sea to Muriwai, the commencing point: Also all that area which is bounded towards the North by the Waitemata Harbour from the Meola Stream to the north-west angle of Lot No. 38A of Tamaki Farms; and thence towards the East, South, and West by the boundaries of the Auckland Municipal Police District (including the Town of Auckland).

### "CAPTAIN" RELIEF FUND.

Royal Naval College, Portsmouth,

13th October, 1870.
Sir,—I am directed by the Central Managing Committee to request your co-operation in aid of the above Fund, and to express a hope that by your powerful influence and patronage in your Government, the Fund will receive that augmentation which it so much needs, and which the Committee feel sure requires no recommendation from them to insure the substantial aid and sympathy of their fellow-countrymen abroad.

Such an unparalleled calamity, resulting in loss of life greater than at the battle of Trafalgar, has consequently left a large number of families in most distressing circumstances. A sum of £60,000 is required to alleviate the distress of the Widows, Orphans, and Relatives, who depended for their maintenance on those lost in the "Captain," and the support of Government is totally inadequate to meet these cases. Up to the present time only £20,000 has been collected, so that there is a wide margin left for the charitably disposed, and the Committee are confident that this National loss only requires to be known, to meet with that hearty response which has invariably characterized our countrymen in distant lands.

The Committee therefore trust your Excellency will take such steps as you may deem advisable to cause the object they have in view to be made known throughout your Government.

The following is the Report of Admiral Sir A. Milne, received at the Admiralty on Saturday, 10th September, 1870:-

"Lord Warden," at Sea off Cape Finisterre, 7th September, 1870.

SIR,—It has been my painful duty to forward by Her Majesty's vessel "Psyche" to Vigo, the following telegram, to be transmitted to the Lords Commissioners of the Admiralty, reporting the sad loss of Her Majesty's ship "Captain," with all hands:

"Very much regret sending painful news. 'Captain," with all hands:

tain' must have foundered in the night. She was close to this ship at 2 this morning. Sudden S.W. gale. Very heavy squalls. Daybreak—'Captain' missing; this afternoon her boats and spars found; all have unfortunately perished. 'Inconstant' sails to-morrow with report."

I beg leave to transmit to their Lordships full and early details of this most disastrous event, and I therefore send the "Inconstant" to Devonport with the despatch. Yesterday morning, the 6th instant, I went on board to inspect the "Captain," with Captain Brandreth and my Flag-Lieutenant, and visited most minutely every part of her. At 1 p.m. a trial of sailing with the ships of the squadron—("Lord Warden," "Minotaur," "Agincourt," "Northumberland," "Monarch," "Hercules," "Inconstant," "Warrior," "Bellerophon," "Bristol,")—was commenced, and continued until 5 p.m., when the recall was made. The direction of the wind was S. by W., force about 6; some of the ships carrying their royals during the whole time-" Captain" included. At 4 o'clock the breeze had freshened, and the trail of the "Captain," which at first was 9½, increased to an average from 11 to 13, the sea washing over the lee side of her deck as she met a swell on her lee bow, the lee gunwale on deck being level with the water. I returned to the "Lord Warden" at 5.30 p.m. Being close to the rendezvous, 20 miles west of Cape Finisterre, the squadron was again formed into three divisions; the "Lord Warden," "Minotaur," and "Agincourt" leading, the "Captain" being the last, astern of the "Lord Warden." The signal was also made to take in two reefs and send down royal yards, and the ships stood to the W.N.W. under doublereefed topsails, foretopmast staysail and foresail; topgallant sails furled; steam ready to be used as required. Force of the wind about 6 to 7.

At 8 and 10 p.m. the ships were in station, and there was no indication of a heavy gale, although it looked cloudy to the westward. At 11 the breeze began to freshen, with rain. Towards midnight the barometer had fallen, and the wind increased, which rendered it necessary to reef; but before 1 a.m. the gale had set in at S.W., and square sails were furled.

At this time the "Captain" was astern of the ship,

apparently closing under steam. The signal "Open order" was made, and at once answered; and at 1.15 a.m. she was on the "Lord Warden's" lee quarter, about six points abaft of the beam. From that time until about 1.30 a.m., I constantly watched the ship; her topsails were either close reefed or on the lap, her foresail was close up, the mainsail having been furled at 5.30 p.m., but I could not see any fore and aft set. She was heeling over a good deal to starboard, with the wind on her port side. Her red bow light was all this time clearly seen. Some minutes after, I again looked for her light, but it was thick with rain, and the light was no longer visible. The squalls of wind and rain were very heavy, and the "Lord Warden" was kept by the aid of the screw and after trysails with her bow to a heavy cross sea, and at times it was thought that the sea would have broken over her gangways. At 2.15 a.m. (the 7th instant), the gale had somewhat subsided, and the wind went round to the N.W., but without any At 2.15 a.m. (the 7th squall; in fact, the weather moderated, the heavy bank of clouds had passed off to the eastward, and the stars came out clear and bright, the moon, which had given considerable light, was setting. No large ship was seen near us when the "Captain" had been last observed, although the lights of some were visible at a distance. When day broke the squadron was somewhat scattered, and only ten ships instead of eleven, could be discerned; the "Captain" being the missing one. We bore up for the rendezvous, thinking she might have gone in that direction, but no large vessel being in sight from the mast-head, I became alarmed for her safety, because, if disabled, she ought to be within sight, and if not disabled in company with squadron, and I signalled the following ships to proceed in the directions indicated to look out:—The "Agincourt" to the S.W.; the "Monarch," S.; the "Warrior," S.E.S.; the "Inconstant," S.E.; the "Hercules," E.S.E.; the "Northumberland," E.; the "Bristol," N.E.; the "Bellerophon, to the N. by E.; the "Minotaur," also These vessels proceeded about ten to fourteen miles, but nothing could be seen of the missing ship.

The greater part of the ships were recalled and formed in line abreast, and steered at three or four cables apart to the S.E., looking for any wreck. The "Monarch" first picked up a top-gallant yard of the "Captain," the "Lord Warden" another, with sails bent, then some studding-sail booms, and on the "Psyche" joining me from Vigo at sunset, she reported having passed two cutters painted white, bottom up, with a large amount of wreck, apparently the hurricane deck, among which was found the body of a seaman with "Rose" marked on his flannel.

I have thus stated all that occurred under the eyes of the Flag-Captain and myself, and I much regret to say that I can come to no other conclusion than that the "Captain" foundered with all hands on board, probably in one of the heavy squalls between 1.30 and 2.15 a.m. of this morning (7th instant), at which time a heavy cross sea was running, but how the catastrophe occurred will probably never be known. I had the most perfect confidence in Captain Burgayne, Commander, Shearchanks, and the captain Burgoyne, Commander Sheepshanks, and the executive officers with whom I had come in contact. Captain Burgoyne himself was a thoroughly practical seaman, and it is impossible that she could have been better commanded. The service will mourn the loss of an officer of such ability and promise. I regret, also, Captain Coles should have shared the same fate. He had been several passages in his newly-constructed ship, and took a deep interest in all that concerned her.

I greatly deplore the sad event, which has cast a deep gloom on the whole squadron.

The gunner of the unfortunate ship "Captain" has reached the Admiralty. From his report, and the depositions of other survivors, it appears that she capsized in a heavy squall shortly after midnight. Captain Burgoyne, who was on deck, ordered topsails to be lowered and sheets let go, but in vain. The force of the wind, acting on the sails and on the bottom of the hurricane deck, proved too much for her stability.

The following persons, who escaped from Her Majesty's ship "Captain," and landed at Corcubion, north of Cape Finisterre, on the evening of the 7th instant, arrived this day at Portsmouth, in Her Majesty's steamship "Volage":—

Statement of Mr. James May, gunner, R.N.:

Mr. James May, gunner, second class, states that he was awoke about twelve o'clock on the night of the 6th, by some marines making a noise outside of his cabin, and finding the ship more than usually unsteady, he dressed himself to go on deck, and see if the guns were all right in the turrets. In passing the engineers' bathroom he exchanged a remark with the engineer officer who had come off the first watch, and thus he is certain as to its being just past twelve o'clock. When he got up into the after-turret, the ship gave a very heavy roll to starboard, and continued in that position, gradually heeling over more and more, until he found the water coming into the point hole on the top of the turret, through which he crawled, and then found himself overboard. He however succeeded, with five others, including Captain Burgoyne, in reaching the steam pinthe top of the turret, through which he crawled, and then found himself overboard. He however succeeded, with five others, including Captain Burgoyne, in reaching the steam pinnace, which was floating bottom uppermost, and observing the launch passing within a few yards of them he cried out, "Now jump, men; this is your only chance." He and three others did so, and succeeded in getting into the boat. They in vain endeavoured to regain the pinnace to save their captain, but the sea running so very high prevented them fulfilling their task, and in the attempt they were struck by a heavy sea, nearly swamping the boat, and washing one man (George Myers) overboard. It was then determined to let the boat run before the sea, as the land was known to be to leeward of them. About two o'clock they sighted the light on Cape Finisterre, and afterwards observed land. They made for it, and succeeded in landing about noon of the 7th at Finisterre, and at four o'clock, after making all necessary inquiries, and drying their clothes, proceeded to Corcubion, where they found the Vice-Consul, who telegraphed and sent the news of the sad disaster through Corunna to England. The "Monarch's" boats picked them up. Mr. May speaks highly of the manner in which Charles Tregenna steered the oar.

THE following Report of an Exploration by Mr.
John Rochfort, with a view to finding a practicable Railway Line to Wairarapa via Wai-nui-omata, is published for general information.
W. GISBORNE.

Wellington, 17th January, 1871. Sir.—I have the honor to inform you that, agreeably with your instructions, I called on Mr. Hugh Sinclair, for the purpose of examining a route to the Wairarapa discovered by his sons. Mr. John Sinclair at once offered to guide me through, and I have to thank them both for the way in which they furthered my chieft.

Commencing my description from the Hutt, this route crosses the dividing range at an elevation of

567 feet, and falls 314 feet to Mr. Sinclair's house in the Wai-nui-omata. It then follows up the river about six miles and a half, rising 491 feet more. Here it ascends the range dividing the last-named river from the Orongorongo, an additional 751 feet. This is the lowest part of the range, and is 1,495 feet above the sea, or 1,242 feet above Mr. Sinclair's house, and is the highest point of the route. To gain this elevation with a gradient of 1 in 40 would require nine miles and a half of distance, whereas there are only six miles and a half: a line would therefore have to begin to ascend three miles below Mr. Sinclair's house.

I omitted to say that we ascended a hill about 2,200 feet high, from whence we could see all over the line, and ascertained that there was no lower

place.

Mr. Sinclair's route now follows down a branch of the Orongorongo in a southerly direction for about three miles, to its confluence with another stream which leads to the saddle dividing this river from the Wairongomai (N. 30° E., and two miles distant). This pass is 365 feet below the other, or 1,130 feet above the sea, and might be easily reached from the Wai-nui-omata range by heading the first branch, and following the hills round gradually to the lower elevation.

At this point an unexpected difficulty occurs: the saddle of the Orongorongo, which rises very gently on its own side, terminates abruptly on the east side of the range; and instead of meeting the source of the Wairongomai River it overlaps it, making a sudden drop of 900 feet, which there is no possible way of avoiding, as the side ranges are nearly perpendicular slips.

Mr. Sinclair said he had never seen this part of the range before, or he would not have put the Government to the expense of this exploration, and expressed himself quite satisfied that this route was impracti-

cable.

The sides of the Wairongomai are very rough and full of slips, and the distance down to the Lake from the saddle is about seven miles, and bears about N. 43° E. About two miles from the saddle, a branch comes in on the North side, up which the range is visible which separates the Pakuratahi; its bearing is about North.

We returned round by the coast from the Wairarapa, and I have no hesitation in saying that in addition to the distance by the coast road being nearly double that of the Hutt line, a railway could not be made at any reasonable cost, because of the many slips which it would be impossible to avoid, and the small streams which push forward immense shingle fans into the surf.

These two questions may now fairly be considered as being set at rest; and I feel assured that the line I have chosen over the Rimutaka is the best that will be found.
