A PROCLAMATION.

WHEREAS by an Order in Council made on the first day of November, one thousand eight hundred and fifty-eight, the Province of Hawke's Bay was constituted and established under "The New Provinces Act, 1858," and it is provided by the Constitution Act that it shall be lawful for the Governor of New Zealand, by Proclamation or otherwise, to dissolve the Provincial Council of any Province, whenever he shall think it expedient so to do:

Now therefore, I, the Governor of the Colony of New Zealand, in exercise of the said power, do, by this Proclamation, dissolve the Provincial Council of the said Province of Hawke's Bay.

Given under the hand of His Excellency Sir George Ferguson Bowen, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, at the Government House, at Wellington; and issued under the Seal of the said Colony, this fourth day of February, in the year of our Lord one thousand eight hundred and seventy-one.

A PROCLAMATION.

WHEREAS by "The Otago Hundreds Regulation Act, 1869," it is enacted that, subject to the provisions in the said Act contained, it shall be lawful for the Governor from time to time, by Proclamation published in the *New Zealand Gazette*, to constitute into a Hundred any portion of the Waste Lands of the Crown, within the Province of Otago, not forming part of any Hundred for the time being existing, notwithstanding that such lands or any part thereof shall be comprised within any pastoral lease or

license heretofore or thereafter to be granted by the Crown under any law regulating the occupation or disposal of Waste Lands of the Crown, and whether or not the same shall have been included within the boundaries of any proclaimed gold field: And whereas by "The Otago Hundreds Regulation Act 1869 Amendment Act, 1870," it is enacted that no Hundred shall thereafter be proclaimed in the Province of Otago unless one third part at least of the area thereof shall be determined under the provisions of the said "Otago Hundreds Regulation Act, 1869," to be land available for agricultural purposes, and that no Hundred shall exceed twenty thousand acres in extent, and that, in determining the boundaries of all Hundreds thereafter proclaimed, due regard shall be paid to the natural features of the country over which any such Hundred is to be proclaimed:

Now therefore, I, Sir George Ferguson Bowen, the Governor of the Colony of New Zealand, in pursuance and exercise of all powers and authorities in me vested, do hereby constitute and proclaim those districts or portions of the Waste Lands of the Crown within the Province of Otago, not forming part of any existing Hundred, particularly described in the Schedule hereto, to be Hundreds under and subject to the provisions of the said Acts.

SCHEDULE.

The Crookston Hundred,

Containing 20,000 acres, being parts of Runs Nos. 212 and 163, the boundaries whereof are more particularly delineated upon the plan numbered three, authenticated by the signature of the Colonial Secretary, and deposited in the office of the Secretary for Crown Lands.

The Wairuna Hundred,

Containing 20,000 acres, being parts of Runs Nos. 31 and 78, the boundaries whereof are more particularly delineated upon the plan numbered four, authenticated by the signature of the Colonial Secre-

tary, and deposited in the office of the Secretary for Crown Lands.

ORDER IN COUNCIL.

At the Government House, at Wellington, this third day of February, 1871.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The University Endowment Act, 1868," it is enacted that it shall be lawful for the Governor in Council at any time, and from time to time, after communication with the Superintendent of any Province, to except from sale and reserve any of the Waste Lands of the Crown for the purposes in the said Act mentioned, and that all such exceptions and reservations of land situate within any Province shall be deemed to have been made whenever the Governor, by writing under his hand, shall have notified to the Superintendent of the Province in which any land so excepted and reserved is situate, that the same is required for the purposes of the said Act, and such notifications shall have been published in the *New Zealand Gazette*: Provided that the maximum quantity shall not exceed in any Province ten thousand (10,000) acres:

And whereas His Excellency the Governor has communicated with the Superintendent of the Province of Auckland with respect to the making the reserve hereinafter mentioned:

Now therefore, His Excellency the Governor of New Zealand, in exercise and in pursuance of the power and authority conferred on him by the said Act, and by and with the advice and consent of the Executive Council of New Zealand, doth hereby except from sale and reserve for the purposes mentioned in the said Act, that portion of the Waste Lands of the Crown in the Province of Auckland hereinafter described, that is to say,—

All that parcel of land in the Province of Auckland, containing by admeasurement three hundred and fifty-four (354) acres, more or less, situated in the Parish of Ararimu, in the County of Eden, and being allotment numbered seven and northern portion of allotment numbered five, bounded on the North-east by a road three thousand one hundred and eighty-nine links, two thousand two hundred and eighty-three links, and two thousand nine hundred and fifty links; on the South by other portion of allotment numbered five, three thousand five hundred links and one thousand six hundred and twenty-five links, and by allotment numbered six, nine hundred links and five thousand five hundred and fifty links; on the South-west by a road two hundred links, three hundred and thirty-nine links, two hundred and thirty links, five hundred and eighteen links, three hundred and sixty-five links, four hundred and nineteen links, nine hundred and seventy-one links, two hundred

and ninety-nine links, one hundred and seventy-nine links, two hundred and sixty-two links, and two hundred and sixty-six links; and on the North-west by allotment numbered eight, seven thousand eight hundred and seventy-five links.
