

G. F. BOWEN, Governor. A PROCLAMATION.

THEREAS by "The Petty Sessions Act, 1865," it is enacted that as soon as conveniently may be after the establishment of a Petty Sessions District, and afterwards from time to time as may be deemed expedient, the Governor shall, by Proclamation in the New Zealand Gazette, appoint a meeting of the Justices of the Peace resident in such district to be yearly held within such district, at some specified time and place, for the purpose of choosing a Chairman of Petty Sessions and settling a rota of attendance: And whereas by an Order in Council bearing date the eleventh day of August, one thousand eight hundred and sixty-nine, a Petty Sessions District, hereinafter named, was defined and established:

And whereas by a Proclamation bearing date the thirteenth day of January, one thousand eight hundred and seventy, Cameron's Inn, Mataura Bridge, was appointed to be the place, and the first Wednesday in the month of March the time, at which a meeting of the Justices of the Peace resident within such district should be yearly held, for the purpose of choosing a Chairman of Petty Sessions and settling a rota of attendance: And whereas no meeting was held at the place appointed on the first Wednesday of March instant:

Now therefore, I, Sir George Ferguson Bowen, the Governor of New Zealand, in pursuance and in exercise of the power and authority in that behalf vested in me, do hereby proclaim and appoint that for the Mataura District a meeting of the Justices of the Peace resident within such district shall be yearly held at Cameron's Inn, Mataura Bridge, at twelve o'clock noon, on the first Tuesday in the month of April, for the purpose of choosing a Chairman of Petty Sessions and settling a rota of attendance.

Given under the hand of His Excellency Sir George Ferguson Bowen, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at Wellington, this fourteenth day of March, in the year of our Lord one thousand eight hundred and seventy-one.

"To inquire and ascertain the names (in full), rank, regiments or corps, of such persons as aforesaid who were killed in action, or died from wounds received during any of the military operations above referred to; and also the names and dates of the actions or services in which, or in consequence of wounds received at which, such persons as aforesaid died."

All persons who have claims for the Medal and have not made application for it, are requested to apply, with as little delay as possible, to the Hon. the Minister for Colonial Defence, as the Commissioners are required to report within four calendar months from the 3rd February, 1871.
