WHEREAS by "The New Zealand University
Act, 1870," it is amongst other things
provided that the Council of the University
established under the said Act shall be nominated
and appointed by the Governor in Council, and
shall consist of twenty Councillors, and that the said
Council shall elect out of their own body a Chancellor and Vice-Chancellor for such period as is cellor and Vice-Chancellor for such period as is therein mentioned: And also that all questions which shall come before the said Council shall be decided by the majority of the members present or voting by proxy as thereinafter provided; and that the Chairman at any such meeting shall have a vote, and in case of any equality of votes a casting vote also; and that no question shall be decided at any meeting unless six members be present: And also, that the said Council shall have full power to make and alter any statutes and regulations (so as the same be not repugnant to any existing law or to the provisions of the said Act) touching the discipline of the said University, the number, stipend, and manner of appointment and dismissal of the officers thereof, the matriculation of students, the examination of the control of tions for fellowships, scholarships, prizes, exhibitions, degrees, or honors, and the granting of the same respectively, the fees to be charged for matriculation or for any such examination or degree, the lectures or classes of the Professors and the fees to be demanded by them, the manner and time of demanded by them, the manner and time of convening the meetings of the said Council and Senate, and in general touching all other matters whatsoever regarding the said University, and that the said Council shall also have power to make and alter any statutes and regulations for the conduct alter any statutes and regulations for the conduct of examinations for scholarships or exhibitions to be held in any School of Law or Medicine, or in any University outside the limits of the Colony, and for the terms on which such scholarships shall be held:

HEREAS by an Act of the General Assembly of New Zealand, intituled "The New Zealand Settlements Acts Amendment Act, 1866," power is given to the Governor to reserve portions of any of the land taken under "The New Zealand Settlements Act, 1863," for the several purposes for which reserves may be made under the twelfth section of "The Waste Lands Act, 1858," and may make grants thereof under "The Public Reserves Act, 1854," or otherwise, as the case may require: And whereas the purposes for which such reserves may be made under the said twelfth section of the said "Waste Lands Act, 1858," are for the construction of trunk lines of read ones sites for public buildings for the lines of road, or as sites for public buildings for the use of the General Government, or for other purposes of public utility or convenience: And whereas the piece of land described or mentioned in the Schedule hereto has been taken under "The New Zealand Settlements Act, 1863," and it is expedient that it should be reserved for the purposes set opposite in the said Schedule:

Now therefore, I, Sir George Ferguson Bowen, the Governor of New Zealand, in pursuance and exercise of the powers so vested in me, do hereby except from sale and reserve to Her Majesty, her heirs and successors, for the purposes mentioned in the Schedule hereto, the allotment or parcel of land situated in the Upper Waikato District, in the Province of Auckland, and mentioned or referred to in the said Schedule.
