WHEREAS by "The Registration Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by Proclamation in the New Zealand Gazette, to divide the Colony of New Zealand, for the purposes of the said Act, into such and so many districts as he may think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation dividing the Colony or any part of it anew into districts, or increasing the number or altering the boundaries of districts, as from time to time he may think requisite:

And whereas by a Proclamation duly made and issued, bearing date the seventh day of September, one thousand eight hundred and sixty-three, the Governor, in pursuance of the said recited power and authority, did constitute districts for the purposes of the said Act, called the "Greytown" and "Wairarapa" Districts, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the first day of October, one thousand eight hundred and sixty-three:

And whereas by a Proclamation duly made and issued, bearing date the twenty-seventh day of September, one thousand eight hundred and sixty-six, the Governor, in pursuance of the said recited power and authority, did, amongst others, constitute a district, for the purposes of the said Act, called the "Manawatu" District, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the first day of November, one thousand eight hundred and sixty-six:

And whereas it is expedient to revoke so much of the said Proclamations as relates to the said districts, and to divide anew the territory formerly comprised within such districts.

within such districts:

Now therefore, I, Sir George Ferguson Bowen, the Governor of the said Colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said Proclamations so far as relates to the "Greytown" and "Wairarapa" Districts, and to the "Manawatu" District, and do proclaim and declare that the territory formerly comprised within such districts shall be and is hereby divided for the purposes of the said

Act into five districts, the names and boundaries whereof shall be as follows:—

GREYTOWN DISTRICT.

The boundary commences at the mouth of the Whareama River; thence along the sea coast to Cape Palliser, and continued to Taourakira Head; thence along the Rimutaka and Tararua Ranges until it intersects a line drawn West from the source of the Waignawa River; thence along said line and along the Waignawa River to its junction with the Ruamahanga River; thence on a line East to the Taueru River; thence along the southern boundary of the Castle Point District to the starting point.

MASTERTON DISTRICT.

Bounded towards the North by a portion of the Palmerston District; on the East by the Castle Point District; on the South by a portion of the Greytown District; and on the West by the Manawatu District.

THE CASTLE POINT DISTRICT.

The boundary commences at the mouth of the Waimata River; thence along the sea coast to the mouth of the Whareama River; thence on a line bearing West to the Taueru River; thence up said river until it intersects a line bearing East and West through Rangitumu Hill; thence along said line to the Ruamahanga River; thence up said river until it crosses the track through the Forty-Mile Bush; thence along said track to the boundary of the Province of Hawke's Bay; thence along said boundary to the starting point.

PALMERSTON NORTH DISTRICT.

The boundary commences at the Gorge of the Manawatu; thence down the Manawatu River to the Oroua River; thence up the Oroua River to Awahuri, where the main road line from Rangitikei to Palmerston intersects it; thence along said main road line to the Rangitikei River; thence up the Rangitikei River to Waitapa; thence on a line East to the Tararua Ranges; thence along the said ranges to the starting point.

FOXTON DISTRICT.

The boundary commences at the Gorge of the Manawatu; thence along the Tararua Ranges until it meets a line drawn east from the source of the Waikanae River; thence along said line and down the Waikanae River to the sea coast; thence up the

coast to the mouth of the Rangitikei River; thence up said river to "Bull's," Middle Rangitikei; thence by the southern boundary of the Palmerston North District to the starting point.

MASTERTON DISTRICT.

Bounded towards the North by a portion of the Palmerston District; on the East by the Castle Point District; on the South by a portion of the Greytown District; and on the West by the Manawatu District.

THE CASTLE POINT DISTRICT.

The boundary commences at the mouth of the Waimata River; thence along the sea coast to the mouth of the Whareama River; thence on a line bearing West to the Taueru River; thence up said river until it intersects a line bearing East and West through Rangitumu Hill; thence along said line to the Ruamahanga River; thence up said river until it crosses the track through the Forty-Mile Bush; thence along said track to the boundary of the Province of Hawke's Bay; thence along said boundary to the starting point.

PALMERSTON NORTH DISTRICT.

The boundary commences at the Gorge of the Manawatu; thence down the Manawatu River to the Orona River; thence up the Orona River to Awahuri, where the main road line from Rangitikei to Palmerston intersects it; thence along said main road line to the Rangitikei River; thence up the Rangitikei River to Waitapa; thence on a line East to the Tararua Ranges; thence along the said ranges to the starting point.

FOXTON DISTRICT.

The boundary commences at the Gorge of the Manawatu; thence along the Tararua Ranges until it meets a line drawn East from the source of the Waikanae River; thence along said line and down the Waikanae River to the sea coast; thence up the coast to the mouth of the Rangitikei River; thence up said river to "Bull's," Middle Rangitikei; thence by the southern boundary of the Palmerston North District to the starting point.

And I hereby declare that this Proclamation shall come into operation and take effect on the second day of October, one thousand eight hundred and seventy-one.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Native Reserves Amendment Act, 1862," it is amongst other things provided, that where under the provisions of "The Native Reserves Act, 1856," the assent of the aboriginal inhabitants is required to bringing land under the operation of the said "Native Reserves Act, 1856," the Governor may, by Order in Council, declare such assent to have been ascertained, and thereupon the title of the aboriginal inhabitants in the land to which the same shall relate shall be held as follows:deemed to be extinguished, and the land shall, from the date of such Order in Council, vest in Her Majesty for the purposes and subject to the provisions of the said "Native Reserves Act, 1856," as altered by the recited Act, and that as effectually as if the same had been ceded and conveyed by such aboriginal inhabitants to Her Majesty:

Now therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby declare that the assent of the aboriginal inhabitants to the bringing the piece of land described in the Schedule hereunder written under the operation of "The Native Reserves Act, 1856," has been ascertained.

SCHEDULE.

All that piece of land situate at Queen Charlotte Sound, in the Province of Marlborough, and known as the Iwituaroa or Umungata Reserve, bounded towards the North, East, and West by land leased to Mr. George Humphries, and towards the South by high watermark in Queen Charlotte Sound.

THE Regulations for the Examination of Candidates for employment in the Civil Service, dated 1st February, 1871, and published in Gazette No. 15, of 2nd March, 1871, are rescinded, and the following amended Regulations, to take effect from the 1st January, 1872, are published for general information. W. GISBORNE.

REGULATIONS RESPECTING EXAMINATIONS UNDER "THE CIVIL SERVICE ACT, 1866."

1. No person can enter the Civil Service as a probationer, or as a subordinate of the fifth class, unless he shall be of the full age of seventeen years, and not more than twenty-two years. The Board of Examiners may, however, examine candidates who are not younger than fifteen years.

2. Every candidate for examination must apply to be examined in a form to be prescribed by the Board, such application to be addressed to the Secretary, and to be accompanied by the following certificates:-

Age.—Certificate from Registrar of Birth. Any person unable to procure such certificate to account for its non-production, and to prove his age by satisfactory evidence.

Health.—A certificate of health signed by some

legally qualified Medical Practitioner.

Character.—A certificate of general good conduct from some Clergyman or Schoolmaster.

3. The examination shall be divided into two anches,—the one qualifying for appointment, the branches,other qualifying for promotion to any class above the fourth. One branch shall be called the Junior EXAMINATION, and the other branch shall be called the SENIOR EXAMINATION.

4. Every candidate must pass the Junior Examination (see section 9) before he shall be eligible for

5. Every civil servant must pass the Senior Examination (see section 10) before he shall be eligible

for promotion to any class above the fourth.

6. The Board shall have power, subject to the Governor's approval, to vary the optional subjects, and to frame such further rules for the conduct of examinations as they may deem fit, due notice of which shall be published in the New Zealand Gazette.

7. Every candidate must pass a certain standard of proficiency, to be fixed by the Board of Examiners. The Board, in publishing the result of examinations, shall classify the successful candidates according to merit; but the examination is not competitive for office, the Government being entitled to select any successful candidate for appointment at its discretion.

8. Examinations shall be held at such times and places, and before such persons, as the Board may

from time to time appoint.

9.—Junior Examination.

English.-Including dictation, reading, spelling, grammar, and composition.

Arithmetic.-Including vulgar and decimal fractions.

History and Geography.

10. SENIOR EXAMINATION.

Compulsory Subjects.
English, Latin, Arithmetic, and Geography.

Optional Subjects.

Greek, French, German, Maori, Algebra, Euclid, Book-keeping, Natural Science, History, Political Economy. The candidate must pass in at least two of the optional subjects in addition to the compulsory subjects.

11. Any candidate may undergo the Junior and Senior Examinations in the same term; but no candidate shall be eligible for the Senior Examination who is above the age of twenty-three years, nor be allowed to pass the same unless he has passed the Junior Examination.

12. Every passed candidate may receive a certificate, signed by two members of the Board and the Secretary, on payment of a fee of one guinea.

13. A register of candidates who have been examined shall be kept by the Board, and lists of those who pass shall be published from time to time in the New Zealand Gazette.

RULES PRESCRIBED BY THE BOARD OF EX-AMINERS, WITH THE APPROVAL OF HIS EXCELLENCY THE GOVERNOR.

SENIOR EXAMINATION. Compulsory Subjects.

English.—Dictation, reading, spelling, grammar, and composition (including abstract and précis writing).

-Any one of the following: Latin.-

Sallust.—Cataline and Jugurtha.
Virgil.—Any four books of the Æneid; the Board to be informed which books are chosen. Horace.—1. Odes and Epodes; or, 2. Satires and Epistles: the Board to be informed of the selection.

Cæsar.—De Bello Gallico. Cicero.—Orations.

Passages for translation will be set from these authors, and candidates will be required to answer grammatical and historical questions arising out of the passages so set.

Arithmetic.—(Including vulgar and decimal frac-

tions, averages, and percentages.)

Geography.—Political and Physical.

Optional Subjects.

Any two or more of the following subjects, at the option of the candidate

Greek .- Any one of the following :-

Xenophon.—Anabasis.

Homer.—Any one book of the Iliad.

Sophocles or Euripides.—Any one play.

Passages for translation will be set from these authors, and candidates will be required to answer grammatical and historical questions arising out of the passages so set.

French.—Translations from French into English,

and vice versâ.

German.-Translations from German into English, . and vice versá.

Maori.

Algebra.—So far as to include the solution of simple equations.

Euclid.—The first Four Books.

Book-keeping.— Natural Science.—Outlines of Natural Philosophy,

Zoology, Botany, or Geology.

History.—History of England, including Colonial History, especially of New Zealand.

Political Economy.—Elementary principles of.

II.—CERTIFICATES.

Certificates will be issued in the form C in the Schedule to candidates who pass the Junior Exami-

Certificates will be issued in the form D in the Schedule to candidates who pass the Senior Examina-

III.—CLASSIFICATION.

Senior Examination.

The names of successful candidates in the Senior Examination will be published in the order of comparative proficiency, ascertained by the total number of marks received by each candidate in all the subjects in which he has passed. No marks will be allowed for any subject in which the candidate has not received the minimum number of marks required for passing.

Certificates will be issued to passed candidates on

the following principle:—

First Class.—For each subject in which a candidate shall obtain not less than two-thirds of the maximum number of marks allotted thereto.

Second Class. - For each subject in which a candidate shall obtain less than two-thirds, but not less than one-half, of the maximum number of marks allotted thereto.

Third Class.—For each subject in which a candidate shall obtain less than one-half of the maximum number of marks allotted thereto.

IV .-- CONDUCT OF EXAMINATIONS.

On application being received, notice will be given to the candidate, by the Secretary to the Board, of the time and place of examination. Further instructions will also be forwarded at the same time.
