WHEREAS power is vested in the Governor of New Zealand by Proclamation to declare any house, building, enclosure, or place to be a Public Gaol:

Now therefore, I, Sir George Ferguson Bowen, the Governor, as aforesaid, do hereby declare and proclaim the following house or building, that is to say.

The House or Building situated on Block 43 in the Town of Lawrence, in the Province of Otago, heretofore used as a Lock-up,

to be a Public Gaol.

Given under the hand of His Excellency Sir George Ferguson Bowen, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at Wellington, this seventh day of January, in the year of our Lord one thousand eight hundred and seventy-one.

WHEREAS by "The Marriage Act Amendment Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by Proclamation in the New Zealand Gazette, to divide the Colony of New Zealand, for the purposes of the said Act, into such and so many districts as he may think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's district; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation dividing the Colony or

any part of it anew into districts or increasing the number or altering the boundar.es of districts, as from time to time he may think requisite:

And whereas by a Proclamation duly made and issued, bearing date the twelfth day of November, one thousand eight hundred and sixty-seven, the Governor, in pursuance of the said recited power and authority, did amongst others constitute a district for the purposes of the said Act, called the "Gabriel's" District, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the second day of December, one thousand eight hundred and sixty seven:

And whereas by a Proclamation duly made and issued, bearing date the thirtieth day of November, one thousand eight hundred and sixty-five, the Governor, in pursuance of the said recited power and authority, did amongst others constitute districts for the purposes of the said Act, called the "Waikouaiti" and "Hamilton" Districts, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the first day of February, one thousand eight hundred and sixty-six:

And whereas it is expedient to revoke so much of the said Proclamations as relates to the said districts, and to divide anew the territory formerly comprised within such districts:

Now therefore, I, Sir George Ferguson Bowen, the Governor of the said Colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said Proclamations so far as relates to the said districts, and do proclaim and declare that the territory formerly comprised within such districts shall be and is hereby divided, for the purposes of the said Act, into five districts, the names and boundaries whereof shall be as follows:—

BLUE SPUR DISTRICT

Comprises all that area bounded by a line commencing at a point in the road line along the northwestern watershed of Monro's Gully, bearing due east from Trigonometrical Station E, Tuapeka East Survey District, and proceeding thence in

an Easterly direction to the road line along the south-eastern watershed of the said Monro's Gully; thence in a South-westerly direction along the said road line to the south boundary of Block XVIII., Tuapeka East Survey District aforesaid; thence in a Westerly direction along the said boundary to a point due south of Trigonometrical Station E aforesaid; thence in a Northerly direction to the road line first above mentioned; thence in a North-easterly direction along the said road line to the starting point.

GABRIEL'S DISTRICT

Comprises all that area described in the Proclamation above referred to, bearing date the 12th of November, 1867, and published in the New Zealand Gazette No. 61, 14th November, 1867, excepting therefrom the area contained in Blue Spur District above described.

HYDE DISTRICT

Comprises all that area bounded towards the North by the Taieri River and Run 203, from Sowburn to Kakanui Peak; thence along the north-eastern and south-eastern boundaries of Run 255 to Deep Dell Creek, at its junction with the Waihemo River; thence due South to a point due east of the north-eastern corner of Run 307; thence Westerly to Run 307; thence along the south-eastern boundary of the said Run 307 and Sutton's Stream to the Rock and Pillar Ranges; thence along the western boundaries of Runs 213 and 204 to the Taieri River, at the junction of Sowburn, the starting point.

HAMILTON DISTRICT

Comprises all that area bounded by a line proceeding from Lammerlaw along the western watershed of the Upper Taieri River to South Roughridge Hill; thence to North Roughridge Hill; thence to Mount Ida; thence along the ranges to Kyeburn Hill; thence to Kakanui Peak; thence along the northern and western boundary of Hyde District, before described, to Sutton's Stream; thence along Sutton's Stream to its source; and thence to Lammerlaw, the starting point.

WAIKOUAITI DISTRICT

Comprises all that area bounded towards the Northwest by Hyde District, before described; towards the North-east by the Kakanui Mountains and the Horse Range to the ocean; towards the South-east by the ocean; and towards the South and Southwest by the Dunedin, North Taieri, and West Taieri Districts.

And I do declare that this Proclamation shall come into operation and take effect on the fifteenth day of February, one thousand eight hundred and seventy-

one.

HYDE DISTRICT

At the Government Buildings, at Wellington, this twenty-first day of December, 1870.

THE HONORABLE WILLIAM FOX, PRIME MINISTER, Presiding, and Members of the Executive

WHEREAS by an Act of the General Assembly of New Zealand, intituled "The New Zealand Post Office Act, 1858," it is enacted that it shall be lawful for the Governor in Council from time to time, by Proclamation to be published in the New Zealand Gazette, to fix, alter, and abolish the rates of postage at any time within the Colony for the transmission of letters and newspapers by post, either between places within New Zealand or to and from between places within New Zealand or to and from places beyond seas: And whereas by "The New Zealand Post Office Act Amendment Act, 1866," it is enacted that the postage on newspapers posted within the Colony for delivery within the Colony shall be one penny each: And whereas by "The New Zealand Post Office Act Amendment Act, 1870, No. 2," it is enacted that notwithstanding anything contained in "The New Zealand Post Office Act Amendment Act, 1866," it shall be lawful for the Governor in Council from time to time to make regulations for the transmission by post of newspapers, and any such regulations to alter and revoke, and subject to such regulations and the conditions the Governor of New Zealand, in pursuance of the

therein contained to exempt from payment of postage all newspapers addressed to the Manager, Keeper, Clerk, Secretary, Librarian, or other person having the charge of any Athenæum, Mechanics' Institute, Hospital, Public Library, or Lunatic Asylum in New Zealand; or to any such Athenæum, Mechanics' Institute, Hospital, Public Library, or Lunatic Asylum, without the addition of the name or description of any person: Provided that it shall not be lawful by any such regulations to permit the delivery free of postage of any newspaper except to such Athenæum, Mechanics' Institute, Hospital, Public Library, or Lunatic Asylum in New Zealand, of more than one copy of any issue or number of any newspaper to any such Athenaum, Mechanics' Institute, Hospital, Public Library, or Lunatic Asylum: And whereas it has been considered expedient, subject to the provisions of the said last-mentioned Act, to exempt from payment of postage newspapers addressed to the institutions or establishments mentioned in the Schedule hereto without the addition of the name or description of any person:

Now therefore, His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, in pursuance of the said recited power and authority, and by and with the advice and consent of the Executive Council of New Zealand, doth by this present Order exempt from payment of postage, subject to such conditions excelled in the said subject to such conditions specified in the said recited section of the said last-mentioned Act, all newspapers transmitted by post addressed to such institutions or establishments as are mentioned in the Schedule hereto, without the addition of the name or description of any person: And further doth declare that this Order shall take effect on and after the first day of December, one thousand eight

hundred and seventy.

WHEREAS by the fifteenth section of "The Juries Act, 1868," it is enacted that in case any Circuit Court or sittings of the Supreme Court for trial of civil or criminal cases, or District Court, or Court of Sessions of the Peace, shall thereafter be lawfully directed or appointed to be holden at any town other than those at which Courts are now holden, the Clerk of the Besident Magistrate's Court there, if there be one, or a Jury Officer to be appointed for the jury district of such town in manner for the jury district of such town in mainter in the said Act mentioned shall act as Jury Officer for the jury district of such town, and such Jury Officer, and all Justices of the Peace, and the Registrars, Clerks, or other officers of Courts, constables and officers of police, and Sheriffs shall within such time as the Governor shall Sheriffs, shall within such time as the Governor shall order for that occasion only do and perform all such acts, matters, and things, in and towards preparing, collecting, allowing, sending, and delivering the lists of men qualified and liable to serve on juries, and making out the jury books for every such jury district as are thereinbefore required ordinarily to be done at a different time or period, and all such last-mentioned jury books shall be brought into use and the persons whose names shall be therein set down shall be liable WHEREAS by "The Regulation of Elections whose names shall be therein set down shall be liable to serve immediately after the same shall have been lawful for the Governor, by Warrant under his made out by the Sheriff, and the said last-mentioned books shall be used until new books shall have been prepared under the provisions hereinbefore contained: And whereas sittings of the District Court have been lawfully directed or appointed to be holden at the Town of Timaru, being a town other than one at which Courts were then holden: Now therefore, I, Sir George Ferguson Bowen, the Governor of New Zealand, in exercise of all powers and authorities in this behalf vested in me by the said Act, do hereby order that the Jury Officer for the jury district of Timaru, and all Justices of the Peace, and the Registrars, Clerks, or other officers of Courts, constables and officers of police, and Sheriffs, shall before the first day of March next do and perform all such acts, matters, and things, in and towards preparing, collecting, allowing, sending, and delivering the lists of men qualified and liable to serve on juries, and making out the jury books for the jury district of Timaru, as are thereinbefore in the said Act ordinarily required to be done at a different time or period.

And I do order that for the purposes aforesaid, the words in the sections of the said Juries Act, 1868, specified in the first column of the Schedule hereto shall respectively be construed and read as if the words in the second column of the said Schedule were inserted in lieu of such words in the said sections respectively.

I have been informed by several people used to navigating these seas, that Onaseuse or Hunter Island does not exist, and this is borne out by our observations on the 7th instant.
