HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by "The Gold Mining Districts Act, 1871," it is among other things enacted that it shall be lawful for the Governor in Council, under his hand and the Public Scal of the Colony, from time to time to delegate to such person as the Governor in Council may deem fit, all or any of the powers vested in the Governor by the said Act, except the powers conferred by sections seventy and seventyone, or by subsection thirteen of section ninety-eight thereof, subject or not to any limitations or restrictions, and in like manner to alter or revoke any such delegation: And whereas it is expedient that the Governor should delegate to the person hereinafter named the powers herein mentioned and set forth:

Now therefore, I, Sir George Ferguson Bowen, the Governor of the Colony of New Zealaud, in pursuance and exercise of the powers and authority in me vested by the said Act, and by and with the advice and consent of the Executive Council of the said Colony, do, by this order under my hand and the Public Seal of the Colony, hereby delegate unto

## THOMAS BANNATENE GILLIES, Esquire,

the Superintendent of the Province of Auckland, all the powers vested in me under or by virtue of the said Act, except the powers conferred by sections seventy and seventy-one, and by subsection thirteen of section ninety-eight thereof, to have, hold, and exercise within the Province of Auckland the said powers hereby given to the said Thomas Bannatyne Gillies, so long as he shall be and remain Superintendent of the said Province, and no longer: Provided that this delegation shall not have any force or effect until the fifteenth day of January, one thousand eight hundred and seventy-two: Provided further, that no rule or regulation made under the delegation aforesaid, shall become or have the effect of law until the same shall have been approved by the Governor

WHEREAS by the one hundred and thirty-third VV section of an Act of the General Assembly of New Zealand, intituled "The Municipal Corporations Act, 1867," it is enacted that it shall be the duty of the Town Clerk of every borough, as soon as con-'it is enacted that it shall be the duty of veniently may be after every election of a Mayor for such borough, to give notice to the Colonial Secretary for the time being of such election, and of the person elected; and it shall be lawful for the Governor, if he shall think fit, and if such person shall not then be a Justice of the Peace, by warrant under his hand, published in the New Zealand Gazette, to appoint such person to be a Justice of the Peace for the Colony; and it is also thereby enacted that in every such appointment it shall be expressed that it is made under the one hundred and thirty-third section of the said Act; and it is further declared that such appointment shall continue in force only during the Mayoralty of such person, and the person so appointed shall not, by virtue of such appointment, be authorized to sit or act as a Justice of the Peace elsewhere than within the borough:

[CIRCULAR.] Downing Street, 23rd September, 1871. -With reference to my Circular Despatches of SIR,the 27th August, 1870, and 2nd February last, on the subject of Naturalization, I transmit to you, for your information and guidance, a copy of a Circular Despatch and its enclosures, which has been addressed by Earl Granville to Her Majesty's Diplomatic Representatives and Consuls, containing instructions for their guidance in carrying into effect the Naturalization Conventions with the United States of the 13th May, 1870, and the 23rd of February, 1871. I also enclose a copy of the original Convention and of the form of the Declaration of Alienage given in the Convention, which, as you will see, has been regulated by a Secretary of State, in accordance with the Imperial Act.

I have to call your attention to the provisions in Article II. of the Convention, enclosed in the Foreign Office Circular, as to communicating from time to time to the Government of the United States lists of the persons who have declared their renunciation of American naturalization, and at the same time to request that you will make the notifications pointed out by the Foreign Office in their Circular Despatch of the 4th September.

The instructions as to the mode of making the Declarations, which were given in my Circular Despatch of the 2nd February, apply to Declarations of Alienage made under the Conventions with the United States.

# ENCLOSURE 1.

Convention between Her Majesty and the United States of America, Supplementary to the Convention of 13th May, 1870, respecting Naturalization.—Signed at Washington, 23rd February, 1871. (Ratifications exchanged at Washington, 4th 1871.)

WHEREAS by the Second Article of the Convention between Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, and the United States of America, for regulating the citizenship of subjects and citizens of the Contracting Parties who have emigrated or may emigrate from the dominions of the one to those of the other Party, signed at London, on the 13th of May, 1870, it was stipulated that the manner in which the renunciation by such subjects and citizens of their naturalization, and the resumption of their native allegiance, may be made and publicly declared, should be agreed upon by the Governments of the respective countries; Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, and the President of the United States of America, for the purpose of effect-

ing such agreement, have resolved to conclude a Supplemental Convention, and have named as their is also enclosed, may be made and publicly declared.

Plenipotentiaries, that is to say: Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, Sir Edward Thornton, Knight Commander of the Most Honorable Order of the Bath, and Her Envoy Extraordinary and Minister Plenipotentiary to the United States of America; and the President of the United States of America, Hamilton Fish, Secretary of State, who have, agreed as follows :-

#### Article I.

Any person being originally a citizen of the United States who had previously to 13th May, 1870, been naturalized as a British subject, may at any time before 10th August, 1872, and any British subject who, at the date first aforesaid, had been naturalized as a citizen within the United States, may, at any time before May 12, 1872, publicly declare his renunciation of such naturalization by subscribing an instrument in writing, substantially in the form hereunto appended, and designated as Annex A.

Such renunciation by an original citizen of the United States of British nationality shall, within the territories and jurisdiction of the United States, be made in duplicate, in the presence of any Court authorized by law for the time being to admit aliens to naturalization, or before the Clerk or Prothonotary of any such Court: if the declarant be beyond the territories of the United States, it shall be made in duplicate, before any diplomatic or consular officer of the United States. One of such duplicates shall remain of record in the custody of the Court or officer in whose presence it was made; the other shall be, without delay, transmitted to the Department of State.

Such renunciation, if declared by an original British subject, of his acquired nationality as a citizen of the united states, shall, if the declarant be in the United Kingdom of Great Britain and Ireland, be made in duplicate, in the presence of a Justice of the Peace; if clsewhere in Her Britannic Majesty's dominions, in triplicate, in the presence of any Judge of civil or criminal jurisdiction, of any Justice of the Peace, or of any other officer for the time being authorized by law, in the place in which the declarant is, to administer an oath for any judicial or other legal purpose : if out of Her Majesty's dominions, in triplicate, in the presence of any officer in the Diplomatic or Consular Service of Her Majesty.

# . Article II.

The Contracting Parties hereby engage to communicate each to the other, from time to time, lists of the persons who, within their respective dominions and territories, or before their Diplomatic and Consular Officers, have declared their renunciation of naturalization, with the dates and places of making such declarations, and such information as to the abode of the declarants, and the times and places of their naturalization, as they may have furnished.

#### CIRCULAR.

#### Foreign Office, 4th September, 1871.

With reference to my Circular Despatches of the 30th of December and 22nd of April last, I transmit to you herewith a copy of a Supplementary Convention concluded between Her Majesty and the United States of America, on the 23rd of February last, the ratifications of which were exchanged at Washington on the 4th of May, prescribing the manner and form in which the renunciation by subjects and citizens of Great Britain and of the United States respectively, of their insturalization and the resumption of their native allegiance in accordance with the provisions of the previous Convention of the 13th of May, 1870, of which a copy

I likewise transmit to you a copy of the Order in | legation, or consulate], this Council of the 17th of August, 1870, declaring, as 187 required by the 3rd section of the Act 33 Vict., cap. 14, that the Convention of the 13th of May, 1870, had been entered into by Her Majesty; and I have now to instruct you to publish a Notification. reciting that section of the Act, together with the Order in Council and the two Conventions, and calling upon all British subjects who have become naturalized within the United States, and who may desire to resume their allegiance as British subjects, to make the declaration in the form prescribed before the 12th of May, 1872.

You will at the same time point out that, although the supplemental Convention of the 23rd of February last only requires that American citizens who have been naturalized as British subjects should make the declaration of renunciation before an United States' Court of Justice or Diplomatic or Consular Officer of the United States, it will be necessary, in order to meet the requirements of the British Act of Parliament, that the declaration should also be made before one of the British Judicial, Diplomatic, or Consular Officers mentioned in the 3rd section.

You will add that no fee will be levied for receiving these declarations.

The declarations are to be made in triplicate, one copy to be delivered to the Declarant, or retained in your archives, and the third forwarded to this Department for registration by the Home Office, in the same manner as the declarations which you were instructed to take in my Circular of the 30th of December last.

I take this opportunity of stating that, as some misapprehension has arisen with regard to the form of "Declaration of British Nationality" annexed to that Circular, you must be careful in all cases when you are called upon to receive a Declaration of British Nationality to append to it the Note given in the form, and which is to be considered as part of the declaration.

A similar Circular has been addressed to Her Majesty's Consuls.

Convention between Her Majesty and the United States of America relative to Naturalization.— Signed at London, May 13, 1870. (Ratifications exchanged at London, August 10, 1870.)

HER Majesty the Queen of the United Kingdom of Great Britain and Ireland, and the President of the United States of America, being desirous to regulate the citizenship of British subjects who have emigrated or who may emigrate from the British dominions to the United States of America, and of citizens of the United States of America who have emigrated or who may emigrate from the United States of America to the British dominions, have resolved to conclude a Convention for that purpose, and have named as their Plenipotentiaries, that is to say :

Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, the Right Honourable George William Frederick, Earl of Clarendon, Baron Hyde of Hindon, a Peer of the United Kingdom, a Member of Her Britannie Majesty's Most Honourable Privy Council, Knight of the Most Noble Order of the Garter, Knight Grand Cross of the Most Honourable Order of the Bath, Her Britannie Majesty's Principal Secretary of State for Foreign Affairs :

And the President of the United States of America, John Lothrop Motley, Esquire, Envoy Extraordinary and Minister Plenipotentiary of the United States of America to Her Britannie Majesty;

Who, after having communicated to each other their respective full powers, found to be in good and due form, have agreed upon and concluded the following Articles :-

#### Article I.

British subjects who have become, or shall become, and are naturalized according to law within the United States of America as citizens thereof, shall, subject to the provisions of Article II., be held by Great Britain to be in all respects and for all pur-poses citizens of the United States, and shall be treated as such by Great Britain.

Reciprocally, citizens of the United States of America who have become, or shall become, and are naturalized according to law within the British dominions as British subjects, shall, subject to the provisions of Article II., be held by the United States to be in all respects and for all purposes British subjects, and shall be treated as such by the British subjects, and shall be treated as such by the United States.

#### Article II.

Such British subjects as aforesaid who have become and are naturalized as citizens within the United States, shall be at liberty to renounce their natu-ralization and to resume their British nationality, provided that such renunciation be publicly declared within two years after the twelfth day of May, 1870.

Such citizens of the United States as aforesaid who have become and are naturalized within the dominions of Her Britannic Majesty as British subjects, shall be at liberty to renounce their naturalization, and to resume their nationality as citizens of the United States, provided that such renunciation be publicly declared within two years after the exchange of the ratifications of the present Convention.

The manner in which this renunciation may be made and publicly declared, shall be agreed upon by the Government of the respective countries.

#### Article III.

If any such British subject as aforesaid, naturalized in the United States, should renew his residence within the dominions of Her Britannic Majesty, Her Majesty's Government may, on his own application, and on such conditions as that Government may think fit to impose, readmit him to the character and privileges of a British subject, and the United States shall not, in that case, claim him as a citizen of the United States on account of his former naturalization.

In the same manner, if any such citizen of the United States as aforesaid, naturalized within the dominions of Her Britannic Majesty, should renew his residence in the United States, the United States' Government may, on his own application, and on such conditions as that Government may think fit to impose, readmit him to the character and privileges of a citizen of the United States, and Great Britain shall not, in that case, claim him as a British subject on account of his former naturalization.

#### Article IV.

The present Convention shall be ratified by Her Britannic Majesty, and by the President of the United States, by and with the advice and consent of the Senate thereof, and the ratifications shall be exchanged at London as soon as may be within twelve months from the date hereof.

ORDER IN COUNCIL.

At the Court at Windsor, the 17th day of August, 1870.

#### THE QUEEN'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEBEAS by "The Naturalization Act, 1870," it is enacted that, where Her Majesty has entered into a Convention with any foreign State, to the effect that the subjects or citizens of that State who have been naturalized as British subjects may divest themselves of their status as such subjects, it shall be lawful for Her Majesty, by Order in Council, to declare that such Convention has been entered into by Her Majesty; and from and after the date of such Order in Council, any person being originally a subject or citizen of the State referred to in such Order, who has been naturalized as a British subject, may, within such limit of time as may be provided in the Conven-tion, make a declaration of alienage; and from and after the date of his so making such declaration, such person shall be regarded as an alien, and as a subject of the State to which he originally belonged as afore-said: And whereas, on or about the thirteenth day of May last past, a Convention between Her Majesty and the President of the United States of America was duly signed at London, the ratifications whereof were duly exchanged at London the tenth day of August instant, whereby the subjects or citizens of the United States of America who have been naturalized as British subjects are at liberty to renounce their naturalization, and divest themselves of their status as such British subjects, provided that such | lowing Articles :-

renunciation be publicly declared within two years after the exchange of the ratifications of the said Convention: Now therefore, Her Majesty, by and with the advice of Her Privy Council, doth hereby declare that Her Majesty has entered into a Convention with the said United States of America, to the effect that the subjects or citizens of those States who have been naturalized as British subjects may divest themselves of their status as such subjects.

# ENCLOSURE 4.

#### Section 3 of 33 Vict., cap. 14.

3. Where Her Majesty has entered into a Convention with any foreign state to the effect that the subjects or citizens of that State who have been naturalized as British subjects may divest themselves of their status as such subjects, it shall be lawful for Her Majesty, by Order in Council, to declare that such Convention has been entered into by Her Majesty; and from and after the date of such Order in Council, any person being originally a subject or citizen of the State referred to in such order, who has been naturalized as a British subject, may, within such limit of time as may be provided in the Convention, make a declaration of alienage, and from and after the date of his so making such declaration such person shall be regarded as an alien, and as a subject of the State to which he originally belonged as aforesaid.

A declaration of alienage may be made as follows; that is to say,—If the declarant be in the United Kingdom, in the presence of any Justice of the Peace; if elsewhere in Her Majesty's dominions, in the presence of any Judge of any Court of civil or criminal jurisdiction, of any Justice of the Peace, or of any other officer for the time being authorized by law in the place in which the declarant is to administer an oath for any judicial or other legal purpose. If out of Her Majesty's dominions, in the presence of any officer in the Diplomatic or Consular Service of Her Majesty.

#### Article II.

Such British subjects as aforesaid who have become and are naturalized as citizens within the United States, shall be at liberty to renounce their naturalization and to resume their British nationality, provided that such renunciation be publicly declared within two years after the twelfth day of May, 1870.

Such citizens of the United States as aforesaid who have become and are naturalized within the dominions of Her Britannic Majesty as British subjects, shall be at liberty to renounce their naturalization and to resume their nationality as citizens of the United States, provided that such renunciation be publicly declared within two years after the exchange of the ratification of the present Convention.

The manner in which this renunciation may be made and publicly declared shall be agreed upon by the Governments of the respective countries.

#### Article III.

If any such British subject as aforesaid, naturalized in the United States, should renew his residence within the dominions of Her Britannic Majesty, Her Majesty's Government may, on his own application and on such conditions as that Government may think fit to impose, readmit him to the character and privileges of a British subject, and the United States shall not, in that case, claim him as a citizen of the United States on account of his former naturalization.
