WHEREAS by "The Oyster Fisheries Act, 1866," it is, amongst other things, enacted that the Governor may from time to time, by Proclamation in the New Zealand Gazette, declare any natural oyster-bed to be closed against dredging for any period to be stated in such Proclamation:

And whereas it is expedient that the natural oyster-beds at Port Adventure, in Stewart Island,

should be temporarily dosed:

Now therefore I, Sir George Ferguson Bowen,
Governor of the Colony of New Zealand, in exercise and pursuance of the power and authority in me vested by the said Act, do hereby proclaim and declare that the natural oyster-beds at Port Adventure, in Stewart Island, shall be closed against dredging for a period of two years, from the twenty-second day of July, one thousand eight hundred and seventy-two.

REGULATIONS FOR SCHOLARSHIPS.

THAT no candidate under fifteen years of age shall be admitted to the examination for a scholarship, and no candidate be entitled to hold a scholarship unless he shall enter his name upon the books of some affiliated institution or of the Otago University, and attend regularly the course of studies and lectures prescribed by such institutions or the Council.

That all scholars be subject to the supervision and control of the authorities of the institutions at which they have entered, in accordance with section 11 of "The New Zealand University Act, 1870."

That no person be admitted to a scholarship unless he shall have matriculated as a member of the University.

That these Regulations come into force on the 13th day of October, 1872.

N.—REGULATIONS FOR THE AFFILIATION OF SCHOLASTIC OR COLLEGIATE INSTITUTIONS.

THAT scholastic or collegiate institutions in the

Colony be affiliated on the following conditions:—

I. That such institutions provide, for the purposes of teaching and lecturing, lecture-rooms with suitable

apparatus and appliances.
II. That, at such periods of the year as may be determined upon by the Council, lectures be regularly given by the teachers and lecturers of these institutions.

III. That it may be shown to the satisfaction of the Council that such institutions are competent to

supply, through their teachers and lecturers, adequate instruction in at least three of the following branches of education, or in such other branches as may be determined upon by the Council, namely-

1. Classics.

2. Mathematics and Natural Philosophy. 3. Modern Languages other than English.

4. Physical Science.

5. English Language and Literature.

6. General History.

7. Moral Philosophy and Logic.

8. Jurisprudence.

That these Regulations come into force on the 13th day of October, 1872.

And whereas by the fourth section of "The Diseased Cattle Act Amendment Act, 1865," it is enacted that the Governor may, by an Order in Council, from time to time annul, make void, alter or vary or make anew, any Orders in Council, regulations, appointments, or prohibitory or other declarations made and published by the Governor under the authority of "The Diseased Cattle Act, 1861," or of "The Diseased Cattle Act Amendment Act, 1865," or by the Superintendent of any Province under or in pursuance of any powers delegated under the powers of delegation contained in "The Diseased Cattle Act, 1861," or "The Diseased Cattle Act Amendment Act, 1865:"

And whereas by the fifth section of "The Diseased Cattle Act Amendment Act, 1865," it is enacted that the power of annulling, making void, or allowing or varying and making anew, any such regulations, appointments, or prohibitory or other declarations, vested in the Governor by "The Diseased Cattle Act Amendment Act, 1865," may from time to time be delegated by the Governor in Council, by warrant under his hand, to the Superintendent of any Pro-

vince:

And whereas the said Governor hath, by and with the advice and consent of the Executive Council of New Zealand, delegated to James Macandrew, Esq., the Superintendent of the Province of Otago, within the said Province, so long as he shall remain Super-intendent of the Province, the several powers vested in the Governor or the Governor in Council by the second, fourth, fifth, seventh, ninth and tenth sections of "The Diseased Cattle Act, 1861," aforesaid, and all the powers which by the fifth section of "The Diseased Cattle Act Amendment Act, 1865," the Governor in Council is authorized so to delegate:

Now therefore, I, James Macandrew, by virtue of such powers in me vested, do hereby proclaim and declare that, after the date of the publication hereof in the New Zealand Gazette, the Colonies of Victoria, New South Wales, and South Australia, Queensland, Western Australia, and Tasmania, and all the other Provinces in the Colony of New Zealand, the County of Westland in the said Colony, and the Chatham Islands, shall be deemed Infected Districts within the meaning of the said Acts: And I do further proclaim and declare the following Regulations for the destruction of Diseased Cattle, and for the preventing and regulating the removal or transportation of Cattle from the said several Infected Districts into the Province of Otago:-

I. — If any person shall import, drive, or remove, or cause to be imported, driven, or removed, or assist in driving or removing any cattle from any of the said infected districts into the Province of Otago, except into a Quarantine Ground, and after having obtained a Quarantine certificate from an Inspector of Cattle, such person shall be liable to a penalty of fifty pounds for every head of cattle so imported, driven, or removed. II.—It shall be lawful for any Inspector of Cattle

or Police Constable to destroy or cause to be

destroyed any diseased cattle which shall pass into this Province from any of the said dis-

tricts contrary to these Regulations.

III.—If any person shall wilfully impede or obstruct any Inspector or any Police Constable acting under the authority of these Regulations, every person so offending shall be liable to a penalty of fifty nounder. to a penalty of fifty pounds.

IV.—These Regulations shall take effect from

and after the day following the date of publication in the New Zealand Gazette.
