A PROCLAMATION.

WHEREAS by "The Gold Fields Act, 1866," it is provided that it shall be lawful for the Governor at any time subsequent to the proclamation of a gold field, to withdraw by Proclamation therefrom any Crown lands which he may deem it necessary to withdraw, and that such lands shall henceforth be dealt with, sold, occupied, and disposed of under any law or laws for the time being in force regulating the sale, occupation, or disposal, or in any way affecting or relating to the management or dealing with the Crown lands within the Province in which such gold field is situate, in like manner in every respect as though such lands had never been comprised in any proclaimed gold field :

Now therefore, I, Sir George Ferguson Bowen, the Governor of the Colony of New Zealand, in pursuance and in exercise of the power and authority for this purpose vested in me, do hereby withdraw from the Nelson South-West Gold Field, proclaimed on the eighth day of June, one thousand eight hundred and sixty-eight, so much of the parcels of land described in the Schedule hereto, as are included within the said gold field.

SCHEDULE.

1. All that block of land lying between a point on the Inangahua River known as the "Landing," and Larry's Creek, in the Inangahua Valley, in the Province of Nelson, containing three thousand seven hundred and ten acres, one rood and seventeen perches, more or less, and bounded as follows:—On the West by the River Inangahua; and on the North, East, and South by the boundaries of the surveyed sections, excepting all sections at present applied for under the Agricultural Leasing Regulations.

2. All that block of land lying between Larry's Creek and Fern Flat, in the Valley of the Inangahua, in the Province of Nelson, containing two thousand six hundred and eight acres three roods and seven perches, more or less, bounded as follows:—On the West by the Inangahua River; on the North by Larry's Creek; and on the East and South by the

boundaries of the surveyed sections, excepting all sections at present applied for under the Agricultural Leasing Regulations.

3. All that block of land in the Inangahua Valley, in the Province of Nelson, lying between the Inangahua and Waituhu Rivers, containing three thousand six hundred and one acres, more or less, bounded as follows:—On the North and East by the River Waituhu; on the South and East by the boundaries of the surveyed sections; and on the West by the River Inangahua, excepting all sections at present applied for under the Agricultural Leasing Regulations.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Wellington Reclaimed Land Act, 1871," it is, among other things, enacted that the Mayor, Councillors, and Burgesses of the City of Wellington (in the said Act thereafter called "The Corporation aforesaid"), and their successors, may from time to time, with the previous

consent of the Governor in Council, demise or let all or any part of the lands described in the First Schedule thereto, for such term of years in possession not exceeding forty-two years, and at such annual rent or rents as they shall, with the previous sanction of the Governor in Council, determine:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS at a sitting of the Native Land Court of New Zealand at Hamilton, in the District of Waikato, Province of Auckland, on the twenty-ninth day of June, one thousand eight hundred and seventy-two, the claim of Hohaia Ngahiwi and others, aboriginal natives of New Zealand, residing at Tamahere, to a piece of land called Motumaho No. 2, situate at or near Hangawera in the district aforesaid, was heard, and a certain order was thereupon made by the Court aforesaid: And whereas it is enacted by "The Native Lands Act, 1865," and "The Native Lands Act, 1867," and "The Native Lands Act, 1870," that the Governor in Council may order a rehearing of any matter judicially heard, before the Court aforesaid, and before one or more Judges of the Court, and one or more Assessors, as may be specified in the Order in Council ordering such rehearing, and within such period of time as may be limited in such order, provided that no such order for rehearing shall be made after six months shall have elapsed from the date of the original decision: And whereas it is expedient that the said claim shall be reheard before the said Court:

Now therefore, His Excellency the Governor, with the advice and consent of the Executive Council of the Colony, in pursuance and exercise of the above-recited power and authority, doth hereby order that the aforesaid claim of Hohaia Ngahiwi and others to the aforesaid piece of land shall be reheard before a Judge of the said Court and one Assessor thereof.

And doth order that such rehearing shall take place before the thirty-first day of December, one thousand eight hundred and seventy-three.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Maori Real Estate Management Act, 1867," it is enacted that if any title to or interest in any hereditaments shall accrue to any Maoris, who or any of whom shall be infants, lunatics, or under legal disability, it shall be lawful for the Governor in Council, if he think fit, to order that such hereditaments, or any part thereof, or interest therein, as shall to the Governor in Council be shown to belong to such infant, lunatic, or other person under legal disability, shall be vested in Trustees, as the Governor in Council shall think fit: And whereas by virtue of a Crown grant bearing date the twenty-second day of November, one thousand eight hundred and sixty-nine, the parcel of land and hereditaments described in the Schedule written hereon, became vested in Tamaho Te Huhu, Kaperiere Haumea, and Kapakuku, of the District of Mangonui, in the Province of Auckland, Aboriginal Natives of New Zealand: And whereas Tamaho Te Huhu, one of the said grantees, died intestate: And whereas at a Native Lands Court held at Onoke, in the District of Hokianga, in the Province aforesaid, Hekiera Tamaho claimed to succeed to the interest of the said Tamaho Te Huhu in the said parcel of land described in the said Schedule, and it was recommended by the said Court that the said Hekiera Tamaho should succeed to the interests of the said Tamaho Te Huhu, and it is expedient that Kaperiere Haumea be appointed Trustee under the said Act on behalf of the said Hekiera Tamaho during his minority:

Now therefore, His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, with the advice and consent of the Executive Council of the Colony, in exercise and in pursuance of the powers and authorities vested in him by the said Act, doth hereby order that the interest of the said Tamaho Te Huhu in the said land so described in the said Schedule shall be and remain vested in the said Kaperiere Haumea, of the District of Mangonui, in the Province of Auckland, an Aboriginal Native of New Zealand, as Trustee within the meaning and for the purposes of the said Act for the said Hekiera Tamaho during his minority.

All that parcel of land in the Province of Auckland containing by admeasurement seventy (70) acres, more or less, situate at Kaitaia, in the District of Mangonui, County of Mangonui, being called or known by the name of "Tawhati," and numbered eight hundred (800): bounded towards the East and South by the Kaitaia River; towards the West and North-west by lines six hundred and eighty (680) links, four hundred and seventy (470) links, nine hundred and forty-seven (947) links, and one thousand four hundred and seventy (1470) links; and towards the North by a line one thousand three hundred and sixty (1360) links.

WHEREAS by "The Maori Real Estate Management Act, 1867," it is enacted that if any title to or interest in any hereditaments shall accrue to any Maoris, who or any of whom shall be infants, lunatics, or under legal disability, it shall be lawful for the Governor in Council, if he think fit, to order that such hereditaments, or any part thereof, or interest therein, as shall to the Governor in Council be shown to belong to such infant, lunatic, or other person under legal disability, shall be vested in Trustees as the Governor in Council shall think fit: And whereas by virtue of a Crown grant, bearing date the thirty-first day of March, one thousand eight hundred and seventy, the parcel of land and hereditaments described in the Schedule written hereon became vested in Rupene Te Whetuki and Rehara Ngawharawhara, of the District of Hauraki, in the Province of Auckland, Aboriginal Natives of New Zealand: And whereas Rehara Ngawharawhara, one of the said grantees, died intestate: And whereas at a Native Lands Court held at Shortland, in the District of Hauraki, in the Province aforesaid, on the tenth day of August, one thousand eight hundred and seventy-two, Te Mura claimed to succeed to the interest of the said Rehara Ngawharawhara in the said parcel of land described in the said Schedule, and it was ordered by the said Court that the said Te Mura should succeed to the interest of the said Rehara Ngawharawhara in the said hereditaments, and it is expedient that the said Rupene Te Whetuki should be appointed a Trustee under the said Act on behalf of the said Te Mura during his minority:

Now therefore, His Excellency Sir George Ferguson Bowen, the Governor of New Zealand, with the advice and consent of the Executive Council of the Colony, in exercise and in pursuance of the powers and authorities vested in him by the said Act, doth hereby order that the estate or interest of the said Rehara Ngawharawhara in the said parcel of land shall be and remain vested in the said Rupene Te Whetuki as Trustee within the meaning and for the purposes of the said Act for the said Te Mura during his minority.
