Description of Road Alteration, Kai-iwi to Waingongoro.

(L.S.) PROCLAMATION.

WHEREAS by a Proclamation bearing date the thirty-first day of July, one thousand eight hundred and seventy-one, made in pursuance of "The Immigration and Public Works Act, 1870," a certain road between Kai-iwi and Waingongoro was proclaimed and declared to be a road under the said Act, as therein mentioned: And whereas by the said Act it is provided that the Governor may from time to time revoke or alter any such Proclamation so made as aforesaid; and whereas it is expedient that the boundaries of the said road should be altered as far as regards that portion of it situated between a public road adjoining and lying to the north of Suburban Allotment No. 10, Township of Carlyle (Patea), and the junction line of Suburban Allotments 63 and 64 abutting on the Kakaramea Road, and which is of the length of 79 chains 68 links, or thereabouts: And whereas on and prior to the date of the said in part recited Proclamation, it was the opinion of the Governor and the Executive Council of New Zealand that the said road was not a road which should be constructed by the Superintendent and Provincial Council of the Province of Wellington, but in the last recital to such Proclamation, the word "Auckland" was inserted instead of the word "Wellington"

"Wellington."
Now therefore, I, Sir George Alfred Arney, the Administrator of the Government of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me for that purpose by the hereinbefore in part recited Act, do hereby proclaim and declare that the hereinbefore in part recited Proclamation shall be altered by excepting thereout that portion of the said road hereinbefore mentioned, and that, in lieu thereof, the piece or portion of road particularly described in the Schedule hereto shall be and become a part of

the said road from Kai-iwi to Waingongoro. And I do hereby also proclaim and declare that the piece of road so intended to become part of the said road from Kai-iwi to Waingongoro is delineated on a plan deposited in the Office of the Public Works Department, at Wellington, in the Province of Wellington, and therein coloured red, and which plan is authenticated for the purposes of this Proclamation by the signature of the Honorable Edward Richardson, the Minister for Public Works, and that the said road, as altered, shall be and be deemed to be a road under the provisions of the said Act. And I do hereby further proclaim and declare that the word "Wellington" shall be and be deemed to have been inserted in the last recital to the said in part recited Proclamation instead of the word "Auckland," and as altered by this Proclamation I do hereby confirm the said in part recited Proclamation.

SCHEDULE,

DESCRIPTION OF ROAD ALTERATION—KAI-IWI TO WAINGONGORO.

THE alteration commences at the public road lying to the north of and adjoining Suburban Allotment No. 10, Township of Carlyle (Patea); thence through Sections No. 63 and No. 64, being bounded on both sides by said sections, to a point on the Kakaramea Road about 10 chains south of the dividing line between sections 63 and 64; thence along Kakaramea Road as before.

Consent for Contractor to alter Bridge over the River Ashley.

At the Government House, at Wellington, this twenty-eighth day of May, 1873.

Present:

HIS EXCELLENCY THE OFFICER ADMINISTERING THE GOVERNMENT IN COUNCIL.

WHEREAS a certain contract was made and entered into on the seventeenth day of February, one thousand eight hundred and seventythree, between the Minister for Public Works, in the name and on behalf of Her Majesty the Queen, of the one part, and Edward George Wright, Contractor, of the other part, for the construction in New Zealand, by the said Contractor, of a Bridge over the River Ashley, in the Province of Canterbury: And whereas by the fifth section of the general contitions of the said contract, in pursuance of the provisions and requirements of the twenty-fifth section of "The Immigration and Public Works Act, 1870," it is provided, inter alia, that the Contractor is to make and execute, in manner and with the materials in the said conditions provided and specified, any additions, deviations, or alterations to, from, or in the works which the Engineer for the time being who shall have principal charge of the works on behalf of the Government may from time to time, previously to the commencement or during the progress of the works, by an order in writing, require, at and for such prices or rates as shall be agreed upon in writing between the Contractor and the Minister for Public Works; but no additions, deviations, or alterations whatever which shall be claimed by the Contractor will be admitted or recognized under any circumstances, or will be allowed or paid for, which shall be done or executed without or contrary to any previous order from the Engineer in writing as aforesaid: Provided always that no addition, deviation, or alteration from the plans and specifications to be ordered by the Engineer as aforesaid, shall involve an increased expenditure in connection with the works or any part thereof, unless distinctly authorized by writing under the hand of the Minister for Public Works, who, before authorizing any such deviation, shall obtain from the Engineer an estimate of the increased expenditure arising therefrom: Provided also that in all cases where such deviation, addition, or alteration as last aforesaid from the plans and specifications shall involve an outlay exceeding £500, the consent of the Governor in Council shall first be obtained. And in all cases it shall be the duty of the Contractor to satisfy himself that such addition, deviation, or alteration (if any) has been duly authorized in the manner required by "The Immigration and Public Works Act, 1870;" and also, that to any such outlay as aforesaid, requiring the consent of the Governor in Council as aforesaid, such consent has been obtained as required by the said Act: And whereas at the request of the Provincial Government of Canterbury it has been determined to construct the above-named bridge to carry the broad guage instead of the narrow guage as originally intended, in addition to deviation from or alteration in the works previously determined upon in connection with the said bridge: And whereas the said Minister of Public Works has received from the Engineer aforesaid an estimate of the increased expenditure arising from the said alteration, addition, or deviation aforesaid, and has authorized, by writing under his hand, such addition to, deviation from, or alteration in the said works: an upset price fixed as therein mentioned, which

And whereas such deviation, addition, or alteration as last aforesaid will involve an outlay exceeding five

hundred pounds:

Now therefore, His Excellency the Administrator of the Government, by and with the advice and consent of his Executive Council, and in exercise and pursuance of all powers and authority in this behalf in him vested, doth hereby consent to the said addition, alteration, and deviation, and the said increased expenditure, provided such increased expenditure do not exceed five thousand pounds.

Altering Regulations for the Sale of the Township of Ormond.

Officer Administering the Government. ORDER IN COUNCIL. At the Government House, at Wellington, this eleventh day of June, 1873.

Present:

HIS EXCELLENCY THE OFFICER ADMINISTERING THE GOVERNMENT IN COUNCIL.

WHEREAS by "The New Zealand Settlements Act, 1863," it is provided that after setting apart sufficient land for all persons who shall be entitled thereto under the contracts therein referred to, it shall be lawful for the Governor in Council to cause towns to be surveyed and laid out, and also suburban and rural allotments; and that all such towns, suburban and rural lands shall be sold, occupied, and disposed of for such prices, in such manner, and for such purposes, upon such terms, and subject to such regulations as the Governor in Council shall, from time to time, prescribe for that purpose: And whereas by "The New Zealand Settlements Amendment and Continuance Act, 1865," it is enacted that the order and manner in which land taken under the authority of "The New Zealand Settlements Act, 1863," and "The New Zealand Settlements Amendment and Continuance Act, 1865," should be laid out for sale and sold, should be at the discretion of the Governor, who shall have power to cause such land, or any part thereof, to be laid out for sale and sold from time to time, in such manner, for such consideration, and in such allotments as he shall think fit, and subject to such regulations as he shall, with the advice of the Executive Council, from time to time prescribe:

And whereas by "The New Zealand Settlements Amendment Act, 1866," it is provided that the said lands shall be sold for such consideration, or at such price, and whether for cash or otherwise, as the Governor shall from time to time prescribe; and that all lands taken under the authority of the said "New Zealand Settlements Act, 1863," and "The New Zealand Settlements Amendment, and Continuance Act, 1865," or either of them, and sold or disposed of under the authority of the said first recited Act, shall be sold or disposed of under regulations to be made by the Governor in Council, which regulations shall be published in the New Zealand Gazette: And whereas by Orders in Council issued under the hereinbefore in part recited Acts, dated respectively the eleventh day of May, one thousand eight hundred and seventy-one, and the eight day of March, one thousand eight hundred and seventy-three, the Governor did make certain regulations for the sale and disposal of the lands taken under the said Acts as therein mentioned: And whereas by one of the said regulations it is provided that all town land shall be sold in quarter acre sections, at regulations should be made for the sale of the town

land hereinafter mentioned:

Now therefore, His Excellency the Administrator of the Government, in pursuance and exercise of all the powers and authorities in him for that purpose vested, doth hereby, with the advice and consent of the Executive Council of the said Colony, make the regulations set forth in the Schedule hereto for the purposes of the hereinbefore in part recited Acts.

SCHEDULE.

1. These regulations shall come into operation on their publication in the New Zealand Gazette, and, subject to the terms thereof, shall be read with and as part of the regulations for the sale and disposal of confiscated lands made by the hereinbefore mentioned Orders in Council of the eleventh day of May, one thousand eight hundred and seventy-one, and the eighth day of March, one thousand eight hundred and seventy-three.

2. Notwithstanding anything contained in the said regulations, all town lands in the Township of Ormond, in the District of Poverty Bay, in the Province of Auckland, shall be sold in acre sections (as near as may be), at an upset price of five pounds

per acre.

Election of Councillors for the Borough of Westport.

To all to whom these Presents shall come, GREETING:

WHEREAS by "The Municipal Corporations Act, 1867," it is enacted that for the first election of Councillors under the said Act in every borough in which no Councillors shall as yet have been in office, those persons enrolled on any electoral roll which, under the provisions of "The Registration of Electors Act, 1866," shall for the time being be in force, whose qualifications are in respect of lands and tenements situate within the borough, and none other, shall, on such day as the Governor shall appoint, not being less than forty days after the same shall have become such borough, and in the manner therein mentioned, elect the whole number of Councillors by the said Act assigned to such borough; and by the said Act it is also provided that every election of Councillors for any borough not divided into wards shall be held by and before the Mayor of the borough, and that if at any time there shall be no Mayor, the Council of the borough, or, if there be no such Council, the Governor, may and shall appoint some person by and before whom such election shall be conducted:

And whereas the Town of Westport was, by Proclamation bearing date the sixteenth day of April, one thousand eight hundred and seventy-three, constituted a borough under the said Act:

And whereas it has been made to appear to me that there is no Mayor of the said borough, nor any Council of the said borough, and that the said

borough is not divided into wards:

Now know ye that I, Sir George Alfred Arney, the Officer Administering the Government of New Zealand, in exercise and pursuance of the powers vested in me by the said Act, do hereby appoint the seventh day of July, one thousand eight hundred and seventy-three, to be the day whereon the first election of Councillors for the Borough of Westport shall take place and in further exercise of the powers. shall take place, and in further exercise of the powers and authorities vested in me by the said Act, I do

price shall in no case be less than twenty pounds an hereby appoint Joseph Giles, of Westport, Esquire, acre: And whereas it is expedient that additional to be the person by and before whom the said election shall be held.

University Regulations approved.

THE following Regulations of the New Zealand University, approved by His Excellency the Officer Administering the Government in Council on the 4th June, 1873, are published for general information.

STATUTE AS TO Admission to Degrees New IN THE UNIVERSITY STUDENTS \mathbf{OF} ZEALAND.

That no undergraduates of the University of New Zealand be admitted to the degree of Bachelor of Arts until he shall have kept nine terms, and have

passed the examination required by the University:
Provided, nevertheless, that undergraduates of
the University of New Zealand who shall study at the University of Otago shall be admissible to a B.A. degree in the University of New Zealand after having kept three years' terms in accordance with the Regulations of the University of Otago, and after having passed the examination prescribed by the University of New Zealand as the examination for such degree.

THE REGULATIONS FOR COURSE OF STUDY AND ANNUAL EXAMINATIONS.

1. Every student, upon matriculation, shall obtain the approval of the Chancellor as to the course of instruction to which he will attend during the terms of the University prior to taking his degree, and the Chancellor shall be satisfied that he will obtain adequate instruction in at least three of the following branches of education, viz. :-

(1.) Classics.

(2.) Mathematics and Natural Philosophy.(3.) Modern Languages other than English.

(4.) Physical Science.

(5.) English Language and Literature.(6.) General History.

(7.) Moral Philosophy and Logic.

(8.) Jurisprudence.

2. The following regulation of the Council is hereby repealed:—"That persons who have matriculated shall be required to present themselves annually for examination by the University at Lent Term; and if any absent themselves from such examination, or fail to pass it satisfactorily, they shall, at the discretion of the Council, be required to keep additional terms before proceeding to the B.A. degree," and the following substituted:-

(1.) All students shall be required to pass an examination, in each year, in such subjects and before such Examiners as may from time to time be appointed under a resolution of the Council; and if any absent themselves from such examination, or fail to pass it satisfactorily, they shall, at the discretion of the Council, be required to keep additional terms before proceeding to a B.A. degree.

(2.) Such examination shall be made, so far as possible, to coincide with the annual examination for scholarships, the subjects for which will be given out one year previously.

(3.) This examination shall be open to others than members of the University and those qualified to hold scholarships, and two classes (the first to be arranged in order of merit, and the second alphabetically) shall be formed out of those examined; the first consisting of those who have passed their examination with credit, and the second of those to whom the Examiners have only not refused their certificate of approval.

(4.) Any student who shall have satisfactorily passed the annual examination shall be deemed to have kept the three terms of the

previous year.

REGULATIONS FOR THE GENERAL EXAMINATION FOR THE DEGREE OF BACHELOR OF ARTS.

1. No student can be admitted to the final examination for the ordinary degree of Bachelor of Arts who has not entered upon his ninth term, having previously kept eight terms, or unless he shall have kept three years' terms in the University of Otago.

2. The subjects of this examination shall be—

(1.) Classics: portions of Greek and Latin authors, to be previously determined upon, with critical, historical, and grammatical

questions.

(2.) Mathemtics, Arithmetic, Euclid (four books), Elementary Algebra, definitions and explanations of algebraical signs and terms, addition, subtraction, multiplication, and division of algebraical quantities and algebraical fractions, the elementary rules of ratio and proportion, easy equations of a degree not higher than the second, involving not more than two unknown quantities, and questions producing such equations; and also the proofs of the rules of arithmetical and geometrical progression, with simple examples. Elementary Mechanics, treated so as not necessarily to require a knowledge of Trigonometry—viz., the composition and resolution of forces acting in one plane at a point; the mechanical powers, and the properties of the centre of gravity. And Elementary Hydrostatics—viz., the pressure of non-elastic fluids, specific gravities, the properties of elastic fluids, and the principal instruments and machines whose action depends on the properties of fluids.

(3.) Modern Languages, other than English, French, or German.—A portion of some author previously determined upon.

(4.) English Language and Literature.—A portion of some standard English suffer.

portion of some standard English author, and an English Essay on some subject to be given. (5.) General History.—Some period to be

previously determined upon. (6.) Physical Science.—One or more of the following branches:—(a.) Chemistry; (b.) Geology and Mineralogy; (c.) Botany; (d.) Zoology, including Anatomy and Physiology, as defined in extent by a schedule to be determined upon. The examination to have reference to books on each subject which shall be determined upon by the Council of the

University.
(7.) Moral Philosophy and Logic—viz., Moral and Political Philosophy, Mental Philosophy, Logic, and Political Economy. The examina-tion to have reference to books on each subject, as may be prescribed by the Council of

the University.
(8.) Law and Constitutional History, with reference to books and periods of history to

be determined upon.

3. No person shall be approved by the Examiners unless he show a competent knowledge of three o the above subjects of examination, one of which must be Classics or Mathematics.

4. Every person intending to present himself for final examination shall, at least six months previously, signify to the Chancellor the subjects, not being more than four of the above subjects, in which he shall elect to be examined.

5. The subjects of the final examination shall be determined by the Council, and published by the

Chancellor one year previously.

6. The plan of examination, indicating the days and hours of examination, and the places where the examination shall be held, and the marks which shall be given for each subject, shall be determined by the Chancellor, and by him notified to the Examiners.

7. To conduct the examination there shall be not less than three Examiners, to be appointed by the

Council.

- 8. The names of the students who pass the examination shall be placed in four classes, the names in the first class being arranged in order of merit, and the remainder alphabetically; and those classes shall be published by the Chancellor as soon as is convenient after the receipt by him of the reports of the Examiners.
- 9. The report of each Examiner shall state the number of marks obtained by each person in the several subjects of examination, and no person shall be deemed to have shown competent knowledge in any subject unless he shall have obtained half the prescribed number of marks.

REGULATIONS FOR HONOR EXAMINATIONS.

1. At the conclusion of the B.A. degree examination, additional papers will be given to such of the persons examined as may desire to obtain honors in any of the subjects selected by them for examination, provided that notice shall be given by such persons of their intention at least six months previously.

2. In Classics, the additional paper shall comprise a passage for translation from English into Latin prose, and passages selected from the best Greek and Latin authors for translation into English. Mathematics, the additional paper shall comprise the following subjects of examination, treated with the Differential Calculus, and without the methods of Analytical Geometry:—Euclid: Books I. to VI.; Book XI., props. 1 to 21; Book XII., props. 1, 2.

Arithmetic and the elementary parts of Algebra, namely, the rules for the fundamental operations upon algebraical symbols, with their proofs; the solution of simple and quadratic equations; arithmetical and geometrical progression, permutations and combinations, the binomial theorem, and the

principles of logarithms.

The elementary parts of Plane Trigonometry, so far as to include the solutions of triangles.

The elementary parts of Conic Sections, treated geometrically, but not excluding the method of orthogonal projections; together with the values of the radius of curvature, and of the chords of curvature passing through the focus and centre.

The elementary parts of Statics, namely, composition and resolution of forces acting in one plane at a point, the mechanical powers, and the properties of

the centre of gravity.

The elementary parts of Dynamics, namely, the octrine of uniform and uniformly accelerated motion, of falling bodies, projectiles, collision, and cycloidal oscillations.

The first, second, and third sections of Newton's "Principia;" the propositions to be proved in

Newton's manner.

The elementary parts of Hydrostatics, namely, the pressure of non-elastic fluids, specific gravities, floating bodies, the pressure of the air, and the construction and use of the more simple instruments and machines.

The elementary parts of Optics, namely, the laws of reflection and refraction of rays at plane and spherical surfaces, not including aberrations; the eye; telescopes.

The elementary parts of Astronomy, so far as they are necessary for the explanation of the more simple phenomena, without calculation.

In Modern Languages, and English Language and Literature, the additional papers shall not be confined to any particular author.

In History, the additional paper shall be of a general character, and shall not refer to any period

previously specified.

In the remaining subjects, the questions shall not be so much of a special kind, having reference to books on the several subjects, as of a general character, having reference to the subjects themselves.

No Students shall be required to present themselves for this additional examination, but the names of those who have passed the additional examination with credit shall be arranged in an Honor Class in order of merit, and the special subjects in which distinction has been obtained shall be indicated in each case.

REGULATIONS FOR THE APPROPRIATION OF FUNDS FOR SCHOLARSHIPS AND OTHER PURPOSES.

1. The following Regulations are hereby repealed :-

- "That one thousand pounds (£1,000) be appropriated for the establishment of twenty (20) Scholarships, to be awarded for proficiency in one or more of the following subjects:

 - "1. Classics.
 "2. Mathematics. "3. Physical Science.

"4. Modern Languages, other than English History and English Literature.

"That there shall be one Scholarship in each of the above-mentioned branches of study of the value of seventy pounds (£70) and that the remainder be of the value of forty-five pounds (£45), and that the tenure of each Scholarship be for the term of the University course. "That the balance of the three thousand pounds

(£3,000) be appropriated to the payment of

the incidental expenses of the Council. That these Regulations come into force on the 13th day of October, 1872;"

and the following are substituted in lieu thereof:-

- 2. The sum of one thousand pounds (£1,000) out of the funds of the University is hereby appropriated for the establishment from time to time, and as hereinafter provided, of fifty Scholarships of twenty pounds (£20) each for proficiency in any one of the following subjects:1. Classics.

 - 2. Mathematics.
 - 3. Physical Science.
 - 4. Modern Languages, other than English; also History and English Literature.

Of these fifty Scholarships,

Thirteen (13) shall be allotted to Classics; Thirteen (13) shall be allotted to Mathematics; Twelve (12) shall be allotted to Physical Science

Twelve (12) shall be allotted to Modern Languages other than English and English Literature,

if there be that number of candidates who shall have

obtained the requisite number of marks.
Scholarships in the several subjects may be held

conjointly

No candidate shall be eligible for a Scholarship to whom less than half marks shall have been assigned.

Nothing herein contained shall affect the tenure of Scholarships gained at the Scholarship Examination to commence on the 26th May, 1873. But such Scholarships shall continue to be held according to the conditions under which they were gained; but all sums at the disposal of the Council for Scholarship purposes, other than those required for the fulfilment of such conditions with the scholars of 1873, shall be from time to time applied to the maintenance of the Scholarships established by this Regulation until the whole number of fifty be complete.

Until the full sum of one thousand pounds (£1,000) shall be available, all lesser sums available shall be distributed as nearly as may be in the proportion prescribed for Scholarships in the four

subjects above specified.

A Scholarship shall become vacant by neglect on the part of the holder to attend any one of the Annual University Examinations, or through failure to pass such examination satisfactorily, unless the holder shall produce to the satisfaction of the Chancellor that he was unable from illness to attend.

3. The sums appropriated to Scholarships shall be

paid to a separate fund.

4. All savings arising from vacancies or other causes in any year shall be available to increase the number of Scholarships payable in ensuing years. The number of Scholarships to be competed for in each year shall from time to time be determined by the Council. The tenure of such Scholarships shall be for the term of the University course.

5. The balance of the University funds is hereby appropriated for expenditure in affiliated institutions, and for general purposes of the University, in accordance with provisions of "The New Zealand

University Act, 1870?"
