Proclamation reconstituting the District Court of Auckland.

(L.S.) JAMES FERGUSSON, Governor.

A PROCLAMATION.

WHEREAS by "The District Courts Act, 1858," it is enacted that there shall be within the Colony of New Zealand, Courts of Record possessing Civil and Criminal jurisdiction, to be called District Courts, and the Governor is empowered from time to time, as he shall think fit, by Proclamation in the *New Zealand Gazette*, to constitute throughout the Colony, or in any part thereof, districts within which such Courts shall be respectively held, and such districts to abolish, and the boundaries thereof to define or alter, and also to declare by what local name such Courts shall be designated:

And whereas, by a Proclamation bearing date the twenty-second day of May, one thousand eight hundred and sixty-six, and published in the *New Zealand Gazette* on the twenty-third day of May, one thousand eight hundred and sixty-six, Sir George Grey, the then Governor of the said Colony, did, in pursuance and exercise of the aforesaid power and authority, constitute and proclaim the district of the Colony therein described to be a district within which a District Court designated

"THE DISTRICT COURT OF AUCKLAND" should be held under the said Act, and under "The District Courts Act Amendment Act, 1865:"

And whereas it is expedient that the boundaries of the said district should be altered:

Now therefore, I, Sir James Fergusson, Baronet, the Governor of the Colony of New Zealand, in pursuance and exercise of the aforesaid power and authority, do hereby proclaim and declare that from and after the first day of December, one thousand eight hundred and seventy-three, the boundaries of the said district shall be altered, and that thenceforth the boundaries thereof shall be as hereinafter described, and that the designation of the said Court shall be

"THE DISTRICT COURT OF AUCKLAND."

Description of District:

All that portion of the Province of Auckland. Bounded—towards the North and East by the sea

from Cape Maria Van Diemen to Ngakuri-a-whare Point; thence towards the South-east and North-east by the Tauranga Block (confiscated land) to its most southern corner; thence again towards the South-east by a right line to the most northern corner of the Province of Taranaki, and by the Mokau River to its mouth; and towards the West and South-west by the sea to the commencing point.

Given under the hand of His Excellency the Right Honorable Sir James Fergusson, Baronet, a Member of Her Majesty's Most Honorable Privy Council, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, at Christchurch; and issued under the Seal of the said Colony this seventeenth day of November, in the year of our Lord one thousand eight hundred and seventy-three.

Providing for Election of Superintendent and Provincial Council of the Province of Westland.

(L.S.) JAMES FERGUSSON, Governor.

A PROCLAMATION.

WHEREAS by "The Province of Westland Act, 1873," it is enacted that the Provincial Council of the Province of Westland shall in the first instance consist of such number of Members, over and above the Superintendent of the said Province, as the Governor shall by Proclamation direct and appoint, not being less in number than fifteen: And it is also enacted that the Governor by Proclamation may constitute within such Province convenient Electoral Districts for the election of Members of the Provincial Council, and may appoint and declare the number of Members to be elected for every such District for such Provincial Council, and to make provision for the formation of the first Electoral Rolls for the election of the Superintendent of such Province, and the election of the Members of the Provincial Council thereof:

Now therefore, I, Sir James Fergusson, Baronet, the Governor of the Colony of New Zealand, in

pursuance and exercise of the power and authority vested in me by the said Act, do hereby proclaim, direct, appoint, constitute, and provide as follows:—

1. The Provincial Council of the Province of Westland shall consist of fifteen Members, over and above the Superintendent of such Province.

2. The said Province shall be and the same is hereby divided into seven Electoral Districts,—that is to say, Hokitika, Greymouth, Paroa, Arahura, Kanieri, Totara, and Okarito—the boundaries of which said Districts are described and set forth in the Schedule to this Proclamation, and are delineated on the map or plan thereof deposited in the office at Wellington of the Colonial Secretary, and which map or plan is signed by Gerhard Mueller, Esquire, Chief Surveyor, appointed under “The Westland Waste Lands Act, 1870.”

3. The number of Members to be elected to serve in the Provincial Council for the said several Electoral Districts shall be as follows, viz.:—

For the Electoral District of Hokitika,	3 Members.
For the Electoral District of Greymouth,	3 ditto.
For the Electoral District of Paroa,	2 ditto.
For the Electoral District of Arahura,	2 ditto.
For the Electoral District of Kanieri,	2 ditto.
For the Electoral District of Totara,	2 ditto.
For the Electoral District of Okarito,	1 ditto.

4. The first Electoral Rolls for the election of Members of the said Provincial Council shall be prepared by

GERARD GEORGE FITZGERALD, Esq., R.M.,

who, within fifteen days from the date hereof, shall form such Rolls by placing the name of every person who is at this present time registered as an elector entitled to vote in the election of Members of the House of Representatives on account of any tenements or hereditaments comprised within the limits of the said Province, on the Electoral Roll of that one of the said districts within which the tenements and hereditaments in respect whereof he is so registered are situated.

5. The Rolls so to be formed as aforesaid may be partly written and partly printed, or wholly written or wholly printed, as may be most convenient, and shall, within twenty-two days from the date hereof, be severally published by the said Gerard George FitzGerald, by affixing the same to the outer door of the Resident Magistrate's Court in the respective districts to which such Rolls shall relate, or in some other public and conspicuous place within the said districts.

6. Every such Roll so affixed as aforesaid shall be signed by the said Gerard George FitzGerald, and from and after the day of such publication the said several Rolls shall be the Electoral Rolls to be used respectively for the said districts for the election of Members of the said Provincial Council until new Electoral Rolls shall be made for the same under the provisions of the law in force for the time being for the registration of electors.

7. The first Electoral Roll for the election of the Superintendent of the said Province shall be prepared by the said Gerard George FitzGerald, who, within fifteen days from the date hereof, shall form the same by placing thereon the name of every person who is at this present time registered as an elector entitled to vote in the election of Members of the House of Representatives on account of any tenements or hereditaments comprised within the limits of the said Province, so as that the whole of such names shall appear on one Roll to be formed under the authority hereof.

8. The provisions contained in the fifth and sixth clauses hereof shall be applicable to the formation of the said Roll for the election of the said Superin-

tendent, except that it shall only be necessary to publish the same by affixing copies thereof, signed by the said Gerard George FitzGerald, on the outer doors of the Resident Magistrates' Courts at Hokitika and Greymouth respectively.

From and after the day of such publication the said Roll shall be the Electoral Roll to be used for the election of the Superintendent of the said Province until a new Electoral Roll shall be made for the same in accordance with law.

SCHEDULE.

ELECTORAL DISTRICT OF HOKITIKA.

COMPRISING the Town of Hokitika, being all that parcel of land containing six hundred and forty acres, more or less, situate on the Hokitika River, commencing at a point on the high bank of the old bed of the aforesaid river, the said point being forty chains forty links west of Trigonometrical Station No. 31; thence following a line bearing north twenty degrees fourteen minutes east (magnetic) a distance of sixty-two chains sixty-five links; thence westerly at a right angle a distance of eighty-five chains forty links to the sea beach, following the said beach southerly to the mouth of the Hokitika River; and from thence returning along the northern bank thereof and the high bank of the old river bed above mentioned to the commencing point; and also all that parcel of land containing six hundred and forty acres, more or less, situate on the Hokitika River. Bounded—on the Northward by Reserve No. 271 (in red); on the Westward by the sea; on the East by Section No. 8238 and a line in continuation of the western boundary thereof; and on the Southward by a line at right angles to the last-described boundary, and about one hundred and thirty chains distant on the average from the reserve above mentioned.

ELECTORAL DISTRICT OF GREYMOUTH.

Comprising the Town of Greymouth, being all that parcel of land commencing at the South Spit at the mouth of the River Grey. Bounded on the West by a line of one hundred and sixty chains and eighty links, extending along the beach from the South Spit aforesaid; thence along the South Town Belt, one hundred and fifteen chains and fifty links; thence along the East Town Belt, one hundred and twenty chains and ninety links; thence along the Native Reserve No. 31, for a distance of forty-one chains and thirty links, to the River Grey; and thence along the River Grey to the sea.

ELECTORAL DISTRICT OF PAROA.

Commencing at a point on the sea coast one hundred and sixty chains and eighty links to the southward of the South Spit at the mouth of the River Grey; thence easterly along the southern boundary of the Greymouth District hereinbefore defined, one hundred and fifteen chains and fifty links; thence northerly along the eastern boundary of the last-named district

to the River Grey; thence easterly along that river to the junction with it of the Arnold River; thence up the Arnold River to Lake Brunner, and along the boundary of the Province of Nelson to the source of the Teremakau; thence following down the northern bank of the Teremakau to the coast, and along the coast to the commencing point.

ELECTORAL DISTRICT OF ARAHURA.

Commencing at the mouth of the Teremakau up that river to its source, thence southerly along the dividing range to the source of the Arahura River; thence following down the southern bank of that river to the sea coast, and northwards along the coast to the commencing point.

ELECTORAL DISTRICT OF KANIERI.

Commencing at the mouth of the Arahura River up the southern bank of that river to its source; thence southerly along the dividing range to the source of the Kokatahi; thence down the southern bank of that river to its junction with the Hokitika River; thence southerly up the western bank of Hokitika River to line HO; thence westerly down line HO to Mahinapua Lake and by a line touching the northern bank of the said lake to the sea coast, and northerly along the coast to the commencing point, excepting the Town of Hokitika.

ELECTORAL DISTRICT OF TOTARA.

Commencing at the source of the Kokatahi River; thence down the southern bank of that river to its junction with the Hokitika River; thence southerly up the western bank of Hokitika River to line HO; thence westerly down line HO to Mahinapua Lake, and by a line touching the northern bank of the said lake to the sea coast; thence southerly along the coast to the Wanganui River; thence up the said river to its source, and northerly along the dividing range to the commencing point.

ELECTORAL DISTRICT OF OKARITO.

Commencing at the mouth of the Wanganui River; thence up the said river to its source; thence along the dividing range to the boundary of the Province of Otago, following the said boundary to the coast, and northerly along the coast to the commencing point.

Warrant fixing Intervals of Sittings at Auckland of District Court of Auckland.

WHEREAS by "The District Courts Act, 1858," it is made lawful for the Governor, from time to time, by notification in the *New Zealand Gazette*, to fix the times and places within the district at which every District Court shall be held:

And whereas by "The District Courts Act Amendment Act, 1865," it is enacted, that as to the times of holding such Courts, it shall be sufficient for the Governor, if he shall so think fit, to fix the interval only within which such Courts shall be held at each place, and it shall in such case be lawful for the Judge of such Court to fix the particular times and days for the holding of such Courts, and from time to time to alter the same, provided that such time and day shall fall within the interval so fixed by the Governor:

Now therefore, I, Sir James Fergusson, Baronet, the Governor of the Colony of New Zealand, do hereby, in pursuance and exercise of the said power and authority, fix that Sessions of the District Court of Auckland shall be held at Auckland, in the Province of Auckland, at intervals of not less than thirteen days nor more than twenty-one days between the first day of each sittings of such Court.

2. Horses or light-wheeled vehicles will not be allowed to enter upon the bridge within fifteen minutes, drays within thirty minutes, and cattle and sheep or pigs within one hour, of the advertised time of arrival and departure of any train from the Rakaia Railway Station.

3. Horsemen or wheeled vehicles will not be allowed to travel at a greater rate than six miles an hour across the bridge.

4. Traction engines, or engines employed in agriculture, flax-dressing, or any other purpose, will not be permitted on the bridge otherwise than on the goods waggons in use on the Provincial Government Railways.

5. No greater weight than two tons gross on any one pair of wheels with tires less than five inches wide will be permitted to cross the bridge.

6. In the event of a special train, the Provincial Government shall have the power to put in force the same restrictions as described in clause 2 for advertised trains.

7. Any damage done to any part of the bridge by the contravention of any of the foregoing rules may be recovered by a summary process; and any person or persons entering upon the bridge within the prohibited hours, or resisting the gatekeepers in the execution of their duties, will be subject to a penalty hereinafter mentioned.

8. Any person in a state of intoxication will not be permitted to enter upon the bridge whilst in such condition.

9. Any person offending against any of these regulations will be liable to a penalty not exceeding ten pounds.
