A PROCLAMATION.

WHEREAS by "The Licensing Act, 1873," it is, amongst other things, enacted that the Governor shall, as soon as conveniently may be after the passing of the said Act, by Proclamation in the *Government Gazette*, define such territorial divisions as he may think proper to be Licensing Districts for the purposes of the said Act, and from time to time may alter and re-define the boundaries of the same: And whereas it is also further enacted by the said Act, that in the Proclamation declaring the said several districts the Governor shall in each case declare the number of persons of whom the Licensing Court of such district shall consist, such number not being more than seven nor less than three:

Now therefore, I, Sir James Fergusson, Baronet, the Governor of the Colony of New Zealand, in pursuance of the provisions of the hereinbefore cited Act, do hereby proclaim, constitute, and appoint that the several territorial divisions, the boundaries whereof are defined and set forth in the Schedule hereto, shall be Licensing Districts for the purposes of the said Act; also that each such district shall be known by the name by which it is designated in the said Schedule: And I do hereby further proclaim and declare that the Licensing Court of each one of the districts hereby proclaimed, constituted, and appointed, shall consist of four Commissioners, inclusive of the Resident Magistrate, who shall at any time hereinafter be appointed by me, the Governor aforesaid, to carry into effect the provisions of the said Act within such district.

Given under the hand of His Excellency the Right Honorable Sir James Fergusson, Baronet, a Member of Her Majesty's

Most Honorable Privy Council, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at Wellington, this twenty-third day of February, in the year of our Lord, one thousand eight hundred and seventy-four.

SCHEDULE.*

PROVINCE OF AUCKLAND.

1. MONGONUI DISTRICT.

Bounded towards the North and North-east by high watermark of the sea and Whangaroa Harbour from Cape Maria Van Diemen to the mouth of the Iwitaua Creek; towards the South-east by the Iwitaua Creek aforesaid, part of the eastern and southern boundaries of the Parish of Kohumaru, the Koho Wainui River, the south-eastern and part of the south-western boundaries of the Maungataniwha Block to the westernmost angle of the said block, and thence in a straight line bearing westerly to the sea at the North Head of Herekino Harbour; and towards the West by high watermark of the sea from the North Head of Herekino Harbour aforesaid to Cape Maria Van Diemen, the place of commencement.

2. HOKIANGA DISTRICT.

Bounded towards the North by the Mongonui District from the sea at the North Head of the Herekino Harbour to the south-westernmost angle of the Maungataniwha Block; towards the East by a

straight line from the said angle to the summit of a hill at Okaihau, called "Te Pare o Kawa;" thence in a straight line to the south-western point of Omaper Lake; thence by a straight line to the summit of the north-eastern peak of the Tutumoe Range, and continuing along that range to Mongonui Bluff; towards the South-west by high watermark of the sea from Mongonui Bluff aforesaid to the North Head of Herekino Harbour.

3. BAY OF ISLANDS DISTRICT.

Bounded towards the North and North-west by the Mongonui District from the mouth of the Iwitaia Creek to the south-westernmost angle of the Maungataniwha Block; towards the West by the Hokianga District; towards the South by a straight line from the most eastern peak of the Tutumoe Range to the confluence of the Wairua and Mangaharuru Rivers; thence by a straight line to the North Head of Tutukaka Harbour; and towards the East and North-east by high watermark of the sea and Whangarei Harbour from the North Head of the Tutukaka Harbour to the mouth of the Iwitaia Creek aforesaid; including the Cavalli, Moturoa, and adjacent Islands, and also including the Orohia and adjacent Islands in the Bay of Islands.

4. WHANGAREI HEADS DISTRICT.

Bounded towards the East and South by the sea from the head of Rocky Bay to the south-eastern boundary of the Parish of Tamaterau; thence towards the North-west and West by the south-eastern and eastern boundaries of the said Parish of Tamaterau to its most north-eastern angle; thence by a straight line to the most eastern angle of the Parish of Paraheke, and thence by a straight line due north till it meets a straight line drawn from Kohatu Point to the head of Rocky Bay; and thence towards the North by part of the said line to the commencing point.

5. WHANGAREI DISTRICT.

Bounded towards the East and South-east by the western and north-western boundaries of the Whangarei Heads District hereinbefore defined, from the north-western angle of the said Whangarei Heads District to the Whangarei Harbour, and thence by the waters of the said Whangarei Harbour to the southern boundary of the Parish of Maungatapere; thence towards the South by the southern boundary of the said Parish of Maungatapere, and a straight line in continuation thereof to the Wairua River; thence towards the North-west by the said Wairua River to the north-eastern boundary of the Parish of Hikurangi; thence towards the North-east by the north-eastern boundary of the said Parish of Hikurangi; and thence towards the North by part of a line drawn from Kohatu Point to the head of Rocky Bay, to the commencing point.

6. MANGAPAI DISTRICT.

Bounded towards the North and East by the Whangarei District hereinbefore defined from the Wairua River to the Whangarei Harbour, and by the waters of the said Whangarei Harbour and the sea to the north head of Ruakaka River; thence towards the South-east by a line to the south-eastern angle of the Parish of Mangapai, and thence by the south-eastern boundary of the said Parish of Mangapai to the north-eastern boundary of the Parish of Ruarangi; thence towards the North-east by part of the north-eastern boundary of the said Parish of Ruarangi; thence towards the South-west by the south-western boundaries of the Parishes of Ruarangi and Maungakaramea to the Waionepe River, and thence by a straight line to the junction of the

Wairua and the Mangakahia Creek; and thence towards the North-west by the said Wairua River to the commencing point.

7. WAIPU DISTRICT.

Bounded towards the North-east, South-west, and North-west by the Mangapai District hereinbefore defined, from the Tauraroa River to the north head of the Ruakaka River; thence towards the East by the sea to the south-eastern angle of the Parish of Waipu; thence towards the South by the southern boundaries of the Parishes of Waipu and Maretutu to the south-western boundary of the last-mentioned parish; thence towards the South-west by the south-western boundary of the said Parish of Maretutu, and by the Mongonui River to its junction with the Tauraroa River; and thence towards the North-west by the said Tauraroa River to the commencing point.

8. MATAKOHE DISTRICT.

Being all that territory in the Province of Auckland comprising the Parishes of Matakohē, Papanoa, Wairoa, and Whakapirau, and the Native land called Hukatere.

9. MANGAWAI DISTRICT.

Bounded towards the North-east by the sea from Bream Tail to the eastern angle of the Parish of Arai; thence following the south-eastern boundary of the said parish to its junction with the Parish of Oruawharo; thence by Allotments Nos. 104 and 103 of the Parish of Oruawharo aforesaid, and Te Hana River; thence towards the South-west by the Oruawharo and Tupuni Rivers; thence following the south-eastern and south-western boundaries of the Parish of Kaiwaka and the Kaiwaka River; towards the West by the Parish of Wairau; and towards the North-west by the Parish of Waipu, and a straight line produced to Bream Tail.

10. PORT ALBERT DISTRICT.

Bounded towards the North-east by the Kaiwaka River, the Parish of Kaiwaka, the Topuni, Oruawharo, and Te Hana Rivers, and thence following the northern boundaries of Allotments Nos. 103 and 104 of the Parish of Oruawharo to the southern angle of the Parish of Arai, and thence by the Parish of Arai aforesaid; towards the East and South-east by the Hotea River; towards the South by the Kaipara River; and towards the West by the entrance to the Wairoa and Otamatea River.

11. MAHURANGI DISTRICT.

Bounded towards the North-east and East by the sea from the south-eastern angle of the Parish of Arai to the Weiti River; towards the South by the Parishes of Okura and Pukeatua, and the Kaukapakapa River; towards the South-west by the Kaipara River; towards the North-west and West by the Hotea River and Parish of Arai. Including also the Island of Kawau, Motukeka, Motureka, Orawaike, Motuhora, and Tiritirimatangi.

12. TOKATOKA DISTRICT.

Bounded on the North by the Hokianga District, from Mongonui Bluff to the summit of the most eastern peak of the Tutamoi Range; thence on the North-west by the Bay of Islands District; towards the East by the Whangarei, Mangapai, Waipu, Matakohē and the Wairoa River; towards the South by the entrance to Kaipara Harbour; and towards the South-west by the sea, from the entrance of Kaipara Harbour to Mongonui Bluff.

13. KAIPARA DISTRICT.

Bounded on the North by the Kaipara Harbour and the Parish of Kaukapakapa; on the East by a

straight line from the south-eastern angle of the said parish to the source of the Rangitopuni River; thence following that river to its mouth; on the South by the Parishes of Waiparera and Waitakerei; and on the South-west by the sea.

14. TAKAPUNA DISTRICT.

Bounded on the North by the Mahurangi District; on the North-east by the sea; on the South and South-west by the Waitemata Harbour to the mouth of the Rangitopuni Creek; on the West by the Kaipara District.

15. WAITAKEREI DISTRICT.

Bounded towards the North by the southern boundary of the Kaipara District, previously described; towards the North-east by high watermark of Auckland Harbour to the Whau Portage Road, and by said road to the Manukau Harbour; towards the South-east by high watermark of the Manukau Harbour aforesaid from the Whau Portage Road before-mentioned to the North Head of said harbour; and towards the West by high watermark of the sea from the North Head of the Manukau Harbour aforesaid to the Muriwai Creek, including Wood's Island.

16. NEWTON DISTRICT.

Bounded towards the North and North-west by high watermark of Auckland Harbour from the Meola Stream to the seaward termination of Franklin Street; thence by the centre of Franklin Street aforesaid to its junction with the Ponsonby Road, and by said road to the Karangahape Road; thence by Karangahape Road aforesaid to its junction with Symonds Street; towards the East by Symonds Street and the Cemetery Road to the Cabbage Tree Swamp Road; towards the South-east and South by the Cabbage Tree Swamp Road aforesaid and the Old North Road to the Meola Stream; and towards the South-west by said stream to Auckland Harbour, the place of commencement.

17. CITY OF AUCKLAND—WEST DISTRICT.

Bounded towards the North by Auckland Harbour; towards the North-east by the centre of Wellesley Street; towards the East by the centre of Queen Street; towards the South-east by the centre of the Karangahape Road; towards the South and South-west by the centre of Ponsonby Road; and towards the North-west by the centre of Franklin Street to Auckland Harbour, the place of commencement.

18. CITY OF AUCKLAND—NORTH DISTRICT.

Bounded towards the North by Auckland Harbour; towards the East by the centre of Queen Street; towards the South by the centre of Wellesley Street to Auckland Harbour.

19. CITY OF AUCKLAND—EAST DISTRICT.

Bounded on the North by Auckland Harbour; on the West by the centre of Queen Street; on the South by the centre of Karangahape Road; and on the South-east by the centre of Symonds Street to the southern boundary of City Section 34; thence along that boundary to the centre of Grafton Road; thence northerly by the centre of said road to the centre of Stanley Street; thence by the centre of Stanley Street aforesaid to the southern boundary of City Section 11; thence by the southern and eastern boundaries of Section 11 to the Mill Stream in Mechanics' Bay, and by that stream to the sea.

20. PARNELL DISTRICT.

Bounded on the North by Auckland Harbour; on the West and North-west by the City of Auckland East District, hereinbefore defined, from the Mill

Stream to Cemetery Road; and thence by the centre of Cemetery Road to Scoria Quarry Road; on the South by Scoria Quarry Road, Kyber Pass Road, and the Epsom and Tamaki Road; and on the East by the eastern boundary of Suburban Section 14 from Tamaki Road to Remuera Creek, and thence by that creek to the sea.

21. EDEN DISTRICT.

Bounded towards the North-east by the centre of the Great South Road from the southern boundary of the Parnell District before described to the centre of the Otahuhu Portage Road; towards the South by the centre of the said Portage Road to the Manukau Harbour, and by high watermark of said harbour to the Whau Portage Road; towards the South-west by the Whau Portage Road aforesaid to the Whau Creek, and by said creek to the Waitemata Harbour; and towards the North-west by high watermark of Waitemata aforesaid to the Meola Stream; thence continuing along the Meola Stream aforesaid to the old Great North Road; and thence by the southern boundaries of the Districts of Newton, City of Auckland West, City of Auckland East, and Parnell, already described, to the centre of the Great South Road first mentioned, the place of commencement, exclusive of the Town of Onehunga District, herein next defined.

22. TOWN OF ONEHUNGA DISTRICT.

Bounded on the North by Mount Smart Road; on the East by Section 17 of the Suburbs of Auckland; on the South by Manukau Harbour; and on the West by Section 13 of the Suburbs of Auckland.

23. TAMAKI DISTRICT.

Bounded towards the North by high watermark of the sea from the eastern boundary of the Parnell District already defined to the western head of the Tamaki River; towards the East by the waters of the Tamaki River aforesaid to the Otahuhu Portage Road; towards the South-east by said Portage Road to the Great South Road; and towards the South-west by the centre of the Great South Road aforesaid and part of the southern and eastern boundaries of the Parnell District, previously described, to high watermark of the sea, the place of commencement.

24. PAKURANGA DISTRICT.

Bounded towards the North by high watermark of the sea from the eastern head of the Tamaki River to the seaward termination of the line which forms the northern boundary of the Parish of Wairoa at the mouth of the Wairoa River; towards the South-east by the northern and western boundaries of the Parish of Wairoa aforesaid, part of the north-western boundary of the Parish of Papakura, and the whole of the south-eastern boundary of the Parish of Manurewa to the Manukau Harbour; and towards the South and South-west by high watermark of the Manukau Harbour aforesaid to the Otahuhu Portage Road; thence by the Otahuhu Portage Road aforesaid and the waters of the Tamaki River to its eastern head, the place of commencement; including the Islands of Waiheke, Ponui, Taylor's Island, and Pukututu.

25. PAKAPURA DISTRICT.

Bounded towards the North and North-east by high watermark of the sea from the seaward termination of the northern boundary of the Parish of Wairoa to Pukorokoro; towards the South-east by the road leading from Pukorokoro aforesaid to the Great South Road; towards the South-west by the Great South Road aforesaid from its junction with the Pukorokoro Road before mentioned to the south-eastern boundary of the Town-

ship of Papakura; thence following the south-eastern boundary of that township to the waters of the Manukau Harbour, and by high watermark of the Manukau Harbour to the south-eastern boundary of the Pakuranga District previously described; and towards the North-west by the south-eastern boundary of the Pakuranga District aforesaid, from the Manukau Harbour to the mouth of the Wairoa River at the northern boundary of the Parish of Wairoa, the place of commencement.

26. RAMARAMA DISTRICT.

Bounded towards the North-east by part of the south-western boundary of the Papakura District previously described, from the south-eastern boundary of the Township of Papakura to the Maungatawhiri River, and by that river to its confluence with the Waikato River; towards the South-east by the Waikato River aforesaid to the line of tramway known as the Mauku and Waikato tramway; towards the South-west by the Mauku and Waikato line of tramway aforesaid from the Waikato River before named to the waters of the Manukau Harbour; and towards the North-west by the waters of the Manukau Harbour aforesaid from the Mauku and Waikato line of tramway to the south-eastern boundary of the Township of Papakura to the place of commencement.

27. WAIUKU DISTRICT.

Bounded towards the North and North-east by high watermark of the Manukau entrance and the waters of the Manukau Harbour to the Mauku and Waikato line of tramway, and by said line of tramway to the Waikato River; towards the South-east by the Waikato River aforesaid from the Mauku and Waikato line of tramway to the sea; and towards the South-west by high watermark of the sea to the Manukau entrance, the place of commencement; including all islands in the Waikato River.

28. RAGLAN DISTRICT.

Bounded towards the North by the left bank of the Waikato; towards the East by a line running from the south-eastern angle of Camerontown to the summit of and along the watershed between the Rivers Waikato and Waipa to Pirongia; towards the South by a straight line from Pirongia aforesaid to the most easterly source of the Mokomoko River, and by that river to the waters of Aotea Harbour; hence along high watermark of the harbour to the south head of Aotea Harbour; and towards the West by the sea from the said south head by high watermark of the sea to the south head at Waikato Heads.

29. KAWHIA DISTRICT.

Bounded on the North by the Raglan District; on the East from Pirongia by the summit of the watershed between the Waipa River and the West Coast, and by a line bearing South 22° East to the most northerly point of the Province of Taranaki; thence towards the south-west and south by the boundary of the said Province to the mouth of the River Mokau; and towards the West by high watermark of the sea from the mouth of the said River Mokau to the south head of Aotea Harbour.

30. MANGAPIKO DISTRICT.

Bounded towards the North by the centre of the road which forms the south-eastern boundaries of Allotments Nos. 18, 19, 20, 20A, 21, 22, 23, 24, 25, and 26 of the Parish of Tuhikaramea, and by the centre of the road which forms the south-western boundaries of Allotments Nos. 45, 46, 47, 48, 51, 52, 53, and 55 of the parish last named; towards the East by the centre of the road which form the eastern boundaries of Allotments Nos. 140, 142, 146A, and

part of the eastern boundary of 147, all of the Parish of Tuhikaramea aforesaid, to the north-western angle of Allotment No. 214; thence by the centre of the road forming the northern boundary of allotment No. 214, the eastern boundary of said lot, and the eastern boundaries of Allotments Nos. 213, 212, 211, and 210 to the northern boundary of allotment No. 314, all of the Parish of Tuhikaramea aforesaid; again towards the North by the northern boundary of Allotment No. 314 aforesaid, and by said northern boundary produced easterly in a straight line to the parish boundary of Te Rapa; again towards the East by part of the western boundary of the Parish of Te Rapa aforesaid, to the north-western angle of Allotment No. 352 of the Parish of Ngaroto; thence by the line which forms the western boundary of Allotment No. 352 aforesaid, and the western boundary of Allotments Nos. 334, 335, 336, 337, 338, 339, 340, 341, 342, 343, 344, 345, 346, 347, 348, 349, 350, and 351 of the said parish to the north-eastern angle of Allotment No. 135 of the parish aforesaid; thence by the centre of the road which forms the south-western boundary of Allotments Nos. 300, 299, and 298, and part of the south-western boundary of Allotment No. 297 continuing the south-western boundary of said Lot 297 to the margin of Lake Ngaroto; thence traversing the north-eastern margin of the said lake to the south-western angle of Allotment No. 54 of the Parish of Mangapiko; thence by the southern boundary of said Allotment No. 54, and the southern boundaries of Allotments Nos. 53 and 52 to the south-eastern angle of Allotment No. 52 aforesaid; thence by part of the western boundary of Allotments Nos. 51 and 50, and part of the northern boundary of Lot No. 50 aforesaid, and the northern boundary of Lot 55; thence by the western, south-western and southern boundaries of said Lot No. 55, and by part of the western boundary of Allotment No. 49, and the western boundary of Allotment No. 48, the northern, western and southern boundaries of Lot No. 47, the southern boundary of Lot No. 46, part of the western boundary of Lot No. 45, part of the northern boundary of lot No. 40, and the eastern boundary of said lot No. 40, to the south-western angle of Lot No. 43; thence by the centre of the road which forms part of the northern boundary of Lot No. 56, the western boundary of Lot No. 56 aforesaid, and the western boundaries of Lots Nos. 58, 59, 61, and part of the southern boundary of Allotment No. 62, to the eastern boundary of Allotment No. 68, all of the said Parish of Mangapiko; thence by eastern boundary of said Lot No. 68, to the Mangapiko River, and by said river to the centre of the road which forms the western boundary of Allotment No. 321; thence by said road and by the south-western boundaries of Allotments Nos. 236 and 234 to the road which forms the north-western boundary of Allotment No. 144, and by the centre of the said road to the south-western angle of allotment No. 145, all of the said parish; thence by the line which forms part of the northern boundary of Allotment No. 322 of the parish aforesaid to the Ruapaha Creek; thence by the Ruapaha Creek to its confluence with the Punui River; towards the South by the Punui River aforesaid to its confluence with the Waipa River; and towards the West by the Waipa River aforesaid, to the road which forms the south-eastern boundary of Allotment No. 18 before mentioned, the place of commencement.

31. RANGIAOHIA DISTRICT.

Bounded on the North by the centre of a road commencing at the north-west angle of Lot 148, in the Parish of Ngioto, and along the centre of the road to its junction with the Hamilton and Ohaupo road; thence in a straight line to the north angle of Lot 137, in the said parish; thence bounded on the

East by a straight line to the south-east angle of Lot 135, in the same parish; bounded again on the North by the northern boundary of Lot 69, in the Parish of Penui, of a temporary reserve, and of Lots 108 and 107 in the same parish; thence on the East by a straight line to that part of the eastern boundary of Lot 105 where it is intersected by a straight line from the north-eastern angle of Lot 170; and again bounded on the North-east by the said straight line to the centre of the road fronting said Lot 170, in the said parish; thence by and including the road which forms the boundary of the confiscated territory until its junction with the road fronting Lot 161 in the said parish; thence by lines forming the boundary of the confiscated territory to its junction with the Penui River; on the South-west by the said Penui River; on the West by a stream running into the said river, and forming the western boundary of Lots 91, 90, 89, 88, 87, and portion of 86, of the Parish of Penui aforesaid; on the South-west by the north-eastern boundary of the school endowment to its junction with a road to the south-west angle of Lot 80, in the Parish of Mangapiko; on the North-west by the said road to the line which divides Lots 80 and 81 of the Parish of Mangapiko aforesaid; on the South-west by the north-eastern boundary of Lots 80, 82, and 101, in the said parish; thence by the eastern boundary of said Lot 101; on the West by the eastern boundary of Lot 178; thence by the Mangapiko River to its junction with the eastern boundary of Lot 68; thence by the eastern boundary of said lot to its junction with a road; thence by the centre of said road to its junction with a road dividing Lots 61 and 62 of the Parish of Mangapiko; thence by the centre of such road to the centre of a road forming the southern boundary of Lot 40 of said parish; thence by centre of said road to the eastern boundary of said Lot 40, and by the east and northern boundaries of said lot to its intersection by the western boundary of Lot 45 of said parish; thence by said boundary to southern boundary of Lot 46; thence by southern boundary of Lots 46 and 47; thence by west and northern boundaries of Lot 47; thence by western boundary of Lots 48 and 49 to the southern boundary of Lot 53, and continuing along said Lots 53 and 54, all which said lots are in the Parish of Mangapiko, to Ngaroto; thence by the margin of Ngaroto to the intersection of and along the line which forms the south-eastern boundary of Lots 167, 168, 169, and 170 of the Parish of Ngaroto; thence crossing a road 100 links wide to the south-west angle of Lot 166 of the said parish; and thence by the western boundaries of Lots 166 to 148, inclusive of the Parish of Ngaroto aforesaid.

32. CAMBRIDGE DISTRICT.

Bounded on the North-east by the centre of the Mangaone and Mangaomapu Rivers to its junction with the road fronting Lot 58, in the Parish of Hautapu; on the North by the centre of the said road to its junction with a road forming the western boundary of Lots 181 and 180 in the said parish; thence on the West by the centre of the said road; on the North-east by the centre of proposed tramway fronting said Lot 180; again on the West by the western boundary of Lot 178; again on the North by the northern boundary of lots 178 and 177; again on the West and North by the west and north boundaries of Lot 174; again on the West and North by the centre of a road forming the western and northern boundary of Lot 171, in the said parish; again on the West by western boundary of Lots 172 and 173; again on the North by northern boundary of Lot 173 in the said parish, and the same line produced to its intersection with the boundary line of the confiscated territory; on the North-east by the boundary of the

said confiscated territory to Kopuahau; on the South-east by the confiscation boundary line to its junction with the Waikato River; on the South and South-west by the centre of said river to its junction with the Tamahere Creek; thence by the centre of said creek to its junction with Mangaone Stream.

33. KIRIKIRIROA DISTRICT.

Bounded towards the North by the Mangawara and Komakorau Rivers from the Waikato River to the south-eastern boundary of Allotment No. 440 of the Parish of Komakorau; thence by a right line bearing due east to the north-eastern boundary of the confiscated territory; towards the East by the confiscation boundary last described; towards the South-east by a right line bearing south-west from the confiscation boundary before mentioned to the Tamahere Creek; thence by said creek to the Waikato River; and towards the South, West, and North by the Waikato River to the Mangawara River, the place of commencement.

34. HAMILTON DISTRICT.

Bounded on the North-east by the centre of the Waikato River; on the South-east by the north-west boundary of the Pukekura Highways District; on the South by the northern boundary of the Punui District; on the West and South by the east and north boundary of the Mangapiko Highways District; on the West and South-west by the east and north-east boundaries of the Whatawhata Highways District; and on the North-west by the south-eastern boundary of the Newcastle Highways District.

35. NEWCASTLE DISTRICT.

Bounded towards the North by the southern boundary of Allotment No. 15 of the Parish of Pepepe, and by the Awa-o-te-Atua River to the Waikato River; towards the North-east by the centre of the Waikato River, from the Tutaekohia Creek to the north-western boundary of the Parish of Pukete; towards the South-east by part of the north-western boundary of the Parish of Pukete aforesaid, from the Waikato River before mentioned to the centre of the road which forms the eastern boundary of Allotment No. 91 of the Parish of Horotiu; again towards the North-east by the centre of the last-named road, and by the centre of the road which forms part of the northern boundary of Allotment No. 146 and the whole of the northern boundary of Allotment No. 147 of the Parish of Pukete, and by said road continued south-easterly to the north-eastern angle of Allotment No. 90 of the parish last named; thence easterly by the centre of the road which forms the eastern boundary of Allotment No. 90 aforesaid, the eastern boundaries of Allotments Nos. 91, 93, 94, and 96, to the northern boundary of the Parish of Tuhikaramea; towards the South by the centre of the road which forms the northern boundary of the Parish of Tuhikaramea aforesaid, to the north-eastern angle of Allotment No. 82 of the Parish of Tuhikaramea; towards the East by the eastern boundary of Allotment No. 82 last mentioned, and the eastern boundaries of Allotments No. 83, 84, 85, and 86, to the centre of the road which forms the eastern boundaries of Allotments Nos. 67, 66, 54, and 55, of the parish aforesaid, and by the centre of said road last described to its junction with the road at the south-eastern angle of Allotment No. 55 aforesaid; towards the South by the centre of the road forming the south-western boundaries of Allotments Nos. 55, 53, 52, 51, 48, 47, 46, and 45 of the Parish of Tuhikaramea, and by the centre of the road forming the south-eastern boundaries of Allotments Nos. 26, 25, 24, 23, 22, 21, 20, 20A, 19, and 18, of the parish aforesaid, to the Waipa River; and towards the West

by the Waipa River aforesaid, from the centre of the road which forms the south-eastern boundary of Allotment No. 18 before mentioned to the road near the mouth of the Timaru or Bluenose Creek; thence westward by said road for a distance of about 88 chains; thence by a right line bearing due north to the Hakarimata Range; thence by said range and by a right line bearing north-east to the south-western boundary of Allotment No. 15, of the Parish of Pepepe first mentioned, the point of commencement.

36. WHANGAPE DISTRICT.

Bounded on the South, from the mouth of the Awa-o-te-Atua River, by the Newcastle District, and by a line running from the south-western angle of Allotment No. 15, Parish of Pepepe, due west to the summit of the watershed between the Waikato River and the West Coast; thence following that watershed towards the North to the Waikato River; and on the North and East by the left bank of the Waikato River to the mouth of the River Awa-o-te-Atua, the point of commencement.

37. RANGIRIRI DISTRICT.

Bounded towards the South by the Mangawara and Komakorau Rivers from the Waikato River to the south-eastern boundary of Allotment 440 of the Parish of Komakorau; thence by a right line bearing due east to the north-eastern boundary of the confiscated territory; thence towards the North along the confiscated boundary to Pukorokoro, on the Hauraki Gulf; thence by a line south-westerly to the most northern source of the Mangatautari River, and by that river to its confluence with the Waikato; and thence by the Waikato River to the mouth of the Mangawara River, at the point of commencement.

38. COROMANDEL DISTRICT.

This district includes all that portion of the Coromandel Peninsula lying to the north of a line commencing at Deadman's Point in the Hauraki Gulf, and running thence along the range to the summit of Kakatarahaia, thence by the Watershed Ranges south-easterly to the source of the Waiwawa River, thence by a straight line to the south-eastern angle of the Purangi Block, thence by the eastern boundary of the said Purangi Block to the sea coast, and includes the Mercury Islands and islands in the Harbour of Coromandel.

39. HAURAKI DISTRICT.

Bounded on the North by the southern boundary of the Coromandel District; on the East by the sea to a point on the coast five miles north of Katikati; thence on the South by a line to the summit of Te Aroha Mountain, and by a line thence to the north-eastern angle of the Waikato Military Settlements Block; on the West by the north-eastern boundary of the Confiscation Boundary to Pukorokoro on the Hauraki Gulf; thence by the Frith of the Thames to Deadman's Point; but exclusive of the Thames District, herein next defined.

40. THAMES DISTRICT.

Commencing at a point bearing from Trig. Station F 282 degrees 36 minutes 31 seconds, distant 11681½ links; thence due east to Rocky Point, 80 chains; thence bearing 126 degrees 52 minutes, distant 4250 links to Trig. Station F; thence by straight line to Trig. Station No. 5, Kuranui Hill; thence by straight line to Trig. Station No. 1, Waitotahi Spur; thence by a straight line to the centre of the Karaka Road, opposite centre of Sandes Street; thence by centre of Karaka Road to the centre of Rolleston Street; thence by centre of Rolleston Street to the centre of the Hape Creek; thence by the centre of

Hape Creek to its confluence with the Kauwaeranga River; thence due westward, 80 chains; thence by a straight line to the point of commencement, a distance of 286 chains or thereabouts—all bearings being on the true meridian. Bounded towards the North by the sea and the gold fields; towards the East by the Thames Gold Field, and an irregular boundary described by the centre of the Karaka Road and Rolleston Street; towards the South by the centre of the Hape Creek, the mouth of the Kauwaeranga River, and the sea; and towards the West by the sea.

41. TAURANGA DISTRICT.

Bounded towards the North by the Hauraki District hereinbefore defined from the sea to the summit of Te Aroha Mountain; thence south-easterly by the summit of Te Aroha Range and a line to the summit of Otanewainuku Mountain; thence on the South-east by a line to the mouth of the Wairaki Stream; and towards the North-east by the sea to the commencing point, including Mayor, Motiti, and Plate Islands, excluding the Te Papa District, hereinbefore defined.

42. TE PAPA DISTRICT.

Bounded towards the North by the Harbour of Tauranga; towards the East by the harbour aforesaid and the Waimapu River to the south-eastern angle of Allotment No. 270, which said allotment, together with all the allotments hereafter mentioned, are in the Parish of Te Papa; towards the South by the southern boundary of said Allotment No. 270; thence crossing a road 100 links wide to the southern boundary of Allotment No. 259; thence by said southern boundary to the road which forms part of the eastern boundary of Allotment No. 258; thence by the centre of said road to the southern boundary of Allotment No. 258 aforesaid; thence by said last-named boundary and the southern boundary of Allotment No. 256 to the road which forms the eastern boundary of Allotment No. 225; thence by the centre of said road to the southern boundary of said Allotment No. 225; and by said last-named boundary and by the southern boundary of Allotment No. 221 to the road which forms its south-western boundary; thence by the centre of said road, and by the centre of the road which forms the southern boundary of Allotment No. 142, to the southern boundary of Allotment No. 138; thence by said last-named boundary to the road which forms the north-western boundary of Allotment No. 138 aforesaid; thence by the centre of said road to the southern boundary of Allotment No. 135 to the southern and western boundaries of said Allotment No. 135, to the southern boundary of Allotment No. 125; thence by part of said southern boundary and by the southern and part of the western boundaries of Allotment No. 122 to the road, which forms part of the southern boundary of said last-named lot; thence by the centre of said road to Omanawa Creek; thence by said creek to its confluence with the Wairoa River; and towards the West by the Wairoa River aforesaid to the Harbour of Tauranga, the place of commencement.

43. MAKETU DISTRICT.

Bounded towards the North by the sea from the mouth of the Wairaki Stream to a point five miles east of the mouth of the Matata River; thence by a line to Mount Edgecumbe; thence by a line to a point five miles due south of the most southerly extremity of Rere Whakaitu Lake; thence by a line till it meets the extremity of a line drawn due south a distance of twenty-two miles from Otanewainuku Mountain; thence by the last-mentioned line and the

south-eastern boundary of the Tauranga District, hereinbefore defined, to the sea.

44. OPOTIKI DISTRICT.

Bounded towards the North by the sea, from a point five miles east of the mouth of the Matata River, to the mouth of the Waiau River; towards the East and North-east by the Waiau River and the south-western boundary of the Opape Native Reserve to its intersection with the confiscation boundary; again towards the north by a straight line drawn from that point of intersection due east to the summit of the watershed between the Bay of Plenty and the East Coast; towards the South-east by the summit of that watershed and by a line bearing $22^{\circ} 30'$ West to the confluence of the Waiau and Waikaretaheki Rivers; thence towards the south-west by a line to the southern angle of the Maketu District, hereinbefore defined; and thence towards the West by the eastern boundary of that district.

45. CAPE RUNAWAY DISTRICT.

Bounded towards the North-west and North by the sea, from the Waiau River to the Matakawa point; towards the South-east by the summit of the watershed between the Bay of Plenty and the East Coast, and along that watershed till it meets the boundary of the Opotiki District; and towards the South, South-west, and West by the Opotiki District to the commencing point.

46. EAST CAPE DISTRICT.

Bounded on the North and East by the sea from Matakawa Point to the mouth of the Waimata River at Turanganui; thence by the said River Waimata to its source; thence by a line to Maungahaumi; and thence towards the North-west by the south-eastern boundary of the Opotiki District; including the adjacent islands.

47. POVERTY BAY DISTRICT.

Bounded on the North-east by a line commencing at Maungahaumi; thence to the source of the Waimata River; thence to the mouth of the same river at Turanganui; thence along the sea coast to Paretu; thence towards the south-west by a line from Paretu to the confluence of the Waiau and Waikaretaheki Rivers; thence along the south-eastern boundary of the Opotiki District to Maungahaumi.

48. WAIROA DISTRICT.

Bounded towards the North-east by the south-western boundary of the Waipu District, hereinbefore defined; towards the East and South-east by the sea from Paretu to the mouth of the Tonghoio River; towards the South-west by that river to its source, and by a line drawn north-west from the source of the said river to the northern boundary of the Province of Hawke's Bay; and towards the North-west by a line drawn from the last-mentioned point to the confluence of the Waiau and Waikaretaheki Rivers.

49. TAUPO DISTRICT.

Comprising all that portion of the Province of Auckland which is not included in any of the districts hereinbefore defined, and also all that portion of the Province of Wellington which lies to the north of the $39^{\circ} 15'$ parallel of south latitude, and also all that portion of the Province of Hawke's Bay which lies north of the River Mohaka between the eastern boundary of the last-named Province and the south-western boundary of the Wairoa District, hereinbefore defined.

PROVINCE OF HAWKE'S BAY.

50. PETANE DISTRICT.

Bounded on the North by the Mohaka River; on the North-east by the south-west boundary of the Wairoa District to the sea; thence on the East by the sea to the mouth of the Ahuriri Harbour; thence by a line across the said harbour to the mouth of the Tutaekuri or Meanee River; and following up that river to that point in its course where it intersects the western boundary of the Province; and thence along that boundary in a northerly direction to the Mohaka River.

51. THE TOWN OF NAPIER DISTRICT.

Commences at the northern side of Alfred Street, Meanee Spit, in the Town of Napier, and crosses Ahuriri Harbour to the mouth of the River Meanee or Tutaekuri, and following the bank of the said river to Awatoto; thence by a due east line to the sea coast, and along the sea coast in a northerly direction to the point opposite the northern side of Sections 68 and 69 Meanee Spit.

52. NGARURORO DISTRICT.

Bounded on the North by the southern boundaries of the Petane and the Town of Napier Districts to the sea; thence on the East by the sea to Waimarama; thence on the South-west by the northern boundary of the Waipaoa District, herein next defined; and on the North-west by the western boundary of the Province.

53. WAIPAOA DISTRICT.

Commencing at Mount Park, on the Ruahine Range, follows a line nearly due east to the west point of the Kereru Bush, skirting the southern boundary of the said bush to the boundary of Messrs. Smith and Carlyon's runs; by the said boundary to the source of the Manga-o-nuku Stream following the Manga-o-nuku down stream till it intersects the road leading from Maraekakaho to Hampden; thence in an easterly direction to the northern point of the Raukawa Bush; thence due east to the Tuki Tuki River, near Ngawhakatara; across that river, and by a line due east to the sea at Waimarama; thence by the sea shore southerly to Black Head; thence from the sea coast proceeding westerly along the south boundary of the Hapuku Block to the Huatokitoki; following down that stream to the Taurakaitae Stream, following up that stream to Lake Purinui; thence following the Purinui Stream to its most southerly source; thence by a line bearing south-westerly to the summit of the nearest peak of the Puketoi Range; thence along that range by straight lines down from peak to peak to Wahataura on the southern boundary of the Province; thence on the South and West by the said boundary of the Province to Mount Park, the point of commencement.

54. PORANGAHAU DISTRICT.

Bounded on the East by the sea from Black Head to the Waimata River; thence on the South by the southern boundary of the Province to Wahataura on the Puketoi Range; and thence on the West and North by the easterly and southerly boundaries of the Waipaoa District, hereinbefore last defined.

PROVINCE OF WELLINGTON.

55. WHAREAMA DISTRICT.

Commencing on the sea coast at the mouth of the Pahoa River; thence up the said river to its junction with the Wainuioru River; thence up the Wainuioru

River to a point where the southern boundary of Section No. 593, Warehama Block, strikes the said river; thence in a straight line bearing $294^{\circ} 17'$ magnetic to the Tauheru River; thence up the Tauheru River to a point where the western boundary of Section No. 170, Warehama Block, crosses the said river; thence northerly along the western boundaries of Sections Nos. 170, 171, 183, 175, and 174, to the Waitawhiti Stream; thence down the Waitawhiti Stream to its junction with the Tirumea Stream; thence down the said stream to its junction with the Manawatu River; thence easterly along the boundaries of the Province to the mouth of the Waimata Stream; thence southerly along the sea coast to the starting point.

56. UPPER WAIRARAPA DISTRICT.

Bounded on the East by the western boundary of the Whareama District; on the North-east and North by the Manawatu River to the Gorge; on the West by a right line along the summits from peak to peak of the Tararua and Rimutaka Ranges; and on the South and South-west by the Waiohine River from its source to the Ruamahunga River; thence by the Ruamahunga River to the Huangarua River; thence by a straight line to the junction of the Kaikaikuri Creek with the Pahua River; and thence by the Pahua River to its mouth on the sea coast. Exclusive of the Town of Masterton District, herein next defined.

57. TOWN OF MASTERTON DISTRICT.

Comprising all that area situate within a circle the radius of which is one mile in length, measured from the Resident Magistrate's Court House at Masterton.

58. LOWER WAIRARAPA DISTRICT.

Bounded on the North and North-east by the south and south-west boundaries of the Upper Wairarapa District to the sea at the mouth of the River Pahua; thence on the South-east, South, and West, by the sea coast to Taourakira Head, and towards the West by the summit line of the Rimutaka and Tararua Ranges, but exclusive of the Towns of Greytown and Featherston Districts herein next defined.

59. TOWN OF GREYTOWN DISTRICT.

Comprising all that area situate within a circle the radius of which is one mile in length, measured from the Resident Magistrate's Court House at Greytown.

60. TOWN OF FEATHERSTON DISTRICT.

Comprising all that area situate within a circle the radius of which is one mile in length, measured from the Resident Magistrate's Court House at Featherston.

61. HUTT DISTRICT.

Bounded on the South by the sea from Cape Taourakira to Pencarrow Head; thence on the West, again on the South, and on the South-east, by high watermark of Port Nicholson to the point where the prolongation of the north-eastern boundary of Section No. 17, Harbour Road District, would strike the high watermark; thence across the Hutt Road, and along the north-eastern boundary of the said Section No. 17, and along a prolongation of the same to the summit of the watershed between Port Nicholson and Porirua; thence towards the North-west by the summit of the said hills to the Tararua Range; thence towards the South-east by the summit of the Tararua and Rimutaka Ranges to Cape Taourakira.

62. CITY OF WELLINGTON—THORNDON DISTRICT.

Bounded on the East and North-east by the Har-

bour west; on the North by Harbour Section No. 1, from the Harbour waters around the exterior boundaries of Town Section No. 660 to the north-western corner of the Town Belt; on the West by the Karori-Makara District; on the South and South-east by the north side of Kumutoto Street and Bolton Street (including Town Acres 473 and 474), in a line with the north side of Bolton Street to the Town Belt, including that part of the Town Belt lying to the westward of the Tinakori Road.

63. CITY OF WELLINGTON—LAMBTON DISTRICT.

Bounded on the North and North-west by Thorndon District; on the West and South-west by the Karori Road; on the East by the harbour; on the South by a line drawn from the south-east corner of the Town Acre 507 along the southern boundary of the said acre and of Town Acres 475 and 451 to the Town Belt, and shall include that part of the Town Belt lying between Thorndon District, the sections on Wellington Terrace, a line in continuation of Margaret Street, to section 28 of Karori Country District and the Karori Road and District.

64. CITY OF WELLINGTON—TE ARO DISTRICT.

Te Aro District includes all the portion of the City of Wellington and of the Town Belt not comprised within the two other City Districts.

65. KARORI-MAKARA DISTRICT.

Bounded on the North and North-west by the southern and south-eastern boundaries of the Porirua District; on the North-east by the Hutt District; on the East by that portion of the shore of Port Nicholson Harbour which extends from the extreme point of the south-eastern boundary of the Hutt District at high water mark in Port Nicholson to Town Section 660 of the City of Wellington; thence along the northern boundary of that section; thence along the northern and western boundaries of the City of Wellington Town Belt to the coast; and thence following the sea coast to the mouth of the Ohariu River.

66. PORIRUA DISTRICT.

Bounded on the North by a straight line drawn from the sea coast due east (magnetic) over the crest of Paikakariki Hill, and prolonged till it meets the north-western boundary of the Hutt District; thence towards the South-west along that boundary to the north-western corner of Section No. 17, Harbour Road District, at its point of junction with the north-eastern corner of Section No. 2 of the Kinapori District; thence along the north-western boundary of the said Section No. 2, and along the north-western boundary of section No. 17, Porirua Road District, to the point where it meets the Porirua Road; thence along the said road to the north-eastern corner of Section No. 21 of the same district; thence along the north-western boundaries of the said Section No. 21 and Section No. 106 of the same district to the north-eastern corner of Section No. 20 of the Ohariu Road District, and along the northern boundary of the said section to where it meets a road; thence across the said road to the south-eastern corner of Section No. 22 of the last named district, and following along the southern boundary of the said section till it strikes the eastern branch of the Ohariu River; thence along that branch to its confluence with the Ohariu River, and by the Ohariu River to its mouth at the sea coast.

67. OTAKI DISTRICT.

Bounded towards the North by the south bank of the river Ohau from its mouth to its most easterly source; thence by a straight line due east (magnetic) to the summit of the Tararua Mountains; thence

towards the South-west by the summit of the said Tararua Mountains to the northern extremity of the Hutt District; thence again towards the South-west by the north-western boundary of the said Hutt District; and towards the South by the northern boundary of the Porirua District, including the adjacent islands.

68. PALMERSTON DISTRICT.

Bounded towards the North and North-west by the Manawatu and Oroua Rivers to the source of the Oroua River; thence by a line to the summit of the nearest peak of the Tararua Mountains; thence by straight lines from peak to peak along the summit of the Tararua Mountains to a point due east of the most easterly source of the Ohau River and by the south bank of the said River Ohau to the sea; and thence towards the West by the sea to the mouth of the Manawatu River.

69. FOXTON DISTRICT.

Bounded towards the North by the Rangitikei River to the north-western corner of the Rangitikei Manawatu Block; thence by the northern boundary of the said block to the Oroua River; thence by the Oroua and Manawatu Rivers to the sea; and thence towards the West by the sea from the Manawatu River to the mouth of the Rangitikei River.

70. RANGITIKEI DISTRICT.

Bounded towards the North and the North-west by the Turakina River from its mouth to the northern corner of the Rangitikei Block; thence by the north-eastern boundary of the said block to the Rangitikei River; thence towards the South-east and South by the Rangitikei River to its mouth; and thence towards the West and South-west by the sea to the mouth of the Turakina River.

71. WANGAEHU DISTRICT.

Bounded towards the North by the Wanganui River from the sea to the north-eastern boundary of the Wanganui Block; thence along that boundary of the said block to the Wangaehu River; thence by a straight line across the Wangaehu River to the northern corner of the Rangitikei Block on the Turakina River; thence by that river to the sea; and thence by the sea to the mouth of the Wanganui River.

72. KAI IWI DISTRICT.

Bounded on the East by the Wanganui River from its mouth at the sea to Parakino; thence on the North-east by a straight line drawn from Parakino aforesaid bearing on the summit of Mount Egmont to the point where the said line strikes the Waitotara River; on the West by the Waitotara River to the sea; and on the South by the sea to the mouth of the Wanganui River; excepting the town of Wanganui District, herein next described.

73. TOWN OF WANGANUI DISTRICT.

Bounded towards the North-east and South-east by the Wanganui River; and towards the South-west and North-west by the Town Belt. Together with the parcel of land adjoining the Town of Wanganui, and commonly known as the Town Belt, granted to the Superintendent of the Province of Wellington by Letters Patent or Crown Grant dated the third day of June, 1861, under the Public Seal of the Colony and the hand of Thomas Gore Browne, the then Governor thereof.

74. WAITOTARA DISTRICT.

Bounded on the East by the Waitotara River on western boundary of Kai Iwi District; on the North-east by the straight line aforesaid bearing on the summit of Mount Egmont drawn from Parakino on

the Wanganui River, being the north-eastern boundary of the confiscated land; on the north-west by the boundary line between the Provinces of Wellington and Taranaki to the sea coast; and on the South-west by the sea from the mouth of the Patea River to the mouth of the Waitotara River.

PROVINCE OF TARANAKI.

75. PATEA DISTRICT.

Bounded on the East from the mouth of the River Patea by the boundary line between the Provinces of Taranaki and Wellington; on the North-east by a straight line bearing on the summit of Mount Egmont drawn from Parakino on the Wanganui River to the point where the said line is intersected by the Kairoa and Waimate Road; and from that point of intersection, on the West by the said Kairoa and Waimate Road and the Waimate Stream to the sea; and on the South by the sea from the Waimate Stream to the mouth of the Patea River.

76. EGMONT DISTRICT.

Bounded on the East by the Patea District from the mouth of the Waimate Stream to the intersection of the Kairoa and Waimate Road by the straight line drawn from Parakino on the Wanganui River bearing on the summit of Mount Egmont; on the North-east from the said point of intersection by the last-named straight line to the said summit of Mount Egmont; on the East by a straight line drawn from the said summit of Mount Egmont to the southern angle of the Grey Block; on the North-east by the south-western boundary of the said block to the sea; and on the West and South-west by the sea.

77. WAIONGONA DISTRICT.

Bounded on the East and North-east by a straight line drawn from the summit of Mount Egmont to the source of the Waiongona River, and by that river to the sea; on the North-west by the sea; on the South-west and West by the north-east and eastern boundary of the Egmont District from the extreme west point of the Grey Block to the summit of Mount Egmont.

78. TOWN OF NEW PLYMOUTH DISTRICT.

Comprising the Town of New Plymouth and Town Belt as laid out by the New Zealand Company.

79. WAITARA DISTRICT.

Bounded on the North-west and West by the sea from the mouth of the Waiongona River to the tunnel at Parininihi; and thence by a straight line in a direction due east (true bearing) for a distance of twenty miles; on the South-east by a straight line drawn from the eastern extremity of said northern boundary in a direction south 39° west (true bearing) till it intersects the straight line between the summit of Mount Egmont and Parakino on the Wanganui River; on the South by the said last-named straight line from its intersection with the said south-eastern boundary to the summit of Mount Egmont; and thence on the West and South-west by the east and north-eastern boundaries of the Waiongona District, from the summit of Mount Egmont to the source of the Waiongona River; and by the said river to the sea.

PROVINCE OF MARLBOROUGH.

80. PELORUS DISTRICT.

Bounded towards the East by the Queen Charlotte Sound District; towards the South by the Wairau

District; towards the West by the boundary of the Province; and towards the North by the waters of Pelorus Sound, including all the islands in or about Pelorus Sound, but excluding the Town of Havelock District, herein next defined.

81. TOWN OF HAVELOCK DISTRICT.

Bounded towards the North and East by the waters of Pelorus Sound from the north-west corner of Section 97, Town of Havelock, to a point in transit with the southern boundary of Section numbered 219 in the said town; thence towards the South by a right line to the south-western corner of said section; thence towards the West and North-west by the western boundaries of Sections numbered 219, 218, and 217, in the said town; thence towards the West by a right line to the north-western corner of Section numbered 205 in the said town; thence by a right line to a public street fronting Sections numbered 91, 92, 93, 94, 95, and 96 in the said town; thence towards the South-west by the southern side of that street to Section numbered 98, Havelock Suburban; thence towards the North-west and West by Sections numbered 98 and 99, Havelock Suburban; thence towards the South-west by the dividing line between Section numbered 99, Havelock Suburban and Section numbered 100, Town of Havelock, and by that line continued across Neil Street to Section numbered 118, Havelock Suburban; thence towards the North by a right line to the south-west corner of Section numbered 133, Town of Havelock; thence towards the South-west and South by Sections numbered 118 and 119, Havelock Suburban, to the south-west corner of Section numbered 117, Town of Havelock; thence towards the North by a right line to the south-west corner of Section numbered 128 in the said town, and thence towards the West by a right line to the north-west corner of Section numbered 97, in the said Town of Havelock.

82. QUEEN CHARLOTTE SOUND DISTRICT.

Bounded towards the South by the north bank of the Wairau River from its mouth to the junction of the Waikakaho Stream; thence by the Waikakaho Stream to its source; thence by the summit of the dividing range between the Kaituna and Mahakipawa and Waitohi Valleys to Cullen's Point; thence towards the West by the waters of Pelorus Sound to Blaymire Point, Kenepuru Sound; thence by a right line to Mount Stokes; thence by a right line to Cape Lambert; thence by the waters of Cook Strait, Queen Charlotte Sound, Port Underwood, and Cloudy Bay to the mouth of the Wairau River; including all the islands in and about Queen Charlotte Sound and Port Underwood, but excluding the Town of Picton District, herein next defined.

83. TOWN OF PICTON DISTRICT.

As defined by the original plan thereof in the Crown Lands Office, Picton; and all adjacent lands within ten chains of the said town.

84. WAIRAU DISTRICT.

Bounded towards the North and West by the sea, from the mouth of the Awatere River to the mouth of the Wairau River; thence by the north bank of the Wairau River and the Onamalutu Creek, to the south-west corner of Section 106, District of Kaituna; thence by the western boundary of Sections 106 and 107, Kaituna; thence by a line to the nearest point on the summit of the watershed between the Onamalutu and Kaituna Valleys, and by that watershed to the summit of the dividing range between the Pelorus and Wairau Valleys; thence by that summit to the boundary of the Province; and by that boundary to Barefells Pass; thence on the South and East by the Awatere

District; excluding the Town of Blenheim District, herein next defined.

85. TOWN OF BLENHEIM DISTRICT.

Consisting of Sections 46, 47, 48, Opawa, and of Sections 1, 3, 50, and 51, Omaka, as shown on the New Zealand Company's plan of the Wairau Plains.

86. AWATERE DISTRICT.

Bounded towards the North by the sea from Cape Campbell to the Awatere River; thence towards the North and West by the Awatere River, from its mouth to a point in Section 30, Wakefield Downs, being the south-western corner of the boundary of the Vernon Run; thence by a right line to the south-western corner of Section 28, Wakefield Downs; thence by the eastern side of the road between Sections 33 and 29, Wakefield Downs, and Sections 4 of Block I., and 2 of Block I., District of Awatere, to the Utawai Stream; thence by the Utawai Stream to the northern boundary of Section 2, Block I, District of Awatere; thence along that boundary to Maxwell Pass Stream; thence by the Maxwell Pass Stream to the watershed; thence by a tributary of the Taylor River to the Taylor River at the base of the hill called the Maori; thence by the eastern side of the Taylor Pass Road to its junction with the road between Sections 28 and 48, Omaka; thence by that road to the western side of the Taylor Pass Road; thence by the western side of the Taylor Pass Road to the junction of the Taylor Pass Creek with the Taylor River; thence by the Taylor River to the summit of the dividing range between the Wairau and Awatere Valleys, and by that summit to Barefells Pass; thence by the boundary of the Province to the junction of the Acheron and Clarence Rivers; towards the East and South by the boundary of the Province to the Clarence River; thence by the Clarence River to the sea; thence by the sea to Cape Campbell.

87. KAIKOURA DISTRICT.

Bounded towards the North and West by the Clarence River to the boundary of the Province; towards the South by the boundary of the Province to the sea; towards the East by the sea, to the mouth of the Clarence River.

PROVINCE OF NELSON.

88. AMURI DISTRICT.

Starting from the Top House, and taking the boundary line between the Provinces of Marlborough and Nelson, to the mouth of the River Conway; thence by the coast line to the mouth of the Hurunui River; thence by the banks of the Hurunui River and Lake Sumner to the top of the saddle between the Teremakau and Hurunui Rivers; thence by a line to Mount Princess; thence by a line to Mount St. Arnaud; and thence by a line to the Top House.

89. WAIMEA SOUTH DISTRICT.

Bounded towards the North-east by a line drawn from Mount Arthur to the junction of the River Wangapeka with the River Motueka; thence by a line drawn to the source of the Pigeon Valley Stream; thence by the Pigeon Valley Stream to its junction with the Wai-iti; thence by the Wai-iti to its junction with the Waimea; and thence by the boundary of the Waimea East District to a point about two miles south of Mount Rintoul; thence by the boundary line between the Nelson and Marlborough Provinces to the Top House; thence by a line west (magnetic) to the summit of the nearest point of the northern watershed of Lake Rotoiti, and the Rotoiti

and Buller Rivers; thence by a right line to the summit of the eastern watershed of the Mokihinui River; and thence by right lines from peak to peak along that watershed to Mount Arthur.

90. WAIMEA EAST DISTRICT.

Bounded by the low watermark of the Waimea Mud Flats, from the mouth of the River Waimea to the north-west angle of Section No. 1, Suburban South; thence by the boundary line of the City of Nelson and Suburban North Districts; thence by the boundary line between the Nelson and Marlborough Provinces to a point on the main range about two miles south of Mount Rintoul; thence by a line drawn north-west from the point on the main range until it strikes the River Lee; thence by the River Lee to its junction with the River Waimea; and thence by the River Waimea to its mouth at low watermark on the Waimea Mud Flats, including islands Nos. 1 and 2, 179A, and other islands in the Waimea River.

91. SUBURBAN NORTH DISTRICT.

Bounded by the sea from the Lighthouse on the Boulder Bank to Point Dickens; thence by the sea line from Point Dickens to the head of that arm of Tennyson Inlet which approaches nearest to Squally Cove, Croixelles Harbour; thence by the boundary line between the Nelson and Marlborough Provinces to a point on the main range about two miles south of the Dun Mountain; thence by a line drawn north-west from the point on the main range until it strikes the Brook Street Stream; thence by the said stream to the boundary of the City of Nelson District; and thence by the boundaries of the City of Nelson District to the Lighthouse on the Boulder Bank, including D'Urville, the Chetwode, and other adjacent islands within the Province of Nelson, and excepting the City of Nelson District herein next defined.

92. CITY OF NELSON DISTRICT.

Bounded by a line drawn from the Lighthouse on the Boulder Bank to the south-west angle of section numbered 1 on the plan of Suburban North; thence by the southern boundary of the said section; thence by the boundaries of Block A, in the Wakatu District, to the bank of the River Maitai; thence by the western boundary of section numbered 11 on the plan of the Maitai Valley; thence by the eastern boundaries of block B, in the Wakatu District; thence by the boundaries of Sections numbered 1 and 4 on the plan of the Brook Street Valley; thence by the northern boundary of Section numbered 7 on the plan of Brook Street Valley; thence by the northern boundary of Sections numbered XII., 7, 6, 11, and part of 12, on the plan of Suburban South, to the Britannia Heights; thence by the eastern boundary of Sections numbered 4 and 1 on the plan of Suburban South; thence by the northern boundary of the said Section 1 to high watermark, Nelson Haven; thence by a line to the south-west angle of Fifeshire Island, and thence by the outer edge of the Boulder Bank to the Lighthouse.

93. WAIMEA WEST DISTRICT.

Starting from where the River Baton intersects the Waimea South boundary, following the River Baton to its junction with the River Motueka; thence by a straight line to the northern angle of the reserve of the Village of Thorpe; thence in a straight line to the road lying between Sections 62 and 153, Moutere; thence by a line in the same direction to the coast at low watermark; thence to the Waimea River; thence to its junction with the Wai-iti; thence by the Wai-iti to the junction of the Pigeon Valley Stream; thence by the Waimea South

boundary to the point where it is intersected by the Baton, including the islands not included in the Waimea East District.

94. MOTUEKA DISTRICT.

Bounded by a line following the main ridge from Mount Arthur to Separation Point; thence by the coast line at low watermark, including the islands adjacent thereto, to the Waimea West District; thence by the Waimea West District and the Waimea South District to Mount Arthur.

95. TAKAKA DISTRICT.

Bounded towards the North by the high watermark of Golden Bay, from the mouth of the River Pariwhaka-aho in Section numbered 79, Section 13, to Separation Point; thence on the East by the western boundary of the Motueka District to the summit of Mount Arthur; thence towards the South-west by a straight line drawn to the summit of Mount Snowden; thence towards the West by a straight line drawn to the summit of Slate River Peak; and hence towards the North-west by a straight line drawn to the mouth of the River Pariwhaka-aho, at the starting point; including the island at the mouths of the Rivers Takaka and Motupipi.

96. AORERE DISTRICT.

Bounded towards the North, North-west, and West by the high watermark of Golden Bay, from the mouth of the River Pariwhaka-aho as above defined round Cape Farewell, including the Sandspit to the mouth of the River Heaphy on the West Coast; thence towards the South by a straight line drawn from the mouth of the River Heaphy to the summit of Mount Domett; thence towards the East by the western boundary of the Takaka District. Excluding the Town of Collingwood District herein next defined.

97. TOWN OF COLLINGWOOD DISTRICT.

Comprising all that area situate within a circle, the radius of which is one mile in length, measured from the Resident Magistrate's Court House at Collingwood.

98. BULLER DISTRICT.

Bounded on the North from the mouth of the River Heaphy by the southern boundary of the Aorere District; on the North-east by the south-western boundary of the Takaka District to Mount Arthur; thence on the Eastward by the western boundary of the Waimea South District, and from the south-western angle of the last-named district by a line to a point on the Papahaua Range, at the head of the River Mokihinui; thence along the Papahaua Range to a point on the River Buller two miles below its junction with the Inangahua; thence following the River Buller down to its junction with the Blackwater; thence up the Blackwater to its source, and on to the Paparoha Range to a point on the eastern boundary of the Charleston District at the head of the River Nile; thence along the range in a northerly direction to Buckland Peaks; thence following the watershed between the Rivers Okari and Totara to the mouth of the Totara River; and thence following the coast line to the mouth of the River Heaphy, from whence this description commenced; excluding the Town of Westport District, herein next defined.

99. TOWN OF WESTPORT DISTRICT.

Bounded on the Northward by the high watermark of the South Pacific Ocean; on the Eastward partly by a straight line, bearing 155° 53', drawn from the aforesaid high watermark in the direction of Domett Street to the north-east corner of the

Municipal Reserve; thence by Domett Street, 155° 53', 625 links, 125 links, 3075 links, 125 links, and 7815 links; on the Southward partly by Daniell Street, 245° 53', 3800 links, 125 links, and 1100 links, partly by a continuation of Palmerston Street, 155° 53', 500 links, and partly by a line between Sections 7A and 5 to the banks of the River Buller, bearing 245° 53'; and on the Westward by the banks of the River Buller to the northern boundary as given above.

100. LYELL DISTRICT.

Bounded on the Northward by the southern boundary of the Waimea South District, and partly by part of the southern boundary of the Buller District; thence by part of the eastern boundary of the Buller District to a point on the River Buller two miles below its junction with the Inangahua; thence up the River Buller to the said Inangahua junction; thence by a right line in a south-easterly direction fifteen miles to a point on the summit of the Brunner Range; thence southerly along the summit of the said Brunner and Victoria Ranges to Mount Haast; thence by a line drawn through Lake Christabel to the western boundary of the Amuri District; thence following that boundary to the Top House.

101. INANGAHUA DISTRICT.

Commencing at a point on the Paparoha Range at the head of the River Nile; thence along the eastern boundary of the Buller District to its junction with the Lyell District; thence along part of the western boundary of the Lyell District to Mount Haast; thence along the watershed between the Rivers Grey and Inangahua to the said Paparoha Range; excluding the Town of Reefton District, herein next defined.

102. TOWN OF REEFTON DISTRICT.

Comprising all that area situate within a circle the radius of which is one mile in length, measured from the Resident Magistrate's Court House at Reefton.

103. GREY DISTRICT.

Bounded on the North partly by the southern boundary of the Inangahua District, and partly by the southern boundary of the Lyell District; thence by part of the western boundary of the Amuri District to the saddle between the River Hurunui and the River Teremakau; thence by the boundary line between the Province of Nelson and the Province of Westland to the junction of the River Arnold with the River Grey; and thence by the eastern boundary of the Cobden District and part of the eastern boundary of the Charleston District to the point on the Paparoha Range from whence this description commenced; excluding the Town of Ahaura District herein next defined.

104. TOWN OF AHAURA DISTRICT.

Comprising all that area situate within a circle, the radius of which is one mile in length, measured from the Resident Magistrate's Court House at Ahaura.

105. CHARLESTON DISTRICT.

Bounded by a line drawn due east from Razorback Point to the top of the Paparoha Range; thence by a line following the said range to Mount Buckland; thence by the southern boundary of the Buller District to the sea; and thence by the coast line to Razorback Point.

106. COBDEN DISTRICT.

Bounded on the Northward by the southern

boundary of the Charleston District, from Razorback Point to a point on the Paparoha Range, being the south-east corner of the Charleston District; thence along the Paparoha Range to the junction of the River Arnold with the River Grey; thence following the River Grey to the sea; and thence by the coast line to Razorback Point.

PROVINCE OF WESTLAND.

107. TOWN OF GREYMOUTH DISTRICT.

Bounded on the West by a line of 160 chains and 80 links, extending from the South Spit along the beach; thence along the South Town Belt 115 chains and 50 links; thence along the East Town Belt, 120 chains and 90 links; thence along the Native Reserve, No. 31 for a distance of 41 chains and 30 links to the River Grey; and thence along the River Grey to the point of commencement.

108. COALDALE DISTRICT.

Commencing at the north-east corner of the Greymouth District, hereinbefore described; thence easterly along the south bank of the River Grey to the junction of the River Arnold; thence south along the east bank of the River Arnold to the south-east corner of the Coal Reserve, No. 274; thence west along the south boundary of the said reserve to its intersection with the south-east corner of Rural Section 1599; thence south along the east boundary of said section; thence West along the south boundary of the said section and Block No. I to its intersection with the A-K line; and thence by a straight line drawn westerly to the south-east corner of the aforesaid Greymouth District; and thence northerly along the east boundary of the said district to the point of commencement.

109. PAROA DISTRICT.

Commencing on the sea coast at the south-west corner of the Greymouth District hereinbefore described; thence easterly along the south boundary of the said district hereinbefore described and Coaldale District to the point of intersection of the A-K line with Block I.; thence southerly along the A-K line to Rata Tree Peak; thence along the Ka' Kawau watershed by a line generally south-west; thence south-west by a straight line down to the point of intersection of the A-C line and New River; thence south to the River Teremakau; thence westerly along the south bank of the River Teremakau to the sea coast; and thence northerly along the sea coast to the point of commencement.

110. ARNOLD DISTRICT.

Commencing at Rata Tree Peak; thence northerly along the east boundary of the before-described Paroa District; thence west along the southern boundary of the Coaldale District to the River Arnold; thence southerly along the east bank of the said river to Lake Brunner; thence along the margin of the said lake to the mouth of the Big Hohonu River; thence westerly by a line following generally the watershed between the New River on one side, and the Arnold Creek, Maori Gully, and Still Water on the other, to Mount Fox; thence along the watershed to Mount Card; and thence westerly by a straight line to Rata Tree Peak.

111. CLIFTON DISTRICT.

Commencing at Rata Tree Peak; thence easterly along the southern boundary of the before-described Arnold District to Lake Brunner, at the mouth of the Big Hohonu River; thence westerly by a line

following generally the watershed between the Black-water River and the New River, crossing the A-T line at the south-east angle of the Pakihi to the River Teremakau, at the point of termination of the eastern boundary of the before-described Paroa District; and thence along the eastern boundary of the said Paroa District to the point of commencement.

112. GREENSTONE DISTRICT.

Commencing at the River Teremakau, at the extreme south-west corner of the before-described Clifton District; thence easterly along the south boundary of the said Clifton District to Lake Brunner; thence along the margin of the said lake to the River Arnold; and thence easterly along the south boundary of the Nelson Province to the west margin of Lady Lake; thence by a line running due south to the River Teremakau; and thence westerly along the north bank of the said river to the commencing point.

113. WAIMEA DISTRICT.

Bounded on the Northward by the south bank of the Teremakau River; on the Eastward by the Province of Canterbury; on the Southward by the south bank of the Arahura River; and on the Westward by the sea coast.

114. KANIERI DISTRICT.

Bounded on the Northward by the south bank of the Arahura River; on the Eastward by the Province of Canterbury; on the Southward by the south bank of Hokitika River; and on the Westward by the sea coast; exclusive of the Town of Hokitika District, herein next defined.

115. TOWN OF HOKITIKA DISTRICT.

Commencing at a point on the high bank of the old bed of the aforesaid river, the said point being 40 chains 40 links west of Trigonometrical Station 31; thence following a line bearing N. 20 degrees 14 minutes E. (magnetic); a distance of 62 chains 65 links; thence westerly at a right angle a distance of 86 chains 40 links to the sea beach, following the said beach southerly to the mouth of the Hokitika River; and from thence returning along the northern bank thereof and the high bank of the old river bed above mentioned to the commencing point. And also all that parcel of land containing 640 acres, more or less, situate on the Hokitika River, West Coast, bounded on the Northward by Reserve 271 in red; on the Westward by the sea; on the East by Section No. 8238, and a line in continuation of the western boundary thereof; and on the Southward by a line at right angles to the last-described boundary, and about 130 chains distant on the average from the reserve above mentioned.

116. TOTARA DISTRICT.

Bounded on the Northward by the south bank of Hokitika River; on the Eastward by the Province of Canterbury; on the southward by the south bank of Mikonui River; and on the Westward by the sea coast, exclusive of the Town of Ross District, herein next defined.

117. TOWN OF ROSS DISTRICT.

Comprising all that piece or parcel of land, containing 200 acres, more or less, situate on the branch of the Totara called Donnelly's Creek, commencing at a point about 87 chains above its confluence with the Totara, having a frontage of about 50 chains on Donnelly's Creek, and running back in a rectangular block in a south-westerly direction a distance of about 50 chains, to contain the quantity required.

118. WAITAHA DISTRICT.

Bounded on the Northward by the south bank of the Mikonui River; on the Eastward by the Province of Canterbury; on the Southward by the south bank of the Wanganui River; and on the Westward by the sea coast.

119. WATAROA DISTRICT.

Bounded on the North by the Big Wanganui; on the South by the Okarito River, Mapouriki Lake and Potter's Creek to its source; thence by a line due east (magnetic) to the boundary of the Provinces of Canterbury and Westland; on the East by the Province of Canterbury; and on the West by the sea coast; exclusive of the Town of Okarito District, herein next defined.

120. TOWN OF OKARITO DISTRICT.

Comprising all that piece or parcel of land containing 320 acres, more or less, situate at Okarito on the west side of the lagoon, having a frontage of about 100 chains to the lagoon, the south-western boundary being a line at right angles to the general direction of the coast, and the south-eastern boundary being a line at right angles to the last-described boundary, and to include the above quantity, subject to Native reserve.

121. WEHEKA DISTRICT.

Bounded on the North by the Wataroa District and the Town of Okarito District; on the South by the Paringa River to its source, thence by a right line due east to the boundary of the Provinces of Canterbury and Westland; on the South-East by the Province of Canterbury; and on the North-west by the sea.

122. HAAST DISTRICT.

Bounded on the North by the southern boundary of the Weheka District; on the South by the Province of Otago; on the East by the Province of Canterbury; and on the West by the sea.

PROVINCE OF CANTERBURY.

123. WAIPARA DISTRICT.

Bounded on the North by the Hurunui; on the East by the sea; on the South by the River Waipara from the sea to the source of its southern branch; thence by a right line to the source of the River Ashley; thence along that river to the south-east boundary of pasturage run No. 235; thence by a straight line passing over the summit of Oxford Hill to the River Waimakariri, and by the south bank of the Waimakariri River; and on the West by a right line from the top of the saddle dividing the Hurunui from the Teremakau River, to the source of the River Poulter, following the western bank of that river to its confluence with the Waimakariri.

124. OXFORD DISTRICT.

Bounded on the North and West by the Waipara District hereinbefore defined; on the East by the Sefton District, and by a true north and south line drawn through the trig. pole C. 29, on the south bank of the Waimakariri; on the South by the south bank of the Waimakariri.

125. SEFTON DISTRICT.

Bounded on the North by the south bank of the River Waipara; on the East by the sea from the mouth of the Waipara to the mouth of the Ashley; on the South by the south bank of the Ashley from the sea to its confluence with the Okuku and the

east bank of the Karetu to the bush; thence by a right line to the Trigonometrical Station on the summit of Mount Grey; thence by a right line passing over the summit of Mount Brown to the Waipara River.

126. RANGIOEA DISTRICT.

Bounded on the North by the Sefton District; on the West by Oxford District; on the South by the centre of the Harewood Road from a point where it intersects the west boundary of the district to a point where it meets a road lying on the south-west boundary of Section No. 1728, the middle of that road to the corner of Section 1631, the middle of road lying on the boundaries of Sections 1631, 1539, and 1508, to the north-west corner of 1029; the west boundary of 1029 to a point where it meets Southbrook, and the middle of Southbrook to the west boundary of the Native reserves; on the East by the boundary of the Native reserve, the middle of road lying on the south-west boundary of Sections 1655, 355, 355A, and 431, the west boundary of 432, to the Harewood Road, the middle of the road to the south corner of 544, and the middle of the road lying on the east boundary of 544 to the point where the said road meets the River Ashley.

127. MANDEVILLE DISTRICT.

Bounded on the North by the Sefton District and the Rangiora District; on the West by the Oxford District; on the South by the south bank of the Waimakariri River and a line drawn from trig. pole C. 19 on the south bank of that river to trig. pole C. 27 on the sea coast; on the East by the sea coast: Exclusive of the Town of Kaiapoi District, herein next defined.

128. TOWN OF KAIAPOI DISTRICT.

Boundary commencing at the south-west corner of Rural Section No. 338E, on the North Road; thence South-westerly across the branch of the Waimakariri, and along the southern bank of the said branch to a point in line with the eastern boundary of Rural Section 365; thence in and along the line of the said eastern boundary of Rural Section 365, a distance of about 45 chains 80 links; thence Easterly at a right angle about 66 chains 50 links along the southern side of a public street or road crossing Rural Sections 321, 468, and 297, to the northern bank of the main stream of the Waimakariri, following the said northern bank of the said main stream, and the western bank of the branch stream, a distance altogether of about 64 chains; thence to the Northward, crossing the branch stream and meeting the line of the eastern side of Hall Street, continuing along the said eastern side of Hall Street till it meets the northern side of Cass Street, following along the northern side of Cass Street to a point on the southern boundary of Rural Section 338E about 13 chains from the south-western corner of the said section, and returning along the southern boundary line of the said section to the commencing point, and numbered and marked MD 14 on the maps setting out and describing the Mandeville District of the Province of Canterbury, in the Land Office, Christchurch, together with the remainder of Rural Section 320.

129. AVON DISTRICT.

Bounded on the North by the River Waimakariri from the sea to the western boundary of Section No. 5620; on the East by the sea; on the South by the north boundary of the City of Christchurch and the River Avon to the sea; on the West by the western boundaries of Sections Nos. 6, 52, 105, 133, 142, 299, 135, 151, and the northern boundary of

Section No. 151 to the north-western boundary of the Papanui Church Reserve, by the north-western boundary of that reserve, and by the eastern side of the Harewood Road, by Papanui to the western boundary of Section No. 203, by that boundary and by the western boundaries of Sections No. 203, 5, 3, 25, 292, 291, 280, 279, 243, 331, 1471, and 5620.

130. RICCARTON DISTRICT.

Bounded on the North by the River Waimakariri; on the East by the Avon District and the west boundary of the City of Christchurch; on the South by the Lincoln Road to Archer's Bridge, and the Lincoln and Riccarton Junction Road to its junction with the Great South Road, the Great South Road to its junction with the Harewood Road by Riccarton, the Harewood Road by Riccarton to a point in a line with the Prebbleton and Kaiapoi Junction Road; on the West by the Prebbleton and Kaiapoi Junction Road to the Waimakariri at the north-east corner of Rural Section No. 2197.

131. CITY OF CHRISTCHURCH—NORTH-WEST DISTRICT.

Bounded towards the North by the road separating Sections 242 and 299 from Sections 453 and 135 from the junction of the road west of section 242 to the Papanui Road, following southerly the said road to the road running between Sections 136 and 243F, and by that road to the Caledonian Road at the eastern corner of the latter section; towards the East by the City of Christchurch North-East District; towards the South by the north bank of the River Avon; and towards the West by the road separating Sections 18 and 80 to the road first before mentioned.

132. CITY OF CHRISTCHURCH—SOUTH-WEST DISTRICT.

Bounded towards the North by the north bank of the River Avon; towards the East by the City of Christchurch South-East District; towards the South by the Pound Road to the Lower Lincoln Road, following north-easterly the said road to the road separating sections 113 and 118; and towards the West by the said last-mentioned road to the Riccarton Road, and by a straight line drawn from the north-western corner of Section 155 to the road separating Sections 18 and 80 on the north bank of the River Avon.

133. CITY OF CHRISTCHURCH—NORTH-EAST DISTRICT.

Bounded towards the North by the road separating Sections 136 and 243F to the road east of Section 2256; towards the East by the last-mentioned road to its junction with the East Christchurch Road, following that road easterly to the Stanmore Road, and by the Stanmore Road to the north bank of the River Avon; towards the South by the north bank of the said River Avon; towards the West by Colombo Street to the North Town Belt; thence westerly, following the northern side of the same to the Caledonian Road, and by the Caledonian Road to the road first before-mentioned.

134. CITY OF CHRISTCHURCH—SOUTH-EAST DISTRICT.

Bounded towards the North by the north bank of the River Avon; towards the East by the Stanmore Road, crossing the River Avon to the road separating Sections 69 and 84, and by that road to the Ferry Road, following that road westerly to the Hills Road, and by the Hills Road to the road separating sections 62 and 74; towards the South by the last-mentioned road, and by a straight line drawn

from the western end of the same to the junction of Wilson's Road with the road leading to the pound, and by the latter road to its junction with Colombo Street; towards the West by Colombo Street, crossing the River Avon to the northern bank thereof.

135. HEATHCOTE DISTRICT.

Bounded on the North by the Avon District and the City of Christchurch; on the East by the sea; on the South by the ridge of the Port Hills and Lyttelton Harbour; on the West by the Dyer's Pass Road and the continuation of Colombo Street South to the City of Christchurch.

136. TOWN OF LYTTTELTON DISTRICT.

Bounded on the North by the ridge of hills lying on the north side of Lyttelton; on the East by the spur of the hill running down to the sea immediately on the east side of Gollan's Bay; on the South by the sea; and on the West by the eastern boundary of the Native reserve at Rapaki.

137. PORT VICTORIA DISTRICT.

Bounded on the East by the north-east boundary of the Native reserve at Rapaki, a straight line from the south-east corner of the Native reserve across the harbour to the Church Gully in Church Bay, the Church Gully to the Mount Herbert Peak Road, the west side of the Mount Herbert Peak Road to a point where it is intersected by a straight line from Mount Herbert Peak to the head of Little River; on the South by a straight line from Mount Herbert Peak to Mount Herbert, a straight line from Mount Herbert through L 1 to the ridge of the Port Hills; and on the West by the ridge of the Port Hills.

138. PORT LEVY DISTRICT.

Bounded on the North by the sea; on the East by a line bearing S. 8 deg. 30 E. (magnetic) drawn from a point half-way between the East Head of Port Levy and the West Head of Pigeon Bay to the south side of the Purau and Akaroa Road; on the South by the south side of the Purau and Akaroa Road and the Mount Herbert Peak Road; and on the West by the Port Victoria District.

139. PIGEON BAY DISTRICT.

Bounded on the North by the sea; on the East by the ridge of the Spur between Decanter Bay and Little Akaroa, to a point where it meets the highest ridge of the hills; on the South by the highest ridge of the hills and the Akaroa and Purau Road; and on the West by the Port Levy District.

140. OKAIN'S BAY DISTRICT.

Bounded on the North and East by the sea; on the South by the highest ridge of the hills and the spur leading to Putakolo Head; and on the West by the Pigeon Bay District.

141. TOWN OF AKAROA AND WAINUI DISTRICT.

Bounded on the North by the Port Levy, Pigeon Bay, and Okain's Bay Districts; on the East and South by the sea; and on the West by the summit of the spur running down to the Eastern Head of Island Bay, the main ridge of hills through Mount Bossu, Carew's Peak, Saddle Hill, Kitson's Pole, Wainui Peak, French Hill, Wooded Peak, to Barry Pass, the south side of the Barry Pass Road to the Little River Railway Reserve, the south side of the Tera-wera Valley Road and continuation thereof to its junction with the north side of the Port Levy and Little River Road, the north side of the Port Levy and Little River Road to its junction with the Purau and Akaroa Road.

142. LITTLE RIVER DISTRICT.

Bounded on the North by the Lincoln, Halswell Port Victoria, Port Levy Districts, and by the Akaroa and Wainui District; on the East by the Akaroa and Wainui District; on the South by the sea; and on the West by the east shore of Lake Ellesmere and the Springs Districts.

143. SPRINGS DISTRICT.

Bounded on the South-east by the edge of Lake Ellesmere; on the South-west by the Selwyn; on the North-east by the Lincoln District and the west bank of the River Halswell; and on the North-west by the Great Southern Railway from the Selwyn to where it is intersected by the southern side of the Great South Road, and also by the Great South Road from such intersection to the Lincoln District.

144. LINCOLN DISTRICT.

Bounded on the North by the Spreydon and Templeton Districts and the Great South Road; on the East by the Spreydon and Halswell Districts; on the South by the south bank of the Halswell; and on the South-west by the road from the Thirteen-Mile Bridge to trig. pole L I and the Lincoln and Coal Tramway Road to its junction with the Weedon and Springs Road, by the Weedon and Springs Road to its junction with the Great South Road.

145. HALSWELL DISTRICT.

Bounded on the North by the Spreydon District; on the East by the Heathcote District and the ridge of the Port Hills as far as the highest of Cooper's Knobs; on the South by a stream rising on the western side of Cooper's Knobs and falling into the River Halswell; and on the West by the River Halswell.

146. SPREYDON DISTRICT.

Bounded on the North by the City of Christchurch and the Riccarton and Templeton Districts; on the East by the Heathcote District; on the South by the River Heathcote to the south side of the Canal Reserve, and the River Halswell to the old river bed, and the west edge of the old river bed to the Great South Road.

147. TEMPLETON DISTRICT.

Bounded on the North by the Waimakariri; on the East by the Riccarton District to the Great South Road; on the South by the Great South Road; and on the West by the road forming the north-east boundary of Section 6363 and the continuation thereof to its junction with the road forming the north-west boundary of Section 5835; thence by the latter road to the road dividing Sections 5720 and 5721; thence by that road to its junction with other roads north of the northern boundary of Section 11581; thence by the road leading from the last-mentioned junctions in a northerly direction west of and about 16 chains from the western boundary of Section 5194 to the Waimakariri aforesaid.

148. COURTENAY DISTRICT.

Bounded on the North by the Waimakariri; on the East by the Templeton District; on the South-east by the Lincoln and Springs District; on the South-west by the River Selwyn and the Wakaepa branch of the Selwyn; on the North-west by the south-east boundary of Run No. 41.

149. SOUTH MALVERN DISTRICT.

Commencing at a point on the north bank of the Wakaepa branch of the River Selwyn, the same being the southernmost corner of Run No. 41; thence

north-easterly, following the eastern boundary of that run to the Auchen Lower Road; thence following a straight line to the south-western corner of Section 3719, thence in a straight line to the north-east corner of Section 10759, thence in a straight line to the north-west corner of Section 3107, where it joins the river, and from thence returning along the northern bank of the Wakaepa River before mentioned to the commencing point

150. EAST MALVERN DISTRICT.

Commencing at a point on the southern bank of the River Waimakariri, the same being the eastern corner of Run No. 41; thence south-westerly following the south-eastern boundary of that run to the Auchen Lower Road; thence north-westerly following a straight line to a point on the western boundary of Section 3719, where it is intersected by the western boundary of the before-mentioned run; thence following a straight line to the north-eastern corner of Section 13715; thence in a straight line to an angle in the Dalethorpe and Kowai Road, situate 33 chains 50 links north of the southernmost corner of Section 14801; thence north-easterly following the eastern side of the said road to the north-west corner of Section 5177; thence easterly following the northern boundary of that section to the north-eastern corner thereof; thence north-westerly following a straight line to the southernmost corner of Section 5321; thence following the south-western, the western, and the north-western boundaries of that section and the south-eastern boundary of Section 4573 to the southernmost corner of Section 4803; thence following the south-western boundary of the latter section to the westernmost corner thereof; thence following a straight line to the westernmost corner of Section 4739; thence following the north-western boundary of that section to the River Waimakariri aforesaid, and from thence returning along that river to the commencing point.

151. MALVERN DISTRICT.

Bounded on the North by the Upper Waimakariri District; on the Eastward by the Waimakariri, and also by the East Malvern District; on the Southward by the South Malvern District and the River Wakaepa branch of the Selwyn; and on the Westward by a straight line drawn from the southern end of Lake Lyndon to the junction of the aforesaid branch of the Selwyn with a creek running from the Thirteen-Mile Bush.

152. UPPER WAIMAKARIRI DISTRICT.

Bounded on the North by the Waipara District and the Province of Westland; on the South by Staircase Gully and the northern branch thereof to its source, thence by a straight line to Mount Torlesse, thence by a straight line in a south-westerly direction to the easternmost branch of the stream which intersects the West Coast Road near the south-east corner of Section 9824, thence following the said branch and stream above-mentioned to the southern side of the said road, thence westerly following the southern side thereof to the stream forming part of the southern boundary of Section 9824, thence following up the latter stream to its source, thence by a straight line to the southernmost end of Lake Lyndon, thence by a straight line to Red Hill; on the West by the summit of the High Snowy Range from Red Hill and also by the Black Range to the head waters of the Waimakariri, thence by an east and west line (true) to the Province of Westland; and on the Eastward by the summit of the range leading from Ashley Head, the Puketerahi Range, the northern boundary of Run No. 270, and the River Waimakariri.

153. LAKE COLERIDGE DISTRICT.

Bounded on the North by the Upper Waimakariri District; on the South-west by the River Rakaia to its southernmost source, and a straight line therefrom due west true to the Province of Westland; on the North-west by that Province; and on the East by the western boundary of Runs 67 and 96, and a continuation of that boundary to the north bank of the Hororata; thence by the north bank of that river to its principal source, thence by a straight line from said source to the head of the nearest stream running into the Wakaepa River, thence by that stream and by the Malvern and Upper Waimakariri Districts.

154. RAKAIA DISTRICT.

Bounded on the South-east by the Ellesmere District; on the North-east by the Malvern and Courtenay Districts; on the South-west by the River Rakaia; and on the West by Lake Coleridge Districts, above described.

155. ELLESMERE DISTRICT.

Bounded on North by the Springs and Courtenay Districts; on the East by Lake Ellesmere; on the South by the sea and the Rakaia; and on the North-west by the Great South Road.

156. ASHBURTON DISTRICT.

Bounded on the North-east by the Rakaia and Ellesmere Districts; on the South-east by the sea; on the South-west by the Rangitata; and on the North-west by the Mount Somers District.

157. MOUNT SOMERS DISTRICT.

Bounded on the North by the Lake Coleridge District; on the North-east by the Rakaia and Lake Coleridge Districts; on the South-east by the north boundary of Run No. 499, and a line in continuation thereof to the River Hinds; thence following down that river to the north-western boundary of Run No. 59; thence following the latter boundary to the River Ashburton; thence following a straight line by the northern end of the island to the northern branch of the River Ashburton; thence following down the same to the north-western boundary of Run 124, and from thence following that boundary and the north-western boundary of Run No. 116, and a line in continuation thereof to the River Rakaia; on the South-west by the Rivers Rangitata and Clyde to the source of the latter, and a true west line; and on the North-west by the Province of Westland.

158. MOUNT PEEL DISTRICT.

Bounded on the North and North-eastward by Mount Somers District; on the Eastward by the Ashburton District, and by a road leading from the Rangitata River within Reserve No. 1237 (in red) to Tripp's Cutting on the high bank of the Orari River, following the continuation of that road to its junction with the road passing through Section 9548; thence south-easterly following the latter road to the road running through Section 9010; thence south-westerly, following that road to the eastern boundary of Run 546; thence westerly and southerly, following that boundary to the stream running from the south-eastern corner of Run 546; thence following down that stream to its confluence with the southern branch of the River Hae Hae-te-moana, following up the said branch to the western boundary of Run 548; thence following that boundary and the River Opuha to a point in line with the south-eastern boundary of Run 416; thence following that line to the River Opihi before mentioned; on the South by the River Opihi from the easternmost corner of Run No. 416 to a

point in line with the eastern boundary of Run 254, a branch of the River Opuha forming the northern boundary of Runs 254 and 357, and an east and west line forming part of the northern boundary of Run No. 357 continued to the ridge; on the West by the east boundary of Run 254 and the ridge of the hills dividing the waters of the Opihi and the Rangitata from the waters of the Tekapo.

159. GERALDINE DISTRICT.

Bounded on the North by the Ashburton District; on the West by the Mount Peel District; on the South by the Opihi River; and on the East by the Main South Road to Section 5961; thence following the northern boundary line of 5961 and 11526, and a line in continuation of the same, to the eastern boundary of Section 9031; thence following the eastern and north-western boundaries of the latter section to the Geraldine Road; thence following that road south-easterly to the road running through Section 7319; thence following the latter road by trig. pole 5 and through Section 3275 to the north-eastern corner of Section 7462; thence following the eastern boundary of Section 7462 to the south-east corner thereof; thence following a straight line to the south-west corner of Section 13741; and from thence following the road forming the western boundary of that section to the River Opihi before mentioned.

160. TEMUKA DISTRICT.

Bounded on the North-east by the Ashburton District; on the South-east by the sea; on the Southward by the River Opihi; and on the North-west by the Geraldine District.

161. LEVELS DISTRICT.

Bounded on the North by the Temuka District; on the East by the sea; on the South by the Pareora; on the West by Section No. 6192 on the River Opihi, following the watercourse therefrom and the stream following into the Tengawai the River Tengawai to a point opposite Section No. 5209, crossing the river, and following down a small stream to the River Pareora; but excluding the Town of Timaru as herein next defined.

162. TOWN OF TIMARU DISTRICT.

Bounded on the North and East by the sea; on the South by the north boundary of Section No. 1702, the north side of a road lying to the north of Section No. 2367, the Cemetery Reserve, and the north boundaries of Sections 1706 and 1607; on the West by the east boundary of Section No. 1606, the east and north boundaries of Section No. 707, the east boundary of Section No. 1652 till it meets Whales Creek to the sea.

163. WAIMATE DISTRICT.

Bounded on the North by the Levels District, the Pareora to its westernmost source, and an east and west line from thence to the Hakateramea; on the East by the sea; on the South by the north bank of the River Waiho from the sea to its northernmost source, thence by an east and west line to the River Hakateramea; on the West by the Hakateramea.

164. WAITAKI DISTRICT.

Bounded on the North by the Waimate District, herein lastly before described; on the East by the sea; on the South by the Province of Otago; on the West by the Hakateramea.

165. MOUNT COOK DISTRICT.

Bounded on the North and West by the Province of Westland; on the East by the Mount Peel, Levels, Waimate, and Waitaki Districts; on the South by the Province of Otago.

PROVINCE OF OTAGO.

166. PAPAOKAIO DISTRICT.

Bounded on the North by the Waitaki River; towards the South-east by the sea; on the South by the Oamaru Town; West by the Oamaru Stream to the Big Hill, thence by the southern boundary of the Awamoko and Maerewhenua Hundreds to the south-west corner of the Maerewhenua Hundred, and on the West by the western boundary of the Maerewhenua Hundred to the Waitaki River.

167. TOWN OF OAMARU DISTRICT.

Bounded towards the North-west by Blocks numbered respectively II. and IV., Oamaru Survey District, 4596 links; also by Block numbering II., 3215 links; towards the North-north-east by Block numbered I., Oamaru District, 6426 links; towards the East by high watermark of the sea, 15800 links; towards the South-east by Block numbered IV., Oamaru District, 2000 links; towards the South by Block numbered IV., 6950 links; towards the South-west by the said Block numbered IV., 6544 links; and towards the West-north-west by the said Block numbered IV., 4576 links.

168. KAKANUI DISTRICT.

Bounded on the East and North-east by the Oamaru Town and the Oamaru Stream; on the North by the Papakaio District; on the West by the western boundary of the Kakanui Hundred; on the South by the southern boundary of the said Hundred to where it meets the Kauroo Stream, thence by that stream and the Kakanui River to the sea; and on the South-east by the sea.

169. MAEREWHENUA DISTRICT.

Bounded on the East by the Papakaio and Kakanui Districts, from the Waitaki River to the south-western corner of the Kakanui Hundred; thence on the South-east by a right line drawn to the summit of the Kakanui Peak; thence on the South-west and South by the Naseby District to Mount Ida; thence on the West by the west branch of the Otamakau River, and by that river to the Waitaki; and on the North by the Waitaki.

170. AHURIRI DISTRICT.

Bounded on the East by the Maerewhenua District from the Waitaki to Mount Ida; thence on the South-west and South by the St. Bathans District to Mount St. Bathans; thence again on the South-west by the Cromwell District to the Lindis Pass and the Longslip Creek; thence on the East by the Longslip Creek to its junction with the Ahuriri River; thence by that river and the East Head Creek to the Waitaki; and on the North by the Waitaki.

171. CARDRONA DISTRICT.

Bounded on the South-east by Cromwell District; on the East by the Ahuriri District to the Waitaki River; on the North by that river to the east branch of the Matukutuke River; on the West by a line due south from said boundary to Fox's Creek, thence along the boundary of the Dunstan Gold Field to the Treble Cone, thence along said boundary to Mount Cardrona, and thence to Queensberry Hill.

172. QUEENSTOWN DISTRICT.

Bounded on the East by the Cardrona District, the Arrow District, and the Clyde District; on the South-east by an imaginary line from Lorn Peak, on the Hector Mountains, running south-west to the Mataura River, at a point midway between Howell's Fords, on the road to Kingston; on the South-west by the boundary of the Otago Godl Fields. **Except-**

ing the Town of Queenstown District, herein next defined.

173. TOWN OF QUEENSTOWN DISTRICT.

Bounded towards the North-west by Crown lands 3130 links, by Cemetery Reserve 2110 links, also by Crown lands 1930 links; towards the North-east by Crown lands 4920 links; towards the South-east by Crown lands 1700 links; towards the South by Lake Wakatipu 1500 links, be the same more or less; and towards the South-west by Crown lands 1100 links.

174. ARROW DISTRICT.

Bounded on the East by the Cromwell District; on the South by the Clyde District on the North-west by an imaginary line from Ben Nevis on the Hector Mountains to the junction of the Shotover River with the Kawarau River, thence along the Shotover to the bridge at Foster's Ferry, thence due north to the Coronet Peak on the Harris Mountains, and thence to Mount Hyde and the boundary of the Cardrona District; and on the North-east by the Cardrona District.

175. CROMWELL DISTRICT.

Bounded on the South by the Clyde District; on the West by the Carrick Range to Kawarau River, thence by the Kirtle Burn to Queensberry Hill; on the North-west by an imaginary line from said hill to the head waters of Luggatt Creek, thence by said Creek to Clutha River in a north-easterly direction to Trig Hill; thence in the same direction to the Lindis Burn, thence by the Lindis Pass, thence by the Longship Creek to the boundary of the Otago Gold Fields; on the East by a line along the boundary of the Otago Gold Fields to Mount St. Bathans, thence along the Dunstan Range to the head waters of the Lauder Creek, and thence by the Blacks District, excepting the Town of Cromwell District herein next defined.

176. TOWN OF CROMWELL DISTRICT.

Bounded towards the North by a line commencing on the west bank of the Clutha River and proceeding in a westerly direction, with a magnetic bearing of 269° 25' to the north-east corner of Cemetery Reserve, 4100 links; thence along a line in the same direction, 7100 links; thence by a line at a right angle in a southerly direction, 6940 links; thence by a line at a right angle in an easterly direction to the Kawarau River, 4900 links; thence along the Kawarau and Clutha Rivers to the starting point, as delineated on the record map of the said town deposited in the Survey Office at Dunedin.

177. BLACKS DISTRICT.

Bounded on the South and West by the Alexandra and Clyde Districts; on the North-west by the Dunstan Range to the head waters of the Lauder Creek; on the North-east by the Lauder Creek to its junction with the Manuherikia River, thence by the Manuherikia River to the Pool Burn junction, thence by the Pool Burn to its junction with the Ida Burn, thence by a line from said junction in a south-east direction to Rough Ridge, and thence along the Rough Ridge to South Ridge Hill.

178. ST. BATHAN'S DISTRICT.

Bounded on the West by the Blacks District; on the North-west by the Cromwell District; on the North by an imaginary due east line from Mount St. Bathans to the Hawkden Mountains; and on the North-east by the watershed of the Hawkden Mountains to Mount Ida; and on the South-east by an imaginary line from Mount Ida along the watershed of the Rough Ridge to the boundary of the Blacks District.

179. NASEBY DISTRICT.

Bounded on the West and North-west by the Blacks and St. Bathans Districts; on the North by an imaginary line from Mount Ida due east to Kyeburn Hill; on the East by an imaginary line from Kyeburn Hill running south across the Macraewhenua Pass to Kakanui Mountains, and hence south-east along the watershed of those mountains to the Kakanui Peak; on the South-east by an imaginary line from Kakanui Pass south-westerly to the Taieri River; thence to the hill known as Flat Cap, and thence to the South Rough Ridge Hill, on the boundary of the Blacks District.

180. OTEPOPO DISTRICT.

Bounded on the North-east and North by the Kakanui District, on the North-west by the Macraewhenua District; on the South-west by the north-eastern boundary of the Macraes District from the Kakanui Peak to Mount Fortune; thence on the South by a right line to the southernmost source of the Waianakarua River, by the southern branch of the said river to the sea; and on the East by the sea to north of the Kakanui River.

181. HAMPDEN DISTRICT.

Bounded on the North and North-west by the Otepopo District; on the South-west by the watershed of the Horse Range from Mount Fortuna to the Kartigi Beach; and on the South-east and East by the sea to the mouth of the Waianakarua River.

182. PALMERSTON DISTRICT.

Bounded on the North-east by the Hampden District; on the West by the Macraes District from Mount Fortune to the Silver Peak Hills; on the South-east by a line drawn from the summit of the north-west point of the Silver Peak Hills to Mount Trotter, thence by Trotter Creek to Mount Royal, thence by Stony Creek to the sea; and on the East by the sea to the Kartigi Beach.

183. HAWKSBURY DISTRICT.

Bounded on the North-west by the Palmerston District from Stony Creek to the Silver Peak Hills; thence by the south-eastern boundary of the Macraes District to the junction of the Sutton Stream and the Taieri River; towards the South-west by the Taieri River; towards the South by the North Taieri and Blueskin Districts to the sea; and towards the East by the sea from the Waihema Creek to the Stony Creek. Excepting the Town of West Hawksbury District herein next defined.

184. TOWN OF WEST HAWKSBURY DISTRICT.

Bounded towards the North by the Main North Road, 4100 links; towards the East by the Government Township of Hawksbury, 8000 links; towards the South by land sold to John Jones, 2000 links; and towards the West by the other part of Section 15, Block VI, Hawksbury District aforesaid, 7500 links; be all the said linkages more or less, as the same is delineated in the map of the said Township of West Hawksbury, deposited in the office of the Registrar of Deeds at Dunedin.

185. MACRAES DISTRICT.

Bounded on the West by the Hyde District; on the North-west by the Naseby District; on the North-east by the boundary line of the Otago Gold Fields along the Kakanui Range to Mount Fortune; on the East by the said boundary line of the Otago Gold Fields to the north-west point of the Silver Peak Hills, said point being due west of Watkins' Hill; and on the South by an imaginary line running due west from said point on the Silver Peak Hills to Mount Stoker, and thence to the junction of the

Sutton Stream with the Taieri River on the boundary of the Hyde District.

186. HYDE DISTRICT.

Bounded on the North by the Teviot District; on the North-east by the Hindon District; on the South-east by the Outram and the Waipori Districts to the Tokomaripo River; thence along the north-western boundary of the North Tokomairiro Hundred to Lovell's Creek; on the South-west by Lovell's Creek to Mount Stuart, thence by an imaginary line running north-west to the Waitahuna River; and thence in same direction to Crook Burn; on the South by the Crook Burn to its junction with the Clutha River; on the West by the River Clutha to the junction of the Black Clough Burn therewith, thence by the Black Clough Burn to the summit on the Tapanui Range, thence by an imaginary line along the watershed of said range to Spylaw Hill, on the boundary of the Teviot District. Bounded towards the N.N.W. and W.N.W. by suburban lands, part of Block No. 1, Upper Kaikorai District; towards the N.N.E. from the Town Belt boundary by the prolongation of the centre of Argyle Street from its intersection with Heriot Row, Constitution and Elder Streets; towards the N.N.W., E.N.E., and N.N.E. by the centre of Elder Street, part of Pitt Street, and Frederick Street, from the aforesaid intersection at Argyle Street to and including its prolongation through the harbour reclamation to the harbour; towards the S.E. by the harbour; towards the S.S.W., S.S.E., and S.S.W. by High Ward District.

237. LOTHIAN DISTRICT.

Bounded on the North by the Mabel and Waimumu Districts; on the East by the Mataura; and on the South and West by the One-Tree Point and Myross Districts.

238. MYROSS DISTRICT.

Bounded on the North by the Makarewa; on the West by the west boundary of Sections 59, 50, 49, and Bush Reserve, Block X, Sections 25, 13, and 12, Block IX., and Section 1, Block IX., Sections 34, 21, and 6, Block IV., Invercargill Hundred; on the South by the Waihopai and the north boundary of Blocks VII. and VIII., Invercargill Hundred; and on the East and North-east by the east and north-east boundaries of the Invercargill Hundred.

239. MABEL DISTRICT.

Bounded on the North-west by the Makarewa; on the North by the north boundary of Block I., Forest Hill and the Hedgehope; on the East by the east boundary of the Forest Hill and Mabel Hundreds; on the South by the road from Invercargill to Dunedin; and on the South-west by the north-east boundary of the Invercargill Hundred.

240. WAIMUMU DISTRICT.

Bounded on the West by the Forest Hill Hundred and the Mabel Hundred; on the South by the Dunedin Road and the north boundary of Block XXXV., and Sections 9, 11, 12, and 14, Block III., Lothian Hundred, the north boundary of Mataura Hundred, the north boundary of Block LVII.; on the East by the Mataura and the west boundary of Run 116; on the North by the north boundary of the Waimumu Hundred.

241. TARINGATURA DISTRICT.

Bounded on the North by a line due west from the junction of the Paikerewao with the Mataura till it cuts the bush, thence by the north-east face of the bush to the north-west boundary of the late Province of Southland; on the North-west and North by the north-west and north boundary of the said late Province; on the West by the west boundary of Runs by the Aparima River; on the South by the north 188 and 198; on the South and again on the West boundary of the hundreds; and on the East by the Mataura River.

242. WAKATIPU DISTRICT.

Bounded on the North-west by the boundary of the late Province of Southland; on the North-east and East by the Mataura; and on the South by the Taringatura District.

243. TE ANAU DISTRICT.

Bounded on the North by the north boundary of the late Province of Southland; on the West by the Waiau; on the South by the Waiau District; and on the East by Runs 188, 198, and 187.

244. WAIKAI DISTRICT.

Bounded on the West by the Waiau; on the South by Aparima Hundred and Longwood District; on the East by the Aparima River; and on the North by the Waiau River from the most northern corner of Run No. 413 to its junction with the Waicooe Creek, thence by that creek to its source, thence by a line to the most northerly source of the Wairaki River, thence by that river to the western boundary of Run No. 187, thence by that boundary to the Aparima River, and thence by that river to its junction with the Braxtonburn.

245. MOUNT PLEASANT DISTRICT.

Bounded on the North by a due east and west line (true bearing) on transit with Trigonometrical Station V. on Woody Knoll; on the East by the Aparima River; on the South by part of the Jacob's River Hundred; on the West by a due North and South line (true bearing) in transit with the top of Ferndunlaw Hill.

246. ORETIKI DISTRICT.

Bounded on the North by an east and west line from Ferndunlaw to the Waiau; on the West by the Waiau; on the South-west and South by the sea; and on the East by Jacob's River Hundred.

247. LONGWOOD DISTRICT.

Bounded on the North by an east and west line north of the bend of the river in Section 46, Block III., Jacob's River Hundred; on the West by the west boundary of the Jacob's River Hundred; on the South by the sea; and on the North and East by the sea, Jacob's River Estuary, and the Pourapourakino River.

248. JACOB'S RIVER DISTRICT.

Bounded on the North by the north boundary of the hundred; on the East by the Jacob's River; on the South and South-west by the estuary and the Longwood District; on the West by the west boundary of the Jacob's River Hundred.

249. TOWN OF RIVERTON DISTRICT.

Bounded towards the North-east by Block VI., Jacob's River Survey District; towards the South-east by the Maori Reserve; and towards the West by Jacob's River Estuary.

250. SOUTH RIVERTON TOWN DISTRICT.

Bounded on the North and East by the sea and Jacob's River Estuary; on the South and East by the south-eastern boundary of Section 3, Block II., Jacob's River Hundred; on the South and West by the south-western boundary of Sections 9 and 13, Block II., and 3, 4, 5, 6, and 7, Block I., Jacob's River Hundred; and on the North-west by the north-western boundary of Section 7, Block I., Jacob's River Hundred aforesaid.

251. WAIMATUKU DISTRICT.

Bounded on the West by the Jacob's River; on the East by the east boundary of the Jacob's River Hundred; and on the South by the sea.

252. NEW RIVER DISTRICT.

Bounded on the North by north boundary of New River Hundred; on the East by the Oreti; on the West by the Waimatuku; and on the South by a due west line from the junction of the Oriti and Makarewa to the ocean beach.

253. HEDDON BUSH DISTRICT.

Bounded on the North by a due east and west line (true bearing) in transit with Trigonometrical Station V., on Woody Knoll; on the East by the

Oreti River; on the South by the New River Hundred; and on the North by the Aparima River.

254. WINTON DISTRICT.

Bounded on the North by the north boundary of Winton and Forest Hill Hundred; on the East by the Waimumu Hundred; on the South by the Hedgehope and the north boundary of Block I., Forest Hill Hundred, continued west to meet the south boundary of Winton Hundred, thence by the said south boundary of the Winton Hundred; and on the West by the Oreti River.

255. WALLACE TOWN DISTRICT.

Bounded on the North by the north boundary of the New River Hundred and a line in continuation thereof to the Makarewa; on the South-east and South by the Makarewa; and on the West by the Oreti River.

256. WAIKEWI DISTRICT.

Bounded on the North by an east and west line from the junction to the sea beach and the Makarewa; on the East by the east boundary of the Waikewi Road District; on the South by the Waihopai and the New River Estuary; and on the South-west by the sea.

257. WAIHOPAI DISTRICT.

Bounded on the South by the road forming the north boundary of the Town of Invercargill; on the West by the west boundary of Section 1, Block I., Invercargill Hundred; on the South by the road from Invercargill to Dunedin; on the East by the west boundary of Block II., Invercargill Hundred; and on the North and West by the Waihopai and New River Estuary.

258. TOWN OF INVERCARGILL DISTRICT.

Bounded on the North by Sections 27 and Park Reserve Block I., Invercargill Hundred; on the East by Sections 1, 14, and 8, Block I., Invercargill Hundred; on the South by Section 1, Block III., Invercargill Hundred; and on the West by the New River Estuary.

259. APPLEBY DISTRICT.

Bounded on the North by the Waihopai District and the Town of Invercargill; on the West by the Town of Invercargill and New River Estuary; on the South by south boundary of Invercargill Hundred; and on the East by the east boundary of Block II., Invercargill Hundred, continued south to meet the south boundary.

260. CAMPBELLTOWN DISTRICT.

Bounded on the North by Appleby District; on the North by the New River Estuary; on the West by Foveaux Straits; on the South by the sea; and on the East by the east boundary of the Campbelltown Road District.

261. TOWNSHIP OF CAMPBELLTOWN DISTRICT.

Being all that portion of Campbelltown Hundred known as the Township of Campbelltown.

262. STEWART'S ISLAND DISTRICT.

Comprises Stewart's Island, Sclanders' Island, Ruapuke Island and other islands adjacent thereto.

263. CHATHAM ISLANDS DISTRICT.

Comprises the group known as "The Chatham Islands."
