HEREAS by "The Immigration and Public Works Act, 1874," (hereinafter referred to as "the said Act,") it is, amongst other things, enacted that whenever, by virtue of any Proclamation made under the sixth section of "The Immigration and Public Works Act, 1873," any lands shall have been declared to be waste lands of the Crown in the manner provided in the said section, it shall be lawful for the Governor from time to time by Proclamation to take effect from a day to be named therein, or without naming any such day, to withdraw all or any part or parts of such lands from the operation of the provisions of the said sixth section: Provided that nothing in the now reciting Act contained, shall prejudice or affect the sale of any such lands or any part or parts thereof, or any contract or agreement for the sale of any such lands or any part or parts thereof made before any such Proclamation shall take effect as aforesaid. take effect as aforesaid:

And whereas by Proclamation bearing date the twenty-fourth day of June last, published in the New Zealand Gazette of the twenty-fifth June last, I, Sir James Fergusson, Baronet, the Governor of New Zealand, in exercise and pursuance of the provisions contained in the said sixth section, and being satisfied that the lands in the Schedule to the said Proclamation described were free from native claims and all difficulties in connection therewith, did proclaim and declare that the said lands, including amongst others the lands mentioned and described in the Schedule hereto, should be, and the same did thereby become, waste lands of the Crown, subject (except as by the said sixth section is provided) to be sold and dealt with as in the said Proclamation

And whereas it is expedient that the said lands described in the Schedule hereto should be withdrawn from the operation of the provisions of the said section:

Now therefore, I, the Right Honorable Sir James Fergusson, Baronet, the Governor of the Colony of New Zealand, in exercise and pursuance of the power and authority vested in me by the said Act, do hereby proclaim and declare that the lands mentioned and

the day of the date hereof, be withdrawn from the operation of the said sixth section of "The Immigration and Public Works Act, 1873," and the said last-mentioned lands are hereby released and discharged from the effect and consequences of the said hereinbefore recited Proclamation as if the same had never been made.

At the Government House, at Wellington, this fifth day of September, 1874.

Present: HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Wellington Special Settle-ments Act, 1871," it is, among other things, enacted that it shall be lawful for the Superintend ent of the Province of Wellington, with the advice of his Executive Council, by Proclamation in the Government Gazette of the said province, to set aside, out of the waste lands within the Province of Wellington the Native title of which has been extinguished, any block or blocks for the purpose of special settlement,

not exceeding in the whole one hundred thousand acres, on such terms as may be sanctioned by the Governor in Council, anything in the existing regulations for the management or disposal of the waste lands in the province to the contrary notwithstanding:

And whereas the said Superintendent, with the advice of his Executive Council as aforesaid, hath proposed to set aside the block of land in the township of Carnarvon, in the Manawatu district, in the said province, described in the First Schedule hereto, containing twenty-one thousand eight hundred acres more or less, as a special settlement under the said Act, for the members of an Association formed for the purpose of draining and improving the said block of land, and locating families of settlers thereon, and which said Association is represented at present by John Douglas, of Otago, Gentleman, upon the terms hereinafter mentioned:

And whereas the said Superintendent, with the advice of his Executive Council as aforesaid, hath requested the Governor to sanction the said terms:

Now therefore, His Excellency Sir James Fergusson, Baronet, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in him by the said Act, and by and with the advice and consent of the Executive Council of the said colony, doth hereby sanction the terms set forth in the Second Schedule hereto as the terms under which the said proposed special settlement shall be made under the said Act.

TERMS AND CONDITIONS FOR THE OCCUPATION AND PURCHASE OF THE BLOCK OF LAND PROPOSED TO BE SET ASIDE FOR THE PURPOSE OF SPECIAL

1. In the construction of these terms and conditions, unless the context shall otherwise require, the following expressions shall have the meaning hereby assigned to them :- "Association," shall mean the said John Douglas and the persons associated or to be associated with him for the purposes aforesaid. "Land" shall mean the block of land described in the First Schedule hereto. "Purchaser" shall mean any one purchasing on behalf of the Association the said land. "Receiver of Land Revenue" shall mean the Receiver of Land Revenue at Wellington, or other the officer for the time being acting as such. "The said Act" shall mean "The Wellington Special Settlements Act, 1871."

2. All moneys required to be paid for the land under these terms and conditions shall be paid to the Receiver of Land Revenue, and receipts given by him shall be sufficient discharges for the payment of the moneys therein respectively acknowledged to have

3. The price of the land shall be twelve shillings Land Revenue in cash, immediately after the publication of this Order in Council; and for the purpose of such payment the area of the said land shall be taken to be 21,800 acres.

4. The external boundaries of the land shall be surveyed at the cost of the Provincial Government of Wellington, by a qualified surveyor, to be approved by the Superintendent of the Province of Wellington,

And if on such survey the same without delay: shall be found to contain a greater area than 21,800 acres, the Association shall pay to the Receiver of Land Revenue, for every acre in excess of 21,800 acres, the price of twelve shillings and sixpence per acre; but if the same shall be found to be less than 21,800 acres, the Superintendent of the Province of Wellington shall pay to the Association, out of the revenues of the said province, the sum of twelve shillings and sixpence per acre for every acre less than 21,800 acres the land shall be found to contain.

5. The Association shall, immediately after the com-

pletion of the survey of the land, and upon production to the Commissioner of Crown Lands for the Province of Wellington, and satisfying the said Commissioner that the conditions hereafter contained have been fulfilled, be entitled to a grant from the Crown of the said land in fee-simple (except of the block of seven thousand acres hereafter mentioned), to the said John Douglas, his heirs and assigns, or to him or them jointly, with any other person or persons he or they may in writing require. And all usual and accustomed fees payable for or in respect of the issue of the said Crown grant shall be paid by the Association.

(a.) That the Association will, within two years and six months from the date of this Order in Council, expend a sum of £10,000 at the least upon the said land, and in draining and

otherwise improving the same.

(b.) That the Association will, for and during the period of one year at the least from and after the date of this Order in Council, employ forty men at the least upon the said land, and in draining and otherwise improving the same.

(c.) That the said Commissioner of Crown Lands shall and may within six months from the date of this Order in Council, select out of the said land in one or more blocks seven thousand acres, which in his judgment shall be suitable for the settlement of and occupation by the settlers hereinafter mentioned, which land so selected is hereafter referred to as the "Selection Blocks," and the said block shall be surveyed and laid out by the Association in sections of

one hundred acres each.

(d.) That the Association will, before the 4th day of September, 1876, place upon the selection block at least seventy families of persons desirous to settle on the said Selection Blocks, and the terms and conditions upon which such persons shall be entitled to settle on such Selection Blocks shall be, that the head of each family shall have the right, at any time within the period of five years from the said 4th day of September, 1876, to acquire by purchase one hundred acres of the said Selection Blocks at a price of two pounds per acre, to be paid to the said Association by equal annual instalments during the four years following the selection by the settler of his land: Provided that the person selecting may, at any time within the said four years, pay up the balance unpaid of the said sum of two pounds per acre.

(e.) Each head of such family shall be entitled to a Crown grant of the land selected by him upon proof to the satisfaction of the Commissioner of Crown Lands that he has been continuously in the occupation of the land selected by him, and has paid to the Association the sum of two pounds per acre of the land selected by him.

(f.) The said Commissioner of Crown Lands shall also cause to be surveyed and laid off, out of the said land to be conveyed to the said Association, four hundred acres of land, in not more than two blocks, as reserves for Natives, to be dealt with and disposed of as the Governor may from time to time direct; and the said four hundred acres shall be excepted from the grant to the said Association.

6. The Crown grant of the land to be granted to the Association shall be withheld from the Association until the conditions hereinbefore contained have been fulfilled to the satisfaction of the Commissioner of Crown Lands.

And whereas by "The New Zealand Settlements Amendment and Continuance Act, 1865," it is enacted that the order and manner in which land taken under the authority of "The New Zealand Settlements Act, 1863," and "The New Zealand Settlements Amendment and Continuance Act, 1865," should be laid out for sale and sold, should be at the discretion of the Governor, who shall have power to cause such land or any part thereof to be laid out for sale and sold from time to time in such manner, for such consideration, and in such allotments as he shall think fit, and subject to such regulations as he shall, with the advice of the Executive Council, from time to time prescribe:

And whereas by "The New Zealand Settlements Amendment Act, 1866," it is provided that the said lands shall be sold for such consideration or at such price, and whether for cash or otherwise, as the Governor shall from time to time prescribe; and that all lands taken under the authority of the said "New Zealand Settlements Act, 1863," and "The New Zealand Settlements Amendment and Continuance Act, 1865," or either of them, and sold or disposed of under the authority of the said first-recited Act, shall be sold or disposed of under regulations to be made by the Governor in Council, which regulations shall be published in the New Zealand Gazette:

And whereas under the hereinbefore in part recited powers, the Governor in Council did, on the eleventh day of May, one thousand eight hundred and seventyone, make and issue certain regulations for the sale and disposal of confiscated lands as therein provided:

And whereas the said regulations provide for the making of reserves of such lands for the purposes therein specified, and it is provided that the purposes for which any reserves have been made may be changed, or the reservation of the same withdrawn by the Government, but so that no change or withdrawal shall be made except after notice of three months in the New Zealand Gazette, and by special Order of the Governor in Council:

And whereas the parcel of land hereinafter particularly mentioned has been reserved and set apart under regulations made under the authority of the said in part recited Acts, and it is expedient that the purpose of the same should be changed:

The births were 316 in August, against 269 in July, while the deaths were 4 more in number than the deaths in July.

Of the deaths, males contributed 53; females, 55: 53 of the deaths were of children under 5 years of age, being 49 07 of the whole number; 25 of these were of children under 1 year of age.

The deaths of children under 5 years of age exceeded those in July by 7.

Three females died aged respectively 65, 68, and 71 years; 6 males died between the ages of 65 and upwards, the oldest

being 79.

Three of the above 9 deaths occurred in Wellington, and 3 in Dunedin.

The following Table shows the Causes of the Deaths of Persons of both Sexes under 5 years of age and 5 years and upwards, and the proportions per cent. of Deaths from each cause in the Boroughs named, and that were registered, during the month of August, 1874.

The number of deaths from Zymotic Diseases is the same as in July. There is a slight increase in deaths from Constitutional Diseases upon the July deaths, but yet they are fewer than they were in June. There were 11 deaths from Phthisis, of which 5 occurred in Dunedin; they were all deaths of adults of 23 years and upwards—one of the persons dying from that cause being of the age of 67. The deaths being limited to persons of mature ages, leads to the inference that many of them arrived in the colony with their lungs already diseased. Deaths from Local Diseases were less numerous in August, being 12 less than in July—the great reduction being in diseases of the Nervous System. Diseases of the Respiratory System were, however, on the increase, the deaths from Bronchitis alone having increased from 5 to 14. More deaths occurred from diseases of the Respiratory System in Christchurch than in any other borough. In Auckland there were 2, in Dunedin 2, in Christchurch 11, and in Wellington 5 deaths of this class

There appears to have been during August a more than usually heavy rainfall throughout the Colony north of Canterbury. In Nelson the increase was most remarkable, being 14 265 inches in excess of the average rainfall in former years.

Notes for July, 1874.

Mongonui.—Rather a fine month for time of year; maximum rainfall recorded on 8th, 0.88 inch; high winds on 7th from N. and on 21st from S., with rain; on latter date hail and thunder; thunder also on 11th and 15th; prevailing winds S.W., and generally moderate. Maximum temperature in shade, 65°; minimum, 35°.

Auckland.—Very showery, but total rain rather under average; maximum fall registered on 7th, 0.555 inch; wind prevailed from S; strong squalls on 12th and 20th from S.W.; thunder on 15th. Maximum temperature, 64.6°; minimum, 35°.

Taranaki.—Cold, wet weather, with a few fine bright frosty days; greatest rainfall recorded on 15th, 1.86 inch; southerly winds prevailed and moderate, except on 11th and 14th, when it blew strong from that quarter, accompanied by thunder and hail on 14th. Maximum temperature, 64°; minimum, 30°.

Napier.—Changeable weather, though fine at times; cold, and occasionally frosty nights; maximum rain on 12th and 15th, 0.29 inch; prevailing southerly winds, no strong gales. Maximum temperature, 68°; minimum, 31°.

Wellington.—Very wet, cold, and severe weather during this month, with only a few bright days; very stormy at times, especially on 6th, 10th, and 11th, from N.W. with rain; on 15th, S.E., and 16th and 17th from S.W., with rain and hail; and on 21st and 22nd from S.W., with slight rain; foggy on 4th and 31st; prevailing N.W. and S.E. winds; maximum rainfall on 16th, 1.50 inch for previous 24 hours. Maximum temperature, 58°; minimum, 33°.

Wanganui.—Raw and cold with frequent rain and stiff breezes, generally from W.; on 11th and 12th heavy rain, causing fresh in river, 1.32 inch recorded on 12th; and on 14th there was a heavy westerly gale; snow on 20th, fog on 30th. Maximum temperature, 59°; minimum, 32°.

Wanganni.—Raw and cold with frequent rain and stiff breezes, generally from W.; on 11th and 12th heavy rain, causing fresh in river, 1'32 inch recorded on 12th; and on 14th there was a heavy westerly gale; snow on 20th, fog on 30th. Maximum temperature, 59°; minimum, 32°.

Nelson.—Showery weather, but less total rain than usual, very light winds prevailing from S.E. and E.; greatest rainfall recorded on 1st for previous 24 hours, 1'36, and 1'08 inch registered on 7th; cold weather generally. Maximum temperature, 60°; minimum, 25° in shade.

Cape Campbell.—Strong S. and S.E. winds prevailed, often reaching to a gale; rainfall small, the maximum recorded on 15th, 1'85 inch. Maximum temperature, 62°6°; minimum, 37°.

Christchwarch.—Showery throughout and cold, but very slight total rainfall for time of year; winds moderate, and chiefly from S.W.; snow on 20th, 21st, and 24th, occasionally fine days but dull; maximum rainfall on 21st, 0'35 inch. Maximum temperature, 62°; minimum, 26'1° in shade.

Bealey.—Showery unpleasant weather, with occasional fine days, very cold and severe; small rainfall on the whole, the maximum occurred on 6th, 2'35 inches for previous 24 hours; wind changeable and light, but strong gale on 6th from N.W. with thunder; thunder also on 10th; snow fell on 8 days; fog on 7 days. Maximum temperature, 50'4°; minimum, 23'7° in shade.

Hokitika.—Showery and cold weather generally, though rainfall below the average, the maximum recorded on 6th, 3'10 inches; prevailing E. and N.E. winds, and generally moderate; on 6th and 7th heavy squalls from N.E., with rain and thunder on 6th; on 10th short gale from N. with rain, and on 20th heavy rain and wind from W. to S.E.; fog on 2nd; fine weather at times though very cold. Maximum temperature, 61'7°; minimum, 26'9°.

Dunedin.—Weather changeable, very severe from 15th to 21st, with heavy falls of snow, and towards end of month it was extremely fine, with light winds; small rainfall, the maximum recorded on 12th, 20th, and 21st; heavy rain, the maximum fall

GENERAL REMARKS.

Except at some of the Stations in the North, the rainfall is generally under the average for previous years, and with one or two exceptions the winds have been moderate; the temperature, however, has been considerably below the average throughout, and high atmospheric pressure prevailed; frequent snow and hail storms occurred, and frosts, causing the weather to be unusually severe. Earthquakes were reported at Opunake on 4th, at 9:35 p.m., sharp, preceded by loud rumbling; on 28th at Wanganui, 4:37 p.m., sharp shock, direction N.E. to S.W., 20 seconds duration; and at Opunake on same date a slight shock at 4:35 p.m., direction N. to S. Aurora visible in South on 25th.
