A PROCLAMATION. WHEREAS by "The New Zealand Native Reserves Act, 1856," it is, amongst other things, provided that when any lands within the jurisdiction of any Commissioners of Native reserves shall have been or shall be reserved or set apart for the benefit of the aboriginal inhabitants over which the Native title shall have been extinguished, such Commissioners shall have and exercise over such lands full power of management and disposition, subject to the provisions of that Act: And whereas by "The Native Reserves Amendment Act, 1862," the powers and duties of the Commissioners of Native Reserves are transferred to the Governor, who may by the provisions of the same Act delegate such power and duties: And whereas the Native title of the land mentioned in the Schedule hereunder written

the land mentioned in the Schedule hereunder written has been extinguished, and it is desirable that its management and disposition should remain with and vest in the Governor or his delegate: Now therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of the Colony, doth proclaim and declare that the land set forth in the Schedule hereunder written has been set apart for the hereeft of the written has been set apart for the benefit of the aboriginal inhabitants.

Changing Purpose of Reserve in Westland.

ORDER IN COUNCIL. At the Government House, at Wellington, this twenty-fourth day of August, 1875.

WHEREAS by "The Westland Waste Lands Act, 1870," it is, among other things, enacted, that reserves theretofore or thereafter to be made of waste lands shall be managed and administered by the Governor in Council: And it is also enacted that the specified purposes for which any reserves shall be held may be changed, and any such reserves may be leased, mortgaged, or sold, either in whole or in part, by the Governor in Council as therein men-tioned: And whereas the parcel of land described in the Schedule hereto was, on the date and in the in the Schedule hereto was, on the date and in the manner therein mentioned, declared to be a reserve for the purposes therein set forth, and such reserve is now subject to the provisions of the said Act: And whereas it is expedient that the purpose of such reserve should be changed :

Now therefore, His Excellency the Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in him by the hereinbefore in part recited Act, and by and with the advice and consent of the Executive Council of the said Colony, doth hereby order that the purpose for which the said reserve was originally made shall be changed, and the same shall be and become a reserve for the purposes of a public racecourse; and the lands in the Province of Westland, the boundaries whereof are described in the said Schedule hereunto annexed, are hereby reserved accordingly for a racecourse.

Negotiations for Purchase of Tuwhakatupua Block.

WHEREAS by "The Immigration and Public Works Act Amendment Act, 1871," the Governor is, among other things, empowered to enter into arrangements for the acquisition of particular portions of land in the North Island for the purpose of mining for gold, for the establishment of special settlements, or for the purpose of railway construction:

And by the said Act it is also provided that it shall be lawful for the Governor, whenever he shall have determined to enter into negotiations for the purchase of such land, to insert a notice in the New Zealand Gazette that it is his intention to enter into such negotiations, and after such notice is inserted it shall not be lawful for any one to purchase or acquire from the Native owners any right, title, or interest, or contract for the purchase or acquisition from the Native owners of any right, title, or in-terest, in the lands specified in such notice, unless the notice be cancelled by the Governor: Provided that no such notice shall have longer operation than

for the period of two years : Now therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance of the provisions of the hereinbefore in part recited Act, and in exercise of the powers thereby vested in me, do hereby give notice that it is my intention forthwith to enter into negotiations for the purchase from the Native owners of the block or parcel of land situate in the Province of Wellington, and described in the Schedule hereto.

 Mongonui.—Fine to the 9th; from 10th to 13th strong gales from East, and rain; the maximum rainfall recorded on 12th, 5.66 inch; from 14th to 29th, fine westerly weather; fog on 18th; on 30th a N.E. gale and rain; prevailing westerly winds. Maximum temperature in shade, 49°; minimum, 41°.
 Auckland.—Showery and dull, with intervals of bright clear weather; prevailing westerly winds, and strong on 20th from S.W.; the maximum rainfall recorded on 12th, 1.620 inch. Maximum temperature in shade, 64°; minimum, 39°5.
 Taranaki.—Wet and unpleasant, with a few fine days; maximum temperature in shade, 64°; minimum, 33°.
 Nopier.—Very wet and unsettled weather; the greatest fall of rain recorded on 20th, 303 inch; prevailing southerly winds, and strong on 7th and 20th; fog on 29th and 30th. Maximum temperature in shade, 64°; minimum, 34°.
