HIS EXCELLENCY THE GOVERNOE IN COUNCIL.

THEREAS by the nineteenth section of "The W Public Health Act, 1872," it is enacted that the Governor in Council may make orders from time to time directing that the provisions thereinafter in Second Part of the said Act contained, or any of them, be put in force in New Zealand, or in such parts thereof or in such places therein as in such orders respectively may be expressed, and may in like manner revoke or renew any such order; and, subject to such re-vocation or renewal as aforesaid, every such order shall be in force for six calendar months from the publication of such order, or for such shorter period as in such order shall be expressed, and no longer; and every such order shall be published in the General Government Gazette, and such publication shall be conclusive evidence of such order to all intents and purposes; and none of the said provisions shall be in force in any part of New Zealand until an order directing the same to be put in force shall have been made and published as aforesaid :

Now therefore, His Excellency the Governor, with the advice and consent of the Executive Council, and in exercise and pursuance of all power and authority in this behalf in him vested, doth hereby direct that the provisions contained in the sections of the said Act numbered from twenty to forty-five, both in-clusive, shall be put in force in the Province of Nelson.
