*Orphan Asylum, Lyttelton, to be an Industrial School.*

PROCLAMATION.

WHEREAS by "The Neglected and Criminal Children's Acts Amendment Act, 1875," it is enacted that the Governor may from time to time, by Proclamation in the *New Zealand Gazette*, declare that any public school in which orphan children are received and educated, either wholly or partly out of public funds, shall be an Industrial School for the purposes of "The Neglected and Criminal Children's Act, 1867," or for such particular parts of the said Act as shall be mentioned in any such Proclamation; and, from and after a date to be fixed in and by such Proclamation, such school shall be deemed to be an Industrial School for the purposes in such Proclamation set forth:

And whereas the Orphan Asylum at Lyttelton, in the Province of Canterbury, is a public school in which orphan children are received and educated either wholly or partly out of the public funds; and whereas it is expedient that such Orphan Asylum should be declared to be an Industrial School, for the purposes hereinafter appearing:

Now therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the above recited Act, do hereby proclaim and declare that the said Orphan Asylum at Lyttelton shall be, from and after the first day of January next, an Industrial School for the purposes set forth in the said twenty-

third section of the said "Neglected and Criminal Children's Act, 1867."

that the Governor may from time to time, by Proclamation published in the *New Zealand Gazette*, appoint any hulk, ship, or floating prison to be used as and to be a public prison for the reception and safe keeping of prisoners convicted and sentenced for any offences by any Court in New Zealand; and may from time to time define, by Proclamation published as aforesaid, the limits and boundaries around such hulk within which no person shall come, and the place of embarking and landing prisoners to and from such hulk; and that any such Proclamation as aforesaid may from time to time be altered or revoked by the Governor:

And whereas by a Proclamation bearing date the seventeenth day of December, one thousand eight hundred and seventy-four, the hulk called the "Sarah and Esther," then moored off Tahita Point, in the Otago Harbour, was appointed to be a public prison within the meaning of the said Act, and the space of twelve yards around such hulk was defined to be the limits and boundaries within which no person should come, and Deborah Bay was defined to be the place of embarking and landing prisoners to and from such hulk:

And whereas owing to an alteration in the position of the said hulk, it is expedient to alter the said Proclamation:

Now therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the said Act, do hereby define Otago Peninsula to be the place of embarking and landing prisoners to and from such hulk.

*Constituting Districts under "The Debtors and Creditors Act, 1875."*

(L.S.) NORMANBY, Governor.

A PROCLAMATION.

WHEREAS by "The Debtors and Creditors Act, 1875," it is enacted that the Governor may from time to time, as he thinks fit, by Proclamation in the *New Zealand Gazette*, constitute any part of New Zealand into a district under this Act, and such districts may be coterminous with a district under "The District Courts Act, 1858," or not, and may abolish any such district, or alter the boundaries thereof, and declare by what local name each such district shall be called:

Now therefore, I, George Augustus Constantine,

Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me, do hereby proclaim and constitute the districts described in the Schedule hereto to be districts under the said "Debtors and Creditors Act, 1875," and do also hereby declare that such districts shall be called by the local name set over the descriptions of such districts.

SCHEDULE.

AUCKLAND DISTRICT.

This district comprises all that portion of the Province of Auckland bounded towards the North and East by the sea from Cape Maria Van Diemen to Matakawa Point; thence towards the South-east by a right line to the north-western corner of the Province of Hawke's Bay; towards the South by the southern boundary of the Province of Auckland; towards the West and North-west by the Province of Taranaki; and towards the West and South-west by the sea; together with the adjacent islands.

TARANAKI DISTRICT.

This district comprises the whole of the Province of Taranaki, and is coterminous with the District Court District.

HAWKE'S BAY DISTRICT.

This district comprises the whole of the Province of Hawke's Bay, and that portion of the Province of Auckland which lies to the south-eastward of the Auckland District hereinbefore defined; together with the adjacent islands.

WELLINGTON DISTRICT.

This district comprises the whole of the Province of Wellington; together with the adjacent islands, and Chatham Island, and its adjacent islands.

NELSON DISTRICT.

This district is bounded towards the South-east by the boundary of the Province of Nelson, from the sea to the Top House; thence towards the South by a right line to the confluence of the Rotoroa River with the Buller River; thence towards the West by a right line to the summit of Mount Arthur; thence again towards the South by a right line to the mouth of the Karamea River, and on all other sides by the sea; together with the adjacent islands; and is coterminous with the District Court District.

WESTLAND DISTRICT.

This district comprises the whole of the Province of Westland, together with that portion of the Province of Nelson contained within the following boundaries; that is to say, towards the North by the Nelson District hereinbefore defined; towards the East by the Nelson District to the junction of the River Gowan, or Rotoroa, with the River Buller, and thence by a right line to the summit of Mount Princess; thence towards the South-east by a right line to the saddle between the Hurumui and Teremakau Rivers; thence towards the South-west by part of the southern boundary of the Province of Nelson to the sea; and thence towards the North-west by the sea to the mouth of the River Mackay, the commencing point; and is coterminous with the District Court District.

MARLBOROUGH DISTRICT.

This district is bounded towards the North and East by the sea, from Elaine Bay, in Tennyson Inlet, to the mouth of the Clarence River; towards the South by the Clarence River to its outlet from Lake Tennyson, and thence by a right line to the summit of Mount Princess; towards the West by the Westland District hereinbefore defined; and again towards the North and towards the North-west by the Nelson

District hereinbefore defined; together with the adjacent islands.

#### CANTERBURY DISTRICT.

This district is bounded towards the North by the Marlborough District hereinbefore defined; towards the South-east by the sea; towards the South-west by the south bank of the Ashburton River, and a right line due North-west to the summit of the main range of the Southern Alps; and towards the North-west by the Westland District hereinbefore defined; together with the adjacent islands.

#### TIMARU AND OAMARU DISTRICT.

This district is bounded towards the North-east by the Canterbury District hereinbefore defined; towards the East by the sea; towards the South-west by right lines from Vulcan or Shag Point along the summit of the Horse Ranges and the Kakanui Mountains, and a right line to Kye-burn Hill, and thence by a right line to Little Domett Peak; thence towards the South by a right line due west to the summit of the Hawkdun Mountains; again towards the South-west by right lines along the summit of the Hawkdun Mountains to a point due east of Mount St. Bathans; thence again towards the South by a right line to the summit of Mount St. Bathans; thence towards the West by a right line due north to the northern boundary of the Province of Otago; again towards the South by the said boundary of the Province of Otago; and towards the North-west by the Westland District hereinbefore defined; and is coterminous with the District Court District.

#### OTAGO GOLD FIELDS DISTRICT.

This district is bounded towards the North by the Westland and Timaru and Oamaru Districts hereinbefore defined; towards the East, North, and North-east by the Timaru and Oamaru District; again towards the East by a line from the summit of the Kakanui Mountains, following the nearest spur to the junction of the Deepdell Creek with the Waihemo or Shag River, thence by right lines from peak to peak along the watershed between the Waikouaiti and Taieri Rivers to Silver Peak, and thence by a right line to the source of Silver Stream, and along the said stream to the West Taieri Road; thence towards the South-east and South by the said road to the boundary of the Hundreds, thence by the boundary of the Hundreds to the east branch of the Tokomairiro River, thence by the said river to the Main South Road, by the Main South Road to Lovell's Creek, by Lovell's to the south-west boundary of Run No. 54, by the said boundary of said run to the Crook Burn, and by the Crook Burn to its junction with the Clutha River, and thence by a right line to a point twenty chains due west of the Clutha River; thence towards the West by a line parallel to the Clutha River to a point due east of Spylaw Hill; thence again towards the South and South-east by a right line to the summit of Spylaw Hill, thence by a right line to the source of Spylaw Burn, thence by the Spylaw Burn to its junction with the Pomahaka River, thence by the Pomahaka River to the confluence of the Parasol Creek, thence by the said creek to its source, and by a right line thence to the summit of Black Umbrella Mountain, thence by right lines from peak to peak along the range between the western branch of the Waihaka River and the Otama Creek to the southern boundary of Run No. 193, and by that boundary to the Maitara River; thence towards the West by the Maitara River to its source, and by a right line to the summit of Eyre Peak, and thence by right lines from peak to peak along the western watershed of Lake Wakatipu to a point due east of Mount Christina; thence again

towards the South by a right line to the summit of Mount Christina, by a right line thence to the nearest source of the Cleddau River, and by that river and the southern shore of Milford Sound to the sea; and thence again towards the West by the sea to the mouth of the Awarua River, the commencing point; and is coterminous with the District Court District.

#### DUNEDIN DISTRICT.

This district is bounded towards the North-east by the Timaru and Oamaru District hereinbefore defined; towards the South-east by the sea; towards the South-west by the Taieri River, the eastern and northern shores of Lake Waipori, and the Meggat Burn, to the Otago Gold Fields District hereinbefore defined; and towards the North-west by the Otago Gold Fields District; and is coterminous with the District Court District.

#### TOKOMAIRIRO DISTRICT.

This district is bounded towards the North and North-east by the Otago Gold Fields and Dunedin Districts hereinbefore defined; towards the South-east by the sea; and towards the West by the meridian of 169° East longitude to the Suburban Hundred, by the eastern and northern boundaries of that Hundred to the Maitara River, and by the Maitara River to the Otago Gold Fields District; and is coterminous with the District Court District.

#### WESTERN OTAGO DISTRICT.

This district is bounded towards the North-east and East by the Otago Gold Fields and Tokomairiro Districts hereinbefore defined; and towards the South and West by the sea; together with the adjacent islands, and Stewart Island and its adjacent Islands; and is coterminous with the District Court District.
