Districts under "The Marriage Act Amendment Act, 1858."

(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by the second section of "The Marriage Act Amendment Act, 1858," it is enacted that it shall be lawful for the Governor from time to time, by Proclamation in the New Zealand Gazette, to divide the colony for the purposes of the said Act into such and so many districts as he shall think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's District; and further, that the districts existing at the time of the coming into operation of the said Act under any of the Acts repealed thereby shall, until altered, be deemed to be districts proclaimed under the said Act:

And whereas by a Proclamation duly made and issued, bearing date the sixth day of August, one thousand eight hundred and sixty-eight, the then Governor, in pursuance of the said recited power and authority, did, amongst others, constitute districts called the "Coromandel" District and the "Shortland" District, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the first day of September, one thousand eight hundred and sixty-eight:

And whereas it is expedient to revoke so much of the said Proclamation as relates to the said districts, and to divide anew the territory comprised within

such districts:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the said colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said Proclamation so far as the same relates to the Coromandel and Shortland Districts, and do proclaim and declare that the territory formerly comprised within the said districts shall be and is hereby divided, for the purposes of the said Act, into three districts, the names and boundaries whereof shall be as follows:—

COROMANDEL DISTRICT.

This district is bounded on the North and Northest by the sea from Wangapoua Harbour to Cape Colville; on the West by the sea from Cape Colville

to the Waikowhau Creek; on the South by said creek to its source, and thence by a right line to the summit of the watershed between the east and west coasts of the Coromandel Peninsula; thence on the East by right lines from peak to peak along the summit of said watershed to Castle Hill; thence by a right line due north to the source of the Opitonui Creek; thence by said creek to Wangapoua Harbour, the starting point.

MERCURY BAY DISTRICT.

This district is bounded towards the North and East by the sea from Wangapoua Harbour to the north-eastern corner of the Wharekawa East No. 2 Block; towards the South-east by the boundaries of the Wharekawa East No. 1 Block, to the south-western corner of the last-named block; thence towards the South-west by a right line to the summit of the watershed between the east and west coasts of the Coromandel Peninsula, and by right lines from peak to peak along the said watershed to Castle Hill; thence by a right line due north to the source of the Opitonui Crcek; thence by said ereek to Wangapoua Harbour, the starting point.

THAMES DISTRICT.

This district is bounded towards the North by the Coromandel District; towards the North-east and North-west by the Mercury Bay District to the sea; towards the East by the sea to the south head of Whangamata Harbour; thence towards the Southeast by a right line to the summit of Te Aroha, and by a right line to the junction of the Waitaruru Creek with the Piako River; towards the West by the Piako River to its mouth, and by the Frith of the Thames to the mouth of the Waikawau Creek.

And I do declare that this Proclamation shall come into operation and take effect on the first day of July, one thousand eight hundred and seventy-six.

Districts under "The Registration of Births and Deaths Act, 1875."

(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by the seventh section of "The Registration of Births and Deaths Act, 1875," it is enacted that it shall be lawful for the Governor from time to time, by Proclamation in the New Zealand Gazette, to divide the colony, for the purposes of the said Act, into such and so many districts as he shall think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's District; and further, that the districts existing at the time of the coming into operation of the said Act under any of the Acts repealed thereby shall, until altered, be deemed to be districts proclaimed under the said Act:

And whereas by a Proclamation duly made and issued, bearing date the sixth day of August, one thousand eight hundred and sixty-eight, the then Governor, in pursuance of the said recited power and authority, did, amongst others, constitute districts called the "Coromandel" District and the "Shortland" District, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the first day of September, one thousand eight hundred and sixty-eight:

And whereas it is expedient to revoke so much of the said Proclamation as relates to the said districts, and to divide anew the territory comprised within

such districts:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the said colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do herebyrevoke the said Proclamation so far as the same relates to the Coromandel and Shortland Districts, and do proclaim and declare that the territory formerly comprised within the said districts shall be and is hereby divided, for the purposes of the said Act, into three districts, the names and boundaries whereof shall be as follows:—

COROMANDEL DISTRICT.

This district is bounded on the North and Northeast by the sea from Wangapoua Harbour to Cape Colville; on the West by the sea from Cape Colville to the Waikowhau Creek; on the South by said creek to its source, and thence by a right line to the summit of the watershed between the east and west coasts of the Coromandel Peninsula; thence on the East by right lines from peak to peak along the summit of said watershed to Castle Hill; thence by a right line due north to the source of the Opitonui Creek; thence by said creek to Wangapoua Harbour, the starting point.

MERCURY BAY DISTRICT.

This district is bounded towards the North and East by the sea from Wangapoua Harbour to the north-eastern corner of the Wharekawa East No. 2 Block; towards the South-east by the boundaries of the Wharekawa East No. 1 Block, to the south-western corner of the last-named block; thence towards the South-west by a right line to the summit of the watershed between the east and west coasts of the Coromandel Peninsula, and by right lines from peak to peak along the said watershed to Castle Hill; thence by a right line due north to the source of the Opitonui Creek; thence by said creek to Wangapoua Harbour, the starting point.

THAMES DISTRICT.

This district is bounded towards the North by the Coromandel District; towards the North-east and North-west by the Mercury Bay District to the sea; towards the East by the sea to the south head of Whangamata Harbour; thence towards the Southeast by a right line to the summit of Te Aroha, and by a right line thence to Matamata; on the South by a right line to the junction of the Waitaruru Creek with the Piako River; towards the West by the Piako River to its mouth, and by the Frith of the Thames to the mouth of the Waikawau Creek.

And I do declare that this Proclamation shall come into operation and take effect on the first day of July, one thousand eight hundred and seventy-six.

Revocation of Proclamation prohibiting Importation to New Zealand of Grape Vines and Cuttings.

(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by a Proclamation made by His Excellency the Governor in Council, under the authority of "The Customs Regulation Act, 1858," bearing date the tenth day of November, one thousand eight hundred and seventy-four, and published in the New Zealand Gazette on the twelfth day of November of the same year, the importation into New Zealand of the following goods, that is to say, Grape Vines and Grape Vine Cuttings, was prohibited: And whereas it is expedient to revoke the said Proclamation:

Military Reserve changed to Lighthouse Reserve.

(L.S.) NORMANBY, Governor, A PROCLAMATION.

WHEREAS the parcel of land described in the Schedule hereto, being part of a piece of land containing about 670 acres, was set apart as a Military Reserve: And whereas it is expedient, under the powers conferred by the thirteenth section of "The Waste Lands Act, 1858," to change the specific purpose for which so much of said land as is described in the Schedule hereto was set apart:

Certain Articles declared to be Poisons under "The Sale of Poisons Act, 1871."

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the third section of "The Sale of Poisons Act, 1871," (hereinafter called "the said Act,") it is, amongst other things, enacted that

said Act,") it is, amongst other things, enacted that the Governor, by Order in Council, may from time to time declare that any article in such Order named shall be deemed a poison within the meaning of the said Act; and such Order shall be published in the New Zealand Gazette; and on the expiration of three months from such advertisement the article named in such resolution shall be deemed to be a poison within the meaning of the said Act:

Now, therefore, His Excellency the Governor of New Zealand, with the advice and consent of the Executive Council of the Colony, in pursuance and exercise of the power and authority vested in him in that behalf, doth hereby order and declare that from

and after twenty-ninth day of September, one thousand eight hundred and seventy-six, the following articles shall be deemed to be poisons within the meaning of the said Act, that is to say,—

Digitalis (commonly known as Foxglove), Carbolic Acid,

Carbolic Acid, Nitric Acid, Sulphuric Acid,

Chloral, Chlorodyne;

and that the provisions applicable to the poisons mentioned in the First Schedule to the said Act shall be applicable to the above-mentioned poison Digitalis.

"Telegraph Service of Notices Act, 1872," to apply to certain Documents issued in the Supreme Court.

NORMANBY, Governor. ORDER IN COUNCIL.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by "The Telegraph Service of Notices Act, 1872," it is enacted that the term "notice," when used in the said Act, means any notice or other document which by law or the agreement of parties is required to be served upon any person, or at his house or place of abode or business, in order that such person may be affected thereby; and to the end that the application of this Act may be put beyond doubt, the Governor in Council may, by Order from time to time, prescribe and define classes and kinds of notices or other documents which shall be included within the said term, and thereupon the said term shall be deemed to include all notices and documents falling within such classes and kinds so defined and prescribed, as if the same were in the said Act expressly mentioned as so included; and the Governor in Council may from time to time revoke or alter any such order:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in him as aforesaid, and by and with the consent and advice of the Executive Council, doth hereby define the term "notice" used in "The Telegraph Service of Notices Act, 1872," as including all notices and other documents of every kind in the course of proceedings in the Supreme Court, which the Supreme Court or any Judge thereof may by order require or permit to be served in the manner provided by the said "Telegraph Service of Notices Act, 1872," and the regulations thereunder for the time being in force.

Notification of Governor's Assent to Construction of Railway from Dunedin to Anderson's Bay, and Ocean Beach and Forbury.

NORMANBY, Governor. (L.s.)

WHEREAS by the seventh subsection of the fourth section of "The Railway Companies Act, 1875," (hereinafter called "the said Act,") it is, amongst other things, enacted that if any such proposed branch railway as is mentioned in the Act is approved of, and such approval is signified as hereinafter provided, then the company may proceed with the construction of such railway in accordance with the said Act: And it is further enacted that whenever the Governor shall approve of any proposed branch railway, he shall, by notice published in the New Zealand Gazette, declare his assent to the construction of the railway, and such notice, when so published, shall be sufficient notice to the company of such approval: And whereas the Dunedin, Peninsula, and Ocean Beach Railway Company (Limited) have deposited plans of a projected railway from the Dunedin and Clutha Railway to Anderson's Bay, and Ocean Beach and Forbury, at the office of the Registrar of the Supreme Court at Dunedin, and in other respects complied with the terms of the said Act: And whereas one-half of the whole body of the ratepayers resident within the highway districts through which the railway is proposed to be constructed have not objected to the construction of the railway: Now, therefore, His Excellency the Governor of New Zealand, in pursuance and exercise of the powers and authorities conferred on him by the hereinbefore in part recited Act, and in exercise of every other power enabling him in this behalf, doth hereby notify and declare that he consents to the construction of the said railway from the Dunedin and Clutha Railway to Anderson's Bay, and Ocean Beach and Forbury.
