Districts under "The Registration of Births and Deaths Act, 1875."

(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by "The Registration of Births and Deaths Act, 1875," it is enacted that it shall be lawful for the Governor from time to time, by Proclamation in the New Zealand Gazette, to divide the colony for the purposes of the said Act into such and so many districts as he shall think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's District; and it is provided that the Governor may from time to time alter or revoke any such Proclamation, and issue a new Proclamation dividing the colony or any portion of it anew into districts, or increasing the number of districts, or altering the boundaries of any district or districts, as from time to time he may think requisite; and further, that the districts existing at the time of the Acts thereby repealed, shall, until altered under the said Act, be deemed to be districts proclaimed under the said Act:

And whereas by a Proclamation duly made and issued, bearing date the fifteenth day of July, one thousand eight hundred and seventy-one, the then Governor, in pursuance of the power and authority vested in him, did constitute two districts for the purposes of the said Act, called the Christchurch District and the Ellesmere District, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the fifteenth day of August, one thousand eight hundred and seventy-one:

And whereas it is expedient to revoke so much of the said Proclamation as relates to the Christchurch District, and to divide anew the territory formerly comprised within such district:

Now, therefore, I, George Augustus Constantine, the north bank of the River Marquis of Normanby, the Governor of the said East by the Ellesmere District.

colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said Proclamation so far as it relates to the Christchurch District, and do proclaim and declare that the territory comprised within such district shall be and the same is otherwise divided, for the purposes of the said Act, into three districts, the names and boundaries whereof shall be as follow:—

CHRISTCHURCH DISTRICT

Comprises that portion of the Province of Canterbury bounded on the North by the south bank of the Waimakariri; on the East by the sea and the Lyttelton District to the mouth of the River Halswell; on the South by the north bank of Lake Ellesmere to the mouth of the River Selwyn, thence by the Ellesmere District; and on the West by the South Road from the River Selwyn to its junction with the Home Bush and Selwyn Road, and by the said road to its junction with the Selwyn and Waimakariri Road, and by the last-mentioned road and a line in continuance thereof to the nearest bank of the Waimakariri River.

MALVERN DISTRICT

Comprises that portion of the Province of Canterbury bounded on the North by the south bank of the River Waimakariri; on the East by the Christchurch District; on the South by the River Selwyn, the Wai-ani-wa-ni-wa Branch of the said River to its intersection by the Home Bush Road, a straight line from thence to Porter's Pass, and a straight line from Porter's Pass to Browning's Pass; and on the West by the dividing range.

HORORATA DISTRICT

Comprises that portion of the Province of Canterbury bounded on the North by the Malvern District; on the West by the dividing range; on the South by the north bank of the River Rakaia; and on the East by the Ellesmere District.

And I hereby declare that this Proclamation shall come into operation and take effect on the fifteenth day of December, one thousand eight hundred and seventy-six.

Districts under "The Marriage Act Amendment Act, 1858."

(L.S.) NORMANBY, GOVERNOR. A PROCLAMATION.

WHEREAS by "The Marriage Act Amendment Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by Proclamation in the New Zealand Gazette, to divide the Colony of New Zealand for the purposes of the said Act into such and so many districts as he may think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation dividing the colony, or any portion of it, anew into districts, or increasing the number or altering the boundaries of districts, as from time to time he may think requisite:

And whereas by a Proclamation duly made and issued, bearing date the fifteenth day of July, one thousand eight hundred and seventy-one, the then Governor, in pursuance of the said recited power and authority, did constitute two districts for the purposes of the said Act, called the Christchurch District and the Ellesmere District, the boundaries whereof were therein set forth, which said Proclamation came into operation and took effect on the fifteenth day of August, one thousand eight hundred and seventy-one:

And whereas it is expedient to revoke so much of the said Proclamation as relates to the Christchurch District, and to divide anew the territory formerly comprised within such district:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the said colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said Proclamation so far as it relates to the Christchurch District, and do proclaim and declare that the territory comprised within such district shall be and the same is hereby otherwise divided, for the purposes of the said Act, into three districts, the names and boundaries whereof shall be as follow:—

CHRISTCHURCH DISTRICT

Comprises that portion of the Province of Canterbury bounded on the North by the south bank of the Waimakariri; on the East by the sea and the Lyttelton District to the mouth of the River Halswell; on the South by the north bank of Lake Ellesmere to the mouth of the River Selwyn, thence by the Ellesmere District; and on the West by the South Road from the River Selwyn too its junction with the Home Bush and Selwyn Road, and by the said road to its junction with the Selwyn and Waimakariri Road, and by the last-mentioned road and a line in continuance thereof to the nearest bank of the Waimakariri River.

MALVERN DISTRICT

Comprises that portion of the Province of Canterbury bounded on the North by the south bank of the River Waimakariri; on the East by the Christchurch District; on the South by the River Selwyn, the Wai-ani-wa-ni-wa Branch of the said river to its intersection by the Home Bush Road, a straight line from thence to Porter's Pass, and a straight line from Porter's Pass to Browning's Pass; and on the West by the dividing range.

HORORATA DISTRICT

Comprises that portion of the Province of Canterbury bounded on the North by the Malvern District; on the West by the dividing range; on the South by the north bank of the River Rakaia; and on the East by the Ellesmere District.

And I hereby declare that this Proclamation shall come into operation and take effect on the fifteenth day of December, one thousand eight hundred and seventy-six.

WHEREAS under the provisions of "The Immigration and Public Works Act, 1870," and

the several Acts amending the same, and other Acts, certain lines of railway have been constructed by the Governor: And whereas by "The Immigration and Public Works Act, 1875," the Governor in Council is authorized to make regulations and bylaws applicable to all railways constructed by him under the authority of the said hereinbefore mentioned Acts, and actually open for traffic, whether the whole of such railway shall have been completed or not; and whenever it shall be necessary to extend the operation of such regulations and bylaws to any particular railway, it shall be lawful for the Governor, by a notification published in the New Zealand Gazette, to extend the operation of such by-laws to the railway or railways named therein; and that, from and after a day to be fixed in such notification, the regulations and by-laws so made as aforesaid shall for all purposes be, and be deemed to be, the regulations and by-laws in force for the railway or railways named therein:

Now, therefore, His Excellency the Governor of New Zealand, with the advice and consent of the Executive Council thereof, and in exercise and pursuance of all powers and authorities enabling him in this behalf, doth hereby extend the operation of the By-laws, Rules, and Regulations published in the New Zealand Gazette, Nos. 8 and 27, of 10th February and 11th May, 1876, respectively, to the portion of the line of railway mentioned in the Schedule hereto; said By-laws, Rules, and Regulations to be from that date deemed to be the Regulations and By-laws in force for the portion of the line of railway mentioned in the Schedule aforesaid.

WHEREAS under the provisions of "The Immigration and Public Works Act, 1870," and the several Acts amending the same, and other Acts, the line of railway mentioned and described in the Second Schedule hereto has been constructed by the Governor within the Colony of New Zealand: And whereas under the provisions of the said hereinbefore mentioned Acts, and the enactments incorporated therewith, the Governor in Council is empowered to make rates and charges for the following purposes, that is to say,—

For regulating the receipt and delivery of goods and other things in connection with the said railway:

And whereas it is expedient that the rates and charges, as contained and set forth in the First Schedule hereto, should be made in respect of the said railway, in substitution of the rates and charges made by Order in Council dated the fifteenth day of December, one thousand eight hundred and seventy-four:

Now, therefore, His Excellency the Governor of above conditions be infringed New Zealand, with the advice and consent of the charged one penny on delivery.

Executive Council thereof, and in exercise and pursuance of all powers and authorities enabling him in this behalf, doth hereby make and approve of the rates and charges set forth in the First Schedule hereto, as the rates and charges to be in force with regard to the wharf in connection with the said railway so made and constructed by the Governor as aforesaid, and which is more particularly mentioned in the Second Schedule hereto annexed.

Post Card Regulations.

NORMANBY, Governor. ORDER IN COUNCIL.

At the Government House, at Wellington, this twenty-fourth day of October, 1876.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

In pursuance and exercise of the power and authority vested in him by "The Post Office Act, 1876," his Excellency the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council thereof, doth hereby make the following regulations with respect to the issue and transmission of Post Cards.

REGULATIONS.

On and from the 1st November next, Post Cards will be issued to the public by the Post Office under the following Regulations, and will be sold in packets of six cards for sixpence:—

- 1. Post Cards, whether official or private, having a stamp of one penny impressed upon them, may be transmitted between places in the Colony of New Zealand; and to certain other places, hereafter mentioned, at letter rates.
- 2. The front, or stamped side of the card, is for the address only, and, beyond the written or printed address, nothing whatever must be printed or written upon that side of the card. On the reverse side, any communication, whether of the nature of a letter or otherwise, may be printed or written. Nothing whatever may be attached to the card, nor may it be folded, cut, or otherwise altered. If any of the above conditions be infringed, the card shall be charged one penny on delivery.

3. No cards other than those issued by the Government, or private cards stamped by the Government with a penny stamp, under the special authority of the Postmaster-General, can be used for the purpose of making a written communication through the Post Office, unless such cards be prepaid the ordinary full letter postage.

4. Should a Post Card be observed to bear upon it anything of an obscene, libellous, or obviously objectionable nature, it will be detained and sent to the

Dead Letter Office for disposal.

5. The postage stamp on Post Cards shall be defaced with the single-dated stamp.

6. The existing rules in regard to re-direction shall

also apply to Post Cards.
7. When, owing to a great and unusual influx of letters, books, &c., the transmission of letters would be delayed if the whole mail were dealt with without distinction, Post Cards (unless paid for and posted as letters) may be kept back until the next despatch or delivery.

8. No gratuity is payable upon Post Cards forwarded in mails by steamers or other vessels.

9. Post Cards may be transmitted to the Colonies of Victoria and South Australia under the same conditions as they are transmitted within New Zealand, except that in addition to the impressed stamp they

must have an extra penny stamp affixed to them.

10. All Post Cards addressed to other places out of New Zealand will be detained, and sent to the

Dead Letter Office for disposal.

11. The poundage to be paid licensed stamp vendors shall be at the rate of two pounds ten shillings per centum.

Private Post Cards.

12. Private cards will be received from the public, and impressed with the penny postage stamp, under the following conditions:

(1.) A week's notice must be given by the applicant, and a sample of the card to be used should be forwarded for the Postmaster-General's inspection.

- (2.) None but card of approved quality and colour will be accepted. Each sheet must be of the size of 22 inches by 15 inches, and must not exceed two ounces in weight.
- (3.) Not fewer than fifty sheets of card can be received at one time.
- (4.) On each sheet presented for impression, the applicant's name or monogram must be embossed or printed, and any printing must be thoroughly dry.

(5.) Cards when impressed will be returned to applicant in sheets of twenty-one impressions.

(6.) No fee will be charged for stamping.

(7.) Cash must accompany all cards to be impressed.

(8.) No commission will be allowed upon private cards impressed for licensed vendors.

Fixing Sittings of District Court of Westland.

NORMANBY, Governor.

IN pursuance and exercise of the power and authority in this behalf enabling me, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, do hereby fix and appoint that sittings of the District Court of Westland, for Civil and Criminal Business, shall be held as follow:

In the Supreme Court House at Hokitika, on the first day of February, April, June, August, October, and December in each year.

In the Resident Magistrate's Court House at Greymouth, on the eighth day of February, April, June, August, October, and December in each year.

In the Resident Magistrate's Court House at Westport, on the seventh day of February, April, July, October, and December in each

In the Resident Magistrate's Court House at Reefton, on the fifteenth day of January, the eighth day of March, the fifteenth day of May, August, and November, in each year.

Provided that in case any of the days so fixed as aforesaid shall happen to be a Sunday or a holiday, then the Court appointed for that day shall be holden on the first day thereafter not being a Sunday or a holiday.

Provided further, that this warrant shall not take effect till the first day of January, one thousand eight hundred and seventy-seven.

Justice of the Peace appointed under "The Municipal Corporations Act, 1867."

Tenders called for by Western Australian Government for Removal of Guano from Lacepede Islands.

Colonial Secretary's Office, Perth, 28th September, 1876.

Sir,—I have the honor, by direction of Governor Robinson, C.M.G., to transmit to you the enclosed copy of a notice inviting tenders for the removal of guano from the Lacepede Islands, on the Northwest Coast of this colony; and His Excellency desires me to request that you will be good enough to give all due publicity to the same.

Notice is hereby given, that the Government of Western Australia will be ready to enter into an arrangement with some person or firm desirous of taking guano from one of the Lacepede Islands, situated in about 17° 6′ S. lat., and 122° 10′ E. long., the same being the second westernmost of the group.

The Government is willing to grant the exclusive right of removing guano from the island in question for a term of three years, to commence from the 1st day of July, 1877; the licensee to guarantee to take a minimum amount of 40,000 tons during the three years, of which at least 5,000 tons must be taken in the first year, and 20,000 tons within the two first years. Tenders to state the royalty per ton to be paid in each year, and the nature of the security (to the extent of one thousand pounds) to be given for such payment. The license to be granted will bind the licensee to take the whole of the guano from any

block of not less than five acres in extent before proceeding to take it from any other part of the island, and to conform to such regulations as may be made by the Governor of the colony respecting the mode of taking the guano, and the mode and time of payment.

The Government do not bind themselves to accept the highest or any tender. Tenders to be addressed to the Crown Lands Office, Perth, W.A., and to be sent in on or before 31st January next.
