Certain Diseases declared Infectious.

NORMANBY, Governor. (r.s.) A PROCLAMATION.

WHEREAS by section twenty of "The Public Health Act, 1876," it is, amongst other things, enacted that the Governor in Council may from time to time, by Proclamation in the Gazette, declare that certain diseases are deemed to be infectious within the meaning of the Act now under recital, and upon the publication of any such Proclamation the diseases mentioned therein shall be deemed to be infec-

tious accordingly:
Now, therefore, I, George Augustus Constantine,
Marquis of Normanby, the Governor of the Colony of New Zealand, in exercise and pursuance of the power and authority conferred upon me by the said Act, and by and with the advice and consent of the Executive Council of the said colony, do hereby proclaim and declare that the following diseases, to

wit,-

Cholera, Small-pox, Scarlatina, Diphtheria, Enteric or Typhoid Fever, Typhus Fever, and Measles,

shall be and be deemed to be infectious diseases within the meaning of the said Act.

Given under the hand of His Excellency the Most Honorable George Augustus Constantine, Marquis of Normanby, Earl of Mulgrave, Viscount Normanby, and Baron Mulgrave of Mulgrave, all in the County of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majesty's Most Honorable Privy Council; Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commanderin Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at the Government House, at Wellington, this twenty-eighth day of November, in the year of our Lord one thousand eight hundred and seventy-six.
