(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by "The Gold Fields Act, 1866," it is provided that it shall be lawful for the Governor, at any time subsequent to the proclama-tion of a gold field, to withdraw by Proclamation therefrom any Crown lands which he may deem it necessary to withdraw, and that such lands shall thenceforth be dealt with, sold, occupied, and disposed of under any law or laws for the time being in force regulating the sale, occupation, or disposal, or in any way affecting or relating to the management or dealing with the Crown lands within the province in which such gold field is situate, in like manner in every respect as though such lands had never been comprised in any proclaimed gold field :
