

Waterworks By-law.

Colonial Secretary's Office, Wellington, 23rd December, 1876.

THE following By-law of the Auckland Municipal Corporation was received by the Colonial L. Corporation was received by the Colonial Secretary on the 23rd day of November, 1876, and not having been disallowed by the Governor, is pub-lished in conformity with the provisions of the 8th section of "The Municipal Corporations Acts Amend-ment Act, 1875."

BY-LAW of the Council of the City of Auckland, made in pursuance of "The Municipal Corpo-rations Waterworks Act, 1872," on the 15th day of November, 1876, and sealed with the Common Seal of the Council of the said City on the 15th day of November, 1876.

In pursuance of Section 7, "Municipal Corpora-tions Amendment Act, 1875," and of Section 78, "Municipal Corporations Waterworks Act, 1872," the Council of the City of Auckland ordain as follows :-

1. The following shall be the rates at which the Corporation will supply water within the limits of the City of Auckland, viz.,--

2. Ordinary supply shall mean only such as is required for strictly domestic uses, and the Council reserves the right to determine in any case what

shall be considered a supply for domestic purposes. 3. Extraordinary supply shall mean water used for any other than purposes of ordinary supply, and may be charged extra accordingly.

METERS.

4. Any consumer using the water for other than domestic purposes shall, on delivery of written notice, the requirements of the affix a meter to gauge his supply. Meters shall be mined by the Engineer.

5. Consumers by meter shall be charged a mini-mum at the rate of consumption of 20,000 gallons

mum at the rate of consumption of entropy of a second state of the payable half-yearly in advance, and new applications for service shall be accompanied by the tender of a sum equal to the rate for the broken period of the current half-year, commencing three days after date of application.

Rates by meter shall be payable monthly. 7. Applications for water shall be made to the Water Supply Office, and upon the forms to be obtaind there.

PLUMBERS.

8. Competent plumbers may be licensed to lay pipes and do any work in connection with water supply on payment of an annual fee of £1 1s. and a deposit of $\pounds 5$; and no persons but those duly licensed by the Corporation shall be allowed to attach or alter any service pipe, or in any other way interfere with pipes, taps, cocks, meters, or any matters or things

connected with the water supply. Licensed plumbers shall keep a special day-book of all work done in connection with water service, which book shall be handed in to the Town Clerk when demanded.

9. No licensed plumber shall do any work connected with the water supply without giving at least two (2) clear days' notice thereof, and receiving written authority from the Engineer to do such work, and no work shall be done excepting between

the hours of 8 a.m. and 5 p.m. Notice forms may be obtained on application at the Water Supply Office.

WASTE OF WATER.

10. Any person who causes or permits any wilful negligent or unnecessary waste or use of water to take place, by allowing a cistern or other vessel to overflow, or the water to run from any tap, lock, cock, valve, pipe, work, or engine, shall be guilty of an offence.

REPAIRS.

11. Any person neglecting to repair any service-pipe, meter-tap, or other fixing used in the supply of water, after having received notice from any officer of the Corporation, shall render himself liable to have

the water cut off, and shall be guilty of an offence. 12. The service pipes from the main being the property of the owners or occupiers of the tenements supplied by such service-pipes, the occupier (if any), and, if none, the owner, shall, in every instance in which any damage shall be caused by reason of such service-pipe being out of repair, or leaky or broken, be liable to a penalty.

13. Should any meter be out of repair, or cease to register, or register inaccurately, the officer duly appointed shall estimate the consumption at the average of the previous month charged to the con-sumer, who shall be liable to pay accordingly.

RATES IN ABREAR.

14. At the expiration of fourteen days from the date of any water rate being due, and after delivery of notice on the premises to which such water is laid on, it shall be competent for any officer of the Corporation to stop and cut off any such supply in whatever manner may be deemed advisable.

15. In no case will the use of instantaneous closing taps, valves, or cocks be permitted. Galvanized iron piping of an approved quality only will be allowed for external services, and of the requisite sizes suitable to the requirements of the tenements, as shall be deter16. Water-troughs must be supplied with selfacting ball-cocks, enclosed in a wooden case, and kept locked, so that they cannot be tampered with, or the water turned on without the sanction of the consumer.

WATER-CLOSETS.

17. Where it is desirable to use the water to flush closets, a full and complete apparatus must be provided, comprising a ball-cock and a service system, fitted with a boot or division, to be carried as high as the top of the cistern, and capable of containing not more than one and a half gallons of water when filled within three inches of the top, and two proper valves, so arranged as to let down not more than one boot or division full of water at each pull, or be capable of allowing the water to run to waste, either by intention or neglect; and must also have a down-pipe of lead from the cistern to the basin of not less than one and one quarter inches in diameter, and a proper basin scatterer, weighted lever, pan-trap, and other appliances needful to prevent such water-closets from becoming a nuisance, and thereby inducing an undue consumption of water, and the valves must be worked by brass rods instead of by wires or chains. Every self-acting or pull-down water-closet must be of a description approved by the Waterworks Engineer for the time being, and must have either a lead cistern similar to a pan-closet or a double valve cast-iron service box, of a kind approved by the Waterworks Engineer, and fitted with proper cover to screw on, and internal apparatus in all respects similar to that of the boot of the pan-closet above described, and a similar down-pipe of lead or cast-iron, and must have a proper wide rim flushing basin, and a trap of a kind approved by the Waterworks Engineer. No wire will will be allowed to be used in the construction of these water-closets.

No pipe shall be allowed to communicate, directly or indirectly, with the basin or trap, or otherwise than with the cistern or service-box of a water-closet or soil-pan, and the same shall be so constructed and used as to prevent the waste or undue consumption of water, and the return of foul air and other noisome or impure matter into the mains or other pipes of the Corporation.

18. Overflow pipes from baths will not be permitted unless supplied by meter.

19. Drawing cocks must be of the best quality and most approved description, and must be those known as "screw-down valves," and in exposed or public places must be encased within a wood or iron box under lock and key.

20. All service-pipes must be laid not less than twelve inches beneath the surface of the roadway and gutters, and in each service-pipe connected with the mains must be fixed with two valve-cocks, one at the junction of the main and protected by a strong wooden box, and the other within the building.

21. All water meters must be enclosed in a wooden box, and the keys of both meters and boxes duly labelled with the name of the owner, and must be lodged at the Office of Water Supply. The Corporation reserves the right to affix its own lock upon meters.

PATHS AND ROADS.

22. Plumbers must leave the roads and footpaths in the same state of repair as they find them, and the trenches must be well rammed as the earth and metal are filled in within forty-eight hours.

Where kerbing, channelling, flagging, or asphalte are disturbed, they shall be carefully and substantially re-laid with new work at the expense of the applicant within forty-eight hours, to the satisfaction of the Engineer.

23. Plumbers shall be responsible for all damage done or caused by them in doing any work whatever, and through bad workmanship or inferior material, and, in the event of any such damage, bad workmanship, or neglect, shall be liable to have their licenses cancelled without any refund of deposit or fee.

WRONG OR FALSE INFORMATION.

24. Any person who shall give to any officer of the Corporation false or incorrect information upon any matter pertaining to water supply shall be guilty of an offence.

25. All work shall be done to the approval and satisfaction of the Waterworks Engineer or other officer appointed by the Council, and must be passed by him before the water shall be turned on at the main.

LAYING SERVICES.

26. The Council may, on written application, lay service-pipes from the water mains to the line of street, and consumers shall pay to the Council (when the mains are laid only on one side of the street, road, or alley) the cost estimated from the centre of such roadway, street, or alley, notwithstanding the mains be laid upon any side of such roads aforesaid, and shall, previous to any permit to tap main being granted, deposit with the Town Clerk the Engineer's estimate of the cost of laying such service-pipes, receiving, on completion of the work, any sum deposited in excess, or paying any sum that may be required in addition to cover the expense. A schedule of quantities and cost of services shall, for public information, be kept in the office of the Town Clerk.

PENALTIES.

27. Any person who shall violate or fail to do or observe any rules, matters, or things laid down in these By-laws, or shall do that which he is not entitled or allowed to do under the authority of these By-laws, shall be deemed guilty of an offence, and for each such offence shall forfeit and pay any sum not exceeding five pounds.
