# NORMANBY, Governor. ORDER IN COUNCIL.

At the Government House, at Wellington, this seventh day of April, 1877.

### Present:

WHEREAS by the twelfth section of "The Municipal Corporations Act, 1876," it is provided that the Governor may, by Order in Council gazetted and publicly notified, extend the time within which anything is required to be done by the said Act, so that the true intent and purpose of the said Act may have effect: And whereas by the forty-first section of the said Act it is enacted that the Town Clerk of every Borough shall, on or before the thirty-first day of March in each year, make out, in the manner in the said section mentioned, from the valuation roll a certain list to be called "the burgess list:" And whereas by the forty-second section of the said Act it is enacted that the Town Clerk shall keep the burgess list in his office, and allow it to be inspected without fee by all persons interested therein during all office hours until the fifteenth day of April inclusive: And whereas by the forty-third section of the said Act it is enacted that all objections to the burgess list must be delivered at the office of the Town Clerk on or before the fifteenth day of April: And whereas by the forty-fourth section of the said Act it is enacted that the Town Clerk shall make and sign a list of all such objections, and shall keep such list in his office, and allow it to be inspected without fee by any person interested therein during all office hours from the sixteenth to the twenty-first day of April inclusive: And whereas by the forty-fifth section of the said Act it is enacted that the Borough Council shall hold a sitting upon a day between the twenty-second and thirtieth days of April, both inclusive, to be appointed by the Mayor, and of which he shall

give three days public notice, for the purpose of determining all claims to vote and objections:

And whereas it has been made to appear to His Excellency the Governor that certain things required to be done by the said Act in connection with the making and revision of the burgess lists or rolls for Cook's Ward, St. John's Ward, and Queen's Ward, in the Borough of Wanganui, cannot be done by or within the times required by the said Act:

Now, therefore, His Excellency the Covernor, in

Now, therefore, His Excellency the Governor, in exercise and pursuance of the power and authority vested in him by the twelfth section of the said Act, and by and with the advice and consent of the Executive Council of the Colony of New Zealand, doth hereby extend the time for making the burgess lists for the said Wards respectively, in accordance with the forty-first section of the said Act, to the ninth day of April next; and doth hereby extend the time during which the Town Clerk is to keep the said burgess lists and to allow them to be inspected by all persons interested therein, as mentioned in the forty-second section of the said Act, to the twenty-fourth day of April next:

And doth hereby extend the time for delivering objections to the said burgess lists, in accordance with the forty-third section of the said Act, to the said trenty fourth day of April ports.

said twenty-fourth day of April next:

And doth hereby declare that the time during which the Town Clerk is to keep the list of objections mentioned in the forty-fourth section of the said Act, in respect of the said burgess lists respectively, in his office for purposes of inspection by any person interested therein, shall be extended so that the same shall and may be kept for inspection, as in the said section provided, during all office hours from the twenty-fifth to the thirtieth day of April next, inclusive:

And doth hereby extend the time for holding the sitting of the Wanganui Borough Council, in accordance with the forty-fifth section of the said Act, to a day between the first and the ninth days of May next, both inclusive, which day shall be appointed by the Mayor, and of which notice shall be given, as in the said section provided.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the ninth section of "The Harbour Boards Act, 1870," it is, among other things, enacted that the Governor may, by Order in Council, from time to time delegate to any Harbour Board constituted thereunder all or any of the powers and authorities vested in him by the provisions contained in the seventh and tenth sections of "The Marine Act, 1867," subject to any regulations, restrictions, or stipulations that may be specified in such Order:

And whereas by an Act of the General Assembly of the colony intituled "The Wanganui Harbour and River Conservators Board Act, 1876," a Harbour Board was constituted for the Port of Wanganui, and which Board was specially declared to be a Harbour Board established under and in pursuance of "The Harbour Boards Act, 1870:"

And whereas it is expedient that certain powers should be delegated to the Wanganui Harbour and River Conservators Board, as in manner hereinafter set forth:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, in pursuance and exercise of the hereinbefore recited power and authority enabling me in that behalf, do hereby delegate unto the

aforesaid the several powers and authorities mentioned and set forth in the Schedule hereto annexed, such powers and authorities to be exercised within the limits of the Port of Wanganui, as defined in a warrant bearing date the twentieth day of November, one thousand eight hundred and sixty-eight, and published in the New Zealand Gazette of the twentythird day of November in the same year: subject, however, to such restrictions as in the said Schedule set forth.

And in further pursuance and exercise of the hereinbefore in part recited power and authority, and with the like advice and consent as aforesaid, I do hereby delegate unto the said Wanganui Harbour and River Conservators Board all the powers vested in the Governor in Council by the tenth section of "The Marine Act, 1867:" Provided that the delegation lastly hereinbefore contained shall be limited to the said Port of Wanganui.

### SCHEDULE.

SUCH of the powers vested in the Governor by the seventh section of "The Marine Act, 1867," as enable him to erect, superintend, and maintain harbour marks, buoys, lights, and beacons within the limits of the Port of Wanganui, or the approaches thereto. Subject, however, to such directions as may from time to time be issued by the Commissioner of Customs as to the size, position, and colour of such harbour marks, buoys, and beacons, and in the case of lights, to the approval first obtained of the said Commissioner of Customs; and subject also to the condition that no notices to mariners shall be issued by the Wanganui Harbour and River Conservators

Board until after such notices shall have been approved of by the Marine Department: Also such of the powers vested in the Governor by the said seventh section as enable him to appoint, suspend, or remove Port or Harbour Masters, and other officers of the port or harbour: Provided that this delegation shall be limited to the Port of Wanganui aforesaid.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the sixth section of "The Marine Act, 1867," (hereinafter called "the said Act,") it is, among other things, enacted that the Governor in Council may from time to time delegate all or any of the powers and authorities vested in him by the said Act, subject to any restrictions or stipulations which may be specified in such Order: And whereas by virtue of an Act passed by the General Assembly of the Colony, intituled "The Wanganui Harbour and River Conservators Board Act, 1876," a Harbour Board for the Port of Wanganui Harbour and River Conservators Board: "And whereas it is expedient that the powers and authorities conferred upon the Governor by the twelfth and forty-second sections of the said Act should be delegated to the said Board as hereinafter provided:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the hereinbefore recited power and authority, and by and with the advice and consent of the Executive Council of the said colony, do hereby delegate unto the Wanganui Harbour and River Conservators Board aforesaid, the powers and authorities vested in me by the twelfth and forty-second sections of the said Act: Provided, however, that this delegation shall extend and operate as far as regards the Port of Wanganui only; and that the powers so delegated shall only be exercised by the said Board within the limits of the said port, as the same is defined in a warrant bearing date the twentieth day of November, one thousand eight hundred and sixty-eight, and published in the New Zealand Gazette of the twenty-third day of November in the said year.
