Provisional Reserves for Educational Purposes in the Provincial District of Canterbury.

(L.S.) NORMANBY, Governor.
A PROCLAMATION.

WHEREAS by the twelfth section of "The Waste Lands Administration Act, 1876," it is enacted that it shall be lawful for the Governor from time to time to make out of any waste lands of the Crown provisional reserves for educational purposes of a public character in manner as in the said section is set forth:

And whereas the Waste Lands Board of Canterbury has passed a resolution recommending that the parcels of land described in the Schedule hereto annexed should be set apart and reserved for educational purposes of the character in the said Schedule also more particularly stated:

And whereas it is expedient to give effect to the aforesaid recommendation, and to reserve the said parcels of land accordingly:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of New Zealand, in pursuance and exercise of the authority vested in me by the above-named Act, and of all other powers and authorities enabling me in this behalf, do hereby proclaim and declare that the parcels of land described in the Schedule hereto annexed are provisionally reserved and set apart for the educational purposes in the said Schedule particularly described, subject to the terms and conditions of the aforesaid twelfth section of the above-named Act.

SCHEDULE.

ALL that parcel of land in the Provincial District of Canterbury, containing by admeasurement two thousand two hundred (2,200) acres, more or less, being Section numbered one thousand one hundred and sixteen (1116) (in red), situate in the Ashburton District, including Pudding Hill. Bounded on the

Northward by a branch of the River Ashburton; on the Southward by another branch of the same river; and on the Westward by a straight line bearing N 44° 30' E. (mag.), drawn from a point on the southern boundary situated about three and a quarter miles measured in a straight line from the confluence of the above-mentioned branches of the aforesaid river. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement six hundred and forty (640) acres, more or less, being Section numbered one thousand five hundred and fifty-two (1552) (in red), situate in the Ashburton District. Bounded on the South-east by the north-western boundary of Section 16379 and a line in continuation thereof; on the North-east by the road forming the north-eastern boundary of that section; on the North-west by a line 80 chains long drawn at right angles to the said road; and on the South-west by a line at right angles to the north-western boundary, the said north-western boundary being drawn from a point on the said road so as to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement thirty (30) acres, more or less, being Section numbered one thousand nine hundred and ten (1910) (in red), situate at Wainui, Banks' Peninsula (Town of Akaroa and Wainui Road District). Bounded on the North-westward by the road forming the north-western boundary of Section No. 22828; on the North-eastward by that section; on the South-eastward by Section 22627; and on the South-westward by a line parallel to the north-eastern boundary, so as to contain the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement ten (10) acres, more or less, being Section numbered one thousand nine hundred and thirty-one (1931) (in red), situate in the Ashburton District (Mt. Somers Road District). Bounded on the South-eastward by the road forming the north-west boundary of Reserve 1605 (in red); on the North-

eastward by the road forming the western boundary of Section 5818; on the North-westward by a line parallel to south-east boundary and ten chains distant therefrom; and on the South-westward by a line at right angles to south-east boundary, so as to contain the required quantity. For school purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement twelve (12) acres, more or less, being Section numbered one thousand nine hundred and sixty-four (1964) (in red), situate in the Ashburton District (Ashburton Road District). Bounded on the North-westward by the road forming part of the north-west boundary of Section 20077; on the North-eastward by that section; on the South-eastward by the same section; and on the South-westward by a line in continuation of the south-westernmost boundary of Section 20077. As a site for a school.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered one thousand nine hundred and ninety-nine (1999) (in red), situate in the Ashburton District (Ashburton Road District). Bounded on the South-east by Moore's Beach Road; on the South-west by Sections 23680, 23683, and 23679; on the North-west by the dray track; and on the North-east by a line parallel to the north-east boundary of Section 23680, so as to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand (2000) (in red), situate in the Ashburton District (Mount Somers Road District). Bounded on the South-west by the road forming the north-eastern boundary of Reserve 1607 (in red); on the South-east by pre-emptive rights ZA¹ and T, on run 126; on the North-east by the top of the high terrace of the north branch of the River Ashburton, to be determined on survey; on the North-west by a line at right angles to the first mentioned boundary, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand and one (2001) (in red), situate in the Waitangi District (Waimate Road District), being bounded on the East by Section No. 20000; on the South-east by a branch of the River Waihao; on the North-west by a line at right angles to the first-mentioned boundary; and on the West by a line parallel to the eastern boundary, to include the required quantity. The north-east corner of the above-described land is situate 60 chains north of the south-west corner of Section 20000. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand and two (2002) (in red), situate in the Waitangi District (Waimate Road District), being bounded on the South-east by Sections Nos. 19959, 19958, and 19960; on the North-eastward by Section No. 20221; on the South-west by Section 21743; and on the North-west by a branch of the River Waihao and a line at right angles to the south-west boundary, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand and three (2003) (in red), situate in the Waitangi District (Waimate Road

District), being bounded on the South-east by Sections 21743, 21744, 21745, and 21746; on the North-east by a line in continuation of the north-east boundary of Section 21743; on the South-west by a line parallel to the north-east boundary drawn to meet the western corner of Section 21746; and on the North-west by a line at right angles to the north-east boundary, so as to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand and four (2004) (in red), situate in the Waipara District (Waipara Road District). Bounded on the Northward by the West Coast Road by Hurunui; on the Eastward by Section 18080 and by Section 7081; on the South by Sections 7081 and 7078; and on the Westward by a line at right angles to the first-mentioned boundary, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand and five (2005) (in red), situate in the Waipara District (Waipara Road District), being bounded on the Southward by the West Coast Road by Hurunui; on the Westward by Reserve No. 286 (in red); on the Northward by the River Waitohi; and on the Eastward by a line at right angles to the road above mentioned, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement four hundred and eight (408) acres, more or less, being Section numbered two thousand and six (2006) (in red), situate in the Ashburton District (Mount Somers Road District), being bounded on the West by the road forming the eastern boundary of Section 21515; on the North-east by a road and by Taylor's Branch of the River Ashburton, and also by Section 17760; and on the South-east by Section 17760, and a line in continuation of its south-eastern boundary. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement five hundred and thirty-eight (538) acres, more or less, being Section numbered two thousand and seven (2007) (in red), situate in the Ashburton District (Mount Somers Road District), being bounded on the East by the road forming the eastern boundary of Section 21515; on the North-east by a road dividing Section 19693 and 17763, and also by the southern boundary of Sections 17765 and 19693; on the North-west by Sections 19693, 19630, 19631, and 19908; on the South-west by Sections 19631, 19909, 17762, 19908, and Bowyer's Stream; and on the South-east by a line in continuation of the south-eastern boundary of Section 17760. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement fifty-four (54) acres, more or less, being Section numbered two thousand and eight (2008) (in red), situate in the Ashburton District (Mount Somers Road District), being bounded on the South-west by Section 22634; on the South-east by a line in continuation of the South-eastern boundary of that section; on the North-west by the road forming the north-western boundary of Section 22634; and on the North-east by a line parallel to the first-described boundary, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement five hundred (500) acres, more or less, being Section

numbered two thousand and nine (2009) (in red), situate in the Ashburton District (Mount Somers Road District), being bounded on the North-east by the road forming the north-eastern boundary of Section 23547; on the South-east by the road running between Sections 14751 and 14931, and also by Sections 23512 and 23482; on the South-west by Sections 23512, 23482, 14751, and by the north branch of the River Ashburton; and on the North-west by a line at right angles to the first-mentioned road, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement five hundred (500) acres, more or less, being Section numbered two thousand and ten (2010) (in red), situate in the Ashburton District (Mount Somers Road District), being a rectangular block having a frontage of 79 chains 38 links on the road forming the north-eastern boundary of Section 23547, and extending in a north-easterly direction 63 chains, its southernmost corner being in line with the south-eastern boundary of Section 14751. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement one thousand (1,000) acres, more or less, being Section numbered two thousand and eleven (2011) (in red), situate in the Waipara District (Waipara Road District). Bounded on the Northward by I.P.R.B. on Run No. 694, Class 3, and a line in continuation of the southern boundary thereof; on the Westward by the River Waipara; on the Eastward by Section 23643 and a line in continuation of the western boundary of that section; and on the Southward by a line at right angles to the eastern boundary, to include the required quantity. For educational purposes.

All that parcel of land in the Provincial District of Canterbury, containing by admeasurement five (5) acres two (2) roods, more or less, being Section numbered two thousand one hundred and twenty-six (2126) (in red), situate in the Timaru District. Bounded on the Eastward by Reserve 1367 (in red); on the South-eastward by the road forming the south-west boundary of Section 1933; and on the Northward by a line in continuation of the northern boundary of said Reserve 1367 (in red). For a site for a school.

Given under the hand of His Excellency the Most Honorable George Augustus Constantine, Marquis of Normanby, Earl of Mulgrave, Viscount Normanby, and Baron Mulgrave of Mulgrave, all in the County of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majesty's Most Honorable Privy Council; Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at the Government House, at Wellington, this thirtieth day of July, in the year of our Lord one thousand eight hundred and seventy-seven.

Mount Hutt and Acton Road Districts, constituted under "The Canterbury Roads Ordinance, 1872."

A PROCLAMATION.

BY virtue of the powers and authorities vested in me by "The Canterbury Roads Ordinance, 1872," and "The Abolition of Provinces Act, 1875," I, George Augustus Constantine, Marquis of Normanby, Governor of the Colony of New Zealand, do hereby proclaim and declare that from and after the twenty-eighth day of July, one thousand eight hundred and seventy-seven, the portion of the South Rakaia Road District described in the First Schedule hereto shall be severed from the said South Rakaia Road District, and shall be constituted a new district under the said "Canterbury Roads Ordinance, 1872," under the name of the Mount Hutt Road District; and that the remaining portion of the said South Rakaia Road District, described in the Second Schedule hereto, shall be deemed to be a new district under the provisions of the said Ordinance, and shall be known by the name of the Acton Road District.

FIRST SCHEDULE.

MOUNT HUTT ROAD DISTRICT

Is bounded towards the North-east by the Lake Coleridge and Rakaia Road Districts; towards the South-east by the Great Southern Railway line to the southern boundary of Run No. 91, thence westerly along that boundary to Run No. 118, thence along the eastern and southern boundaries of Run No. 118, thence northerly along the western boundary of that run to Run No. 117, thence westerly along the southern boundary of Runs 117, 739, and 199, to the north-west corner of Run 106, thence southerly along the western boundary of that run to the north branch of the River Ashburton, thence along that river to Run 502, and along the southern boundaries of Runs 502, 466, 352, and the western boundary of Run 352, to the Lake Coleridge Road District.

SECOND SCHEDULE.

ACTON ROAD DISTRICT

Is bounded towards the North-east by the Rakaia and Ellesmere Road Districts; towards the South-east by the sea; towards the South-west by the south-western boundary lines of Runs numbered 129 and 90; and towards the West by part of the western boundary of Run No. 90, and the Mount Hutt Road District.

Given under the hand of His Excellency the Most Honorable George Augustus Constantine, Marquis of Normanby, Earl of Mulgrave, Viscount Normanby, and Baron Mulgrave of Mulgrave, all in the County of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majesty's Most Honorable Privy Council; Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at the Government House, at Wellington, this twenty-eighth day of July, in the year of our Lord one thousand eight hundred and seventy-seven.

WHEREAS by the first subsection of section twenty-six of "The Waste Lands Administration Act, 1876," it is provided that the Waste Lands Boards of the respective land districts shall sit at the Land Office in the principal town of the land district, at certain times to be determined by the Board and approved of by the Governor, and published in the *New Zealand Gazette*: And whereas the Waste Lands Board of the Land District of Auckland has determined to hold its sittings on every alternate Tuesday at two o'clock p.m., instead of the second Tuesday in each month as heretofore fixed, and have requested His Excellency the Governor to approve of such alteration:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in exercise of the power and authority vested in me in that behalf by "The Waste Lands Administration Act, 1876," do hereby approve of the ordinary meetings of the Waste Lands Board of the Land District of Auckland being held at the

principal Land Office, at the City of Auckland, on every alternate Tuesday, at two o'clock p.m., instead of the second Tuesday in each month, as heretofore; and that the first sitting shall be on the twenty-fourth July, one thousand eight hundred and seventy-seven.
