Town of Palmerston proclaimed a Borough under "The Municipal Corporations Act, 1876."

(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by the fifteenth section of "The Municipal Corporations Act, 1876," it is enacted that the Governor may, by Proclamation, declare any of the several places specified in the Third Schedule to the said Act in which a Municipal Corporation has been established under the provisions of an Ordinance of the Province of Otago intituled "The Otago Municipal Corporations Ordinance, 1865," to be a borough constituted under the said "Municipal Corporations Act, 1876," from a day to be named in such Proclamation; subject, however, to certain conditions in the said section mentioned: And whereas the Town of Palmerston, in the Provincial District of Otago, is one of the places specified in the said Third Schedule and

In the Frontiar District of Orago, is one of the places specified in the said Third Schedule, and a petition has been presented to His Excellency the Governor by fifty of the ratepayers of such town praying him to constitute such town into a borough under the said "Municipal Corporations Act, 1876," and such petition was, on the fourth day of September, one thousand eight hundred and seventyseven, publicly notified, and no petition from an equal or greater number of such ratepayers was presented to His Excellency within two months after such public notification praying him not to assent to the prayer of such first-mentioned petition:

Now, therefore, His Excellency the Governor, in exercise and pursuance of all powers and authorities enabling him in that behalf, doth hereby proclaim and declare that from the twelfth day of November, one thousand eight hundred and seventy-seven, the said Town of Palmerston shall be a borough constituted under the said "Municipal Corporations Act, 1876," and shall be called the Borough of Palmerston; and that the boundaries of such borough shall be those specified in the Schedule hereto.

Road District of Wakaia constituted.

NORMANBY, Governor. (L.S.) A PROCLAMATION.

WHEREAS by section six of the Ordinance of the Superintendent and Provincial Council of the late Province of Otago shortly intituled "The Otago Roads Ordinance, 1871," it is enacted that if a majority in number of the persons on the roll or rolls for the time being in force under "The Regis-tration of Electors Act, 1866," or any other Act for the like purpose, should sign and cause to be presented to the Superintendent a petition in the form in the Second Schedule to the said Ordinance, or to the like effect, praying him to constitute the portion of the province in which such persons should reside a road district under the said Ordinance, and in such petition should set forth the boundaries of the portion of the province to which such petition should refer, it should be lawful for the Superintendent, if he should think fit so to do, by Proclamation to constitute such portion of the province a road district, by such name as in and by the Proclamation should be assigned to the same : And it is in the said section of the said Ordinance further enacted and provided that the said Superintendent might, by the Proclamation constituting such road district, declare the number of electoral subdivisions, thereinafter called subdivisions, into which such district might be subdivided, and define the boundaries of such subdivisions respectively: And whereas by virtue of "The Abolition of Provinces Act, 1875," all the powers, duties, and functions vested in, or to be exercised or performed by, the Superintendent of the said late Province of Otago under "The Otago Roads Ordinance, 1871," are now vested in and may be exercised and performed by the Governor: And whereas a majority in number of the persons on the roll for the time being in force under "The Registration of Electors Act, 1866," and the various Acts of the General Assembly of New Zealand amending the same, resident in that portion of the late Province and now Provincial District of Otago described in the First Schedule hereunder written, have signed and caused to be presented to me a petition in the form prescribed by the said Ordinance, praying me to constitute the said portion of the said provincial district described in the said First Schedule hereunder written a road district under the said Ordinance :

Now, therefore, I George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in exercise of the powers conferred upon me by the said Ordinance and the said Act,

Mulgrave, Viscount Normanby, and Baron Mulgrave of Mulgrave, all in the County of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majortrie Most Honorable Pring County District "And Ldo honeby, further proclaim and District". And Ldo honeby, further proclaim and a road district under the said "Otago Roads Ordi-nance, 1871," by the name of "The Wakaia Road District:" And I do hereby further proclaim and declare that the said Wakaia Road District shall be subdivided into three electoral subdivisions, to be known respectively as the Wendon Subdivision, the Argyle Subdivision, and the Nokomai Subdivision; and that the boundaries of the said subdivisions respectively shall be as set forth in the Second Schedule hereunder written.

FIRST SCHEDULE.

DESCRIPTION OF PROPOSED NEW ROAD DISTRICT OF WAKAIA.

Wakaia Road District.

Wakata Road District. ALL that area in the Provincial District of Otago, in the Colony of New Zealand, bounded towards the South by Gore Riding of Southland County; towards the South-west and West by the middle of the Mataura River; towards the North-west by Lake County; towards the North by Vincent County; and towards the East by Tuapeka and Clutha Counties Counties.

SECOND SCHEDULE. BOUNDARIES OF SUBDIVISIONS OF THE WAKAIA ROAD DISTRICT.

Wendon Subdivision.

ALL that area bounded towards the North by a line starting from the Black Umbrella and running due west to the Winding Creek, thence by said creek and Argyle Burn to Wakaia River, thence by said river and Run 326 to Mataura River; thence towards the West by the middle of the said river to the southern boundary of the district; thence towards the South by a line through Pyramid Hill due east to Clutha County; and thence towards the East and North-east by the Clutha and Tuapeka Counties as far as Black Umbrella, being starting point.

Argyle Subdivision. Alterations and Additions to the Rates for the Conveyance, Delivery, and Storage of Goods, Parcels, &c., on all the New Zealand Railways.

IN accordance with the By-laws for the New Zea-land Railways, fixed by Order in Council, dated the 17th day of April, 1877, the following alterations and additions to the rates for the conveyance, delivery, and storage of goods, parcels, &c., on all the New Zealand Railways, are hereby declared to be fixed, and shall come into force from the day of the date hereof :-

PASSENGERS.

Family season tickets will be issued on application to the Manager at two-thirds the rate of ordinary season tickets. Minimum charge as for four persons.

The rate for special trains with one large or two small carriages to be fifteen shillings (15s.) per mile. For every additional carriage five shillings (5s.) per mile. Minimum charge five pounds (£5). per mile. Minimum charge Mileage charged one way only.

Season tickets at half ordinary fares will be issued to apprentices and pupil teachers whose age does not exceed 19 years, upon production of satisfactory certificates from their masters or employers that the 582

applicants are actually serving as apprentices or pupil teachers, and that their age is within the prescribed limits.

GRAIN.

If bags contain more than 4 bushels the excess weight will be charged at a rate and a half.

MISCELLANEOUS.

The driver of any public vehicle plying for hire within the precincts of any railway will be charged a fee of one pound (£1) for a twelve months' license, to be issued at the option of the Manager. No public vehicle allowed to ply within the limits of the railway without a license.

The deaths of persons not residents of the boroughs, occurring at hospitals, have been excluded in all cases. The estimates of the population are calculated on the number of inhabited houses in each borough, as shown in returns supplied by the municipal authorities. The births were 62 more than in September. The deaths were 11 more in number than the deaths in September. Of the deaths, males contributed 52; females, 56: 46 of the deaths were of children under 5 years of age, being 42:59 per cent. of the whole number; 29 of these were of children under 1 year of age. There were 9 deaths of persons of 65 years of age and over: 5 of these persons were males and 4 females; 1 female of 67 died at Auckland; 3 males of 72, 73, and 75, and 1 female of 74, died at Wellington; 1 female of 76 at Christchurch; 2 males of 77 and 81, and 1 female of 70, at Dunedin.

Comparison with the previous Month.—At the five most populous boroughs the death-rates for October were higher than those for September; Thames and Hokitika are the exceptions. Zymotic Diseases.—From this class of disease there were 28 deaths, or 25.92 per cent. of the whole number. Four deaths occurred from Scarlatina at Dunedin against September; but it is important to notice that there were no deaths from the same cause at Hokitika, as nearly 50 per cent. of the total mortality at the latter town for 8 previous months was the result of Scarlatina. One death from Diphtheria took place at Wellington, and one at Christchurch. There was one death from Typhoid Farer at Wellington, and another at Nelson

Scarlatina. One death from Diphtheria took place at Wellington, and one at Christchurch. There was one death from Typhold Fever at Wellington, and another at Nelson. Diseases of the Respiratory System.—The deaths consisted of 12 cases of Bronchitis and Pneumonia, 3 of which occurred at Auckland, 2 at the Thames, 2 at Wellington, 1 at Christchurch, and 4 at Dunedin. In the previous month there were 19 deaths from similar causes, of which 7 took place at Dunedin. Violent Deaths.—Nine were accidental. The deaths of a woman and six children were caused by the burning of houses at Wellington. The death by suicide also took place at Wellington. Comparison with October, 1876.—The total number of deaths for October, 1877 (108), is 5 in excess of the number for October, 1876. Of Zymotic diseases, Scarlatina was not so prevalent in October last as in October of the previous year. Diphtheria caused two deaths in October, 1877, but none in October, 1876. There were 35 deaths in the Borough of Wellington during October, 1877, against only 24 from all causes in October, 1876; but the number for last month is swelled by 7 accidental deaths from fire. deaths from fire.
