*Lands taken for a Road through Allotment number 12 of Section number 11, of the Suburbs of Auckland, Parish of Waitemata, and County of Eden.*

To His Excellency the Most Honorable GEORGE AUGUSTUS CONSTANTINE, Marquis of Normanby, Earl of Mulgrave, Viscount Normanby, and Baron Mulgrave of Mulgrave, all in the County of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majesty's Most Honorable Privy Council; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief of and in Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same.

THE humble memorial of the One Tree Hill District Highway Board, sheweth:

1. That your memorialists require to take for public works all those pieces or parcels of land in the Provincial District of Auckland, and Colony of New Zealand, being two portions of Allotment number twelve of Section number eleven, situate in the Suburbs of Auckland, Parish of Waitemata, and County of Eden. The first portion being fifty links wide in its narrowest part, and commencing one hundred and fifty links from Fountain Street. Bounded on the East by a line one hundred and seventy-eight links; on the South by a line forty-nine links; on the West by a line one hundred and fifty-seven links; being a triangular piece of land containing five perches; be the said several admeasurements a little more or less. The second portion commencing at the north-east corner of Mr. Murdoch's enclosed property in Fountain Street, and proceeding in a southerly direction to the Quarry Reserve at Mount Saint John, containing thirty-seven perches, more or less. Bounded on the North by Fountain Street, fifty links; on the East by land in the occupation of Mr. James Dilworth, three

hundred and seven links; on the North-east by the same land, one hundred and twenty-eight links; on the East by land in the occupation of Mr. D. L. Murdoch, twenty-nine links; on the South by the Quarry Reserve, two hundred and ten links; on the West-north-west and again on the West by land in the occupation of Mr. D. L. Murdoch, three links, forty-five links, and three hundred and twenty-eight links; be the said several admeasurements a little more or less. Both of which portions of land are delineated upon the map herewith to be laid before Your Excellency. For the purpose of altering the old line of road, and forming a new line of road fifty links wide, and otherwise to enable your memorialists to obtain an easier access to the Quarry Reserve on Mount Saint John, situated in their said district; the said pieces or parcels of land so required to be taken as aforesaid being the only access into the Educational Reserve which adjoins the said Quarry Reserve, and thereby benefiting both.

2. That your memorialists caused a survey to be made and plans to be prepared, showing generally the nature of the works proposed to be executed and the lands required to be taken for the same, together with the owners and occupiers of such land, so far as could be ascertained, and caused a copy of such plans to be deposited at the office of the said Board, at the Junction Hotel, Epsom, in the Provincial District aforesaid (the said office being in the said district where the said lands so required to be taken are situate), on the twenty-seventh day of June, one thousand eight hundred and seventy-seven, for the inspection of all persons at all reasonable hours.

3. That your memorialists, in pursuance of section number twenty-two of "The Public Works Act, 1876," aforesaid, caused to be gazetted or published in the New Zealand Government Gazette, issued at Wellington, in the Provincial District of Wellington, in the said Colony of New Zealand, on Thursday, the twenty-eighth day of June, one thousand eight hundred and seventy-seven, the following notice:—

"To the Owners or Reputed Owners, Lessees or Reputed Lessees, and Occupiers of Allotment number Twelve, of Section number Eleven, of the Suburbs of Auckland, Parish of Waitemata, and County of Eden.

"TAKE NOTICE that, in pursuance of 'The Public Works Act, 1876,' the plan and specifications relating to a road which the One Tree Hill District Highway Board propose to take over the above-mentioned allotment, are deposited for inspection at the Junction Hotel, Epsom. The general description of works proposed to be executed is, to alter the old road and to form a new line of road fifty links wide, and the land required to be taken for the said new line of road is fifty links wide in its narrowest part, commencing one hundred and fifty links from Fountain Street. Bounded on the East by a line one hundred and seventy-eight links; on the South by a line forty-nine links; on the West by a line one hundred and fifty-seven links; being a triangular piece of land containing five perches; be the said admeasurements a little more or less.

"And also all that other piece of land, in its narrowest part commencing at the north-east corner of Mr. Murdoch's enclosed property in Fountain Street, and proceeding in a southerly direction to the Quarry Reserve at Mount St. John, containing thirty-seven perches, more or less. Bounded on the North by Fountain Street, fifty links; on the East by land in the occupation of Mr. James Dilworth, three hundred and seven links; on the North-east by the same land, one hundred and twenty-eight links; on the East by land in the occupation of Mr. D. L. Murdoch, twenty-nine links; on the South by the Quarry Reserve, two hundred and ten links; on the West-north-west and again on the West by land in the occupation of Mr. D. L. Murdoch, three, forty-five, and three hundred and twenty-eight links; be the said admeasurements a little more or less.

"And that all persons affected by the proposed road are hereby called upon and required to set forth in writing any well-grounded objections to the execution of such works or the taking of such lands, and to send such writing within forty days from the publication of this notice to the said One Tree Hill District Highway Board, whose office is at the Junction Hotel, Epsom, Provincial District of Auckland.

4. That your memorialists also, in pursuance of the said section number twenty-two of "The Public Works Act, 1876," aforesaid, caused to be twice publicly notified in the *New Zealand Herald and Daily Southern Cross*, published at Auckland, in the Provincial District of Auckland aforesaid, on Wednesday and Thursday, the fourth and fifth days of July, one thousand eight hundred and seventy-seven, respectively, and circulating in the said district, the aforesaid notice published in the *New Zealand Government Gazette*, on Thursday, the twenty-eighth day of June, one thousand eight hundred and seventy-seven.

5. That your memorialists have ascertained that David L. Murdoch, and James Dilworth, and George

Howard, and Every Maclean, Trustees of the assigned estate of Henry Hardington, are the only owners and occupiers of the said two portions of land so required to be taken by the said One Tree Hill District Highway Board, for the purposes aforesaid.

6. That your memorialists have caused a copy of such notice and description so gazetted or published in the *New Zealand Government Gazette*, and twice notified in the *New Zealand Herald and Daily Southern Cross* newspaper, as aforesaid, to be served upon the said owners and occupiers, in the manner and on the dates set opposite their respective names, as follows:—

7. That forty days from the first publication of the aforesaid notice in the *New Zealand Government Gazette* have elapsed, and your memorialists have not within the said forty days from the said publication received any well-grounded objections, nor have any objections in writing whatever been made within the said forty days to your memorialists as to the execution of such works or the taking of such lands.

8. That your memorialists are of opinion that it is expedient that the proposed works should be executed, and that no private injury will be done thereby for which due compensation is not provided by the said "Public Works Act, 1876."

Therefore your memorialists humbly pray that your Excellency in Council, in accordance with section number twenty-five of "The Public Works Act, 1876," will be pleased, by Proclamation gazetted and publicly notified, to declare that the said lands are taken for the use of a road for the purposes above-mentioned.

A PROCLAMATION.

WHEREAS by "The Public Works Act, 1876," it is enacted that, whenever lands are required to be taken for public works, the Minister for Public Works in the case of Government Works, and the County Council or Road Board in the case of county

or district works, shall cause a survey to be made and plans to be prepared showing generally the nature of the works proposed to be executed and the lands required to be taken for the same, together with the names of the owners and occupiers of such lands as far as they can be ascertained, and shall cause a copy of such plans to be deposited in some place in the road district in which such lands are: And it is further enacted that the said Minister in the case of Government works, and the County Council or Road Board in the case of county works or district works, shall cause a notice to be gazetted, and to be twice publicly notified, stating the place where such plans are open for inspection, with a general description of the works proposed to be executed and of the land required to be taken, and in such notice shall call upon all persons affected to set forth in writing any well-founded objections to the execution of such works or to the taking of such lands, and to send such writing within forty days from the first publication of such notice to the said Minister, or to the County Council or Road Board, as the case may be: And it is further enacted that the Minister for Public Works, the County Council, or Road Board, as the case may be, shall cause a copy of such notice and description to be served upon the said owners and occupiers so far as they can be ascertained; and that the said Minister in the case of Government works, the Council in the case of county, and the Board in the case of district works, shall, upon receiving any objection, appoint a time and place within the colony within which the objector may appear before the said Minister, or some person appointed by him in the case of Government works, before the Council in the case of county, or before the Board in the case of district works, and support the objection by such evidence as the objector thinks fit; and that if within the said forty days no such objection is made, or if after due consideration of such objections the said Minister, or the County Council, or Road Board, as the case may be, is of opinion that it is expedient that the proposed works should be executed, and that no private injury will be done thereby for which due compensation is not provided by the Act now in recital, the land proposed to be taken shall be taken in the following manner—that is to say, the said Minister, or the County Council, or Road Board, shall lay before the Governor a memorial containing an accurate description of the land proposed to be taken, together with a map thereof, signed by the Surveyor-General or some certificated surveyor as evidence of the accuracy thereof; and the Governor in Council may thereupon, if he think fit, by Proclamation gazetted and publicly notified, declare that the said lands are taken for the use of a railway, road, or other public work, as the case may be; and from and after a date to be named in the said Proclamation the land therein specified shall become absolutely vested in fee-simple in Her Majesty, discharged from all mortgages, charges, claims, estates, or interests of what kind soever, for the public use named in the said Proclamation:

And whereas the lands described in the memorial above written are required to be taken under the authority of the said "Public Works Act, 1876," for a certain public work—to wit, the construction of a road through Allotment number twelve, of Section number eleven, of the Suburbs of Auckland, Parish of Waitemata, and County of Eden:

And whereas all the requirements and conditions prescribed by the said Act prior to the taking of such lands have been duly performed and fulfilled:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, Governor of New Zealand, in exercise and pursuance of the power and authority in

me vested by the said Act, and of any other power and authority enabling me in that behalf, do hereby proclaim and declare that the lands described in the memorial above written, and shown on the plan thereto attached, are hereby taken for the purposes of a road; and that from and after the day of the date hereof the said lands shall become absolutely vested in fee-simple in Her Majesty, discharged from all mortgages, charges, claims, estates, and interests of what kind soever, for use as a public road.

*Proclaiming Ross a Borough under "The Municipal Corporations Act, 1876."*

(L.S.) NORMANBY, Governor.  
A PROCLAMATION.

WHEREAS by section seventeen of "The Municipal Corporations Act, 1876," the Governor is empowered by Proclamation to declare any district in New Zealand to be a borough under the said Act, from and after a day to be named in such Proclamation:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the said Act, do hereby proclaim and declare that the District of Ross shall be and the same is hereby constituted, as from the first day of January, one thousand eight hundred and seventy-eight, a borough under the said Act; and that the name of such borough shall be the Borough of Ross, and that the boundaries of such borough shall be those specified in the Schedule hereto.

BOUNDED by a line commencing at a peg below Donogue's, at the most westerly corner of Block XXXIX.; thence along the Ocean Beach to the mouth of the Totara River; thence along the southern bank of the Totara River to its junction with Donnelly's Creek; thence along the western bank of Donnelly's Creek to the Jones's Creek Storm Channel; thence by said Storm Channel and Jones's

Creek to its source; thence in a direct line to the starting point.

*Altering the Limits of the Wairau Gold Field.*

(L.S.) NORMANBY, Governor.  
A PROCLAMATION.

WHEREAS by clause three of "The Gold Fields Act, 1866," the Governor is empowered from time to time, by Proclamation, to constitute and appoint any portion of the colony to be a gold field under the provisions of the said Act, and the limits of such gold field from time to time to alter as occasion may require:

And whereas it is expedient to alter the limits of the Wairau Gold Field, in the Provincial District of Marlborough:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the said Act, do, by this Proclamation, appoint that the boundaries mentioned in the Schedule hereto shall henceforth be the limits of the Wairau Gold Field aforesaid, instead of the boundaries defined in a Proclamation under the hand of Arthur Penrose Seymour, Esquire, Executive Officer for the Provincial District of Marlborough, in the Colony of New Zealand, bearing date the twenty-third day of May, one thousand eight hundred and seventy-seven.

SCHEDULE.

ALL that area in the Provincial District of Marlborough bounded towards the South and East by Ward's Pass Stream, from the saddle called "Ward's Pass" to its junction with the River Goulter; thence by the north-western boundary of Mount Patriarch Run to Mount Rintoul; thence by the north-eastern boundary of said run, from Mount Rintoul to the north-western angle of the North Bank Run; thence by the northern boundary of that run to the western boundary of the Hillersden Cattle Run; thence by a right line to Quartz Creek, at the most northern angle of the Quartz Run; thence by Quartz Creek to Bartlett's Creek; thence by Bartlett's Creek and the north-western boundary of Langley Dale Run to the most northern angle of Langley Dale Run; thence by a right line to the north-western angle of Langley Dale Run No. 2; thence by the northern boundary of that run and surveyed sections in Onamalutu Valley to the north-western corner of Section numbered 134, Onamalutu Valley; thence by a line

bearing North 47° East magnetic to a point one mile distant from the trunk line of road through the Kaituna Valley; thence by a right line bearing North magnetic to the watershed between the Onamalutu and Kaituna Valleys: thence towards the North and West by the watershed between the Onamalutu and Kaituna Valleys to the summit of the range between the Wairau and Pelorus Valleys; thence by that summit to the boundary of the provincial district; thence by that boundary to Ward's Pass Saddle: save and excepting all freehold lands, leasehold lands, surveyed sections, and land held under depasturing license within the aforesaid boundaries.

*Authority to charge Tolls on the Dray Road up Lankey's Creek, Inangahua, Nelson South West Gold Fields.*

NORMANBY, Governor.

IN pursuance and exercise of all powers and authorities enabling me in that behalf, under "The Gold Fields Act, 1866," and of all other powers so enabling me, I, George Augustus Constantine, Marquis of Normanby, Governor of the Colony of New Zealand, do hereby authorize and permit Alexander Ross and William John Sunderland, both of Inangahua, in the Nelson South West Gold Fields, to construct and occupy the dray road described in the First Schedule hereto, for a period of five years, to be computed from the first day of October, one thousand eight hundred and seventy-seven; and do also authorize the said Alexander Ross and William John Sunderland, in respect of the said road, to obtain payment from all persons using such road of the tolls or sums of money set forth in the Second Schedule hereto.

FIRST SCHEDULE.

ALL that dray road, of the width of half a chain, commencing on the Inangahua River, and following Lankey's Creek and a tributary thereof, and extending in a northerly direction about a mile and a half to land applied for by the said Alexander Ross and William John Sunderland for coal mining purposes.

WHEREAS by the twelfth section of "The Abolition of Provinces Act, 1875," it is, among other things, enacted that in every Act of the General Assembly, except such as relate to the election of Superintendents and Provincial Councils, and to legislation by such Councils, and the appointment of Deputy Superintendents, and to audit of provincial accounts, and matters of a like kind, and in every Act or Ordinance of the Legislature of an abolished province under the said Act, the expression "Provincial Gazette," or "Provincial Government Gazette," or other similar expressions, should, with respect to any provincial district, be deemed to mean "The New Zealand Gazette," or such newspaper as from time to time may be appointed by the Governor, for the purpose of inserting therein notifications of any kind relating to the Government of the colony or the administration of the Government within any provincial district: And whereas His Excellency the Governor has heretofore appointed the several newspapers specified in the first column of the First Schedule hereto to be the newspapers for inserting such notifications as aforesaid within the several provincial districts specified in the second column of the said Schedule, and whereas it is expedient to revoke such appointments and to appoint other newspapers in lieu thereof:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of every power and authority enabling me in that behalf, do hereby revoke the appointments so made as aforesaid, and in lieu thereof do hereby appoint the newspapers specified in the first column of the Second Schedule hereto to be the newspapers for the purpose of inserting therein notifications of the nature above-mentioned, within the provincial district named opposite the name of each newspaper respectively in such Schedule.
