DISTRICT OF THAMES, PROVINCIAL DISTRICT OF AUCKLAND.

At a sitting of the Native Land Court of New Zealand, holden at Whitianga, Mercury Bay, on the 28th day of November, 1877, and following days, before John Jermyn Symonds, Esquire, Judge, and Wiremu M. Hikairo, Assessor:

In the matter of the several applications of persons for the investigation of their claims to be interested in the several blocks of land named in the first column of the Schedule hereto, it was ordered that a memorial of the ownership of the several persons respectively named in the third column of the said Schedule be inscribed on a separate folium of the Court rolls.
