“Auckland Dog Nuisance Act, 1854,” in force within the County of Whangarei.

A PROCLAMATION.

WHEREAS by an Act of the Provincial Council of Auckland intituled “The Auckland Dog Nuisance Act (Session I., No. 4), 1854,” it is, among other things, enacted that the said Act shall come into operation in such districts as shall be proclaimed by the Superintendent in the Auckland Provincial *Gazette* to come within the operation of the said Act:

And whereas the powers vested in the Superintendent by the said Act are now, by “The Abolition of Provinces Act, 1875,” vested in the Governor: And whereas it is expedient that the district comprised within the County of Whangarei should be proclaimed to come within the operation of the said first-mentioned Act:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, do hereby proclaim and declare that, on and from the date of this Proclamation, the said “Dog Nuisance Act, 1854,” shall come into operation within the district comprised in the County of Whangarei, and the said Act shall extend and apply to the said County of Whangarei accordingly.

Given under the hand of His Excellency the Most Honorable George Augustus Constantine, Marquis of Normanby, Earl of Mulgrave, Viscount Normanby, and Baron Mulgrave of Mulgrave, all in the County of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majesty’s Most Honorable Privy Council; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-

in-Chief in and over Her Majesty’s Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at the Government House, at Auckland, this thirteenth day of March, in the year of our Lord one thousand eight hundred and seventy-eight.
