WHEREAS by a Royal Commission under the hand of His Excellency the Governor in Council, dated the 11th day of May, 1878, the undersigned Charles Heaphy, Esq., V.C., Commissioner of Native Reserves, was appointed a Commissioner to inquire respecting the claims of all or any aboriginal natives claiming to be owners or otherwise beneficially interested in the lands in the Provincial District of Wellington known as the Native Reserved "Tenths," or into the purposes and objects for which such lands respectively may have been intended, or to which their rents and profits should be applied; and, in pursuance of such inquiry, to take evidence on oath or otherwise, and to report to the Governor on the same:

Now, therefore, in pursuance of such Commission and directions, I do hereby give notice that I shall, on Friday, the 2nd of August, 1878, and the following days, at the Maori Hostelry, Wellington, proceed to inquire into the claims of the said Natives to the lands mentioned in the Schedule hereunder written, and into the proper manner in which the rents and profits derivable from such lands should be applied; and do call on all such Natives claiming ownership or beneficial interest in such lands, and on all other persons claiming interests therein, to appear at the above-mentioned time and place to prove their claims and interests.

CITY OF WELLINGTON.

- Town Acres Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 22, 24, and 25, in Aro Street, Polhill's Gully.
- Town Acres Nos. 26, 27, and 28, in E Puni Street.
- Town Acres Nos. 37, 39, 41, 43, and 45, in Wordsworth Street.
- Town Acre No. 49, in Willis Street, being Native Reserved "Tenths" awarded to the Te Aro Natives by Lieut.-Colonel McCleverty.
- Town Acres No. 893, Daniel Street; 864, in Coromandel Street; 972, 974, 976, 978, 980, 982, 984, 986, 988, 1098, 1099, and 1100, in Adelaide Road; Nos. 973, 975, 977, 979, 981, 983, 985, 987, and 989, in Rintoul Street. Nos. 993, 994, 996, 998, 1000, 1002, 1004, also in Rintoul Street; Nos. 995, 997, 999, 1001, 1003, and 1005, in Russell Terrace; with part of Town Acre 543, in Pipitea Street; being Native Reserved "Tenths."

TE ARO PA.

Subdivision No. 25, containing 10 perches, and No. 26, containing 10 perches.

WELLINGTON TOWN BELT.

Part of Block XV., lying between Town Acres Nos. 49 and 27 and 28, and to the southward of Wordsworth Street, containing 4 acres and 35 perches.

Part of Block XV.A., containing 35 acres 1 rood 24 perches, lying to the south of and contiguous to Town Acres Nos. 1, 2, 5, 7, 9, 10, and 11, near Polhill's Gully and part of Block XV.B., containing 18 acres 35 perches, lying to the west of and contiguous to the Gaol Reserve, being awards of Lieut.-Colonel McCleverty to Te Aro Natives.

## OHIO DISTRICT.

Sections 19 and 21, parts of, containing 175 acres, being an award of Lieut.-Colonel McCleverty to Te Aro Natives.

## KAIWHARAWHARA DISTRICT.

The site of the old pa at Kaiwharawhara, containing about 19½ perches, and western part of Block III., called Otara, containing 224 acres, awarded by Lieut.-Colonel McCleverty to the Kaiwharawhara Natives.

South-western part of Block III., or Otara, containing about 13½ acres, awarded by Lieut.-Colonel McCleverty to the Pipitea Natives.

## MAKARA DISTRICT.

The unappropriated portions of Sections 37 and 39, containing about 200 acres, with Sections 77, 88, and 97, called Kumuhore, containing about 351 acres, awarded by Lieut.-Colonel McCleverty to the Ohariu Natives.

## OHARIU DISTRICT.

Section No. 91, containing 139 acres and 26 perches, awarded by Lieut.-Colonel McCleverty to the Te Aro Natives.

No. 12 and part of No. 13, containing about 175 acres, being original Native Reserve "Tenths."

## KINAPORA DISTRICT.

Section No. 7 and part of 9, containing about 221 acres, awarded by Lieut.-Colonel McCleverty to the Pipitea Natives;

Also part of Section 7 and Section 8, containing 150½ acres, awarded by Lieut.-Colonel McCleverty to the Te Aro Natives.

## HARBOUR DISTRICT.

The Native Reserve cut out of Sections 7, 8, and 9, at Ngahauranga, awarded by Lieut.-Colonel McCleverty to the Ngauranga Natives.

## HUTT DISTRICT.

The land not adjudicated upon by the Native Land Court in Sections Nos. 1, 2, 3, 16, and part of 20, Hutt District, together with block to the westward of Sections 16 and 20, containing about 1,416 acres, with Section No. 11; Horokiwi Road District, containing about 100 acres.

Section No. 58, at Taita, containing about 91 acres and 6 perches.

Section No. 41, Lower Hutt District, containing about 152 acres 1 rood 36 perches, awarded by Lieut.-Colonel McCleverty to the Pitoone Natives.

Also the lands not adjudicated upon by the Native Land Court in the following sections, viz.:—

Waiwhetu District.—Section No. 19, containing about 106 acres.

Hutt District.—Section No. 57, containing about 125 acres; part of Section No. 58, containing about 15 acres; and the old pa site at Waiwhetu, containing about 3 acres 2 roods 39 perches; awarded by Lieut.-Colonel McCleverty to the Waiwhetu Natives.

## MUNGAROA DISTRICT.

Section No. 132, containing about 100 acres, being an original Native Reserved "Tenth."

## PAKURATAHI DISTRICT.

Sections Nos. 3, 4, and 7, containing about 350 acres.

## WAINUIOMATA DISTRICT.

Section No. 22, containing about 100 acres.

## MAKARA DISTRICT.

Sections Nos. 22 and 24, containing about 200 acres, being Native Reserved "Tenths."

**NOTE**MA i puta tetahi Kupu Whakahau a Te Kawana i roto i tana Runanga Whiri-whiri, he mea tuhi i te 11 o Mei, 1878, whakatu i a Te Hiwhi (Charles Heaphy, Esq., V.C.) Komihana o nga Whenua Rahui Maori tona ingoa kei raro iho nei hei Komihana tiro-tiro i nga take o nga tangata o etahi tangata Maori ranei e ki ana e whai take ana ratou e whiwhi ana ranei ratou i te painga i runga i nga whenua i te Takiwa Porowinitanga o Poneke e mohiotia nei ko nga whenua rahui Maori o te Kamupene o Niu Tireni, ki te tiro-tiro ano hoki i nga tikanga me nga ritenga i rahuitia ai aua whenua pera, te whakahaerenga ano hoki o nga reti me nga koha e puta ake ana i aua whenua, a i runga i taua tikanga tiro-tiro e ahei ana ia ki te whakarongo korero i runga i te whakaoti tikanga pera ranei, me te tuhi i te pukapuka whakaatu ki a Te Kawana.

Na reira hoki, i runga i te mana o taua Kupu Whakahau me nga kupu tohutohu mai ki au, ka whakaturia atu e abau tera ka haere atu abau ki te Tari Maori i Poneke a te Paraire te 2 o nga ra o Akuhata, 1878, me nga ra i muri iho ki reira tiro-tiro ai i nga take o aua Maori ki nga whenua kua tubia iho ki roto i te kupu apiti i raro iho nei, ki te tiro-tiro ano hoki i te tikanga e tika ai te whakahaere i nga reti me nga koha e puta mai ana i aua whenua pera, a he panuitanga tenei ki nga tangata Maori e ki ana e whai take ana e whiwhi ana i te painga ranei i runga i aua whenua pera, me era atu tangata e ki ana he take to ratou ki aua whenua pera kia haere mai ki taku aroaro i taua ra ki taua kainga kua korerotia i runga ake nei ki te whakatika i a ratou take me a ratou paanga ki te whenua.

Me te eka.—Nama 49 i Willis Tiriti, he tekau i whakataua e Kanara Mekereweti mo nga tangata o Te Aro.

Tetahi wahi o Poraka XV., e takoto ana ki waenganui o nga eka Nama 49, me 27 and 28, i roto i te taone kei te taha whakatetonga o Wordsworth Tiriti, e 4 eka e 35 paati, te nuinga o taua whenua.

Tetahi wahi o Poraka XV.A, e 35 eka i ruuru e 24 paati, kei te taha whakatetonga e tata ana ano hoki ki nga eka i roto i te Taone, Nama 1, 2, 5, 7, 9, 10, and 11, e patata ana ki Porohira Kare, me tetahi wahi o Poraka XV.B, e 18 eka e 35 paati kei te taha hauauru e tata ana ano hoki ki te wahi rahui i te whareherehere, ko aua whenua etahi o nga whenua i whakataua e Kanara Mekereweti mo nga Maori o Te Aro.

## TAKIWA O OHIRO.

Tetahi wahi o nga Tekihana 19 and 21, e 175 eka, he whenua i whakataua e Kanara Mekereweti mo nga Maori o Te Aro.

## TAKIWA O KAIWHARAWHARA.

Te tuunga o te Pa tawhito i Kaiwharawhara e 19½ paati nui ake iti iho ranei me te taha whakatetonga o Poraka III., tona ingoa ko Otara e 224 eka i whakataua e Kanara Mekereweti mo nga Maori o Kaiwharawhara.

Te taha whakate-hauauru-ma tonga o Otara 134 eka, nui ake iti iho ranei i whakataua e Kanara Mekereweti mo nga Maori o Pipitea.

## TAKIWA O MAKARA.

Te wahi toenga o Tekihana 37 and 39, e 200 eka, nui ake iti iho ranei me nga Tekihana 77, 88, and 97, tona ingoa ko Kumuhore e 351 eka, nui ake iti iho ranei i whakataua e Kanara Mekereweti mo nga Maori o Ohariu.

## TAKIWA O OHARIU.

Tekihana 91, e 139 eka e 26 paati i whakataua e Kanara Mekereweti mo nga Maori o Te Aro, Nama 12, me tetahi wahi o Nama 13, e 175 eka nui ake iti iho ranei he tekau i rahuitia i mua mo nga Maori.

## TAKIWA O KINAPORA.

Tekihana Nama 7, me tetahi wahi o Tekihana 9, e 221 eka, nui ake iti iho ranei i whakataua e Kanara Mekereweti mo nga Maori o Pipitea, tetahi wahi hoki o tekihana 7 me Tekihana 8 e 150½ eka i whakataua e Kanara Mekereweti mo nga Maori o Te Aro.

## TE TAKIWA O TE WAHAPU O PONEKE.

Ko te whenua rahui o roto o nga Tekihana 7, 8, and 9, i Ngahauranga i whakataua e Kanara Mekereweti mo nga tangata Maori o Ngauranga.

## TE TAKIWA O HERETAUNGA.

Te whenua i nga Tekihana Nama 1, 2, 3, 16, me tetahi wahi o Tekihana Nama 20, i te Takiwa o Heretaunga kahore ano i whakawakia e te Kooti Whenua Maori, me te Poraka ki te taha whakatehauauru o nga Tekihana 16 me 20, e 1416 eka, nui ake iti iho ranei me te Tekihana Nama 11, i te Takiwa o te rori o Horokiwi, e 100 eka, nui ake iti iho ranei, Tekihana Nama 58, i te Taita, e 91 eka e 6 paati, nui ake iti iho ranei. Tekihana Nama 41, i te wahi o Heretaunga, ki waho nei e 152 eka i ruuru e 36 paati, i whakataua e Kanara Mekereweti mo nga Maori o Pitoone, me nga Tekihana kua tuhia i raro iho nei kahore ano i whakawakia e te Kooti Whenua Maori, ara Tekihana Nama 19, i te Takiwa o Waiwhetu, e 106 eka nui ake iti iho ranei, me Tekihana 57, e 125 eka nui ake iti iho ranei, tetahi wahi o Tekihana 58, e 15 eka nui ake iti iho ranei, me te tuunga tawhito o te Pa i Waiwhetu e 3 eka 2 ruri e 49 paati nui ake iti iho ranei, i whakataua e Kanara Mekereweti mo nga Maori o Waiwhetu.
