

Proclaiming Ashburton a Borough under " The Municipal Corporations Act, 1876.'

NORMANBY, Governor. (L.S.) A PROCLAMATION.

WHEREAS by section seventeen of "The Municipal Corporations Act, 1876," the Governor is empowered by Proclamation to declare any district in New Zealand to be a borough under the said Act, from and after a day to be named in

such Proclamation : Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the said Act, do hereby proclaim and declare that the District of the Township of Ashburton shall be and the same is hereby constituted, as from the thirtieth day of July, one thousand eight hundred and seventy-eight, a borough under the said Act; and that the name of such borough shall be the Borough of Ashburton, and that the boundaries of such borough shall be those specified in the Schedule hereto.

SCHEDULE.

BOUNDED towards the North-east by Rural Sections Nos. 4906 and 5800, and also by lines in continuation of the south-west boundaries of these sections, for a distance of about eighty-nine (89) chains; towards the North-west by Rural Section No. 4905, and also by lines in continuation of the south-eastern boundary thereof, a distance of about forty-five (45) chains; towards the South-east by Rural Sections Nos. 4904 and 4873, and also by lines in continuation of their north-western boundaries, a distance of about ninety-seven (97) chains; and towards the South-west by the River Ashburton: as the same is de-lineated on the plans deposited in the Provincial District Survey Office, Christchurch.

Proclaiming Deposit of Memorial Plan of certain Lands taken for purposes of the Railway from Auckland to Newcastle, and Onehunga Branch (portions of).

NORMANBY, Governor. (L.S.) A PROCLAMATION.

WHEREAS by "The Immigration and Public Works Act, 1872," it is, among other things, enacted that, whenever it shall become necessary that any land which the Governor or the Minister is, by or under the Acts therein mentioned, or any Act authorizing the construction of any railway by the Governor or Minister, authorized to purchase or take for such railway, or any portion thereof, on or over which a railway authorized by the said Acts, or any Act to be passed in pursuance thereof, has been or may hereafter be constructed, should be vested in Her Majesty the Queen, it shall be lawful for the Governor or the Minister to cause a map of all such lands as may have been taken or purchased under

the said Acts or any Act authorizing the construction of any railway as aforesaid, or any portion of such railway, to be prepared. Such map shall fully and accurately set forth the pieces or parcels of land intended to be taken and permanently used, or which have been purchased or taken, or are required to be vested in Her Majesty for the purposes of any such railway, and shall be authenticated by the signature of the Minister, or by that of some person to be appointed by him for that purpose from time to time. And it is also enacted that the Minister shall cause the map to be deposited in the office of the Registrar of Deeds for the registration district within which the lands shall be situated, or if the lands set forth on any such map shall extend beyond the boundaries of any one district, then such map shall be prepared in so many parts as shall be requisite to delineate the lands within each such district, and the map or the parts thereof as aforesaid shall be deposited in the office of the Registrar of Deeds in each registration district where the lands shall be situated to which such map relates; but, for the purposes of the said Act, such map, although consisting of several parts, shall only be deemed to be one map: And whereas by the said Act it is further enacted that it shall thereupon be lawful for the Governor from time to time, by Proclamation in the New Zealand Gazette, to declare that the lands set forth in such map, or any of them, have been taken or acquired for the purposes of the railway in respect of which the same shall have been taken or acquired under the said Acts, or any Act authorizing the same to be taken or acquired; and in such Proclamation the lands intended to be affected shall be therein described by reference to such map so to be deposited as aforesaid: And whereas by "The Public Works Act, 1876," it is, among other things, enacted that the several Acts and Ordinances specified in the First Schedule thereto are thereby repealed, so far as in such Schedule specified, but shall notwithstanding remain in full force so far only as relates to anything done, appointment or instrument made, right or privilege accrued, work authorized, security taken or agreed to be taken, offence committed, forfeiture penalty or liability incurred, action prosecution or proceeding commenced, under the authority of or against the provisions of any such Act or Ordinance, before the passing of this Act: And whereas, in accordance with the provisions of the said in part recited Acts, the Minister for Public Works has caused a map of certain portions of lands which have been taken or purchased on the Auckland to Newcastle line of railway, to be prepared as by the said in part recited Acts is required; and the said map (marked P.W.D. 6483) is authenticated by the signature of the Honorable James Macandrew, as the Minister for Public Works : And whereas the said Minister, on or about the sixteenth day of July, one thousand eight hundred and seventy-eight, caused the said map to be deposited in the office of the Registrar of Deeds, at Auckland:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authority vested in me by the herein-before in part recited Acts, do hereby proclaim and declare that the lands set forth in the said map so deposited as aforesaid have been taken or acquired for the purposes of the hereinbefore mentioned railway from Auckland to Newcastle, which said railway is, by "The Railways Act, 1871," "The Railways Act, 1872," and "The Railways Act, 1873," authorized to be constructed and maintained under the provisions of "The Immigration and Public Works Act, 1870," and the several Acts amending the same. And in further pursuance and exercise of the said powers

and authority, I do hereby proclaim and declare that the lands intended to be affected by this Proclamation are described and delineated in the said map so deposited as aforesaid.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. $\mathbf{B}^{\mathbf{Y}}$ virtue of the powers and authorities vested in me by the eleventh section of "The Public Reserves Act, 1877," I, George Augustus Constantine, Marquis of Normanby, Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, do hereby order and declare that the reserve made for public recreation in the Provincial District of Canterbury, and known as the "Ellesmere Recreation Ground and described in the Schedule hereto, shall be and the same is hereby brought under the operation of and declared to be subject to the provisions of "The Public Domains Act, 1860," and its amending Acts; and such Domain shall hereafter be managed, ad-ministered, and dealt with in manner directed by the said Acts.

SCHEDULE.

ALL that parcel of land in the Ellesmere District, in the Provincial District of Canterbury, containing by admeasurement two hundred and thirteen (213) acres more or less, being Section numbered one thousand six hundred and thirty (1630) (in red). HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

HEREAS by the eleventh section of "The W Public Domains Act, 1860," it is enacted that the Governor, by Order in Council, may from time to time delegate all or any of the powers by the said Act conferred upon any person for any period, and subject to such stipulations as may be specified in such order, and that every such delegation may from time to time in like manner be altered or re-voked : And whereas it is enacted by "The Public Domains Act, 1865," that the word "person" in the hereinbefore recited section of "The Public Domains Act, 1860," shall be deemed to include more persons than one: And whereas, pursuant to "The Public Reserves Act, 1877," by an Order in Council of even date herewith, the land described in the Schedule thereto is declared to be brought under and to be subject to the said "Public Domains Act, 1860 :"

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of the Colony of New Zealand, doth, by this present order, delegate all the powers conferred by the Act first above mentioned, except the powers under or conferred by subsections five and ten of section five and section eleven, to the under-mentioned persons, who shall be known as the "Ellesmere Domain Board :"

> Samuel Lemon, John McKellab, WILLIAM BISHOP, LAURENCE VIVIAN DESBOROUGH, and WILLIAM GRAHAM,

(herein referred to as "the Board"), subject to the stipulations hereinafter contained, that is to say,-

1. The Board shall meet for the transaction of business on the first Monday in each month, at halfpast four p.m., at the office of the Chairman, or at such other place as may from time to time be fixed by the Board. The first meeting shall be held on Monday, the fifth day of August, one thousand eight hundred and seventy-eight.

2. Special meetings may be convened by the Chairman, or by any two members of the Board, provided that two days' notice of such meeting be given to each member, specifying the business to be transacted at such special meeting; and no other business than that so specified shall be transacted at such meeting.

3. Any three of the said Board shall form a quorum. Any meeting may be adjourned from time to time.

4. The members of the Board shall at their first meeting, and thereafter at an annual meeting to be held on the first Monday in January in every succeeding year thereafter, elect one of themselves to be Chairman, who may join in the discussion, and shall have an original as well as a casting vote. The Chairman shall hold office until the election of his successor.

5. If at any meeting the Chairman is not present at the time appointed for holding the same, the members present shall choose some one of their number to be Chairman of such meeting.

6. If by resignation, death, or incapacity, or other-wise, the office of Chairman shall be or become vacant, the members may at any monthly or special meeting appoint a Chairman.

7. All questions shall be determined by the majority of votes of the members of the Board present at a meeting.

And whereas a number of persons exceeding fifty have associated themselves together into a society for the purpose of promoting the advancement of agriculture, the improvement of stock, and the different branches of rural industry, and the arts therewith connected :

And whereas not fewer than two-thirds of such persons have presented a petition to the Governor in Council, praying for incorporation under the pro-visions of the said Act, as in the said petition more particularly mentioned :

Now, therefore, His Excellency the Governor of the Colony of New Zealand, in compliance with the terms of the said petition, in pursuance and exercise of the power and authority contained in the said Act, and by and with the advice and consent of the Executive Council of the said colony, doth hereby incorporate the said petitioners, and the whole other persons now being members of the said society, and such persons as shall hereafter be admitted members thereof agreeably to the rules of the said society and the provisions of the said Act, into a body corporate, by the style and title of "The Clutha Agricultural and Pastoral Society."

Validating Burgess Roll, and Extending Time for Election of Auditors, Borough of Sydenham.

HIS EXCELLENCY THE GOVERNOE IN COUNCIL. WHEREAS the valuation roll for the Borough W of Sydenham, under the provisions of "The Rating Act, 1876," was not completed in time to permit the things required by Part III. of "The Municipal Corporations Act, 1876," in the forma-tion of a burgess roll for the said borough, to be done on the days and within the periods specified in the said Part of the said Act :" And whereas it hath been made to appear that the Town Clerk for the said borough did, on or before the tenth day of June last, duly make out the burgess list required by the said Act, and did keep such list in his office, and allow it to be inspected without fee by all persons interested therein during all office hours until the twenty-fifth day of June inclusive, and did on the twelfth day of June publicly notify that the said list was so ready for inspection, and that objections thereto were to be delivered at such office on or before the said twenty-fifth day of June aforesaid; and that the Town Clerk did make and sign a list of all such objections in the form required by the said Act, and did allow it to be inspected without fee by all persons interested therein during all office hours from the twenty-sixth day of June to the first day of July inclusive; and that the Mayor of the said borough appointed a sitting of the said Council WHEREAS by "The Agricultural and Pastoral Societies Act, 1877," it is, among other things, enacted that, whenever any number of persons, not being less than fifty, shall have associated themselves together into a society for any of the purposes therein recited, it shall be lawful for the Governor in Coun-cil, on the petition of not fewer than two-thirds of meeting the burgess list so prepared as aforesaid was amended, and all alterations were initialled by the Mayor, and such burgess list was signed and certified by the Mayor and two other members of the Council, as required by the forty-sixth section of "The Municipal Corporations Act 1876:" And whereas it is expedient to validate the said proceedings:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, and in exercise and pursuance of the powers and authorities vested in me by "The Municipal Corporations Act, 1876," do hereby order that the times within which the said several things are required to be done by the said Act be extended from the days in that behalf specified in the said Act up to and inclusive of the several days and times hereinbefore in that behalf respectively mentioned. And with the like advice and consent I do hereby further order that the said several things so done as aforesaid, so far as the same have been respectively done after the times limited by the said Act, or have otherwise been ir-regularly done in matter or form, but not further or otherwise, shall be and the same are hereby validated, and that the burgess roll so amended as aforesaid shall be the burgess roll of the said borough. And with the like advice and consent I do hereby extend the time for the election of Auditors of the said borough until the eighth day of August, one thousand eight hundred and seventy-eight.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by "The Supreme Court Act, 1860," it is enacted that it shall be lawful for the Governor in Council from time to time to divide the colony into judicial districts for the purposes of the said Act, and the limits of such districts from time to time to alter as occasion may require, and that the Governor in Council shall assign every such district to a Judge or Judges of the Supreme Court, who shall have, within the same, all the powers and jurisdiction thereby given to the said Court:

And whereas the Northern District, as defined by a Proclamation dated the twenty-fifth day of November, one thousand eight hundred and sixtynine, and published in the New Zealand Gazette, dated the tenth day of December, one thousand eight hundred and sixty-nine, has been assigned to Thomas Bannatyne Gillies, Esquire, one of the Judges of the said Court:

And whereas it is expedient that the said Northern District should also be assigned to James Prendergast, Esquire, the Chief Justice of the Supreme Court:

Now, therefore, His Excellency the Governor, in pursuance and exercise of all powers enabling him in this behalf, doth hereby, with the advice and consent of the Executive Council of New Zealand, also assign the said Northern District, as defined by the said Proclamation dated the twenty-fifth day of November, one thousand eight hundred and sixtynine, unto

JAMES PRENDERGAST, Esquire, the Chief Justice of the said Court.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. THEREAS by "The Immigrants Land Act Amendment Act, 1875," it is enacted that, in any case where any person who, since the passing of "The Immigrants Land Act, 1873" (hereinafter referred to as "the said Act"), and prior to the coming into operation of the now reciting Act, has paid his own passage to the colony with the intention of settling upon and cultivating land therein, and who has omitted to obtain any certificate or to do any other act by the said Act required to entitle him to a free grant of land thereunder, whether such omission shall have occurred prior to or after arrival in the colony, it shall be lawful for the Governor, by Order in Council, on receiving proof that such person had a bona fide intention to comply with the said Act, to direct and declare that such person shall have and be entitled to all the privileges and benefits which he would have had under the said Act but for such omission as aforesaid. And, further, that every such Order in Council shall state specifically the nature of the omission in respect of which such order shall be made, and shall be forthwith published in the New Zealand Gazette; and thereupon the person named in such Order in Council shall have all the privileges and benefits which he would have had but for such omission as aforesaid ;

And whereas proof has been received by the Governor that the person mentioned in the first column of the Schedule hereto has paid his own passage to the colony with the intention of settling upon and cultivating land therein, and also that he had a *bond fide* intention to comply with the said Act, but has omitted to do the acts mentioned in the second column of the said Schedule, by the said Act required to entitle him to a free grant of land thereunder:

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of the Colony of New Zealand, and in exercise and pursuance of the power and authority vested in him by the said "Immigrants Land Act Amendment Act, 1875," doth hereby direct and declare that the person mentioned in the first column of the Schedule hereto shall have and be entitled to all the privileges and benefits which he would have had under the said Act but for such omission as aforesaid.



ABSTRACT of METEOROLOGICAL OBSERVATIONS, New Zealand, for the Month of APRIL, 1878.

The stations marked thus * are furnished with aneroid barometers only. NOTE .- Altitude of Bealey, 2,104 feet; Queenstown, 1,070 feet.

NOTES FOR APRIL, 1878.

Mongonui.—Fine weather generally, showery during middle and a few days towards end of month; the maximum rain recorded on 13th, 140 in.; strong wind on 13th, S.W., with thunder and rain; thunder also on 14th and 25th; fog on 3rd, 5th, and 23rd; prevailing westerly winds and light.

1:40 in.; strong wind on 18th, S.W., with thunder and rain; thunder also on 14th and 25th; log on otd, out, out, and 25th, provide westerly winds and light.
Auckland.—Generally fine and dry, but dull, warmer than usual; rainfall small, and chiefly light showers at nights; maximum rainfall recorded on 25th, 37 in.; wind very moderate, often calm, and prevailed from westward; fog on 21st.
Taranaki.—On the whole fine, though showery towards end of month; maximum rainfall registered on 24th, '84 in; winds prevailed from S.W.; strong from N.W. on 30th.
Napier.—Remarkably fine throughout; maximum rainfall on 9th, '22 in.; wind prevailed from southward and rather strong; on 15th strong breeze from East, and on 27th from S.W.; fog on 8th.
Wanganui.—Generally fine weather, with a fow showers; the maximum rainfall recorded on 24th, '34 in.; prevailing N.W. winds, and often strong; strong from N.W. ou 5th and 14th, and from S.W. on 15th and 19th.
Wellington.—Very stormy up to 3rd from N.W.; fine pleasant weather from 4th to 20th, with moderate winds; threatening on 21st and 22nd from N.E., and slight rain; wet and squally from N.W. on 23rd. '70 inches rain recorded on 24th, maximum for month; fine from 25th to 28th; stormy and unpleasant on 29th and 30th, with rain; wind changing from N.W. to S.E. during night of 30th; very slight rainfall for time of year, though degree of mosture for month high; prevailing N.W. wind.
Nelson.—Very fine, only a few showery days at end of month, the maximum fall on 24th, '63 in.; prevailing S.W. winds, strong on 18th, 19th, 20th, and 29th.
Cape Campbell.—Strong W. and N.W. gales almost constant up to 25th; on 30th N.W. gale; only one day of rain, on 17th, '08 in.;

Bealey.—Dull, gloomy, wet, and unpleasant month, with an occasional fine day; greatest rainfall recorded on 30th, 2'130 in.; thunder on 26th; fog on 9th, 10th, and 17th; gales on ten days; prevailing N. and N.W. winds, and strong throughout.
Hokitika.—Very wet unpleasant weather, but moderate winds prevailing from S.W. and N.W.; maximum rain recorded on 30th, 2'38 in.; thunder on 26th; hail on 26th; fog on 1st and 2nd.
Duradia —Fine at herinoing but character latter part of month, small writfall the maximum on 30th :442 in a maximum

 tnunder on 26th; hall on 26th; fog on 1st and 2nd.
 Dunedin.—Fine at beginning, but changeable towards latter part of month; small rainfall, the maximum on 30th, '442 in.; prevailing S.W. wind, but moderate, except on 15th, when it was stormy from that quarter; frequent calms; fog on 22nd and 30th.
 Queenstown.—Unsettled generally; often dull and threatening, but clearing off; prevailing westerly wind; stormy on 1st, N.W., and a gale on 14th from same quarter; maximum rain recorded on 30th, 1.42 in.; snow on hills on 3rd; fog on 11th and 30th.
 Southland.—Wet dull weather; maximum rain recorded on 21st, 1.15 in.; wind chiefly from westward, and frequently strong; hail on 15th and 72th. 15th and 17th.

GENERAL REMARKS.

The weather was exceedingly fine during this period, except at Bealey, where the rain was in excess, with strong westerly winds; also at Hokitika very wet, but winds moderate; and in the extreme South the rain was over the average, with cold stormy westerly weather. Earthquakes occurred at Warganui on the 4th, at 12.50 midnight; at Wellington on 28th, at 6.25 p.m., lasting 6 seconds, N. and S., very slight; at Cape Campbell on 11th, at 9 a.m., smart; and Blenheim, 11th, at 8.55 a.m., sharp, N. to E.; at Queenstown on the 25th, at 3.30 a.m., smart. A meteor was observed at Christchurch on 27th, in S.E.
