Southland High Schools Reserves.

(L.S.) NORMANBY, Governor. A PROCLAMATION.

WHEREAS by "The Southland Boys' and Girls' W High Schools Act, 1877," it is, among other things, enacted that it shall be lawful for the Commissioners appointed under "The Education Reserves Act, 1877," or for two Commissioners appointed for that purpose by the Governor, to select, out of the reserves for education in the Education District of Southland, such reserves as will give an annual income at present of five hundred pounds; and, on the Proclamation of the Governor that such reserves have been selected and set apart for the Southland Boys' and Girls' High Schools, the said reserves shall absolutely vest in the Southland Boys' and Girls' High Schools Board incorporated by the Act now in part recited: And whereas George Lumsden, Esquire, and Walter Henry Pearson, Esquire, were the Commissioners appointed by the Governor for the purposes aforesaid, and they have selected the reserves described in the Schedule hereto:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in exercise and pursuance of the powers and authorities vested in me by the said recited Act, do hereby proclaim and declare that the reserves particulars whereof are described in the Schedule hereto have, in pursuance of the provisions of the said recited Act, been selected and set apart for the Southland Boys' and Girls' High Schools in the said Act particularly referred to.

Boundaries of Hokonui Rabbit District extended.

NORMANBY, Governor. (r.s.) A PROCLAMATION.

WHEREAS by a Proclamation dated the twenty-VV first day of July, one thousand eight hundred and seventy-seven, the Governor did, in pursuance and exercise of the powers conferred upon him by "The Rabbit Nuisance Act, 1876," constitute and declare the area described in the Schedule thereto a district for the purposes of the said Act, under the name of the "Hokonui District:"

And whereas by the said recited Act the Governor is empowered from time to time to alter and redefine the boundaries of any district by Proclamation: And whereas it is expedient that the boundaries of the said Hokonui District should be altered and rede-

fined:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the said recited Act, and all powers enabling me in this behalf, do hereby proclaim and declare that, from and after the sixteenth day of September, one thousand eight hundred and seventy-eight, the boundaries of the Hokonui District shall be those set out in the Schedule hereto.

SCHEDULE.

DESCRIPTION OF THE AMENDED BOUNDARIES OF HOKONUI RABBIT DISTRICT.

ALL that area of country comprised within the following boundary lines, namely: commencing at the south-east angle of the Waimumu Survey District where it touches the Mataura River; thence westerly and northerly along the southern and western boundaries of said district to the Hokonui Survey District; thence due West to the Oreti River; thence northerly up said river, and along the Irthing Stream to the main road, Invercargill to Kingston; thence along said road to the source of the Paiherewao Creek; thence down said creek to the Mataura River; and thence down the Mataura River to the starting point.

Lands set apart as Endowments for Primary Education.

NORMANBY, Governor. (L.S.) A PROCLAMATION.

WHEREAS by "The Education Reserves Act, 1877," it is, amongst other things, enacted that, in order to provide an endowment for primary education in the North Island, at least five per centum of the waste lands in each district therein open for sale on the first day of January, one thousand eight hundred and seventy-eight, and a like per centum out of all land over which the Native title may thereafter be extinguished in each such district, and which should from time to time be acquired or purchased by or on behalf of the Crown, should be reserved and set apart as an endowment for the maintenance of primary education within the education district in which the land is situated:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in exercise of the powers and authorities vested in me by the said recited Act, and of every other power and authority me thereunto enabling, do hereby reserve and set apart the several blocks or parcels of land described in the Schedule hereto as endowments for the maintenance of primary education within the education districts of the North Island in which such blocks or parcels of land are respectively situated.

And whereas the lands described in the memorial above written are required to be taken under the authority of the said "Public Works Act, 1876," for a certain public work—to wit, the construction of a portion of the railway from Amberley to the Bluff, passing by Rangiora, Kaiapoi, Christchurch, Ashburton, Timaru, Oamaru, Palmerston, Port Chalmers, Duneldin, Balclutha, and Invercargill (Addington workshops):

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by the eleventh section of "The Public Domains Act, 1860," it is enacted that the Governor, by Order in Council, may from time to time delegate all or any of the powers by the said Act conferred upon any person for any period, and subject to such stipulations as may be specified in such order, and that every such delegation may from time to time in like manner be altered or rerom time to time in like manner be altered or revoked: And whereas it is enacted by "The Public Domains Act, 1865," that the word "person" in the hereinbefore recited section of "The Public Domains Act, 1860," shall be deemed to include more persons than one: And whereas, pursuant to "The Public Reserves Act, 1877," by an Order in Council of even date herewith, the land described in the Schedule thereto is declared to be brought under and to be subject to the said "Public Domains Act, 1860:"

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of the Colony of New Zealand, doth, by this present order, delegate all the powers conferred by the Act first above mentioned, except the powers under or conferred by subsections five and ten of section five and section eleven, to the under-mentioned persons, who shall be known as the "Opotiki Domain Board:"—

ROBERT KING, STEWART BATES, GEORGE STEVENSON, JOHN FORSYTH CONNELLY, and HENRY WATSON PENNY,

(herein referred to as "the Board"), subject to the stipulations hereinafter contained, that is to say,-

1. The Board shall meet for the transaction of business on the first Monday in each month, at seven o'clock p.m., at the office of the Chairman, or at such other place as may from time to time be fixed by the Board. The first meeting shall be held on Monday, the twenty-third day of September, one thousand eight hundred and seventy-eight.

2. Special meetings may be convened by the Chairman, or by any two members of the Board, provided that two days' notice of such meeting be given to each member, specifying the business to be transacted at such special meeting, and no other business than that so specified shall be trans-

acted at such meeting.

3. Any three of the said Board shall form a quorum. Any meeting may be adjourned from time

to time.

Regulations for the Payment of Grants to Education Boards.

NORMANBY, Governor. ORDER IN COUNCIL.

At the Government House, at Wellington, this seventeenth day of September, 1878.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

DY virtue of the powers and authorities vested in me by "The Education Act, 1877," I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, do hereby make the following regulations prescribing the times and manner at and in which the moneys appropriated by the General Assembly for the purposes specified by the Education Act aforesaid shall be paid and applied, that is to say,—

1. The grant under the Act of three pounds fifteen

shillings per annum for every child in average daily attendance at the public schools shall be made to the

Boards by monthly payments.

2. The moneys appropriated by the General Assembly, at the rate of ten shillings per annum for each child in average daily attendance, for distribu-tion amongst School Committees for educational purposes, shall be paid to the Boards monthly, and the whole of such moneys shall be distributed by the Boards amongst the School Committees according to a predetermined scale based upon the average daily attendance at the public schools under the charge of the several Committees, and shall form a portion of the School Fund to be disbursed by the Committees in terms of the Act.

3. The moneys appropriated by the General Assembly, at the rate of one shilling for each child in average daily attendance, and being the funds made specially applicable to the support of scholarships established by Boards under the provisions of the Act, shall be paid to the Boards once in every three months, or at such other times as the Minister may determine, according to the amount, not exceeding one shilling for each child in average daily attendance as aforesaid, shown by the Boards to be actually due

in respect of such scholarships.

4. The moneys appropriated by the General Assembly in aid of training institutions and the inspection of schools, for school buildings, and for any other purposes, shall, unless otherwise provided, be paid to Boards in such proportions and at such times as the Minister may determine.

- 5. In the months of April, July, October, and January respectively an account shall be taken of the amount of rents or profits received by each Board during the previous quarter in respect of lands or other property vested in the School Commissioners under "The Education Reserves Act, 1877;" and the amount in each case of such rents or profits shall be deducted from the grants thereafter payable to the Board.
- 6. Grants for special purposes shall be applied by Boards solely and exclusively to those purposes for which such grants have respectively been made; and the Minister may from time to time require from Boards statements showing in detail the application of any such special grant.
- 7. The monthly payments to Boards shall be made according to the ascertained average attendance of the preceding quarter, as shown by the summary statements of the quarterly attendance returns furnished by them in terms of the Order in Council of 28th May, 1878.
- 8. The form of the summary statement of quarterly attendance to be furnished by the Boards shall be as follows:-

The total deaths in these boroughs increased from 97 in July to 105 in August. In Wellington they increased from 13 in July to 25 in August; but in Christchurch there was a decrease in the number from 20 in July to 11 in August.

Zymotic Diseases.—The number of deaths from these causes was in the low proportion of 8:66 per cent. of the total deaths, the lowest proportion during 1877 having been 17:86 per cent. in August, and the highest 46:94 in January. Of these deaths last month, one from Diphtheria occurred in Wellington, and one from Typhoid Fever in Christchurch.

Constitutional Diseases.—Deaths from these diseases were somewhat more numerous than in July; of these Pthisis caused 13 in August, against 10 in July.

Local Diseases.—These diseases caused an increase in the number of deaths from 47 in July to 55 in August; deaths from diseases of the Respiratory Organs having increased from 12 in July to 19 in August, and diseases of the Digestive Organs from 5 in July to 11 in August.

The subjoined table shows the mortality for the two months at each town from six principal Zymotic diseases of the Miasmatic order, and also the deaths from certain inflammatory diseases of the lungs. These causes of death have been distinguished from the others of the classes to which they belong, as being the most important special diseases which give rise to sudden increases in the death-rates of towns, and the prevalence of which is closely connected with sanitary condition and climatic influence of the season on health.
