Constituting a River District within Marlborough.

(L.S.) NORMANBY, Governor.
A PROCLAMATION.

WHEREAS by "The Hawke's Bay and Marlborough Rivers Act, 1868," as amended by "The Hawke's Bay and Marlborough Rivers Acts Amendment Act, 1872" (hereinafter called "the said Acts"), it is, amongst other things, enacted that, upon the petition of the owners and occupiers of not less than three-fourths of the annual value of the rateable property of any district therein defined, any part of the province intersected or bounded by any river or rivers from the overflow of which damage may be apprehended, the Superintendent shall, by Proclamation in the *Provincial Gazette*, declare that this Act shall come into operation within such part of the province, and shall, by such Proclamation, define the boundaries of the same and declare the same to be a district under this Act, and shall also fix the name by which such district shall be known:

And it is also further enacted that the Superintendent shall also in such Proclamation determine the number of Conservators who are to constitute the Board for each such district, but in no case shall the number be less than five nor more than seven:

And whereas, by the operation of "The Abolition of Provinces Act, 1875," all the powers by the said Acts vested in the Superintendent are now vested in, and are to be exercised and performed by, the Governor:

And whereas a petition as aforesaid of the owners and occupiers of the district hereinafter mentioned has been presented to me, praying that the said Acts may be brought into operation within such district:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, Governor of the Colony of New Zealand, in exercise and pursuance of the power and authority vested in me by the said Act, and of every other power and authority in that behalf, do hereby declare and appoint that the said Acts shall come into operation within that part of

the Provincial District of Marlborough described in the Schedule hereto, on and after the seventeenth day of January instant; and do also declare and appoint that the said part of the Provincial District of Marlborough shall be and the same is hereby constituted a district under the said Acts, to be called by the name of "The Pukaka River District," the boundaries whereof shall be as described in the Schedule hereto, and also that the number of Conservators of which the said Board shall consist shall be five.

SCHEDULE.

BOUNDED towards the North by part of the southern boundary of Section forty (40), Pictou Suburban, and the south-eastern boundary of Section forty-one (41), Pictou Suburban; thence by part of the northern boundary of the same section to a point in transit with the eastern boundary of Section seven (7), Tuamarina Run, and by that boundary extended to the north-eastern corner of Section seven (7) aforesaid; thence by Crown land to the north-western corner of Section nine (9), Tuamarina Run, and by the western and part of the south-eastern boundary of that section to the north-western corner of Section eleven (11), Marshland Run; towards the East by Sections eleven (11), ten (10), and seven (7), Marshland Run, and forty-four (44) and forty-five (45), Pictou Suburban; and North-east by Section forty-five (45) aforesaid; thence by Crown land until it reaches the north-western boundary of Section four (4), North Bank of Wairau; thence by that section to its most southerly point; and thence by a reserve for a village and a Native reserve to a small creek; towards the South-west by a Native reserve to the Wairau River; thence towards the West by that river to a point in transit with the eastern boundary of a road line numbered one hundred and sixteen (116), and by that boundary extended and produced to the Wairau River aforesaid; thence by that river to a point in transit with the eastern boundary of Section fifty-two (52), Waitohi Valley, and by that section to a point in transit with the eastern boundary of Section fifty-one (51), Waitohi Valley;

and thence by that section to the starting point: as the same is more particularly delineated on the original plans which are deposited in the office of the Chief Surveyor, Blenheim.

Division of Borough of West Harbour into Four Wards, under "The Municipal Corporations Act, 1876."

(L.S.) NORMANBY, Governor.
A PROCLAMATION.

WHEREAS by "The Municipal Corporations Act, 1876," section twenty-one, it is enacted that, if not less than one-fourth of the burgesses of a borough petition the Governor, praying him to divide such borough into wards, the Governor may, by Proclamation, divide such borough into not less than three nor more than six wards, and shall in such Proclamation assign such names and boundaries to each ward as he thinks fit: And whereas not less than one-fourth of the burgesses of the Borough of West Harbour have petitioned me to divide such borough into four wards:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, the Governor of the Colony of New Zealand, in pursuance and exercise of the hereinbefore recited authority, do hereby proclaim and declare that the Borough of West Harbour shall be and the same is hereby divided into four wards, having the names mentioned in the first column of the Schedule hereto; and that the boundaries of such wards shall be those set forth in the second column of the said Schedule opposite the name of each ward respectively.

Rothesay Ward.	Comprises all that part of the Borough of West Harbour, bounded towards the North-west by a right line commencing at a point on the western boundary of Section numbered 2 of 29, Block IX., North Harbour and Blueskin Survey District, and proceeding to Trigonometrical Station E, said district, four thousand one hundred (4100) links; thence to a point on the south-western boundary of Section numbered 3 of 27 of the aforesaid block and district, seven hundred and twenty (720) links; thence towards the North-east by said Section 3 of 27 and Section numbered 26 of the aforesaid block and district, two thousand

Rothesay Ward —continued.	six hundred and sixty (2660) links; thence towards the East by said Section 26 and Section numbered 62 of the aforesaid block and district, a road line, and Sections numbered respectively 32B and 32A, Upper Harbour West Survey District, three thousand seven hundred and seventy-two (3772) links; thence across a road line to the Otago Harbour; thence towards the South by said Otago Harbour to Ravensbourne Ward, six thousand eight hundred (6800) links; and thence towards the West by Ravensbourne Ward to the starting point: be all the aforesaid linkages more or less; as the same is delineated on the plan deposited in the Survey Office, Dunedin.
Ravensbourne Ward.	Comprises all that part of the Borough of West Harbour, bounded towards the North-east by a line commencing at a point at Pelichet Bay, and forming the south-western boundary of Section numbered 51, Block IX., North Harbour and Blueskin Survey District, one thousand and ninety (1090) links; thence towards the North-west by a right line to a point on the western boundary of Section numbered 2 of 29, said block and said district, eight thousand one hundred and fifty (8150) links; thence towards the East by the said Section 2 of 29 and Section numbered 65 of the aforesaid block and district to the northern boundary of Section numbered 56 of the aforesaid block and district, one thousand two hundred and fifty (1250) links; thence towards the South-west by said Section 56, ninety-five (95) links; thence again towards the East by Section 56 aforesaid, two thousand five hundred and eighteen (2518) links; thence across a road line to the north-west corner of Section numbered 40, Upper Harbour West Survey District; thence by said Section 40, one thousand five hundred and fifty (1550) links; thence across a road line to the Otago Harbour; thence towards the South-east and South-west by said Otago Harbour, fourteen thousand eight hundred (14800) links to the starting point: be all the aforesaid linkages more or less; as the same is delineated on the plan deposited in the Survey Office, Dunedin.
St. Leonards Ward.	Comprises all that part of the Borough of West Harbour, bounded towards the North-west by a right line commencing at a point on the south-western boundary of Section numbered 3 of 27, Block IX., North Harbour and Blueskin Survey District, and proceeding to a point on the south-western boundary of Section numbered 2 of 5, said block and district, nine thousand nine hundred and ten (9910) links; thence towards the North-east by said Section 2 of 5 and Section numbered 63 of the aforesaid block and district, and Section numbered 13, Upper Harbour West Survey District, four thousand eight hundred and eighteen (4818) links; thence across a road line to the Otago Harbour; thence towards the South-east by said Otago Harbour to Rothesay Ward, seventeen thousand (17000) links; and thence towards the South-west by Rothesay Ward to the starting point: be all the aforesaid linkages more or less; as the same is delineated on the plan deposited in the Survey Office, Dunedin.
Sawyer's Bay Ward.	Comprises all that part of the Borough of West Harbour not included in the Ravensbourne Ward, the Rothesay Ward, and the St. Leonards Ward; as the same is delineated on the plan deposited in the Survey Office, Dunedin.

Sheep Districts of Nelson and Canterbury amended.

(L.S.) NORMANBY, Governor.
A PROCLAMATION.

WHEREAS by the eighth section of "The Sheep Act, 1878," it is enacted that the Governor, by Proclamation, may from time to time divide the colony into districts for the purposes of the said Act, and may also part any district into subdivisions; and that every such district and subdivision may from time to time, in like manner, be altered or constituted anew, in such manner as the Governor shall think fit:

And whereas, by Proclamation of the twenty-fourth day of December last, the colony was divided into districts for the purposes of the said Act, as the same are defined in the Schedule to the said Proclamation:

And whereas it is expedient to constitute anew the Nelson District and the Canterbury District for the purposes of the said Act and the subdivisions thereof respectively:

Now, therefore, I, George Augustus Constantine, Marquis of Normanby, Governor of the Colony of New Zealand, in exercise and pursuance of the powers and authorities vested in me by the hereinbefore recited Act, do hereby proclaim and declare that so much of the aforesaid Proclamation of the twenty-fourth day of December last passed as describes the Nelson District and the Canterbury District, and the subdivisions thereof, respectively, is hereby rescinded: And I hereby proclaim and declare that the Nelson District and the Canterbury District, and the subdivisions thereof, respectively, shall, for the purposes of the said Act, be as the same are described in the Schedule hereto, and that such districts and subdivisions shall be known respectively by the names set forth in the said Schedule; and that all boroughs in such districts shall be deemed to be included in the counties wherein they are situate.

SCHEDULE.

NELSON DISTRICT.

THE Nelson District shall comprise the following Subdivisions:—

The Buller and Grey Subdivision.

Bounded towards the West by the Pacific Ocean from the mouth of the River Heaphy to the mouth of the River Grey; thence up the River Grey to its junction with the Arnold River; thence up the Arnold River to Lake Brunner; thence up the boundary of the Provincial District of Westland until it strikes the eastern boundary of the Nelson South-West Gold Fields; thence by the eastern boundary of the

Nelson South-West Gold Fields to the junction of the Rivers Hope and Buller; thence in a straight line to the Karamea Bend on Square 156; thence in a straight line to Mount Peel; thence by the summit of the range to Mount Domett; thence in a straight line to the mouth of the River Heaphy.

The Golden Bay Subdivision.

Bounded by the sea-coast from the mouth of the River Heaphy to Reef Point, Tasman Bay; thence in a straight line to the summit of Mount Richards; thence in a southerly direction by the summit of the range to Mount Campbell; thence in a straight line to Mount Peel; thence by the northern boundary of the Buller and Grey Sheep District to the mouth of the Heaphy River, on the sea-coast.

The Motueka Subdivision.

Bounded Northward by high-water mark from Reef Point, Tasman Bay, to the West Bluff; thence in a straight line to the junction of the Motupiko and Motueka Rivers; thence by the boundary of the Nelson South-West Gold Fields to the junction of the Rivers Hope and Buller; thence by the boundary of the Buller and Grey Sheep District to the Karamea Bend; thence in a straight line to Mount Peel; thence following the boundary of the Golden Bay Sheep District to Reef Point.

The Nelson Subdivision.

Bounded by high-water mark from the West Bluff, following the coast line to Tennyson Inlet; thence following the boundary of the Provincial District of Marlborough to the Top House; thence in a straight line to Mount Mackay; thence following the boundary of the Nelson South-West Gold Fields to the junction of the Motupiko with the Motueka River; thence by a straight line following the boundary of the Motueka Sheep District to the West Bluff, on the sea-coast.

The Amuri Subdivision.

Bounded Southward by the Canterbury Sheep District; Westward by the eastern boundary of the Nelson South-West Gold Fields to Mount Mackay; thence by a straight line to the Top House; thence by the boundary of the Provincial District of Marlborough to the mouth of the River Conway; thence by the sea-coast to the mouth of the Waiau-ua or Dillon River.

CANTERBURY DISTRICT.

The Canterbury District is bounded towards the North by the south bank of the Waiau-ua or Dillon River, from its mouth to its source at Travers Peak; thence by right lines from peak to peak to the summit of Mount Hochstetter; thence to the saddle between the Hurunui and Teremakau Rivers; thence by a right line from peak to peak to the saddle at the source of the Dobson River; thence by the north bank of that river to its junction with the Ohou Lake; thence along the north bank of the Ohou Lake to the Ohou River; thence along the north bank of the Ohou River to its junction with the Waitaki; thence along the north bank of the Waitaki River to the ocean; and thence by the ocean to the starting point at the mouth of the Waiau-ua or Dillon River; and shall comprise the following subdivisions:—

The Northern Subdivision.

Bounded on the North by the northern boundary of the Canterbury Sheep District; on the West by the western boundary of said district; on the South by the north bank of the Waimakariri River from its source to the ocean; on the East by the ocean.

The Christchurch Subdivision.

Bounded on the North by the Northern Subdivision; on the West by the western boundary of the

the Canterbury Sheep District; on the South by the north bank of the Rangitata River from its source to the ocean; on the East by the ocean.

The Southern Subdivision.

Bounded on the North by the Christchurch Subdivision; on the West by the western boundary of the Canterbury Sheep District; on the South by the southern boundary of the Canterbury Sheep District; on the East by the ocean.

GOD SAVE THE QUEEN!

Australian International Exhibition.

Colonial Secretary's Office,
Wellington, 20th January, 1879.

REFERRING to the notice published in the *New Zealand Gazette* No. 36, of the 26th of April, 1878, relative to the Australian International Exhibition to be held in Sydney, New South Wales, in August, 1879, it is hereby further notified that the Government of New Zealand will be prepared to receive and to forward to Sydney any articles for exhibition which may be prepared by persons resident in this colony.

A Royal Commission will be appointed immediately, who will prepare and publish regulations under which they will receive exhibits for transmission.

As articles for exhibition should be shipped from Wellington not later than June next, persons wishing to exhibit are invited to communicate with Dr. Hector, the Chairman of the Royal Commission, without delay.

All expenses of transmitting and exhibiting approved articles will be defrayed by the Government; but, as experience has proved that in exhibitions of this kind the best effect is produced by a few well-displayed objects of considerable size, and as the space allowed to the colony for exhibition will be limited, a careful selection will have to be made, so that the representation may be complete.

The Collectors of Customs at the various ports have been instructed to receive exhibits, and to forward them to the Chairman of the Exhibition Commission at Wellington, by whom they will be collected and transmitted to Sydney; but no exhibits can be received later than the 30th June, 1879.

After the Exhibition is closed, the exhibits will be either returned to exhibitors free of expense, or sold or otherwise disposed of in Sydney, at the desire of the exhibitors; but the Government undertakes no responsibility for loss or damage, either in transit or during exhibition, or in regard to the price to be realized if sold, nor will they guarantee the safe remittance of the money.
