*Sheep Districts of Marlborough, Nelson, Westland, and Canterbury amended. Notice No. 12.*

A PROCLAMATION.

BY virtue and in pursuance of the powers and authorities vested in me by the eighth section of "The Sheep Act, 1879," and of all other powers and authorities enabling me in that behalf, I, Hercules George Robert Robinson, the Governor of the Colony of New Zealand, do hereby proclaim and declare that so much of the Proclamations of the twenty-fourth day of December, one thousand eight hundred and seventy-eight, and of the twentieth day of January, one thousand eight hundred and seventy-nine, as describe the Westland, the Marlborough, the Nelson, and the Canterbury Sheep Districts, and the subdivisions thereof, respectively, is hereby rescinded: And I hereby proclaim and declare, that the Marlborough, the Nelson, and the Canterbury Sheep Districts, and the subdivisions thereof, and also that the Waiau Sheep District, respectively, shall, for the purposes of the said Act hereafter, be as the same are described in the Schedule hereto, and that such districts and subdivisions shall be known respectively by the names set forth in the said Schedule; and that all boroughs in such districts shall be deemed to be included in the counties wherein they are situate.

SCHEDULE.

NELSON SHEEP DISTRICT.

ALL that parcel of land in the Provincial District of Nelson. Bounded towards the West and North by the sea from the mouth of the Grey River to head of that arm of Tennyson Inlet which approaches

nearest to Squally Cove, Croisilles Harbour; thence towards the East by a right line to Mount McLaren, thence along the summit of the watershed between the Pelorus and Blind Bay over Mount Elliot, Castor Peak, Mount Duppa to Saddle Hill, thence by a right line to the source of the Heringa River, thence by that river to its confluence with the Pelorus River, thence up that river to its source in the Red Hills, thence by the summit of the watershed between the Wairau River and Blind Bay, over Dun Mountain, Mount Richmond, Mount Rintoul to Ward's Pass, thence by Sections Nos. 7, 4, and 3, Wiesenhavern's Run, known as the Red Hills Reserve, thence westerly to and then along the summit of the St. Arnaud Range to Mount Franklyn, thence along the summit of the Spencer Range to Travers' Peak, and thence along the summit of the watershed to the saddle at the source of the Hurunui and Teremakau Rivers; and towards the South by a right line from thence to the issue of the Arnold River from Lake Brunner, thence by the right bank of the said river to its junction with the Grey River, and thence by the right bank of that river to its mouth, the starting point, and shall comprise the following subdivisions:—

*The Buller and Grey Subdivision.*

Bounded towards the North by a right line from the mouth of the River Heaphy to Mount Domett, thence along the summit of the range over Mount Snowdon to Mount Peel; towards the East by a right line from thence to the Karamea Bend on square 156, thence by a right line to the confluence of the Hope and Buller Rivers, thence by the nearest spur to the summit of the watershed between the Howard and Rotoroa Rivers, thence along the summit of that watershed to Mount Travers, thence along the summit of St. Arnaud Range to Mount

Franklyn, thence along the summit of the Spencer Range to Travers Peak, and thence along the summit of the watershed to the saddle at the source of the Hurunui and Teremakau Rivers; towards the South by a right line from thence to the issue of the Arnold River from Lake Brunner; thence by the right bank of that river to its junction with the Grey River, and thence by the right bank of that river to its mouth; and towards the West by the sea to the mouth of the River Heaphy, the starting point.

*The Golden Bay Subdivision.*

Bounded by the sea-coast from the mouth of the River Heaphy to Reef Point, Tasman Bay, thence in a straight line to the summit of Mount Richards; thence in a Southerly direction by the summit of the range to Mount Campbell, thence in a straight line to Mount Peel, thence by the Buller and Grey Subdivision to the mouth of the Heaphy River, the starting point.

*The Motueka Subdivision.*

Bounded towards the East by the sea from Reef Point, Tasman Bay, to the West Bluff; thence towards the South-east by a right line to the confluence of the Motupiko and Motueka Rivers, thence along the right bank of the Motupiko River to the boundary line between Sections Nos. 22 and 23, square 5, thence along that boundary and the production of it to the summit of the watershed between the Tadmor and Motupiko Rivers, thence along the summit of that watershed to the watershed between the Hope and Tadmor Rivers, thence along the summit of that watershed and by the nearest spur to the confluence of the Hope and Buller Rivers; towards the West by the Buller and Grey Subdivision hereinbefore described; and towards the North and North-west by the Golden Bay Subdivision to Reef Point, the starting point.

*The Nelson Subdivision.*

Bounded towards the North by the sea from the West Bluff to the head of that arm of Tennyson's Inlet, which approaches nearest to Squally Cove, Croisilles Harbour; thence towards the East by a right line to Mount McLaren, thence along the summit of the watershed, between the Pelorus and Blind Bay over Mount Elliot, Castor Peak, Mount Duppa to Saddle Hill, thence by a right line to the source of the Heringa River, thence by the right bank of that river to its confluence with the Pelorus River, thence by right bank of that river to its source in the Red Hills, thence by the summit of the watershed between the Wairau River and Blind Bay, over Dun Mountain, Mount Richmond, Mount Rintoul, to Ward's Pass; thence by Sections Nos. 7, 4, and 3, Wiesenhavern's Run, known as the Red Hills Reserve; thence Westerly to, and then along the summit of St. Arnaud's Range to Mount Travers; thence towards the South-west by the Buller and Grey Subdivision hereinbefore described, to the confluence of the Hope and Buller Rivers; and towards the West by the Motueka Subdivision hereinbefore described to the West Bluff, the starting point.

MARLBOROUGH SHEEP DISTRICT.

ALL that parcel of land, partly in the Provincial District of Nelson and partly in the Provincial District of Marlborough. Bounded towards the North and East by the sea from the head of that arm of Tennyson Inlet which approaches nearest to Squally Cove, Croisilles Harbour, to the mouth of the Waiarau or Dillon River; towards the South by the right bank of that river; towards the West again by the right bank of said river to the confluence of the Henry River, and by that river to its source at Travers' Peak, thence along the summit of the

Spencer Range to Mount Franklyn, thence along the summit of St. Arnaud Range to a point in line with the northern boundary of Section No. 3, Wiesenhavern's run, thence to and along the northern boundary of said section, thence along the western and northern boundaries of Sections No. 4 and 7, Wiesenhavern's run, known as the Red Hills Reserve to Ward's Pass, thence by the summit of the watershed over Mount Rintoul, Mount Richmond, and Dun Mountain, to the source of the Pelorus River, thence by that river to its confluence with the Heringa River, thence by that river to its source at Saddle Hill, thence by the summit of the watershed over Mount Duppa, Castor Peaks, Mount Elliot, Mount McLaren, to the starting point in Tennyson Inlet, and shall comprise the following subdivisions:—

*The Kaikoura Subdivision.*

Bounded towards the East by the sea from the mouth of the River Conway to the mouth of the River Kekerangu; thence North by the River Kekerangu to the junction of Benmore Stream, thence by that stream to its source, thence by a tributary of the River Ure to the southern boundary of the Chalk Range Run, thence by the southern boundary of the Chalk Range Run to the Upton Fells Run, thence by the southern boundary of Upton Fells Run to Upton Fells Run No. 2, thence by the south-eastern and south-western boundaries of Upton Fells Run No. 2 to Section No. 11 on the Upton Fells Run, thence by that section to the eastern boundary of the Camden Run No. 2, thence by that boundary and the southern boundaries of Camden Run No. 2 to the summit of the dividing range between the Awatere and Clarence Valleys; thence on the West by a line along the said summit to Lake McRae Run, thence by the eastern boundaries of that run to a point where a right line drawn from the junction of the Acheron and Clarence Rivers to the source of the Conway River intersects it, thence by a right line to the source of the River Conway, and thence by the right bank of that river to its mouth, the starting point.

*The Awatere Subdivision.*

Bounded towards the East by the sea from the mouth of the Kekerangu River to the mouth of the Awatere River; thence on the North and West by the Awatere River from its mouth to a point on Section 30, Wakefield Downs (being the south-western corner of the Vernon Run), thence by a right line to the south-western corner of Section 29, Wakefield Downs, thence by the eastern side of the road between Sections 33 and 29, Wakefield Downs, and Sections 4 and 2, of Block I., District of Awatere, to the Utawai Stream, thence by the Utawai Stream to the northern boundary of Section 2, of Block I., District of Awatere, thence along that boundary to Maxwell Pass Stream, thence by the Maxwell Pass Stream to the watershed, thence by a tributary of the Taylor River to the Taylor River at the base of a hill called the "Maori," thence by the northern boundaries of the Dumgree and Blairich Runs to the summit of the dividing range between the Awatere and Wairau Valleys to Langridge Run No. 2, thence by the western boundary of that run to the summit of the range, thence by the said summit to Saxon's Pass, thence by the stream running out of Saxon's Pass to the Acheron River, thence by that river to the junction of the Saxon, thence by the Saxon for a distance of two hundred and ten (210) chains; thence by a line due East and West to intersect a right line drawn from Tophouse to Barefell Pass, thence by part of said line to Barefell Pass, thence by the Guide River to its confluence with the Acheron River, thence by

that river to its confluence with the Clarence River; thence towards the South by a right line to a point on the Clarence River, where a right line drawn from the junction of the Acheron and Clarence Rivers to the source of the River Conway intersects it; thence towards the South-east by the Kaikoura Subdivision hereinbefore described to the mouth of the Kekerangu River, the starting point.

*The Blenheim Subdivision.*

Bounded towards the East by the sea from the mouth of the Awatere River to the north-east corner of Native Reserve at White's Bay; towards the North by a right line to the north-eastern corner of Section No. 37, Picton Suburban, thence by the northern boundary of that section produced to the Tua Marina River, thence by the northern boundary of the Raydale Run to the north-western corner of that run, thence by a right line to the north-western corner of Section No. 9, Okaramio Valley, thence by a right line to the north-eastern corner of Section No. 72, Havelock Suburban, thence by a right line to the south-west corner of Section No. 85, Havelock Suburban, thence by the watershed between the Atuhau Stream and the Kaituna River to the watershed between the Wairau and Pelorus Valleys, and by that watershed to the watershed between the Wairau River and Blind Bay; towards the North-west by that watershed over Mount Rintoul to Ward's Pass, thence along the northern and western boundaries of Sections No. 7, 4, and 3, Wiesenhavern's Run, known as the Red Hills Reserve, to the Wairau River, thence northerly along the right bank of that river to a point in line with Tophouse and Barefell Pass; towards the West by a right line from thence to the Awatere Subdivision hereinbefore described; and towards the South by the said Awatere Subdivision to the mouth of the Awatere River, the starting point.

*The Picton Subdivision.*

Bounded towards the North and East by the sea, from the head of that arm of Tennyson's Inlet which is nearest to Squally Cove, Croisilles Harbour, to White's Bay; towards the South by the Blenheim Subdivision, hereinbefore described, to the watershed between the Wairau River and Blind Bay; towards the West by the summit of that watershed over Mount Richmond and Dun Mountain, to the source of the Pelorus River, thence by that river to its confluence with the Heringa River, thence by that river to its source at Saddle Hill, thence by the summit of the watershed over Mount Duppa, Castor Peak, Mount Elliot, and Mount McLaren, to Tennyson's Inlet the starting point.

*The Amuri Subdivision.*

Bounded towards the East by the Blenheim, Awatere, and Kaikoura subdivisions, hereinbefore described, from the Wairau River to the mouth of the River Conway, thence by the sea to the mouth of the Waiauua or Dillon River; towards the South by the right bank of that river; towards the West again by the right bank of the said river to its confluence with the Henry River, thence by that river to its source at Travers' Peak; and towards the North-west by the summit of the Spencer Range to Mount Franklyn, thence by the summit of St. Arnaud Range, to a point in line with the northern boundary of Section No. 3, Wiesenhavern Run, thence to and by said Section and the Wairau River to the starting point.

WAIUAU SHEEP DISTRICT.

ALL that parcel of land in the Provincial District of Nelson. Bounded towards the North by the Henry River, from its source at Travers Peak to its con-

fluence with the Waiauua or Dillon River; thence towards the East by the right bank of that river to the boundary fence between St. Leonard's Run and Culverden and Balmoral Runs, thence by that fence to the Hurunui River, at a point at or near the confluence of the Pahau River, thence due south to the right bank of the Hurunui; towards the South by the right bank of the Hurunui River to its source at the saddle between the Hurunui and Teremakau Rivers; and towards the West by the summit of the watershed to Travers Peak, the starting point.

CANTERBURY SHEEP DISTRICT.

ALL that parcel of land partly in the Provincial Districts of Nelson, Canterbury, and Westland. Bounded towards the North by the right bank of the Grey River, from its mouth to the confluence with the Arnold River, thence by the right bank of that river to Lake Brunner, thence by a right line to the saddle between the Teremakau and Hurunui Rivers, thence to and by the right bank of the Hurunui River, to a point due south of where the boundary fence between St. Leonards Run, and Balmoral and Culverden Runs strikes the Hurunui at or near the confluence of the Pahau River; towards the West by that boundary fence to the Waiauua or Dillon River, again towards the North by the right bank of that river to its mouth; towards the East by the sea to the mouth of the Waitaki River; towards the South by the right bank of that river to the confluence of the Ohau River, thence by the right bank of that river to its issue from Ohau Lake, thence along the northern and eastern shore of that lake to the confluence of the Dobson River, thence by the right bank of that river to its source in the Southern Alps, thence by the summit of the Southern Alps to Mount Aspiring, thence by a right line to the mouth of the Awarua River; again towards the West by the sea to the mouth of the Grey River, the starting point; and shall comprise the following subdivisions:—

*The Westland Subdivision.*

Bounded towards the North by the right bank of the Grey River from its mouth to its junction with the Arnold River, thence by the right bank of that river to Lake Brunner, thence by a right line to the saddle at the source of the Hurunui and Teremakau Rivers; towards the South-east by lines from peak to peak along summit of the Southern Alps to Mount Aspiring; thence towards the South by a right line to the mouth of the Awarua River; and towards the West by the sea to the mouth of the Grey River, the starting point.

*The Northern Subdivision.*

Bounded towards the North by the right bank of the Hurunui River from its source at the saddle to a point due south of where the boundary fence between St. Leonards Run and Culverden and Balmoral Runs strikes the Hurunui River at or near the confluence of the Pahau River, thence towards the West by that line of fence to the Waiauua River, thence again towards the North by the right bank of that river to the sea; towards the East by the sea to the mouth of the Waimakariri River; towards the South by the right bank of the Waimakariri River to its source in the Southern Alps; and towards the West by the Westland Subdivision hereinbefore described to the saddle at the source of the Hurunui River, the starting point.

*The Christchurch Subdivision.*

Bounded towards the North by the Northern Subdivision hereinbefore described from the source of the Waimakariri River to its mouth; towards the East by the sea to the mouth of the Rangitata River; towards the South-west by the right bank of that

river to its confluence with the Clyde River, and thence by the right bank of that river to its source in the Southern Alps; and towards the West by the Westland Subdivision hereinbefore described to the source of the Waimakariri River, the starting point.

*The Southern Subdivision*

Bounded towards the North-east by the Christchurch Subdivision hereinbefore described, from the source of the Clyde River to the mouth of the Rangitata River; towards the East by the sea to the mouth of the Waitaki River, thence towards the south-west by the right bank of that river to its confluence with the Ohau River, thence by the right bank of that river, the north-eastern shore of Ohau Lake, and the right bank of the Dobson River to its source in the Southern Alps; and towards the West by the Westland Subdivision hereinbefore described to the source of the Clyde River, the starting point.

*Operation of Sections of "Sheep Act, 1878," suspended in Marlborough and in Amuri. Notice No. 13.*

A PROCLAMATION.

BY virtue and in pursuance of the powers and authorities vested in me by the second section of "The Sheep Act, 1878," and of all other powers and authorities enabling me in that behalf, I, Hercules George Robert Robinson, Governor of the Colony of New Zealand, do hereby proclaim and order that, in the subdivisions of the Marlborough Sheep District, including the Amuri Subdivision, as the same are constituted by Proclamation under the said Act, dated the twenty-third day of September, one thousand eight hundred and seventy-nine, being

within, or partly within, the Provincial Districts of Marlborough and Nelson, the operation of sections twenty-three, twenty-five, twenty-six, twenty-seven, twenty-eight, and twenty-nine of "The Sheep Act, 1878," shall be and is hereby suspended until the thirty-first day of December, one thousand eight hundred and eighty, inclusive; and I do hereby further declare that the exercise of this present authority shall not be deemed to preclude me from similarly suspending the operation of any of the aforesaid sections of the said Act for a further period within the same subdivisions, if it shall be found necessary so to do.

*Revoking notice declaring Clean and Infected Sheep Districts and declaring New Clean and Infected Sheep Districts within the Colony.—Notice No. 14.*

IT is hereby notified that, under the provisions of Section 9, of "The Sheep Act, 1878," His Excellency the Governor, this day, has revoked the notice bearing date the 28th February, 1879, constituting Clean Sheep Districts and Infected Sheep Districts.

IT IS FURTHER NOTIFIED that under the above-named authority His Excellency the Governor, this day, has declared the Sheep Districts of Napier, Canterbury, and Otago, as defined in the Proclamations of 24th December, 1878, and 23rd of September, 1879, to be Clean Sheep Districts; and the Sheep Districts of Auckland, New Plymouth, Wellington, Nelson, Waiau, and Marlborough, as defined in the same Proclamations, to be Infected Sheep Districts.
