Land set apart on Deferred Payments in Otago.

(L.S.) HERCULES ROBINSON, Governor. A PROCLAMATION.

THEREAS by the fifty-third section of "The Land Act, 1877," it is enacted that the Governor, by Proclamation in the Gazette, may from time to time set apart out of any suburban or rural lands such blocks or allotments of land as he shall think fit, and set the same aside for sale on deferred payments, and in such Proclamation may fix a day on which the land shall be open for application; and that he may also in like manner set apart for sale on deferred payments such blocks or allotments as may be recommended by any Land Board, and may also from time to time alter, amend, or revoke any such Proclamation:

And whereas the Land Board of Otago did, on the twelfth day of November, one thousand eight hundred and seventy-nine, pass a resolution recommending that the land described in the Schedule hereto annexed should be set apart for sale on deferred payments:

And whereas it is expedient to give effect to the aforesaid recommendation, and to set apart the said

land accordingly:

Now, therefore, I, Sir Hercules George Robert Robinson, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the above-named Act, do hereby proclaim and declare that the land described in the Schedule hereto is set apart for sale on deferred payments; and that Thursday, the fifteenth day of January, one thousand eight hundred and eighty, shall be the day on which the said land shall be open for application at the Land Office at Dunedin, in allotments as surveyed and marked on the survey map in the office of the Chief Surveyor.

WHEREAS by "The Maori Real Estate Management Act, 1867" (hereinafter called "the said Act"), it is enacted that, if any title to or interest in any hereditaments shall accrue to any Maoris, who or any of whom shall be infants, lunatics, or under legal disability, it shall be lawful for the Governor in Council, if he think fit, to order that such hereditaments, or any part thereof or interest therein, as shall to the Governor in Council be shown to belong to such infant, or lunatic, or other person under legal disability, shall be vested in trustees, as the Governor in Council shall think fit:

And whereas by an order bearing date the twentieth day of December, one thousand eight hundred and seventy-six, under the hand of John Rogan, Esquire, Judge of the Native Land Court, under the seal of the said Court, it was ordered that a memorial of the ownership of Peraniko Patio to the land and heredita ments described in the Schedule hereto be inscribed

on the Court rolls:

And whereas the said Aperaniko Patio is an infant under the age of twenty-one years, and it is expedient that Mehaka Ngahue be appointed trustee under the said Act, on behalf of the said Aperaniko Patio (a

minor fourteen years old):

Now, therefore, His Excellency the Governor of the Colony of New Zealand, with the advice and consent of the Executive Council of the colony, in exercise and in pursuance of the powers and authorities vested in him by the said Act, doth hereby order that the interest and share of the said Aperaniko Patio in the land described in the Schedule hereto shall be and remain vested in

EXHIBITION OF FLASHING WHITE LIGHT ON AKAROA HEAD, BANKS PENINSULA, EASTERN COAST OF MIDDLE ISLAND, NEW ZEALAND.

WITH reference to the preliminary notice issued by this department, dated the 16th day of August last, it is hereby notified that, on and after Thursday, the 1st day of January, 1880, a light will be exhibited from the lighthouse which has been erected on Akaroa Head, the position and character-

istics of which are as follow: The Akaroa Head Lighthouse is situated on Akaroa Head, at the eastern side of the entrance to Akaroa

Harbour, Banks Peninsula.

The tower is 28 feet in height, and is built of timber and painted white. The light will be a SECOND ORDER FLASHING WHITE LIGHT, visible all round as far as the land admits, and will show a FLASH EVERY TEN SECONDS.

The light will be elevated about 270 feet above the sea, and, allowing 15 feet for the height of the eye, will be seen at a distance of $22\frac{s}{10}$ nautic miles in clear weather, and at lesser distances according to the state of the atmosphere.
