A PROCLAMATION.

WHEREAS by the fifty-third section of "The Land Act, 1877," it is enacted, that the Governor, by Proclamation in the *Gazette*, may from time to time set apart out of any suburban or rural lands such blocks or allotments of land as he shall think fit, and set the same aside for sale on deferred payments, and in such Proclamation may fix a day on which the land shall be open for application; and that he may also in like manner set apart for sale on deferred payments such blocks or allotments as may be recommended by any Land Board, and may also from time to time alter, amend, or revoke any such Proclamation:

And whereas the Land Board of Southland did, on the twenty-ninth day of December, one thousand eight hundred and seventy-nine, pass a resolution recommending that the land described in the Schedule hereto annexed should be set apart for sale on deferred payments:

And whereas it is expedient to give effect to the aforesaid recommendation, and to set apart the said land accordingly:

Residence Clauses of Land Act not to apply to certain Lands in Taranaki.

A PROCLAMATION.

IN pursuance of the powers and authorities conferred upon me by the fourth section of "The Land Act 1877 Amendment Act, 1879," I, Sir Hercules George Robert Robinson, the Governor of the Colony of New Zealand, do hereby proclaim and declare that the provisions of subsection four of section sixty-three of "The Land Act, 1877," shall not apply to the whole or any part of the lands described in the Schedule hereto, which were set apart for alienation upon deferred payment prior to the passing of "The Land Act 1877 Amendment Act, 1879," aforesaid.
