

Land taken for Road in the Town of Dargaville, Kaihu Survey District, Hobson County.

(L.S.) JAMES PRENDERGAST, Administrator of the Government. A PROCLAMATION.

WHEREAS the land described in the Schedule hereto is required to be taken under "The Public Works Act, 1876," and "The Public Works Act 1876 Amendment Act, 1878," for a certain work, to wit, the construction of a road in the Town of Dargaville, Kaihu Survey District, County of Hobson:

And whereas the Hobson County Council has laid before the Administrator of the Government the memorial and map mentioned in and signed and certified as required by the said Acts:

certified as required by the said Acts: Now, therefore, I, James Prendergast, the Administrator of the Government of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, in exercise and pursuance of the powers and authorities in me vested by sections twenty-one, twenty-two, twenty-three, twenty-four, and twenty-five of "The Public Works Act, 1876," and by section twenty-eight of "The Public Works Act 1876 Amendment Act, 1878," and of any other power and authority enabling me in that behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes of a road; and that, from and after the fourth day of November, one thousand eight hundred and eighty, the land so described shall become absolutely vested in fee-simple in Her Majesty, discharged from all mortgages, charges, claims, estates, and interests of what kind soever, for use as a road.

# SCHEDULE.

ALL that piece or parcel of land containing by admeasurement 1 rood 12 perches, more or less, being portion of the Tunatahi Block, No. 1844, commencing at the northernmost corner of Allotment No. 1. Bounded—North-westerly by a line, 137 links; North-easterly by a line, 260 links; South-

easterly by the Wairoa River, 136 links; Southwesterly by a line to commencing point, 220 links.

All that piece or parcel of land containing by admeasurement 4 acres 1 rood 19 perches, more or less, being portion of the Tunatahi Block, No. 1844, commencing at a point distant from the southernmost corner of Allotment No. 201, 200 links. Bounded— Westerly by a line, 80 links; generally South-easterly by the Kaihu Creek, the Wairoa River, and by lines, 1380, 75, 1293, 100, and 1640 links respectively; North-easterly by a line, 104 links; generally Northwesterly by lines to commencing point, 1630, 100, 1342, 150, 250, and 866 links respectively.

All that piece or parcel of land containing by admeasurement 5 acres and 30 perches, more or less, being portion of the Tunatahi Block, No. 1844, commencing at the easternmost corner of Allotment No. 80. Bounded—Generally South-westerly by lines, 2945 and 965 links respectively; Northerly by a line, 180 links; generally North-easterly by lines, 830 and 2900 links respectively; South-easterly by a line to commencing point, 137 links: the above parcels of land being situate in the Kaihu Survey District, Town of Dargaville, Provincial District of Auckland, and are more particularly delineated upon the plan hereto attached and coloured red.

Defining the Middle Line of Portion of the Waitaki-Bluff Railway—Branch Line from Palmerston to Waihemo (Dunback Section).

### (L.S.) JAMES PRENDERGAST, Administrator of the Government. A PROCLAMATION.

WHEREAS the branch line of railway from the main line, Waitaki to Bluff, is one of the railways specified in the First Schedule to "The Public Works Act, 1879," and which Act is therein declared to be a special Act authorizing the construction of such railway; and the same is unfinished, and it has been determined to construct and maintain a further portion of such railway:

Now, therefore, I, James Prendergast, Chief Justice of the Colony of New Zealand, and Administrator of the Government thereof, in exercise and in pursuance of the powers and authorities conferred on me by sections one hundred and twenty-two, one hundred and twenty-three, one hundred and twentyfour, and one hundred and twenty-five of "The Public Works Act, 1876," and in exercise of every other power and authority enabling me in that behalf, do hereby proclaim and declare that the middle line of the said further portion of the said railway shall be from a point in Section number sixty, Block seven, Moeraki Survey District, to a point in Section number thirty-three, Block four, Dunback Survey District, all within the Provincial District of Otago, as defined and set forth in the Schedule hereto. The said middle line and the land through which the same passes are set forth in the map and plan marked P.W.D. 7761, and authenticated for the purposes of this Proclamation by the signature of the Honorable Richard Oliver, Minister for Public Works, and which said map and plan is deposited in the office of the Registrar of the Supreme Court at Dunedin, in the Provincial District of Otago.

### SCHEDULE.

COMMENCING at a point in Section No. 60, Block VII., Moeraki Survey District, distant about 9 chains in a south-westerly direction from the north-eastern corner of said section; proceeding thence generally in a north north-westerly direction for a distance of 4 miles 40 chains or thereabouts; passing in, through, over, or into the following territorial divisions, situated in the Provincial District of Otago and Colony of New Zealand, viz. : The said Block VII., Sections Nos. 52, 49, 47, 39, 37, 36, 34, 32, 30, 29, 18, 17, 15, and 13, Block VIII., Sections Nos. 32, 30, and 35, in the said Moeraki District, and Block IV., Sections Nos. 42, 36, 34, Dunback Survey District, and terminating at a point in Section No. 33 in the said Block IV., distant about 13 chains in a southeasterly direction from the northernmost corner of said Section No. 33, and including all adjoining and intervening places, lands, reserves, streams, and watercourses; in the manner delineated on a plan marked P.W.D. 7761, which plan is signed by the Honorable Richard Oliver, Minister for Public Works, and deposited in the office of the Registrar of the Supreme Court at Dunedin; the total length of the middle line as above described being about 4 miles 40 chains.

IIS Excellency the Administrator of the Government of the Colony of New Zealand, having received the certificate required by the twenty-fifth section of "The Diseased Cattle Act, 1871 " (hereinafter called "the said Act "), to the effect that Lots numbers seven, eight, nine, ten, eleven, twelve, thirteen, fourteen, fifteen, sixteen, and seventeen of Section number four of the Suburbs of Panmure, in the North Auckland Cattle District, are free from the disease called pleuro-pneumonia, doth hereby, in pursuance and exercise of the power conferred upon the Governor by the above-mentioned section of the said Act, proclaim and declare the aforesaid lots to be free from disease; and the place comprised within the whole of such lots shall, from the thirtieth day of October, one thousand eight hundred and eighty, cease to be infected within the meaning of the said Act.

# Additions of Land to the several Wards of the Borough of Wellington.

WHEREAS under "The Wellington City Boundaries Act, 1878," the several pieces of land respectively enumerated in the Schedule hereto were

respectively enumerated in the Schedule hereto were included within the boundaries of the borough of the City of Wellington, the same being a borough divided into wards: Now, therefore, in exercise and pursuance of the

Now, therefore, in exercise and pursuance of the powers vested in the Governor by the fourth section of "The Municipal Corporations Acts Amendment Act, 1880," I, James Prendergast, Chief Justice, the Administrator of the Government of Her Majesty's Colony of New Zealand, having been petitioned in that behalf by the Mayor and Council of the aforesaid borough, do hereby declare that the four several parcels of land described in the Schedule hereto shall respectively be added to the four several wards of the aforesaid borough, named the Cook Ward, the Te Aro Ward, the Lambton Ward, and the Thorndon Ward respectively, in manner as in the said Schedule is expressed.

# Subdivision of the South Waimakariri River District.

### (L.S.) JAMES PRENDERGAST, Administrator of the Government. A PROCLAMATION.

IN exercise and pursuance of the powers and authorities granted to the Governor by "The Canterbury Rivers Act 1870 Amendment Act, 1880," I, James Prendergast, Chief Justice of the Colony of New Zealand, and Administrator of the Government of the said colony, do hereby divide the South Waimakariri River District into the nine subdivisions enumerated hereunder; and do also declare that each of such subdivisions shall be a sub-district, with the name and boundaries respectively set forth in the Schedule following.

# SCHEDULE.

# NORTH-EAST CHRISTCHURCH SUB-DISTRICT.

BOUNDED on the East by the eastern side of the East Town Belt; on the North by the northern side of the North Town Belt; on the South by a line in the middle of Worcester Street; and on the West by a line in the middle of Colombo Street.

SOUTH-EAST CHRISTCHURCH SUB-DISTRICT.

Bounded on the North by the North-East Christchurch Sub-district; on the East by the eastern side of the East Town Belt; on the South by the southern side of the South Town Belt; and on the West by a line in the middle of Colombo Street.

NORTH-WEST CHRISTCHURCH SUB-DISTRICT.

Bounded on the North by the northern side of the North Town Belt and the north side of the River Avon; on the East by the North-East Christchurch Sub-district; on the South by a line in the middle of Worcester Street, continued westerly to Rural Section No. 10; and on the West by Rural Sections Nos. 10 and 163.

### SOUTH-WEST CHRISTCHURCH SUB-DISTRICT.

Bounded on the North by the North-West Christchurch Sub-district; on the East by the South-East Christchurch Sub-district; on the South by the south side of the South Town Belt; and on the West by Rural Sections Nos. 9 and 10.

### SYDENHAM SUB-DISTRICT.

Bounded on the East by the east side of Wilson's Road, from the Ferry Road to Wilson's Bridge over the River Heathcote; thence along the southern side of the said river to Piper's Road, the same being the southern boundary of Section No. 227; thence along the southern side of Piper's Road to Colombo Road South; thence along the southern side of Colombo Road South to the road which forms the south-west

boundary of Rural Section No. 238; thence along visions of "The Waste Lands Administration Act, the southern side of the latter road to the road which 1876," or of any other Act for the time being in force the southern side of the latter road to the road which forms the southern boundary of Rural Section No. 72; thence along the southern side of the last-mentioned road to the Lincoln Road; thence by a line along the northern side of the latter road to the South-West Christchurch Sub-district; thence along the southern boundary of the South-West and South-East Christchurch Sub-districts to the south-east corner of the latter sub-district; thence northerly along the eastern boundary of the South-East Christchurch Sub-district to the Ferry Road; thence along the southern side of the last-mentioned road to the commencing point.

### AVON SUB-DISTRICT.

Comprising the Avon Road District as at present existing.

### HEATHCOTE SUB-DISTRICT.

Comprising so much of the present Heathcote Road District as is included within the South Wai-makariri District, as defined by a Proclamation of the Superintendent of Canterbury, dated the 30th January, 1869.

### RICCARTON SUB-DISTRICT.

Comprising the present Riccarton Road District, and so much of the Templeton Road District and the Courtenay Road District respectively as is included within the South Waimakariri District, before mentioned.

# LINCOLN SUB-DISTRICT.

Comprising the present Spreydon Road District, and so much of the Lincoln Road District, the Springs Road District, the Little River Road District, and the Halswell Road District respectively as is in-cluded within the South Waimakariri District, before mentioned.

" The Highways Act, 1871," brought into Operation within the Wanstead Highway District, County of Waipawa.

### JAMES PRENDERGAST,

Administrator of the Government.

WHEREAS by an Act of the Provincial Council of Hawke's Bay initialed "The Highways Act, 1871," it is, amongst other things, enacted that the Superintendent may, from time to time, on the requisition of five voters, by notification in the Pro-vincial Covernment Council vincial Government Gazette, bring that Act into operation in any district, and thereupon, but not previously, that Act shall come into and remain in full operation therein; and in such notification the day, hour, and place of meeting for the first meeting of ratepayers for such district shall be appointed : And whereas, under the provisions of the said Act, a portion of the Provincial District of Hawke's Bay portion of the Provincial District of Hawke's Day has been created a highway district by the name of the Wanstead Highway District: And whereas the powers vested in the Superintendent by the said Act are now, by "The Abolition of Provinces Act, 1875," vested in the Governor: And whereas His Excellency the Administrator of the Government of the Colory of New Zealand has received a requisition the Colony of New Zealand has received a requisition signed by five voters of the Wanstead District, in the Provincial District of Hawke's Bay, requesting him to bring the said Act into operation in the said Wanstead District :

Now, therefore, I, James Prendergast, the Administrator of the Government of the Colony of New Zealand, in pursuance and exercise of every power and authority enabling me in that behalf, do, by this notification, bring "The Highways Act, 1871," into operation within the Wanstead Highway District, and do declare that the first meeting of ratepayers under the said Act shall be held at the Wanstead Hotel, Wanstead, on the twentieth day of November, one thousand eight hundred and eighty, at two o'clock in the afternoon.

# Lands permanently reserved.

WHEREAS by the one hundred and forty-fourth section of "The Land Act, 1877," it is enacted that the Governor may from time to time, either by general or particular description, and whether the same has been surveyed or not, reserve from sale temporarily, notwithstanding that the same may be then held under pastoral license, any Crown lands which, in his opinion; are required for any of the purposes in the said section mentioned:

And whereas by the one hundred and forty-fifth section of the said Act it is provided that land temporarily reserved under the said one hundred and forty-fourth section may, at the expiration of one month but not later than six months after the publication in the *Gazette* of notice of such temporary reservation, be permanently reserved, and that notice of such permanent reservation shall be published in the *Gazette*:

be permanently reserved, and that notice of such permanent reservation shall be published in the Gazette: And whereas the lands specified in the first column of the Schedule hereto were, by the several warrants the dates of which are specified in the third column of the said Schedule, and the notifications of which were published in the Gazettes specified in the fourth column, temporarily reserved under the authority of the said Act for the purposes specified in the second column of the said Schedule:

which were published in the Gazettes specified in the fourth column, temporarily reserved under the authority of the said Act for the purposes specified in the second column of the said Schedule: Now, therefore, I, James Prendergast, Chief Justice of the Colony of New Zealand, and Administrator of the Government thereof, in pursuance and exercise of the power and authority vested in me by the said Act, do hereby permanently reserve the lands so temporarily reserved as aforesaid, and enumerated in the first column of the Schedule hereto, for the purposes specified in the second column of the said Schedule, being the same purposes for which the said lands were so temporarily reserved as aforesaid.

Alterations and Additions to the Rates for the Conveyance, Delivery, and Storage of Goods, Parcels, &c., on the New Zealand Railways.

IN accordance with the By-laws for the New Zea-land Railways, fixed by Order in Council dated the 17th day of December, 1878, the following alterations and additions to the rates for the conveyance, delivery, and storage of goods, parcels, &c., on all the New Zealand Railways, are hereby declared to be fixed :-

# PART I .-- PASSENGERS.

RAILWAY OFFICERS AND EMPLOYES TICKETS. Privilege ordinary tickets and privilege season tickets, at one-fourth the ordinary rates, may be issued to railway officers and employés, or to their wives. The minimum charge for privilege ordinary tickets to be the same as for ordinary tickets.

### PART III.-GOODS.

Class N.—Ships' ballast, gravel, road metal, and shingle will be charged 1s. 6d. per ton less than the classified rates. Rough stone will be charged 2s. per ton for distances of 10 miles and under, instead of the classified rate.

Class P.-Native bricks will be charged 1s. 9d. per ton for distances of 9 miles and under, and sand will be charged 6d. per ton less than the classified rates for distances of 16 miles and under.

### PART IV.-LOCAL RATES.

### PICTON SECTION.

Class K .- Timber.

Timber will be charged at 8d. per 100 superficial feet between Mount Pleasant and Picton, instead of the classified rates, but subject to all conditions and regulations applying to the conveyance of timber.


