

Land set apart on Deferred Payments in the West Coast Land District.

(L.S.) JAMES PRENDERGAST, Administrator of the Government.

A PROCLAMATION.

WHEREAS by the fifty-third section of "The Land Act, 1877," it is enacted that the Governor, by Proclamation in the *Gazette*, may from time to time set apart out of any suburban or rural lands such blocks or allotments of land as he shall think fit, and set the same aside for sale on deferred payments, and in such Proclamation may fix a day on which the land shall be open for application; and that he may also in like manner set apart for sale on deferred payments such blocks or allotments, and from time to time alter, amend, or revoke any such Proclamation :

Now, therefore, I, James Prendergast, Chief Justice of the Colony of New Zealand, and Administrator of the Government thereof, in pursuance and exercise of the power and authority vested in me by the above-named Act, do hereby proclaim and declare that the land described in the Schedule hereto is set apart for sale on deferred payments; and that Monday, the thirteenth day of December, one thousand eight hundred and eighty, shall be the day on which the said land shall be open for application at the Land Offices at Carlyle and Hawera, in allotments as surveyed and marked on the selection maps in those offices.

And, further, in pursuance of the fifth section of "The Land Act 1877 Amendment Act, 1879," I do hereby fix the price at which the land so described shall be sold to be the price set opposite each allotment in the Schedule hereto.

TN pursuance and exercise of the powers and 1 authorities conferred upon me by the twentieth section of "The Land Act 1877 Amendment Act, 1879," I, James Prendergast Chief 1879," I, James Prendergast, Chief Justice of the Colony of New Zealand, and Administrator of the Government thereof, do hereby set apart the lands enumerated in the Schedule hereto for sale as village settlements, upon such terms and conditions as are set forth in an Order in Council of even date herewith, and made under the twenty-first section of the said Act.

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL.

HEREAS by the twenty-first section of "The Land Act 1877 Amendment Act, 1879," it is enacted that the Governor in Council may fix the terms and conditions upon which the lands comprised in any village settlement shall be disposed of, and the mode of payment for the same: And whereas the Governor has, by Proclamation in the New Zea-land Gazette, bearing date this twelfth day of November, set apart the lands enumerated in the Schedule hereto for sale as village settlements: Now, therefore, His Excellency the Administrator

of the Government, in pursuance and exercise of the powers and authorities conferred upon him by the hereinbefore in part recited Act, and by and with the advice of the Executive Council of the Colony of New Zealand, doth hereby fix the following terms and conditions upon which the said village settle-ments shall be disposed of, and the mode of payment for the same, that is to say,— 1. The lands enumerated in Schedule I. hereto

shall be open for application for cash at the Land Offices at Carlyle and Hawera, on Monday, the 20th day of December, 1880, at the prices stated therein. 2. The lands enumerated in State distribution

The lands enumerated in Schedule II. hereto 2. The lands enumerated in Schedule II. hereto shall be open for application on deferred payments at the prices stated therein, at the Land Offices at Carlyle and Hawera, on Monday, the 20th day of December aforesaid, subject to the provisions of Part III. of "The Land Act, 1877," relating to rural land, in cases where the allotments exceed an area of twenty acres and to the provisions of the said of twenty acres, and to the provisions of the said Part III. relating to suburban land, in cases where the area is twenty acres or under.

3. No person shall be allowed to acquire more than one section upon either immediate or deferred payments.

4. If there should be more than one application for any allotment in Schedule I. offered for cash, the right to purchase the same shall be determined by auction amongst the applicants only, and if there should be more than one application for any allot-ment in Schedule II. offered for deferred payments, the right to occupy the same shall be determined by

lot amongst the applicants. 5. Each applicant for a deferred payment section in Schedule II. will be required to make the declara-tion prescribed by section 62 of "The Land Act, 1877," and shall at the time of application deposit with the Receiver of Land Revenue for the West Coast Land District, one-fifth of the price, if the area of the allotment is twenty acres or under, and onetenth of the price if the area is greater than twenty acres. Such payment shall be deemed to be a discharge of the license-fee for the six months ending the 30th day of June, 1881.

6. The purchaser of any lands described in Sche-dule I., upon the full payment of the purchase-money, and the purchaser of any lands described in chedule II. upon the like payment, and also the fulfilment of the terms and conditions prescribed by "The Land Act, 1877," and "The Land Act 1877 Amendment Act, 1879," relating to land on deferred payments, will be entitled to his Crown grant, to be issued in the usual way upon payment of the fees prescribed by law.

NOTE.—The above township consists of fertile level iand, situate on the coast-line, and is accessible by coastal steamer; and the main coach-line of road from Hawera to New Plymouth forms the main street of the township, which is distant 38 miles from New Plymouth. A road-line is now being formed direct across Crown lands to the Railway Station at Stratford, which is distant 24 miles from Opunake.

Lithograph plans of the township can be obtained at any of the land offices in the colony after the 20th instant, and copies of the plan, with list of sections, will be exhibited at the principal post offices and railway stations throughout the colony.

Terms of Sale: One-fourth of purchase-money to be paid at sale, and the balance to the Receiver of Land Revenue, Carlyle or Hawera, within one calen-dar month from date of sale; otherwise the deposit will be forfeited, and the contract for the sale of the land thenceforth be null and void.

Crown-grant fee to be paid on completion of purchase.
