(L.S.) ARTHUR GORDON, Governor. A PROCLAMATION.

WHEREAS by the fifty-third section of "The Land Act, 1877," it is enacted that the Governor, by Proclamation in the Gazette, may from time to time set apart out of any suburban or rural lands such blocks or allotments of land as he shall think fit, and set the same aside for sale on deferred payments, and in such Proclamation may fix a day on which the land shall be open for application; and that he may also in like manner set apart for sale on deferred payments such blocks or allotments as may be recommended by any Land Board, and may also from time to time alter, amend, or revoke any such Proclamation:

And whereas the Land Board of Southland did, on the third day of March, one thousand eight hundred and eighty-one, pass a resolution recommending that the land described in the Schedule hereto annexed should be set apart for sale on deferred payments.

And whereas it is expedient to give effect to the aforesaid recommendation, and to set apart the said land accordingly:

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the above-named Act, do hereby proclaim and declare that the land described in the Schedule hereto is set apart for sale on deferred payments; and that Wednesday, the fourth day of May, one thousand eight hundred and eighty-one, shall be the day on which the said land shall be open for application at the Land Office at Invercargill, in allotments as surveyed and marked on the selection map in that office.

And, further, in pursuance of the fifth section of "The Land Act 1877 Amendment Act, 1879," I do hereby fix the price at which the land so described

shall be sold to be the price set opposite each allotment in the Schedule hereto.

Terms and Conditions of Sale of the Orari Village Settlement in Canterbury.

ARTHUR H. GORDON, Governor. ORDER IN COUNCIL.

At the Government House, at Wellington, this fifth day of April, 1881.

Present:

WHEREAS by "The Public Reserves Sale Act, 1878," it is, amongst other things, enacted that the lands described in the Schedule thereto may, at any time after the passing of the said Act, be sold by the Governor, upon such terms as shall be regulated

And whereas the lands described in the Schedule hereto are required to be sold upon deferred payments, and it is expedient that the terms of such sale should be defined:

by Order in Council:

And whereas by the twenty-first section of "The Land Act 1877 Amendment Act, 1879," it is enacted that the Governor in Council may fix the terms and conditions upon which the lands comprised in any village settlement shall be disposed of, and the mode of payment for the same:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, and in exercise of the powers and authorities aforesaid, doth hereby order and direct that the land described in the Schedule hereto shall be sold upon the following terms, that is to say,—

1. The land described in the Schedule hereto shall be set apart for sale as a village settlement upon deferred payments, in allotments as shown in the official subdivision plan in the Survey Office, Christehurch.

2. The land described in the Schedule hereto shall be subject to the provisions of Part III. of "The Land Act, 1877," relating to suburban lands, and to the provisions of section nine of "The Land Act 1877 Amendment Act, 1879."

3. The land described in the Schedule hereto shall be open for application on Monday, the ninth day of May, one thousand eight hundred and eighty-one, at the Survey Offices at Christchurch and Timaru.

4. No person shall be allowed to acquire more than one allotment.

5. The price at which the lands shall be open for application is ten pounds per acre.

6. If two or more persons shall make application on the same day for any allotment, the right to occupy the same shall be determined by public auction, the bidding being restricted to the applicants.

Each applicant shall deposit one-tenth of the | (inter alia) that in any case in which no sufficient purchase-money with the Receiver of Land Revenue for Canterbury, which deposit shall be deemed to be a discharge of the license-fee due on the first day of July next; but in the case of the sections which are to be submitted to auction, the person who is declared the purchaser of the land shall forthwith pay to the Receiver of Land Revenue, in addition to the sum he has deposited, an amount equal to onetenth of the increased price obtained for the land at

auction over the upset price thereof.

9. The purchaser of any lands described in the Schedule hereto, upon the full payment of the purchase-money, and also the fulfilment of the terms and conditions prescribed by "The Land Act, 1877," and "The Land Act 1877 Amendment Act, 1879," relating to land on deferred payments, will be entitled to his Crown grant, to be issued in the usual way upon payment of the fees prescribed by law.

Making Provision for Election of Mayor of Borough of Queenstown.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS on the twenty-fourth day of November one thousand and the VV ber, one thousand eight hundred and eighty, one Frederick Henry Daniel was, after a poll of the burgesses of the Borough of Queenstown, in the County of Lake, declared to be duly elected as Mayor of the said borough: And whereas, in accordance with the provisions of "The Regulations of Local Elections Act, 1876," the said election was, on the eighteenth day of January, one thousand eight hundred and eighty-one, declared by the Resident Magistrate holding inquiry as by the said Act provided to be void: And whereas, therefore, from such said eighteenth day of January, one thousand eight hundred and eighty-one, there was an extraordinary vacancy in the said office of Mayor within the meaning of the forty-sixth section of the said Act: And whereas the Returning Officer of the said borough failed to appoint a day for the election to fill such vacancy within the time prescribed by the said forty-sixth section: And whereas, owing to such failure by the said Returning Officer, no election has yet been held, and there is no power to hold the same except as is hereinafter provided, and no sufficient provision is made by the said Act or by "The Municipal Corporations Act, 1876," or any amendment thereof, for such a case: And whereas by the twelfth section of "The Municipal Corporations Act, 1876," it is provided

provision is made by that Act the Governor may, by Order in Council gazetted and publicly notified from time to time, make provision for any such case: And whereas, therefore, it is desirable that provision should be made for the case of the election of the Mayor of the said Borough of Queenstown, as is hereinafter done:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, in pursuance and in exercise of the powers vested in him by the said twelfth section of "The Municipal Corporations Act, 1876," and of all other powers in anywise enabling him in that behalf, doth, with the advice and consent of the Executive Council of the Colony of New Zealand, hereby order that the Returning Officer for the Borough of Queenstown may, by public notice, appoint a day, not less than twenty nor more than twenty-five clear days from the gazetting of this Order in Council, for the holding of an election for the office of Mayor of the said borough, notwithstanding that the period provided by the forty-sixth section of the said "Regulation of Local Elections Act, 1876," has expired, but so that such election shall be conducted in all respects as if the same had been held within the said period.

ORDER IN COUNCIL.

At the Government House, at Wellington, this fifth day of April, 1881.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by "The Maori Real Estate Management Act, 1867" (hereinafter called "the said Act"), it is enacted that, if any title to or interest in any hereditaments shall accrue to any Maoris, who or any of whom shall be infants, lunatics or under legal disability, it shall be lawful for the Governor in Council, if he think fit, to order that such hereditaments, or any part thereof or interest therein, as shall to the Governor in Council be shown to belong to such infant, or lunatic, or other person under legal disability,

shall be vested in trustees, as the Governor in Council shall think fit:

And whereas by "The Maori Real Estate Management Act Amendment Act, 1877," it is provided that in all cases in which no trustee of such estate of any infant Maori prior to the passing of the said last-recited Act has been appointed, the Governor may appoint such trustee only on the recommendation of a Judge of the Native Land Court:

And whereas in pursuance of orders bearing dates as contained in the first column of the Schedule hereto, made by the Judges named in the second column thereof, the persons named in the third column were recommended to the Governor as trustees under the said Acts on behalf of the persons named and under the disability described in the fourth column, in respect of the lands described or referred to in the fifth column:

Now, therefore, His Excellency the Governor of New Zealand, with the advice and consent of the Executive Council of the colony, in pursuance and exercise of the powers and authorities vested in him by the said Acts, doth hereby order that the interests and shares of the persons under ability named in the Schedule hereto in the several blocks of land referred to therein shall be and remain vested in the several persons named in the third column thereof as trustees within the meaning and for the purposes of the said Acts for the said persons respectively during the term or terms of their minority or other disability; the said parcels of land having the areas and boundaries set forth in the Crown grants, certificates of title, and memorials of ownership affecting the same, and in the record maps in the office of the Surveyor-General.
