WHEREAS by "The Bridges and Ferries Act, 1868," it is enacted that the Governor may from time to time, by Proclamation in the New Zealand Gazette, declare the said Act to be in operation in any county, district, or other division of the colony to be defined in such Proclamation, and on a day to be fixed in any such Proclamation the said Act shall come into operation within the county, district, or other division named or defined therein, as the case may be, and not before :

And whereas the County Council of the County of Wairoa is desirous that the said Act should be brought into operation in the said county:

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, in exercise and pursuance of the power and authority vested in me by the said Act, do hereby proclaim and declare that on the first day of September, one thousand eight hundred and eighty-one, the said "Bridges and Ferries Act, 1868," shall be in operation in the County of Wairoa.

(L.S.) ARTHUE GORDON, GOVERNOR. A PROCLAMATION.

IN pursuance and exercise of the power and authority vested in the Governor by "The Marriage Act, 1880," I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, do hereby abolish the existing marriage districts known as the Gabriel's and Blue Spur Districts, and do proclaim and declare that the territory heretofore comprised within the said districts is hereby included in one marriage district, the name and boundaries whereof shall be as follow :--

GABRIEL'S DISTRICT.

All that area bounded towards the West by a line parallel to and 20 chains distant from the Clutha River, from a point opposite the Crookburn to a point opposite Beaumont Burn; towards the North and North-west by a right line to the junction of the said Beaumont Burn with the Clutha, and by the Beaumont to its source; thence by a leading ridge to Lammerlaw; towards the North-east and East by the watershed between the Tuapeka and Waipori and Waitahuna Bivers to the source of the Crookburn; and towards the South-east by the Crookburn to its junction with the Clutha, and by a right line across said Clutha River to starting point: as the same is delineated on the plan deposited in the Survey Office, Dunedin.

And I hereby declare that this Proclamation shall come into operation on the first day of September, in the year of our Lord one thousand eight hundred and eighty-one.

Regulations respecting Alluvial Claims under "The Gold-Mining Districts Act, 1873," for Hauraki and Aroha Gold-Mining Districts.

WHEREAS by "The Gold-Mining Districts Act, 1873," it is enacted that it shall be lawful for the Governor, subject to the provisions of the said Act, from time to time to make, alter, amend, and revoke rules and regulations for all or any of the purposes therein set forth, and that no such rule or regulation shall become or have the effect of law until the same shall have been approved by the Governor in Council:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, and in exercise and pursuance of all power in that behalf enabling him, doth hereby make the regulations set forth in the Schedule hereto for the Hauraki and Aroha Gold-Mining Districts, in the Provincial District of Auckland.

REGULATIONS prescribing the size of claims under section 20 of "The Gold-Mining Districts Act, 1873 :".

1. An alluvial claim shall not exceed an area of 10,000 square feet (equal to 100 feet by 100 feet) for each holder of a miner's right, but more than 100,000 square feet shall be held together as one claim.

Double Ground (Class 3).

2. The Warden may in his discretion grant claims in alluvial ground not exceeding twice the ordinary size, on being satisfied that, either from the quality of the ground or any difficulty in working it, such extension of area is necessary; but no such grant shall be made until after application and the posting of notices in manner provided by regulations. And no such claim shall exceed 200,000 square feet.

Extended Claims (Classes 1 and 3).

3. When any extraordinary expenditure of capital or labour is requisite, or if the Warden is satisfied that any ground cannot be profitably worked in claims of ordinary or double size, it shall be lawful for him to ground to be called for him to grant claims in alluvial ground, to be called "Extended Claims;" such claims not to exceed one acre for each holder of a miner's right, and no such claim shall comprise more than six acres.

Frontage Claims (Classes 1 and 3).

4. A frontage claim shall be an area having 100 feet frontage to the terrace, river-bank, lake-bank, or hill-side for each holder of a miner's right, by a depth not exceeding 1,000 yards, but not more than 1,000 feet frontage shall be held as one claim; and the holders of any such claim shall be required within a reasonable time after the discovery of gold within the parallels to mark off an ordinary claim, the boundaries of which shall correspond with the parallels of the frontage claim, and shall thereupon cease to have any right to the remainder of such frontage claim.

River or Creek Claims (Class 3).

5. A river or creek claims to class 5. b. A river or creek claim shall not exceed 100 feet in length for each holder of a miner's right, to be measured in the direction of the course of any stream, by a width of not less than 30 feet, but when the stream exceeds 30 feet in width the width of the claim shall be taken from bank to bank, the banks to be defined when necessary by the Warden; but not more than 1,060 feet in length along the course of any stream shall be held as one claim.

Dredging Claims (Class 3).

6. In dredging claims each holder of a miner's right shall be entitled to an area of 200 feet along the course of the river or stream, by a width bounded by the ordinary high-water mark; but not more than 1114

2,000 feet along the course of any river or stream shall be held as one claim.

Prospecting Claims.

7. The Warden may grant a prospecting claim of double area in alluvial ground, but not more than six such double areas shall be held together as one claim.

Prospecting Areas.

8. A prospecting area may be granted by the Warden in alluvial ground of 600 yards by 400 yards.

Report on Collision between "Tainui" and "Christina" confirmed.

H IS Excellency the Governor has been pleased, in pursuance of the provisions of section 244 of "The Shipping and Seamen's Act, 1877," to confirm the decision of the Court of Inquiry into the collision between the steamer "Tainui" and the schooner "Christina," by which the New Zealand Certificate of Service, No. 2292, of Neil Smith, is suspended from one month from the 10th instant.

H. A. ATKINSON.

THAT the collision in question was solely caused by the wrongful act of the p.s. "Tainui" in deviating from her proper course, and also in attempting to cross the "Christina's" bow. The steamer was bound by the regulations in force to have gone slow, or to stop, or to reverse, as the occasion required; and took none of these precautions when the collision was imminent, but was preventible by due use of such measures. Having regard to Captain Neil Smith's long services and hitherto unblemished conduct, I am unwilling—although on this occasion he had charge of a number of female passengers-to visit him with too severe a punishment; but, looking to the number of coasting craft frequenting this harbour, and the increasing amount of steam traffic to the North Shore, feel bound to pass a sentence which should have the effect of rendering masters of ferry and other steamers cautious. The sentence is ferry and other steamers cautious. that the Certificate No. 2,292, held by Neil Smith, be suspended for one month from this date, and that he pay the costs of this inquiry, $\pounds 22$ 1s.


