*Decision by Chief Judge, Native Land Court, upon an Application for Rehearing of Rangipo Block.*

Auckland, 26th September, 1881.

HAVING considered the application of Topia Turoa and others, dated the 31st May, 1881, and the application of Poihipi Tukairangi, dated the 2nd June, 1881, and the application of Arepeta Haeretuterangi, dated the 3rd June, 1881, for the rehearing of a block of land called Rangipo, in the District of Taupo, which was decided by the Native Land Court at Tapuaeharuru on the 30th day of May, 1881, and having heard counsel thereupon, I hereby, in pursuance of the authority vested in me by "The Native Land Court Act, 1880," and "The Native Land Acts Amendment Act, 1881," make order as follows:—

I confirm the order of the Court in favour of Te Heuheu Tukino and others, for the piece of land called in the order of the Court Rangipo Waiu, No. 1 parcel of the said block, and coloured blue on the plan produced before the Court, containing 26,000 acres or thereabouts.

I confirm the order of the Court in favour of

Meiha Keepa te Rangihwinui and others, and Topia Turoa and others, for so much of the piece of land called in the order of the Court Rangipo Waiu, parcel of the said block as lies to the south of the junction of the Mangaio and Moaowhango Rivers, which piece of land is coloured red on the said plan, and contains 45,000 acres, more or less.

And I order that the title to the residue of the said piece of land which is comprised in the order of the Court for Rangipo Waiu, and which is situate to the north of the junction of the Mangaio River with the Moaowhango River, and is coloured yellow on the said plan, and contains 30,000 acres, more or less, shall be tried again.

And I order that the rehearing of the title to the said piece of land which is situated between the Mangaio River on the west, the Moaowhango River on the east, and the Waipahihi River on the north, shall take place at Upokongaro, near Wanganui, on the 1st day of December, 1881; and I make no order as to costs.

*Whakataunga o te Tumuaiki o te Kooti Whakawa Whenua Maori, mo runga i te tono kia tuaruatia te whakawa o Rangipo Poraka.*

KUA ata whakaarohia e ahau te tono a Topia Turoa me etahi atu, he mea tuhituhi mai i te 31 o nga ra o Mei, 1881, te tono a Poihipi Tukairangi he mea tuhituhi mai i te 2 o nga ra o Hune, 1881, me te tono a Arepeta Haeretuterangi he mea tuhituhi mai i te 3 o nga ra o Hune, 1881, tono kia whakawakia tuaruatia tetahi whenua ko Rangipo te ingoa, i te takiwa o Taupo, i whakawakia taua whenua e te Kooti Whenua Maori ki Tapuaeharuru i te 30 o nga ra o Mei, 1881.

A i te mea kua rongohia ahu i nga kupu a nga roia mo runga i taua tono, na i runga i te mana kua homai nei ki ahau e te "Ture Kooti Whenua Maori, 1880," me te "Ture Whakatikatika i nga Ture Whenua Maori, 1881," ka whakatahi nei ahau:—

Ka whakatuturutia e ahau te Ota o te Kooti whakatahi ki a Te Heuheu Tukino me etahi atu, tera piihi whenua e whakahuatia ana i roto i te Ota o te Kooti ko Rangipo Waiu Nama 1, tetahi wahi o taua poraka (o Rangipo) he mea pani ki te kara puru i runga i te mapi i whakatakotoria ki te aroaro o te Kooti, e tae ana ki te 26,000 nga eka i roto, nui ake iti iho ranei.

Ka whakatuturutia e ahau te Ota o te Kooti whakatahi ki a Meiha Te Keepa Rangihwinui me etahi atu, ki a Topia Turoa me etahi atu, tera wahi katoa o te piihi whenua i kiia i roto i te Ota o te Kooti ko Rangipo Waiu, tetahi wahi o taua poraka (o Rangipo) e takoto ana ki te taha whaka-te-tonga o te huinga o te awa o Mangaio me te awa o Moaowhango, ko taua piihi whenua he mea pani ki te kara whero i runga i taua mapi, e tae ana ki te 45,000 nga eka i roto, nui ake iti iho ranei.

A ka whakahaia e ahau me whakawa ano te take ki te toenga o taua piihi whenua i uru nei ki roto ki te Ota o te Kooti mo Rangipo Waiu, e takoto ana ki te taha whaka-te-raki o te huinga o te awa o Mangaio me te awa o Moaowhango, he mea pani ki te kara kowhai i runga i taua mapi, e tae ana ki te 30,000 nga eka i roto, nui ake iti iho ranei.

A ka whakahaia e ahau ko te take ki taua piihi whenua e takoto ana ki waenganui o te awa o Mangaio i te taha whaka-te-hauauru, te awa o Moaowhango ki te taha whaka-te-rawhiti me te awa o Waipahihi ki te taha whaka-te-raki, me whakawa tuarua ki Upokongaro e tata ana ki Whanganui a te 1 o nga ra o Tihema, 1881. A e kore au e whakatahi i te utu mo te whakawakanga.

Inahoki taku ingoa, he mea tuhi, i tenei te 26 o nga ra o Hepetema, 1881.
