ARTHUR GORDON, Governor. (L.S.) A PROCLAMATION.

WHEREAS by "The District Courts Act, 1858," it is enacted that it shall be lawful for the Governor from time to time, as he shall think fit, by Proclamation in the New Zealand Gazette, to constitute throughout the colony, or in any part thereof, districts within which District Courts shall be respectively held, and such districts to abolish, and the boundaries thereof to define or alter :

And whereas by a Proclamation bearing date the thirteenth day of March, one thousand eight hundred and seventy-seven, a district was defined within which a District Court should be held under the said Act, and it was thereby declared that the said Court should be designated by the name of "The District Court of Taranaki :"

And whereas by a Proclamation bearing date the twenty-ninth day of August, one thousand eight hundred and eighty-one, the boundaries of the said district were altered :

And whereas it is expedient to further alter the boundaries of the said district so defined and altered as aforesaid :

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authority vested in me by the said Act, do hereby proclaim and declare that, from and after the first day of February next, the boundaries of the district within which the District Court of Taranaki shall be held shall be altered, and that thenceforth the boundaries shall be the boundaries hereinafter described.

THE DISTRICT COURT OF TARANAKI. Description of District.

All that area bounded towards the North-west

Boundaries of District Court District of Taranaki by the Mokau River, from its mouth to its most altered. Rangitoto Mountain; towards the East by a right line to the source of the Ongaruhe River, and thence by the centres of the Ongaruhe, the Ngahuinga (or Tuhua), and Wanganui Rivers to the junction of the latter river with the Tangarakau River; thence by a right line to the summit of the watershed west of the Wanganui Biver, near the eastern corner of the Mangaotuku Block; again towards the East by lines from hill to hill, along the summit of the said water-shed, by Mataimoana, Taumatarata, Taurangapiopio, to Paparangiora; thence along a ridge separating the watersheds of the Waitotara River and Kai Iwi Stream to Tutukaikatoa; thence by a ridge and a summit of the Rangitatau Range to the nearest point to Aramairi Trigonometrical Station; thence by a right line to the north-east corner of the Auroa Native Reserve; thence by the northern boundary of the Waitotara Block to the Waitotara River, and thence by the centre of that river to the ocean; and towards the South-west and North-west by the ocean to the Mokau River, the starting point. Boundaries of District Court District of Wanganui altered

ARTHUR GORDON, Governor. (L.S.) A PROCLAMATION.

WHEREAS by "The District Courts Act, 1858," it is enacted that it shall be lawful for the Governor from time to time, as he shall think fit, by Proclamation in the New Zealand Gazette, to constitute throughout the colony, or in any part thereof, districts within which District Courts shall be respectively held, and such districts to abolish, and the boundaries thereof to define or alter :

And whereas by a Proclamation bearing date the thirteenth day of March, one thousand eight hundred and seventy-seven, a district was defined within which a District Court should be held under the said Act, and it was thereby declared that the said Court should be designated by the name of "The District Court of Wanganui : "

And whereas by a Proclamation bearing date the twenty-ninth day of August, one thousand eight hundred and eighty-one, the boundaries of the said district were altered :

And whereas it is expedient to further alter the boundaries of the said district so defined and altered as aforesaid :

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, in pur-suance and exercise of the powers and authority vested in me by the said Act, do hereby proclaim and declare that, from and after the first day of February next, the boundaries of the district within which the District Court of Wanganui shall be held shall be altered, and that thenceforth the boundaries shall be the boundaries hereinafter described.

THE DISTRICT COURT OF WANGANUI.

Description of District.

All that area bounded towards the West and North-west by the Taranaki District Court District, as described in a Proclamation of even date herewith, to the northern boundary of the Kirikau Block; thence by that boundary to the eastern corner of the said block; thence towards the North-east by a line from the eastern corner of the Kirikau Block aforesaid drawn to the summit of the Kirikau Block aroresaid drawn to the summit of the Tongariro Mountain; thence towards the East by right lines from peak to peak to the summit of Rua-pehu Mountain; thence by a right line to Trigono-metrical Station No. 28, on the boundary of Hawke's Bay County; towards the East, North, and again towards the North-east by said county; thence again towards the North-east by said county; thence again towards the East and South-east by lines from peak to peak along the summits of the Ruahine and Tararua Ranges to the north-eastern corner of the Wellington Highway District; thence towards the South by the northern boundary of the said highway district to Cook Strait; thence by the shores of Cook Strait and the ocean to the Waitotara River, the starting point.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by an Order in Council bearing date the tenth day of May, one thousand eight hundred and seventy-nine, the powers granted to the Colonial Secretary under the seventy-fourth and seventy-fifth sections of "The Lunatics Act, 1868," were delegated to Lowther Broad and George Lilly Mellish, and by an Order in Council bearing date the twenty-second day of July, one thousand eight hundred and seventy-nine, the said powers were delegated to William Lawrence Simpson: And whereas it is expedient to delegate the said powers in manner hereinafter expressed :

Now, therefore, His Excellency the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said Colony, doth, by this present order, delegate to the persons named in the first column of the Schedule hereto the powers granted to the Colonial Secretary under the seventy-fourth and seventy-fifth sections of the said Act, and doth hereby order that the said powers shall be exercised by the said persons within the district placed opposite the name of each respectively in the second column of the said Schedule.

Re-delegating powers to the Auckland Domain Board.

ABTHUR GORDON, Governor. ORDER IN COUNCIL.

At the Government House, at Wellington, this seventeenth day of January, 1882.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the twelfth section of "The Public Domains Act, 1881," it is enacted that the Governor, by Order in Council, may from time to time delegate all or any of the powers by the said Act conferred, except the powers conferred by section five and the said section twelve, to any person or persons or body corporate for any period, and subject to such stipulations as may be specified in such order, and that every such delegation may from time to time in like manner be altered or revoked :

And whereas His Excellency the Governor, by Order in Council made on the nineteenth day of

December, one thousand eight hundred and seventyseven, did delegate certain powers conferred by "The Public Domains Act, 1860," to certain persons therein mentioned, subject to certain stipulations therein specified :

And whereas it is expedient to revoke the said Order in Council, and to make another delegation in lieu thereof:

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth, by this present order, revoke the delegation contained in the said Order in Council, and doth, with the like advice and consent, by this present order, delegate, but only with respect to the piece or parcel of land described in the first clause or section of the Schedule to "The Public Domains Act, 1881," all the powers conferred by the Act first above mentioned, except the powers under or conferred by sections five and twelve, to the undermentioned persons :—

(herein referred to as "the delegates"), subject to the stipulations hereinafter contained, that is to say,----

1. The delegates shall hold their first meeting on Monday, the twenty-third day of January, one thousand eight hundred and eighty-two, at the Customhouse and Post Office Buildings, in a room therein called "Ministers'-room." Subsequent meetings shall be held at such time and place as the meeting shall from time to time appoint.

2. The delegates may from time to time at any special meeting make such rules and regulations for conduct of their proceedings as they may think proper and necessary.

3. Special meetings may be convened by the Chairman, or by any two of the delegates, provided that two days' notice of such meeting be given to each delegate, specifying the business to be transacted at such special meeting, and no other business than that so specified shall be transacted at such meeting.

4. Any five of the said delegates shall form a quorum. Any meeting may be adjourned from time to time.

5. The delegates shall, at their first meeting, and thereafter at an annual meeting to be held on the first Monday in every succeeding year thereafter, elect one of themselves to be Chairman, who may join in the discussion, and shall have an original as well as a casting-vote. The Chairman shall hold office until the election of his successor.

6. If at any meeting the Chairman is not present at the time appointed for holding the same, the delegates present shall choose some one of their number to be Chairman of such meeting.

7. If by resignation, death, or incapacity, or otherwise, the office of Chairman shall be or become vacant, the delegates may at any monthly or special meeting appoint a Chairman.

8. All questions shall be determined by the majority of votes of the delegates present at a meeting.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. WHEREAS by the sixteenth section of "The

W Harbours Act, 1878," it is enacted that in any harbour where no Harbour Board is in existence the Governor in Council may authorize any person to construct harbour works (other than the reclamation of land from the sea in any harbour, or the construction of any graving dock or breakwater in any harbour or in the sea), and to use and occupy such part of the foreshore or of any tidal land or tidal waters as may be necessary for the construction or use of such harbour works:

And whereas Messrs. Wigmore and Tolerton, of Whangaroa, desire to build a wharf in Whangaroa Harbour, a place where no Harbour Board is in existence:

Now, therefore, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, doth hereby authorize the said Messrs. Wigmore and Tolerton to build, for the use and benefit of the public, a wharf in Whangaroa Harbour, in accordance with the plans marked M. D. 594 and 596, and deposited in the office of the Marine Department, and to use and occupy such portion of the foreshore or of any tidal land or tidal water as may be necessary for the construction and use of such wharf, subject to the following conditions, that is to say,—

1. That all Her Majesty's subjects shall, at all reasonable times, have free and full liberty to use the above-mentioned wharf, and of ingress and egress thereon.

2. That Her Majesty or the Governor, and all officers in the Government service, acting in the execution of their duty, shall at all times have free ingress, passage, and egress into, through, and out of the wharf without payment.

3. That the said Messrs. Wigmore and Tolerton shall maintain and keep the above-mentioned wharf and all erections thereon in good order and repair, and shall at all times permit to be erected and exhibited therefrom any lights for the guidance of vessels, and shall maintain at their own cost any such lights: Provided that no light shall be exhibited until after it has been approved of by the Marine Department.

4. That any person authorized by the Minister having charge of the Marine Department, or any officer acting with his approval, may at all reasonable times enter upon the said wharf and any buildings erected thereon, and view the state of repairs thereof; and that, upon his leaving at the last known address of Messrs. Wigmore and Tolerton a notice in writing of any defect or want of repair in such wharf or buildings, requiring them, within a reasonable time to be therein prescribed, to repair the same, the said Messrs. Wigmore and Tolerton shall, with all convenient speed, cause such defect to be removed or such repairs to be made.

5. That Messrs. Wigmore and Tolerton will not ercct or suffer to be erected on the said wharf any building or structure whatever, except with the consent of the Marine Department.

6. That nothing herein contained shall authorize Messrs. Wigmore and Tolerton to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs, or any regulation of the Commissioner of Customs, or with any provisions of "The Harbours Act, 1878," or its amendments, or any regulations thereunder.

7. That the rights, powers, and privileges conferred by this Order in Council shall continue in force for ten years, computed from the first day of May, one thousand eight hundred and eighty-one, unless in the meantime altered, modified, or revoked.

8. That the rights, powers, and privileges conferred under or by virtue of this Order in Council may be at any time resumed by the Governor, on giving to Messrs. Wigmore and Tolerton six calendar months' notice in writing. Any such notice shall be sufficient if given by the Governor or the Minister having charge of the Marine Department, or any person acting under his or their instructions, and delivered at the last known address of the said Messrs. Wigmore and Tolerton, their administrators or assigns.

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, in pursuance and exercise of every power and authority vested in me in that behalf, do hereby revoke all appointments heretofore made, and in lieu thereof do hereby appoint the newspapers specified in the Schedule hereto to be the newspapers for the purpose of inserting therein, during the year one thousand eight hundred and eighty-two, all notifications which, by any Act of the General Assembly or Ordi-nance of any Provincial Council, are required to be inserted in the Provincial Government Gazette within the provincial district named opposite the name of each newspaper respectively in such Schedule.

WHEREAS by an Act of the Parliament of South Australia passed in a session held in the twenty-fourth and twenty-fifth years of Her Majesty's reign, No. 12, intituled "An Act to enable the Governor to prevent the Importation of Cattle into South Australia under certain Circumstances, and for other Purposes," it is enacted that it shall be lawful for the Governor from time to time, with the advice and consent of the Executive Council, by Proclamation in the South Australian Government Gazette, to prohibit the introduction or importation of any cattle, or any particular description of cattle, into the said province,

from such places and during such times as should be set forth in such Proclamation: And whereas by another Act of the said Parliament passed in a session held in the twenty-seventh and twenty-eighth years of the reign of Her said Majesty, No. 19, intituled "An Act to amend the Laws relating to the Customs," it is, amongst other things, enacted that, if any goods enumerated or described in the table of prohibitions in the thirty-fourth section of the said Act shall be imported or brought into the Province of South Australia, then, and in every such case, such goods shall be forfeited, or destroyed, or otherwise disposed of, as the Treasurer may direct: And whereas in the said table of prohibitions of goods absolutely prohibited to be imported are included infected cattle, sheep, or other animals, and hides, skins, horns, hoofs, or other part of cattle or other animals, which the Governor in Council may prohibit, in order to prevent any infectious or contagious distemper or disease: And whereas by a Proclama-tion in the Government *Gazette*, on the tenth day of July, one thousand eight hundred and seventy-nine, the introduction or importation into the Province of South Australia of horned cattle, sheep, and pigs, shipped at any place or places beyond the limits of the Australian Colonies (save and except cattle, sheep, swine, and goats shipped from Great Britain, Ireland, the United States of America, and Canada, shipped at Timor to be landed in the Northern Torritory) may prelibited until the soid Paradametican Territory), was prohibited until the said Proclamation should be revoked in the Government Gazette: And whereas disease is known to exist in cattle, sheep, and swine, in divers places beyond the limits of the Australian Colonies, and it is expedient to continue the prohibition until further order herein: Now, therefore, I, the said Governor, in pursuance of the provisions of the above-recited Acts, and of all other powers me enabling, and with the advice and consent of the Executive Council of the said province, do hereby revoke, annul, and make void the aforesaid Proclamation published on the tenth day of July, one thousand eight hundred and seventy-nine, and in lieu thereof I do hereby absolutely prohibit the introduction or importation into the Province of South Australia of horned cattle, sheep, or pigs, shipped in Great Britain, or Ireland, or at any other place or places beyond the limits of the Australian Colonies (save and except cattle, sheep, swine, and goats shipped from the United States of America and Canada; and also save and except cattle, sheep, and swine shipped at Timor, to be landed in the Northern Territory): And I further order and direct that this Proclamation shall take effect from the date hereof, and shall continue in full force and effect until the same is revoked by Proclamation in the aforesaid *Gazette*.

Rules for the Management of the Greytown Cemetery, County of Wairarapa West.

THE following rules for the management of Greytown Cemetery, having been submitted to His Excellency the Governor in Council, are published in accordance with "The Cemeteries Management Act, 1877."

THOMAS DICK.

RULES FOR THE MANAGEMENT OF THE GREYTOWN CEMETERY.

Cemetery Divided.

1. Such portions of the Greytown Cemetery as may from time to time be laid out into blocks shall be divided into burial-plots measuring 10 feet by 5 feet. The following to be the scale of charges :-

Burial-fees. s. d. For every single interment in ordinary grave or vault 1 0 0 For reopening grave or vault for any interment 1 0 0 • • • ... Exclusive Right of Burial in Perreguity.

2. Any person desiring to have the exclusive right of burial in perpetuity in any plot or plots can have the same on payment to the Trustees of the sum of £1 sterling per plot, measuring 10 feet by 5 feet, and for every additional foot 4s., for such right, over and above the burial-charges.

Gound set a ide for Persons who are not Purchasers, and who have not acquired Right to Private Ground.

3. A portion of the ground shall be set aside for the interment of such persons as are not purchasers of, and have not acquired a right to, private ground. On this ground no fencing or other obstruction rising more than one foot above the surface shall be allowed, and no grave shall, under any circumstances, be opened for a new interment sooner than after the expiry of five years from the time of the first or last interment, as the case may be. Flat tombstones will be allowed on payment of a fee of 10s., and the friends or relatives of the deceased may acquire the right to the grave, with the consent of the Trustees, by paying £1 for the ground, 10 feet by 5 feet, and for every additional foot 4s.

In certain Cases Fees may be Omitted.

4. The costs and charges of burial of any person

in the cemetery may in certain cases be remitted on of burial, or for transfers or duplicates of the same, proof being given to the satisfaction of the Trustees must at their own cost provide all duty stamps. that there are no funds available for payment of such fees, and that no person is to be found who is liable for the payment of the same.

Depth of Graves.

5. All graves must be not less than six feet deep; but, in the event of purchasers of private ground desiring a greater depth, an extra charge of 2s. shall be made for every foot more than six feet. No coffin to be within 4 feet 6 inches of the surface.

Trustees reserve Right.

6. The Trustees reserve to themselves the right to regulate the occupation of plots.

Permission to Fence in Plots and Erect Tombstones.

7. Persons purchasing the exclusive right of burial may, by permission of the Trustees, fence in the plots of ground allotted to them, provided that all such fences be kept within the pegs, and that any fence in wood shall not exceed four feet in height; and may erect tombstones, headstones, or other monuments thereon: Provided always that, before any such fence, tombstone, or other monument be erected, a plan thereof, and a copy of every proposed epitaph or other inscription, be submitted to the Trustees, and be duly approved by them.

Trees and Shrubs to be Planted only by Permission.

8. No person shall be allowed to plant in any portion of the cemetery or on any ground on which the exclusive right of burial has been thus acquired, except by express permission in writing from the Trustees, any tall-growing shrub or tree; and any shrub or tree planted in any portion of the cemetery, or on any ground acquired for the exclusive right of burial as aforesaid, may at any time be trimmed, removed, or cut down by order of the Trustees.

Grants of Exclusive Right of Burial.

9. Grants of exclusive right of burial in perpetuity shall be made out in the form marked A annexed to these regulations, and shall only be made out in the name of one particular person to be named therein.

Transfer of Grants.

10. Any purchaser of exclusive right of burial in perpetuity in any particular plot of ground in the said cemetery, in which no interment shall have taken place, may, by permission of the Trustees, transfer his or her interest in the said plot of ground to any other person upon payment being made to the Trustees of a transfer fee of 5s. for every such transfer, and on production to the Trustees of the original grant.

Transfer of Grants on Death of Owner.

11. On the death of any person holding a grant of exclusive right of burial in perpetuity, the grant may be transferred to any other person applying to the Trustees for such transfer, on payment of a fee of 5s., on production of the original grant, and on their pro-ducing sufficient and satisfactory evidence of their authority to apply for the said transfer.

Loss or Destruction of Grants.

12. If at any time a grant of exclusive right of burial should be lost or accidentally destroyed, a duplicate grant may be obtained on application in writing made to the Trustees, and on payment of a fee of 10s. Persons applying for a duplicate grant must give satisfactory written evidence of the loss or destruction of the original grant, and of their authority to apply for a duplicate grant. Should the original grant be at any time found after the issue of a duplicate, the duplicate must be at once returned to the Trustees.

Sexton Appointed.

14. A sexton will from time to time be appointed by the Trustees, whose duty it will be to dig all graves required in the cemetery; and no other person will be allowed to dig any grave therein without express permission from the Trustees.

Records and Books to be Kept.

15. The Trustees shall keep, or cause to be kept, a book, in which shall be entered from time to time the number of every lot disposed of for the exclusive right of burial, the name of the purchaser, and date of disposal. They shall also keep a record of every lot of ground used for the purpose of interment, the name of the person interred, and date of burial.

Plan of Cemetery to be Made

16. As soon as possible after any portion of the cemetery is laid out for the purpose of interments, a complete plan thereof shall be made. The plan shall be marked out in lots, and each lot shall be numbered, and such lots shall be marked out by pegs in the ground.

Plan and Record open for Inspection.

17. The record-book and plan of cemetery, when prepared, shall be open for inspection to the public any day, Sundays and holidays excepted, between the hours of 10 a.m. and 3 p.m.

Burial-warrants to be Issued.

18. In all cases of intended interment the person having management or control of the same shall apply for a burial-warrant to the Trustees or other person appointed to issue the same. The warrant shall be in the form marked B annexed to these regulations, and shall be given to the party applying for the same, upon payment of the fees mentioned in Rule 1.

Levelling and Removing of Earth done by Applicants.

19. The foregoing charges are in addition to any sums that may be paid for grants of exclusive right of burial. They do not include payment for any work required to be done beyond the actual digging of an ordinary grave, and, after the interment, filling in the same. Persons who have purchased the right to fence in parcels of ground must do all levelling re-quired at their own cost, and only on approval of the Trustees; and must at once remove from the cemetery all earth and rubbish not required. If not removed when required by the Trustees, they may cause the said earth and rubbish to be removed at the expense of the person failing to remove same, as above mentioned.

Burial-warrants to be given to Sexton.

20. The burial-warrant when signed shall be given by the party having the management of the funeral to the sexton, and shall be sufficient authority for the interment.

Burial-warrants to be given to Sexton Eight Hours before Interment.

21. Burial-warrants must be given to the sexton at least eight working-hours prior to the time fixed for the funeral, otherwise an extra fee of 5s. must be paid. No free interment will be allowed without the above notice of eight hours.

Time of Funerals.

22. Until otherwise ordered, funerals will only be allowed between the hours of 8 a.m. and 5 p.m., except on Sundays, when the hours will be from 2 to 5 in the afternoon.

Particulars to be given for Warrants.

Duty Stamps for Grants, &c. 23. The following particulars must be given at the 13. Parties applying for grants of exclusive right time of application for a burial-warrant, viz. :---

Fences, Headstones, &c., to be kept in Repair by Surviving Owner.

24. All fences, enclosures, tombstones, headstones, and other monuments must be kept in proper order and repair by the surviving holders of the grant or relatives of the deceased. All wooden or other fences left in a state of decay, or broken down, may at any time be removed from the cemetery by order of the Trustees.

Vaults.

25. Persons purchasing the exclusive right of burial in perpetuity in any plot of ground in the cemetery may, by permission of the Trustees, ex-cavate the same within one foot of their outside boundaries for the purpose of constructing a vault. Before any work is commenced towards the con-struction of any vault the plan and specification of the work connected therewith shall be submitted to the Trustees for approval, and no work shall be commenced until such approval has been obtained.

Construction of Vaults.

26. All vaults shall be lined throughout with brickwork or concrete, and covered in with arched brickwork, concrete, or stone set in cement. The depth, length, and breadth of the vaults shall be according to agreement with the Trustees. The entrance to the vault shall be either by a stone at the top or an iron door. In all cases entrances shall be securely fastened, and all work done to the satisfaction of the Trustees.

Coffins for Vaults.

27. Coffins for vaults must be lined with lead or other approved metal, to be firmly and securely soldered. Coffins may be laid in vaults, and covered in with concrete or cement, so as to prevent the escape of noxious vapour.

Labour, &c., to be Approved by Trustees.

28. All labour, materials, and tools required for constructing vaults or for excavating for vaults must be provided by the parties applying for the same.

Work, &c., of Reopening Vaults to be Approved by Trustees. 29. All labour, materials, and tools required for reopening vaults for interments, and for reclosing the same, must be provided by the party owning the vault, and must be approved by the Trustees.

Vaults must be kept in Repair by Surviving Owner.

30. All vaults must be kept in proper order and repair by surviving owner. If at any time they become out of proper order and repair, the Trustees may give the owner fourteen days' notice to repair the same, by leaving such notice at the last-known place of abode of the owner or his agent. If the address of the owner or his agent is not known, or if the owner fails to do or cause to be done the required repairs within the fourteen days above mentioned, the Trustees may at any time cause all such necessary repairs to be done, and no interment shall thereafter be allowed in such vault until all costs and charges of such repairs have been paid to the Trustees.

Earth and Rubbish to be Removed by Applicants.

31. All earth and rubbish thrown out when excavating for vaults must be removed by the person who applies for permission to construct such vault. If not at once removed when required by the Trustees, they may cause the said earth and rubbish to be removed, and the costs and charges of so doing may be recovered from the person applying for permission to construct such vault.

No Interment to take place in Vault without Warrant.

32. No interment shall be permitted in any vault until the party requiring to open such vault for in-terment has obtained a burial-warrant, as provided for ordinary burials, which warrant shall be sufficient. authority for the vault named therein to be opened.

All Charges and Fees to be paid in Advance.

33. All charges made for any matter or thing connected or relating to the cemetery shall be paid in advance.

Fences may be Removed.

34. In the case of all persons interred in the cemetery previous to the 1st day of January, 1882, and whose surviving relatives or friends have previous to the above date fenced in portions of land round the graves of persons so interred, it is hereby provided that, in all cases where the grant of exclusive right of burial in perpetuity is not acquired, it shall be lawful for the Trustees at any time to remove or alter the position of any of the said fences whenever it may be found necessary to do so.

Bodies not to be Disinterred.

35. No body shall be disinterred or removed from the said cemetery except by order of the Coroner, without express permission in writing from the Trustees.


