Licensing Districts.

(L.S.) ARTHUR GORDON, Governor. A PROCLAMATION.

WHEREAS by the sixth section of "The Licensing Act, 1881," it is enacted that the Governor shall, as soon as conveniently may be after the commencement of the said Act, by Proclamation in the Gazette, from time to time define districts to be licensing districts under the said Act, and from time to time may alter and redefine the boundaries of the same:

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, do hereby, in pursuance and exercise of the power and authority vested in me by the said Act, proclaim and define the several parts of the colony mentioned and described in the Schedule hereto to be ordinary licensing districts for the purposes of the said Act, and that each such district shall be known by the name by which it is designated in the said Schedule.

SCHEDULE.

NORTH ISLAND.

Mongonui County.

Whangaroa.—Bounded towards the South, Southwest, and North-west by the Highway Districts of Whangaroa North, Kaeo, and Totara respectively, from Takou Bay on East Coast to Stoney Creek at its junction with the Orouaiti River; thence towards the North by said Totara Highway District to Whangaroa Harbour; thence by the coast-line to Takou Bay, the starting point.

Mongonui.—Bounded towards the South, Southeast, and again towards the South by the Whangaroa Licensing District, from Whangaroa Harbour to the Oruru Highway District; thence southerly and westerly to the Mangatete River; thence southwesterly by that river to Rangaunu Harbour; thence by the sea to the starting point.

Kaitaia.—Bounded towards the East by the Mongonui Licensing District to the north boundary of Hokianga County; thence westerly by said county to Herekino Bay on West Coast; thence northerly by said coast to Cape Maria Van Diemen; thence easterly by coast-line to North Cape; thence southerly by East Coast to the starting point.

HORIANGA COUNTY.

Waihou.—Bounded towards the North by Mongonui County; towards the East by Bay of Islands County to the centre of the main road dividing the Bay of Islands and Hokianga Counties; thence towards the South by the middle of the said road to the Taheke River, and by the middle of said river and the Waima River to the Hokianga Estuary, and by the south shore of that estuary to the ocean; and towards the West by the ocean.

Waima.—Bounded towards the North by Waihou Licensing District; towards the East by Bay of Islands County; towards the South by Hobson County; and towards the West by the ocean.

BAY OF ISLANDS COUNTY.

Kawakawa.—Bounded towards the East by the Waikare River to the western boundary of Baker's grant, and by said western boundary; thence by a line from the south-west angle of Baker's grant to the northern boundary of Ruapekapeka Block; thence by the eastern boundary of Ruapekapeka Block and by the Waiotu River to south-west angle of Puhipuhi

Thames South.—All that portion of the Borough of Thames not included in Thames Central Licensing District or Thames North Licensing District.

New Plymouth West.—Bounded towards the West by a line commencing at a point on the sea-coast where the production of the middle of Dawson Street intersects the said coast; thence running along the middle of said street to its intersection with the middle of Vivian Street; thence along the middle of said street to its intersection with the middle of Robe Street; thence along the middle of Robe Street to its intersection with the middle of Pendarves Street produced through the Military Reserve and across the Huatoki Stream to the western boundary of New Plymouth East Licensing District; thence following said boundary to the southern boundary of the Borough of New Plymouth.

New Plymouth Central. - Comprises all that portion of the Borough of New Plymouth not included in the Licensing Districts of New Plymouth East and New

Plymouth West.

Patea. - Being all that area known as the Borough of Patea. Bounded towards the North-east by the Patea River; towards the South-west by the ocean to a point at which the production of the north-western boundary-line of Suburban Section No. 55 intersects high-water mark; thence towards the North-west and North by a right line to the most westerly corner of said section, by Sections Nos. 56 and 17, and by a road line north-east of Sections Nos. 18, 9, 6, and 7, and the south-eastern side of that road produced to the Patea River, the commencing point.

Borough of Hawera.—Being all that area known as the Borough of Hawera. Te Aro.—Comprises all that portion of the Borough of Wellington known as the Te Aro Ward of the

City of Wellington.

Wellington Cook .- Comprises all that portion of the Borough of Wellington not included in the Licensing Districts of Thorndon, Lambton, and Te Aro, and known as the Cook Ward of the City of Wellington.

Wanganui Cook.—Bounded towards the North-east

Station by Section No. 1; towards the West by said Section No. 1 and by the Railway Reserve and Section No. 49; towards the South-west by said Section No. 49 and by Section No. 48; again towards the West by Section No. 84; again towards the North by Section No. 8, a road, and Section No. 7a, all of Block X., Oroua Survey District; towards the East by Section No. 29; towards the North-east by said Section No. 29 and by Sections Nos. 28 and 26; again towards the West by said Section No. 26, Block XIV., Oroua Survey District; again towards the North by Section No. 27; again towards the West by said Section No. 27; again towards the North by Section No. 3, Block XV., Orous Survey District, to the Orous River; towards the Front by the Orous River; towards the East by the Orona River; towards the South by the Railway Reserve and Sections Nos. 149 (Native reserve) and 86, Block XIV., Oroua Survey District; towards the West by that portion of Sec-tions Nos. 85 and 132, Block XIV., Oroua Survey District, lying to the west of a line bearing 354° 11 (magnetic) from a point on the northern boundary of Section No. 86, Block XIV., Orona Survey District, distant 796 links from the Awahuri Road; again towards the North by a road-line; again towards the West by Section No. 130, Block XIV., Oroua Survey District, to starting point.

Sydenham.—Being all that area known as the Borough of Sydenham.
