*Exempted Land in Nelson South-West Gold Fields declared open for Mining Purposes.*

(L.S.) ARTHUR GORDON, Governor.  
A PROCLAMATION.

IN pursuance of the power and authority vested in me by the seventh section of "The Mines Act, 1877," I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, do hereby authorize the occupation of the land described in the Schedule hereto for mining purposes, provided that no person shall be allowed to occupy any portion of the said land without obtaining the sanction of the Warden of the district, and that the land shall be at all times worked to the satisfaction of the Warden, who shall have power to stop any works if he sees good reason for doing so.
